wonder what the regulations state about holding a viva voce without the knowledge of a member of the examination committee," read the letter.
On March 8, another letter was submitted to the exam controller by Prof Abdul Mannan, a teacher in the department.
It stated that on January 16, Sazzad conducted the viva voce of some students in absence of two other committee members, which is clearly a violation of university rules.
Talking to The Daily Star some of those students confirmed the allegation.
Contacted, Sazzad denied the allegation and said it was part of a conspiracy against him.
"The external teacher informed me that he could not attend the viva voce," he said.
"We have formed a fact-finding committee following the matter. Once we get the report, we will know what actually happened," said Prof Ruhul Amin, chairperson of the department.
Dhaka University Vice Chancellor Prof M Akhtaruazzaman told The Daily Star, "We will not compromise with university rules. Authorities concerned will take action if anyone is found guilty."

RU flip-flops over admission

In 2015, the RU authorities, led by then VC Prof Muhammad Mizanuddin, first decided to allow only fresh HSC graduates to sit for admission tests from 2016-17 academic session.
In 2017, the new administration changed the rule and reinstated the "second chance" option for 2017-18. Then VC Prof M Abdus Sobhan said they did so to help students, especially those from the north, who were lagging behind in education.
Interestingly, the same

administration withdrew this option from 2019-20, and that decision was in place till 2020-21 session.
In addition, the RU authorities first introduced written test along with MCQ in 2019-20; but they scrapped the written test the very next session.
Former pro-VC Prof Chowdhury Sarwar Jahan told The Daily Star that the admission test is a primary process to find talented students. "So, the authorities should maintain a standard for

quality education, not to serve any other purposes."
Former VC Prof Mizanuddin said, "We abolished the second-try opportunity for the first time to ensure quality education. Afterwards, we saw so many changes in the rules, which were for various purposes. The authorities need to stay neutral while introducing any rule."
Over the matter, pro-VC Prof Sultan-Ul-Islam said, "It is a failure for us that we could not maintain any standard in admission test. But, we are trying to do so in the upcoming days."

Denying the allegation of serving personal purposes, the incumbent VC said, "We kept the second-chance option this year as per recommendations of admission test sub-committee. In addition, there were requests from UGC to do so."

police, judiciary and state machinery.
He said they have heard that the government has made a list of BNP's important leaders in different districts. "A cell has been formed to quickly dispose of the cases against those front-ranking leaders," he alleged.
The BNP leader said the government is also trying to suppress other opposition parties like the left parties by filing cases against them.
"They (government) are trying to make the election field empty as they did it before the national election in 2018 and 2014," he said.
Fakhru also condemned the arrest of their party leader Ishraque Hossain.
He said the new chief election commissioner has been holding talks with different sections of people and making various statements about a credible election. "These are all dramas," he said.

He also criticised the inspector general of police and the DMP commissioner for making political statements against BNP and its leaders. "The way the servants of the republic talk, it gives us an impression that we're not living in a civilised country."

Deputy Secretary Sherman appreciated Bangladesh's willingness to address these issues, while also stressing upon early implementation of the reform process, especially regarding trade union rights in private sectors.
She also discussed the democratic process in Bangladesh and on the possibility of Bangladesh's participation in the next Democracy Summit, according to a message received from Washington.
The two sides also discussed the situation in Ukraine and its global implications, the Indo-Pacific strategy, and security sector cooperation.
Masud also discussed the possibility of officials visiting Bangladesh marking 50 years of US-Bangladesh diplomatic relations, and the issue of deporting the self-confessed killer of Bangabandhu Sheikh Mujibur Rahman -- Rashed Chowdhury -- from the US.
The foreign secretary also met Julietta Valls Noyes, US assistant secretary of state for the Bureau of Population, Refugee and

Migration, and discussed the Rohingya issue.
US assistant secretary Noyes is scheduled to visit Bangladesh soon.
She agreed with Masud that without creating hope of repatriation, the displaced Rohingya population in Bangladesh pose major risks of radicalisation and transnational crimes.
The assistant secretary expressed her country's willingness to remain deeply engaged, and emphasised the need for education, source of livelihood, etc, for the displaced Rohingyas.
The foreign secretary stated that the US should participate in the humanitarian works in Bhasan Char.
He also reiterated that the sanctions should be lifted.
Noyes informed that her upcoming visit is part of the US's reassessment process in this regard.
Masud and Noyes discussed in detail the constraints and challenges of repatriation, and also on possible ways and means to resolve the issue.
Masud also met Senior Director of National

Security Council (NSC) of the White House Sumona Guha over a lunch meeting.
During the discussion, the two sides agreed that a meeting held this week in Washington DC by Bangladesh foreign minister and foreign secretary created new impetus for bilateral ties, and emphasised the importance of regular engagement.
He also discussed the sanctions on Rab and related individuals, and asked whether the sanctions can be partially lifted.
They also discussed the DSA and Bangladesh's efforts to re-examine the law.
Senior Director Guha appreciated Bangladesh's willingness to engage with the US on human rights issues.
