Kyiv keeps pressure on West for more sanctions against Moscow as battle looms in Ukraine's east

Ukraine said yesterday it was seeking another round of European Union sanctions against Moscow and more military aid from its allies as it braces for a major Russian offensive in the east of the country

Russia has failed to take any major cities since it launched its invasion on February 24 but Ukraine says it has been gathering its forces in the east for a major assault and has urged people to flee.

President Volodymyr Zelensky said on Twitter he had spoken on the phone with German Chancellor Olaf Scholz about additional sanctions as well as more defence and financial support for his country. Zelensky also discussed with Ukrainian officials Kyiv's proposals for a new package of EU sanctions, his office said.

In a video address late on Saturday, Zelensky renewed his appeal for a total ban on Russian energy products and more weapons for Ukraine.

The EU on Friday banned Russian coal imports among other products, but has yet to touch oil and gas imports

Mounting civilian casualties have triggered widespread international condemnation and new sanctions, in particular over hundreds of deaths in the town of Bucha, to the northwest of Kyiv that until just over a week ago was occupied by Russian forces, reports

A grave with at least two civilian bodies has been found in Buzova village near Kyiv, a Ukrainian official said, the latest such reported discovery since the Russian withdrawal from areas north of the capital.

Teacher 'framed to cover up graft'

Sources say section of corrupt teachers does not want her to be headmistress

The controversy surrounding a Hindu teacher in Naogaon was an attempt to cover up a long-running corruption by a small section of the school authorities, according to staffers.

Amodini Paul, the assistant headmistress of Daul Barbakpur High School in Naogaon's Mohadevpur, was framed to look contentious by the section to prevent her from taking over from the school's outgoing headmaster, The Daily Star learnt after speaking with a host of

The section wanted one of their own to succeed Dharani Kanta Barman as the school's headteacher but Paul was chosen on the recommendation of Mohd. Salim Uddin Tarafder, a lawmaker from Naogaon-3 constituency

Since taking over as the school's headmaster in 2011, Barman has indulged in corruption, according to the school's staffers The Daily Star spoke with.

He misappropriated the student fees and interest income on stipend funds and traded on recruitment.

In three village arbitrations held until last month, the headmaster and the previous governing committee president were found responsible for misappropriating Tk 35 lakh in donations against the recruitment of three

They were asked to provide Tk 5 lakh and Tk 2.5 lakh each, for the school's development.

The committee president paid his share of the fine, but the headmaster was yet to pay.

Slap down on syndicates

Experts urge govt at webinar

Experts vesterday called for cracking down on syndicates of traders who hike the prices of essentials during Ramadan like clockwork every year by manufacturing a crisis.

There should be valid reasons behind the price hike, which is not the case in Bangladesh, said SM Zulfiqar Ali, a senior research fellow at the Bangladesh Institute of Development Studies.

"It's natural that if the supply increases the price decreases, but in our country, it doesn't happen sometimes."

The government could not take any authoritarian step as the businessmen are influencing the government, he said at a webinar styled "Poverty situation in cities-villages and food price hike" organised by Right to Food Bangladesh.

To buck the trend, it is necessary to stop the business syndicates, extortion in transportation and corruption, said speakers at the webinar.

It is not possible to control such a big market by only enacting laws and rules, said Qazi Kholiquzzaman Ahmad, chairman of Palli Karma Sahayak Foundation.

"On one hand, we want a free market economy, on the other hand, we want to control the market. We need to decide what we want to control and what not," he added.

A middle-income country cannot have weak market management, said Khondaker Golam Moazzem, research director of the Centre for

Policy Dialogue.

"A competitive market or a competitive price structure is absent here," he said.

A well-planned, transparent and accountable supply chain is needed as well as an empowered competition commission, consumers' rights commission and safe food authorities to address the weak market management symptoms.

"We do not have the factual inflation data. If we don't reduce the data inconsistency, it will not be

possible to take proper steps," said Savema Haque Bidisha, a professor at the University of Dhaka's economics department.

The price level has increased 28.07 percent in the last five years, said Mohosin Ali, general secretary of Right to Food Bangladesh, while presenting the keynote paper.

It would be possible to reduce poverty by reducing the income gap between the cities and villages as well as the regional inequality.

Fishermen, police clash over catching jatka

One killed, 16 hurt

A fisherman was shot dead in a clash between police and fishermen over catching jatka (hilsa fry) in the Meghna in Laxmipur on Saturday

Sixteen others, including six river policemen suffered injuries.

Deceased Amir Hossain, 40, was from Bhola. Ignoring the ban, some fishermen were netting hilsa fry near Maju Chowdhury ghat area. As a patrol team of river police asked them to stop fishing around 11:00pm, they attacked the law enforcers with oars of boat and sticks, said Mohammad Kamruzzaman, superintendent (Chandpur and Laxmipur region) of river police.

Police fired shots to bring the situation under control, he said, adding that he, however, did not know how the fisherman died.

"We would be able to say after getting the autopsy report."

Bullet-hit Amir was taken to Dhaka Medical College Hospital around 6:00am yesterday and he died there around 8:30am, said Bachchu Mia, inspector of DMCH police outpost.

Shotgun pellets were found in his head and back, said DMC morgue source.

Of the injured, two policemen were undergoing treatment at Laxmipur Sadar Hospital, reports our Noakhali correspondent.

Anowar Hossain, resident medical officer of the hospital, told this newspaper that they treated 16 people, including six policemen.

As Amir's condition was worsening, he was referred to DMCH, he added.
