Four held over rape of women

Police yesterday arrested five people on charge of raping a woman in Khulna.

The 22-year-old victim is from Munda community at Koyra upazila. The incident took place on Sunday.

The accused are Omar Sadiq, Imran Hossain, Shah Alam and Jobayer Hossain.

Local UP member Sohrab Ali Sheikh said the woman's husband worked in a brick kiln. The miscreants went to her house and raped her when he was at work.

Police rescued and sent her to Khulna Medical College Hospital yesterday.

The victim filed a case against six people with Koyra Police Station, said OC Rabiul Hossain. "We have already arrested five persons. During primary interrogation, they confessed to the crime," he said.

Man stabbed to death in the capital

A man was stabbed to death in Dhaka's Dholapur area yesterday morning.

The deceased Md Akash (22), was a helper of a human-haulier, living in Jatrabari.

Akash was found lying in a pool of blood around 4:30am. He was rushed to DMCH where doctors declared him dead.

It is not known immediately who stabbed him, said police.

4 districts to see mild heat wave

UNB, Dhaka

A mild heat wave is sweeping over the regions of Rajshahi, Pabna, Dinajpur and Jashore and it may continue, said a Met Office bulletin.

Besides, rain or thunder showers with intense lightning flashes accompanied by temporary gusty or squally wind is likely to occur at a few places over Mymensingh and Sylhet divisions and at one or two places over Rangpur, Rajshahi, Dhaka and Chattogram divisions with hails at isolated places, it added.

Weather may remain mainly dry with temporary, partly cloudy sky elsewhere over the country.

Day and night temperatures may remain nearly unchanged over the country, reads the bulletin.

It is forbidden to fill the land without permission. But Capital Petroleum has filled lands illegally," said Prasantha Talukder, sub-divisional engineer of Water Development Board (WDB) in Sitakunda.

Mufidul Alam, director of DoE's Chattogram region, called Capital for a hearing, but they did not attend it.

"DoE already fined it Tk 50 lakh, and a case is being prepared against Capital Petroleum," he added.

Nazim Uddin, administration officer of

Capital, admitted that they did not take any permission from DoE for extracting sand and filling farmland.

"We have been fined by the AC-land and DoE for not getting approval. We are trying to get permission," he said.

Dr Md Sharif Uddin, director of marine fisheries department in Chattogram, told The Daily Star. "The whole marine ecological system of the spot will be seriously affected due to the extraction. Fish habitats in the sea will be obstructed."
