3 bullet-hit as JL factions clash in Ctg

Three leaders of the local unit of Jubo League were shot and wounded in a factional clash in Patiya upazila, Chattogram on Tuesday night.

The injured -- Jamir Uddin (42), Md Saiful Islam (35) and Md Iqbal Hossen (40) -- were admitted to Chattogram Medical College Hospital, said police.

Of them, Jamir is former joint convener of Patiya unit of the youth wing of Awami League.

They are the followers of central Jubo League joint secretary Bodiul Alam, said local sources.

The incident occurred at Amjur Hat in Patiya around 10:00pm, said police quoting locals.

A clash broke out between the supporters of Junglekhain UP chairman Shahdat Hossain Sabuj and UP member Ayar Md Babar over establishing supremacy, said police.

On information, police rushed to the spot and brought the situation under control, said Additional Superintendent of Police Tarik Rahman.

Bank accounts for hire!

In the first part of this 2-part series, we delve into how criminals 'rent' accounts for illegal transactions.

In the documents submitted to a bank, Bappy Hossain (26) mentioned that he's a labourer. But an anomaly came up after analysing his national identity (NÎD) details. It was found that he has around

45 accounts with different financial institutions, most under agent banking. Similarly, Md Raju (31) mentioned that he's a private-service holder, and his NID

details showed a similar scene: around 40

Like these two, at least seven other people were found to have around 227 accounts with different banks in total. And they listed their professions as egg seller,

van driver or domestic help. The question is, why do these seemingly

normal people have so many accounts? In an investigation, police's detective branch (DB) found that organised transnational criminals take these

Detectives found that criminals take these accounts on "rent" for illegal transactions to dodge law enforcers' eyes. For each transaction, they pay Tk 1,000 to 1,500, and Tk 4,000 to 5,000 for opening an account.

Khalilur Rahman, assistant commissioner (Gulshan division) of DB, said some of the accounts have even made transactions worth Tk 30 lakh.

Investigating sources said a Bangladeshi, identified as Biplob Lashkar, is maintaining all the transaction details.

Investigation also found that his present address is at Dhaka's Mohammadpur. But after visiting the address, this correspondent did not find anyone living there.

Sources said Biplob has been involved in fraudulent activities for a long time. At one point, he joined criminal gangs run by a group of Nigerians, who would

Using torture cells to get their way Four of abduction gang

arrested, says DB

In a general setting, Mufti Mamun seems to be a religious person, as he followed the footsteps of his father, an Islamic scholar, or at least what Mamun pretends to be.

However, his main job is confining businesspeople and employees to a torture cell and extorting money by taking compromising

He started by stealing money from his brother in-law. With the money, he bought several shops and started a business.

In those very shops, he has two torture cells. On April 11, Mamun with one of his gang members abducted Shibu Lal, a noted businessperson in Patuakhali, intending to collect around Tk 20 crore as ransom. He planned to set up the biggest garment

factory in the southern part of the country and start a transport business on the Dhaka-Patuakhali route. He also had plans to start his own bus company with the ransom.

However, the plan was foiled after Patuakhali police managed to rescue Shibu from the district's SP complex on April 12. After that, Mamun and his

criminal activities.

associate took shelter in Dhaka.

The district police then gave a requisition to the detective branch (DB) of Dhaka Metropolitan

On information, DB finally arrested Mamun, his associate Pichchi Rana, BRTC bus driver Jashim Uddin and Ashiqur Rahman from the capital's Mirpur and Gulistan areas on Tuesdav.

Rana used to work at a toll plaza, and Ashiqur is a rent-e-car supplier, said police. Law enforcers seized a car, cell phone and 4,000 yaba pills from the arrestees' possession.

Seven get life terms for killing BCL activist

A Chattogram court vesterday sentenced seven persons to life term imprisonment for killing a Chhatra League activist in the district's Karnaphuli nearly four years ago.

Chattogram Speedy Trial Tribunal Judge AKM Mozammel Haque handed down the verdict, said Public Prosecutor Ayub Khan.

The convicts are Md Azam, Faruk alias Ashik, Ali Azgar alias Hridoy, Md Omar Uddin, Sowkat Hossain, SM Ashraful Alam Suman, and Md Parvez. Of them, Ashraful and Parvez are on the run.

According to the case, Mamunur Rashid Sagor (26) was hacked to death by a group of youths as he protested against drug peddling.

Ayub Khan said the court also fined them Tk 50,000 each in default of which they will have to suffer one more year in jail. Around 18 witnesses testified before the court.

According to the case, Mamunur Rashid Sagor (26) was hacked to death by a group of youths as he protested against drug peddling in Shahmirpur, Karnaphuli on September 26, 2018.

At that time, one Abdul Aziz was also hacked and injured as he was in favour of Sagor.

The deceased's family filed the case with the Karnaphuli Police Station. A Chattogram court framed charges on January 5, 2021.


