PM says about govt plan at sports award function


UNB, Dhaka

Finance minister dispels economists' doubts

Finance Minister AHM Mustafa Kamal yesterday dismissed all doubts raised by economists about this fiscal year's GDP growth estimate amid the pandemic and the Ukraine war that has upset the global economy afresh.

"There is no need to see everything with a suspicious eye -- we followed the standard procedure for computing the GDP," he told reporters after a meeting of the cabinet committee on public procurement.

And the multilateral lenders like the World Bank and the International Monetary Fund never raised objections about the methods of the Bangladesh Bureau of Statistics.

In its provisional figures for the Bangladesh economy, the BBS said the GDP will expand by 7.25 percent, which coincidentally is the growth target laid

Thanks to a strong showing by the industrial sector, the economy would grow at more than 7 percent for the third time in 15 years. And yet, the use

Ukraine claims battlefield gains

'Pushes back' invader forces in Kharkiv, shuts Russian gas to Europe; US House passes \$40b in aid for Kyiv

Ukrainian forces reported battlefield gains yesterday in a counterattack that could signal a shift in the momentum of the war, while Kyiv shut gas flows on a route through Russian-held territory, raising the spectre of an energy crisis in

Following days of advances north and east of the second largest city Kharkiv, Ukrainian forces were within just several kilometres of the Russian border yesterday morning, one Ukrainian military source said on condition of anonymity.

Before the advance, Russian forces had been on the outskirts of Kharkiv, 40 km (25 miles) from the border.

The gains appear to be the fastest that Ukraine has achieved since it drove Russian troops away from Kyiv and out of the country's north at the beginning of April.

In Vilhivka, a village east of Kharkiv held by Ukrainian forces, the thump of near constant artillery and swoosh of multiple rocket launchers

could be heard from fighting at the front, now pushed substantially further east, where Ukraine has been trying to capture villages on the banks of the Donets river and threaten Russian supply lines on the

Further east, Ukrainian forces seemed to be in control of the village of Rubizhne, on the banks of the

President Volodymyr Zelensky said successes were putting Ukraine's second largest city beyond the range of Russian artillery. But he cautioned Ukrainians against raising their expectations too high yet.

"We should not create an atmosphere of excessive moral pressure, where victories are expected weekly and even daily," he said.

Meanwhile, shipments from Russia's export monopoly Gazprom to Europe via Ukraine fell by a quarter after Kviv said it was forced to halt all flows from the Sokhranovka transit point in southern Russia. Ukraine accused Kussian-backed separatists of siphoning supplies.

Russian forces have also continued to bombard the Azovstal steelworks in the southern port of Mariupol.

With President Joe Biden warning that Ukraine would within days likely run out of funds to keep fighting, the US House of Representatives voted late Tuesday to send a \$40 billion aid package to the country.

The funding will be used to assist Ukrainian military and national security forces and will go toward weapons, equipment, training, logistics and intelligence support as well as other needs, reports Reuters.

British Prime Minister Boris Johnson vesterday said he had agreed new deals with Sweden and Finland to bolster European security, pledging to support both countries' armed forces should they come under attack.

The agreements, described by Britain as "a step-change in defence and security cooperation", will go some way to assuage fears in Finland and Sweden over threats made by Russia should either nation decide to join Nato.

In Matarbari, officials and employees concerned at the DC office took 20-30 percent "commission" from the compensations. There were also allegations of buying land at a lower price by showing them as salt pan or non-arable land.

An NGO assigned to provide grants to the affected had collected 10-20 percent "commission" from the compensation, the TIB said.

TIB research fellows Md Mahfuzul Haque and Md Newazul Moula presided over the study.

They pointed to excess land acquisition too.

Neighbouring countries require an average 0.23 acres for every megawatt generated by burning coal. It is 0.053 acres in case of LNG. But "a total of 942 acres of additional land has been purchased or acquired for the projects selected under this study", said Md Newazul

Moula presenting the study. The power plant in Barishal should have needed 81 acres, but 310 acres were acquired. In Banshkhali, 660 acres were acquired against a requirement of 304 acres and in Matarbari, 1,358 acres against a need argued.

They said the price of the power produced from the plants was higher than that of plants in India, China, Pakistan, and Australia.

The researchers observed that none of the projects disclosed important project-related information, including the development project proposal environmental impact assessment (EIA), rates, conditions, profit financial distribution. report, and audit report.

The power plant in Barishal initially did not have an EIA and ECC-Environmental Clearance Certificate. The EIA approved later failed to consider the environmental concerns of the Tengragiri Forest, known as the second Sundarbans; Andharamanik Sanctuary; and Gorapadma Green Belt, the report said.

About the lack of competition in the power sector, TIB said the government could prepare a master plan by itself. It took financial help from a donor instead, which in turn repeatedly appointed a certain consultant prepare the plan.
