The iteration also has a special segment for music lovers, screening "Elvis", a biopic on the evergreen rockstar Elvis Presley, crafted by Australian director Baz Luhrmann. New documentaries "Moonage Daydream", based on David Bowie and "Trouble in Mind" made on rock'n'roller Jerry Lee Lewis made by Ethan Coen are also on the screening schedules.

David Cronenberg will return to spook the viewers this time with his Kristen Stewart, Lea Seydoux, and Viggo Mortensen starrer horror film "Crimes of the Future". The film, which echoes the essence of his earlier production from 1970 with the same name, is said to "not"

A total of 21 films, including the ones stated above are competing for the Palme d'Or. The shortlisted films also include masterpieces from previous winners, including the Dardenne brothers from Belgium, Sweden's Ruben Ostlund, Japan's Hirokazu Kore-eda and Romania's Cristian Mungiu. Bangladesh will also maintain its representation after Abdullah Mohammad Saad directorial "Rehana Maryam Noor" made headlines being featured at the Un Certain Regard section of the competition last year.

Eminent director Shyam Benegal is looking forward to release the teaser of "Mujib: The Making of a Nation" at Cannes Market. The film, which is Bangabandhu Sheikh Mujibur Rahman's biopic, features Arifin Shuvoo as Bangabandhu Sheikh Mujibur Rahman, Nusrat Imrose Tisha as Sheikh Fazilatunnessa Mujib, Nusraat Faria Mazhar as Sheikh Hasina, Riaz Ahmed as Tajuddin Ahmed, and Elina Shammi as Khaleda Zia, among others.

Nuhash Humayun's horror project "Moshari" has also been selected for Marché du Film - Festival de Cannes & SITGES Festival International de Cinema Fantàstic de Catalunya's Fantastic 7 section.

The 75th edition of the Cannes Film festival tries it best to keep up with its promise of taking its attendees on a nostalgic ride, revisiting the legacy of cinema worldwide. All the audience can do now is cherish what is to come in the following week.

A menace that goes unnoticed

130 illegal brick kilns in Lalmonirhat and Kurigram

A total of 130 brickfields are being operated illegally in 14 upazilas of Lalmonirhat and Kurigram districts thanks to the inaction of the authorities concerned.

Although these illegal brickfields are in operation, no legal action is being taken by the Department of Environment (DoE) and local administration. They have a list of illegal brick kilns but they are in a slumber for reasons unknown.

Locals alleged that the owners of the illegal brickfields are politically and influential and they are running the brickfields 'managing' all corners.

These illegal brickfields have been built on agricultural land near

residential areas, they said. Montaz Ali, a farmer from

Tentultala village in Ulipur upazila

of Kurigram, said crop production was declining due to the illegal brick kilns and these are also hurting the production of various fruits including mango, blackberry, jackfruit and betel nut. A huge quantity of valuable topsoil is also being burnt in the brick kilns.

The locals do not dare protest the malpractice for fear of repercussion, he said.

Abul Kashem, a farmer from Bhatibari village in Lalmonirhat Sadar upazila, said over two hundred villagers lodged written complaints against the illegal brick kilns on agricultural land but to no avail. The illegal brick kilns are still

in operation. It is unknown to them why the authorities are not taking any legal action in this regard, he said adding that "Due to the illegal brick kilns, we have been facing various problems including reduction of crop production on the land nearby." Mez-Babul-Alam, deputy director of DoE in Rangpur, said 22 out of 119 brickfields in Kurigram have

been approved and 18 out of 51 in Lalmonirhat have been approved. The list of illegal brick kilns has been given to the local administration. "Due to our manpower shortage.

it is not possible for us to conduct regular drives," he said. **Kurigram Deputy Commissioner**

(DC) Mohammad Rezaul Karim said drives against illegal brick kilns were ongoing.

The operation could be expedited if the DoE officials were present, he said.

Lalmonirhat DC Abu Jafor said letters have been sent to all the five upazila administrations to take action against illegal brick kilns.

Immediate action would be taken if the DoE authority demands, he said.

contradicts Japan's 2021 G7 commitment to halt overseas coal financing.

The massive expansion of fossil fuel plants would predominantly built or financed by foreign companies from Japan and the US.

"Companies such as Mitsubishi, JERA and General Electric are pushing for these projects so that they can profit the expansion from of toxic power plants, with little regard for the cost to Bangladesh and Bangladeshis," said Sharif Jamil, general secretary of BAPA.

Investors in the companies need to be aware of the fact that Bangladeshis investment in clean, costeffective energy and not in polluting, expensive LNG, he added.

technology and instead help it meet power needs clean, affordable climate-friendly and technologies," Julien Vincent, executive director of Market Forces, an environmental finance NGO focused on fossil fuel projects in Asia and

Australia. By 2030, subsequent LNG-to-power projects are estimated to cost an average of \$960 million per GW, reaching close to \$18 billion for Chattogram alone, which is six times more than Bangladesh's 2022 budget to mitigate the adverse effects of climate change, according to the study.

Sumitomo Corporation, a Japanese conglomerate, withdrew from Matarbari 2 coal plant, said Yuki Tanabe, programme director of Japan Centre for a Sustainable Environment and Society.

strengthening their climate policies dramatically. Coal and gas projects will not be financeable soon, even if by Japanese investors," he added.

Bangladesh already has significant overcapacity problem, the speakers said. About 60 percent of the installed capacity was not used in fiscal 2020-21.

The gap between power production capacity and actual demand has gradually increased over the last few years, states the report citing the Institute for Energy Economics and Financial Analysis (IEEFA).

The government paid \$1.6 billion to companies for underutilised power capacity in 2021.

On the other hand, Bangladesh Power Development Board (BPDB) is calling for price hikes to offset the crippling of expenses buying power from independent

Bangladesh's overcapacity crisis to electricity users, the report says.

According to IEEFA Bangladesh's economy would be exposed to a volatile price market from imported fuel and people would be forced to face financial risks that should have been borne by foreign private enterprises.

"Climate science and energy economists have made it clear: if we are serious about averting the climate catastrophe, we need to stop building new coal, gas, and oil projects,' the report said.
