Around 1.83 lakh people sat for the test. A case was filed with Lalbagh Police Station centring the incident, and detectives started investigating.

Sumon was found copying answers written behind his admit card. He received the answers on WhatsApp, 42 minutes before the test started, said investigators.

Investigation sources said the syndicate had managed to communicate with at least hundreds of examinees. They made deals of Tk 5 to 7 lakh for providing the answers.

The question leak syndicate members know each other, as they all hail from Patuakhali, they said.

The syndicate worked in three to four layers. First, DSHE staff and officials took photos of the question paper on the way to the exam centre and sent them to Saiful on WhatsApp. Saiful then solved it with help from a group of experts and finally distributed it to examinees, sources said.

Asked about test cancellation, Prof Md Shahedul Khabor Chowdhury, director (college and administration wing) of DSHE, told The Daily Star yesterday that they are holding discussions about the test, but no decision has been taken about cancellation yet.

Asked about carrying out a separate investigation, he said, "We are not conducting any separate investigation, as detectives are already looking into it. We will take our decision after receiving their report."

About the question leak, Prof Shahedul said DSHE has maintained all protocols for the test, including printing the paper at the specified press. "The question did not leak from the press. It either leaked on the way to the exam centre or after the question reached the centre."

Tk 12,000 for medicines," said Azim.

"Around 5:00am, I saw my daughter getting pale and frozen. She was declared dead after a while."

Prof Amzad Hossain, former head of Dhaka Medical College's orthopaedic department, said, "Usually multiple tests are run on a gangrene patient to understand the condition before operating. If the hospital authorities hurried the operation, chances are they didn't run the tests on her."

On the hospital's visiting cards, it was mentioned that the hospital has ICU, NICU, PICU and HDU facilities. However, while visiting the seven-bed five-story hospital yesterday, this correspondent didn't see any such facilities.

None of the staffers wanted to speak to this correspondent.

Two years ago, Rab conducted drives at three private hospitals in Mohammadpur on the grounds of a lack of valid documents for operations, sufficient staff, doctors, nurses and surgical instruments. Makkah-Madina General Hospital was one of them.

The hospital's owner Nurun Nabi was sentenced to a year in prison, while staffers Anwar Hossain and Abdur Rashid were sentenced to six-month prison time each.

Earlier in 2018, the High Court directed the government to immediately shut down 14 private hospitals and clinics in Mohammadpur, including Makkah-Madina General Hospital due to not having licences.

Despite repeated attempts, this correspondent could not get in touch with Nurun Nabi.
