# Mechanism there for 11 yrs but not in use

More than 11 years ago, the government issued an order for the trade of essential commodities, aimed at controlling their prices and curbing price manipulation by unscrupulous businesses through hoarding and other unfair means.

But the "Essential Commodities Distribution and Distributor Recruitment Order, 2011" remains only on paper due to apathy of the authorities concerned and non-compliance by importers and producers.

The commerce ministry issued it on March 16, 2011, under the

**Consumer rights** campaigners say the government has failed to tackle the recent edible oil crisis for not having any list of distributors and supply data of importers and refiners.



"Control of Essential Commodities Act, 1956".

Dishonest businesspeople have been taking advantage of its nonenforcement, manipulating the supply of essential items to raise prices on different occasions.

The recent price hike of edible oil is a glaring example as traders created an artificial crisis to make a fast buck, putting the consumers

Consumer rights campaigners say the government has failed to tackle the recent edible oil crisis for not having any list of distributors and supply data of importers and refiners as prescribed in the order.

They also say that had the order been implemented, those responsible for the artificial crisis could have been identified and punished.

According to the order, importers or producers of essentials will designate one or more distributors in every upazila, city corporation and district and send their lists to a national committee.

It also states that importers or producers will send information on monthly supply of the products to the committee through fax, email

Besides, the millers will issue SO (supply order) to their designated dealers, mentioning the prices and quantities of the items. The nontransferrable SO will be valid for 15 days, the order says

The national committee, headed by the secretary of the commerce ministry, will collect data from field levels -- upazilas and districts - and sit at least once every month to assess the stock, supply, sale and price situation of essentials and act accordingly to ensure the availability of the goods in the market.

The committee is comprised of representatives of government and trade bodies, including the director general of the Directorate of National Consumer Rights Protection (DNCRP), and presidents of the refinery owners' association, distributors' association, Federation of Bangladesh Chambers of Commerce and Industries (FBCCI), Dhaka Chamber of Commerce and Industry (DCCI) and Metropolitan Chamber of Commerce and Industry (MCCI).

# Act fast, act in unison

PM suggests 5 steps for ESCAP to help developing nations, seeks int'l support for Rohingya repatriation

Prime Minister Sheikh Hasina yesterday put forward five proposals to strengthen regional cooperation against the backdrop of the pandemic and Russia Ukraine war.

"I would like to propose [five] steps that ESCAP may take into account as the Russia-Ukraine war must be stopped immediately and joint actions are needed to tackle the situation," she said.

Hasina said this in a video message broadcast in the 78th session of the Economic and Social Commission for Asia and the Pacific (ESCAP) of the UN, reports BSS.

She requested more pragmatic international support measures for countries

should be enhanced to improve regional crisis management

taking action-oriented steps to facilitate collaboration in pursuit of knowledge and innovation. She said ESCAP member states should be assisted

# Taka weakens further

### High imports, poor supply of dollar blamed

The taka yesterday weakened further against the US dollar amid the falling supply of the greenback due to surging imports.

The latest devaluation came when Bangladesh Bank depreciated the inter-bank exchange rate by Tk 0.40 or  $0.\overline{45}$  percent to Tk 87.90 per USD.

The central bank has so far depreciated the taka six

As the shortage of the greenback has already created an instability in the forex market, the central bank has been trying to bring back discipline by depreciating the local currency, a BB official said.

The banking regulator has also increased the BC (bills for collection) selling rate by Tk 0.40 to Tk 88 a dollar and banks are supposed to follow it while selling dollars to the importers.

But banks are still charging importers more than Tk 95 for a US dollar and Tk 98 for travelers in the open market, said an official of a commercial bank, wishing anonymity, yesterday afternoon.

### Mushy, Liton script epic turnaround


Following a disastrous start from Bangladesh that saw them reeling on 24 for five in the first hour of the second Test against Sri Lanka, the hosts staged an outstanding comeback courtesy of a record-breaking unbeaten partnership between Mushfiqur Rahim and Liton Das. At the close of play on the first day, the Tigers had reached 277 for five at Sher-e-Bangla National Stadium in Mirpur yesterday.

Mushfiqur struck his second consecutive century of the series, his ninth Test ton, and remained unbeaten on 115 off 252 balls while Liton continued his sublime form, smashing his third Test hundred and remaining unbeaten on 135 off 221 deliveries.

It was undoubtedly one of Bangladesh's greatest comebacks, especially given the nightmarish start after Mominul Haque elected to bat.

The Lankans came out all guns blazing in the morning session, annihilating Bangladesh's top-order with a fine spell of new-ball bowling from Kasun Rajitha and Asitha Fernando. The Tigers lost five wickets for 24 runs, including the prized

### **E-COMMERCE SCAMS** Find out those responsible: HC

The High Court yesterday ordered finding out the persons and institutions responsible for the financial scams and money laundering through e-commerce platforms.

The authorities concerned of the government and Anti-Corruption Commission have been asked to submit separate compliance reports as early as possible after assessing the amount of misappropriated money.

The court passed the order after examining a compliance report from Bangladesh Financial Intelligence Unit (BFIU), which has found evidence of fraudulence, suspicious financial transactions and money laundering by eight e-commerce platforms.

The eight firms are Dalal Plus, Bangladesh Deal, Amar Bazar Limited, 24 TKT Limited, Daraz Bangladesh Limited, Anonder Bazar Limited, Sohoj Life, and Aladiner Pradeep.Com, which have transacted Tk 859 crore between 2018 and 2021.

The BFIU, which is responsible for enquiring suspicious transactions, sent its findings to the Criminal Investigation Department (CID) for further probe and legal action.

### TAQI MURDER CASE 5 accused show up in court

Five accused in the Narayangani teenage boy Tanwir Muhammad Taqi murder case were present during the hearing at a local court yesterday.

They are: Rifat Bin Osman, Sultan Shawkat alias Bhromor, Yousuf Hossain Liton, Saleh Rahman Shimanto and Tayebuddin Ahmed Jacky.

Narayanganj Senior Judicial Magistrate Kawsar Alam set June 19 for the next hearing in the case, Court police Inspector Asaduzzaman told this paper.

The case is still under probe, he added. The Rab is investigating the case. Nine years have passed after the murder, but the charge sheet in the case is yet to be submitted.

The five accused, who were arrested earlier, are now on bail. Eight more accused are still on the run.

Prosecution lawyer Prodip Ghosh Babu said the court ordered the investigation officer to submit the charge sheet soon.

### Haji Salim taken to BSMMU from jail

Lawmaker Haji Md Salim was taken to Bangabandhu Sheikh Mujib Medical University yesterday, a day after he was sent to jail in a corruption case.

"He was taken to hospital for treatment," Brig Gen ASM Anisul Haque, inspector general of prisons, told The Daily Star yesterday.

Jail officials said Haji Selim was suffering from different health complications, including heart disease and was taken to BSMMU by an ambulance as per court directives.

Salim, who was sentenced for 10 years in a corruption case filed in 2008, surrendered before a Dhaka court on Sunday afternoon and sought bail.

Rejecting his bail petition, the court sent him to Dhaka Central Jail in Keranigani.

It, however, directed the authorities concerned to provide Salim with the first-class division and better treatment in jail, following two separate petitions submitted by the defence.

Brig Gen Md Nazrul Islam Khan, director of BSMMU, said Salim was admitted to the hospital around 10:30am with cardiac problem.

"We would conduct some evaluation sts on his condition and then identify the problem."

# Send us weapons, stop Russia trade

Zelensky tells Davos as Ukraine holds off latest assault in east; Russian soldier handed life sentence for war crimes

Ukrainian President Volodymyr Zelensky used the Davos summit to appeal for more weapons and "maximum" sanctions against Russia, lamenting that tens of thousands of lives would have been saved had countries acted faster.

Appearing by video link yesterday, Zelensky delivered the headline speech to the first World Economic Forum (WEF) to be held in the Swiss Alps in more than two years after the Covid pandemic derailed the event.

The conflict shows "that support to the country under attack is more valuable the sooner it is provided: weapons, funding, political support and sanctions against Russia," said Zelensky, who received a standing ovation.

"If we would have received them by 100 percent of ours needs at once back in February, the result would have been tens of thousands of lives saved," said Zelensky, flanked by Ukrainian flags and wearing an olive green T-shirt.

"This is why Ukraine needs all the weapons that we ask for, not just the ones that have been provided," he said, adding that 87 people were killed in a May 17 Russian strike on a military base in northern Ukraine.

Zelensky called for an oil embargo on Russia, punitive measures against all its banks and the shunning of its IT sector, adding that all foreign companies should leave the country.

"There should not be any trade with Russia," he told the gathering. "I believe there are still no such sanctions against Russia -- and there should be."

While the United States, Britain and Canada have moved to ban Russian oil and gas, the European Union has been divided over imposing similar measures, reports

In the latest fighting at the battlefront, Ukraine said yesterday it had held off a Russian assault on Sievierodonetsk, an eastern city that has become the main target of Moscow's offensive since it finally

seized Mariupol last week.

Russian forces tried to storm Sievierodonetsk but were unsuccessful and retreated, Zelensky's office said.

In Kyiv, a court handed down a life prison sentence on a Russian soldier who had pleaded guilty to killing a Ukrainian civilian at the first war crimes trial of the conflict. The Kremlin complained that it was not permitted to defend its citizen.

In Mariupol, where hundreds of Ukrainian fighters finally laid down their arms last week after a nearly three-month siege, Russian mine clearing teams were combing through the ruins of the giant Azovstal steel plant, reports Reuters.

Ukraine has been trying to secure a prisoner swap for fighters who surrendered at the steel plant last week. The leader of pro-Russian separatists in control of the area said they would be tried by a tribunal, but a Russian deputy foreign minister was quoted as saving Moscow could discuss a swap.

### Moscow offers to sell crude oil to Dhaka

Russia has offered to sell crude oil to Bangladesh amid reducing demand from European countries.

"Russia offered to sell fuel [to Bangladesh], especially crude oil," Nasrul Hamid, state minister for power, energy and mineral resources told reporters at the capital's Bidyut Bhaban vesterday.

"We are reviewing if we really need the fuel from them.'

During the ongoing Russia-Ukraine war, the USA and Britain banned import of oil from Russia, one of the top fuel exporters in the world. The European Union has also announced plans to

In the meantime, some countries including China and India have started importing Russian oil at lower prices, according to reports in international media.

Nasrul Hamid also said, "We want to keep fuel prices stable. We don't want to raise or decrease the price. Although the oil price has dropped in global market, it is not enough to adjust the

He also stressed on introducing electric vehicles as public transport to decrease demand

# Don't harass passengers

DHAKA

State minister for civil aviation tells immigration police, warns of tough action

State Minister for Civil Aviation M Mahbub Ali yesterday asked the immigration police not to question passengers unnecessarily during immigration at the Dhaka airport.

He also instructed the immigration authorities not to interrogate all passengers.

The junior minister said around 21,000 passengers travel through this airport every day. Only those who need to be questioned should be interrogated.

Mahbub Ali said this while talking to reporters after visiting Hazrat Shahjalal International Airport. He also spoke to passengers about the quality of service and their

He said stern actions will be taken against airport officials or employees for their negligence in carrying out their responsibilities and in case of harassing passengers.

He said he has talked to custom officials at the airport to ensure that all passengers' bags are not checked. Only those who are suspected, based on information, will be checked. Only 1 to 2 percent of the passengers will be checked separately.

Mahbub said preparations are ongoing to launch e-gate at the airport soon.

Regarding the ground handling service at the airport, he said the civil aviation ministry has formed a team who will visit the airport three days a week to oversee the SEE PAGE 4 COL 4

# Biman to use own planes for hajj flights

Decision may cause disruption on various routes

Biman Bangladesh Airlines has decided to operate this year's hajj flights with its own aircraft, scrapping its earlier plan to ferry pilgrims in leased aircraft.

He said this in his speech on the preparatory day of the Global Platform for Disaster Risk Reduction (GPDRR) 2022, jointly organised by United Nation Disaster Risk Reduction (UNDRR) and the Indonesian government, at Bali International Conference Centre (BICC).

Indonesian Coordinating Minister for Human Development and Culture Muhadjir Effendy inaugurated the meeting yesterday

Bangladeshi state minister delivered his

speech in the afternoon on "Addressing the recovery needs of women and girls, people with disabilities and other vulnerable

In the 1970 cyclone, 90 percent of the deceased were women and children. The ratio between women-children and men was 14:1, which has now been reduced to 1:1.

"This is a milestone achievement in terms of minimising the gender gap in disaster

management," said Enamur. Citing a recent study report by Bangladesh Institute of Development Studies (BIDS), the minister said 75 percent of risks can be

reduced through better preparedness. Regarding Bangladesh's Covid-19 preparedness, the state minister said the humanitarian response was made with the principle of "no one will be left behind", as

per Bangladesh's National Preparedness and Response Plan for Covid-19. Bangladesh is also updating its disaster preparedness with a National Strategy on Internal Displacement Management 2021.

# 5 killed in road accidents

At least five people were killed in road accidents in Netrakona, Tangail and Faridpur yesterday, report our correspondents.

In Netrakona, two people were killed and  $10\,$ injured in a head-on collision between a truck and a bus in Sadar upazila around 5:15am.

The deceased are bus driver Sabuj Mia (45) and his helper Sohel Mia (35), said OC Khandakar Shaker Ahmed of Netrakona Model Police Station. The Netrakona-bound bus collided with the paddy-laden truck on Netrakona-Mymensingh road, the OC said. The injured were taken to local hospitals, he added.

A team of Mymensingh police removed the two vehicles from the road around 9:00am, resuming vehicular movement on the route, he said.

Police seized the vehicles but the truck driver fled the scene. A case was filed.

In Tangail, two people were killed when a speeding truck hit their bike on Dhaka-Tangail highway in Mirzapur upazila.

The deceased are Yasir Hossain Kanon (20), a college student, and Shahidul Islam (20).

SI Billal Hossain of Gorai Highway Police Station said the accident occurred around 9:30am. Yasir died on the spot while Shahidul succumbed to his injuries at a hospital.

In Faridpur, Abul Bashar, a sergeant of Bangladesh Air Force, was killed in a road accident in Sadar upazila around 3:00am.

Bashar (34) of Satkhira's Assasuni upazila was recently transferred to Jashore airport from Dhaka headquarters. The accident took place on Dhaka-Khulna highway when he was travelling on a covered-van while shifting his furniture and valuables to Jashore.

OC Kangkan Kumar Biswas of Karimpur Highway Police Outpost said, "We suspect that the covered van, in which Bashar was travelling, hit a truck from behind. We found the covered van's front part damaged and recovered the body from its left seat." The van was seized but its driver fled the scene, he added.

I feel honoured to have the opportunity of sharing the screen with Fazlur Rahman Babu, in this short film.

"Ripples" is yet to be released. What is it

Inspired by Purabi Basu's short story `Eker Bhetor Paach', it is written and directed by Senjutee Suborna Tushee. This is her first project in Bangladesh -- she is a student of Film and Television Institute of India, also known as the Pune Film Institute. The film is made by a woman, portraying a woman, for women.

We shot the project in Bikrampur during the pandemic. Keeping the storyline offthe-shelf, the presentation has been altered, thereby making it theatre based. I have portrayed a theatre activist, who is also a musician. For this I had to play guitar taking real lessons from a music director. It was challenging but a completely new experience for me. The project will

release soon. It will be premiered in Bangladesh Focus section at the festival. Bangladeshi films,

# Over 100m forcibly displaced: UN

AFP, Geneva

Russia's war in Ukraine has pushed the number of forcibly displaced people around the world above 100 million for the first time ever, the United Nations said yesterday.

"The number of people forced to flee conflict, violence, human rights violations and persecution has now crossed the staggering milestone of 100 million for the first time on record, propelled by the war in Ukraine and other deadly conflicts," said UNHCR, the UN Refugee Agency.

The "alarming" figure must shake the world into ending the conflicts forcing record numbers to flee their own homes, the UNHCR said in a statement.

The figures combine refugees, asylum-seekers and

more than 50 million people displaced inside their own countries.

UNHCR said the numbers of forcibly displaced people rose towards 90 million by the end of 2021, spurred by violence in Afghanistan, Burkina Faso, the Democratic Republic of Congo, Ethiopia, Myanmar and Nigeria.

Russia invaded Ukraine on February 24 and since then more than eight million people have been displaced within the country, while more than six million refugees have fled across

"One hundred million is a stark figure -- sobering and alarming in equal measure. It's a record that should never have been set," said UN High Commissioner for Refugees Filippo Grandi.

"This must serve as a wake-up call to resolve and prevent destructive conflicts, end persecution and address the underlying causes that force innocent people to flee their homes.

The 100 million figure amounts to more than one percent of the global population. Only 13 countries have a bigger population than the number of forcibly displaced people in the world.

"The international response to people fleeing war in Ukraine has been overwhelmingly positive," said Grandi.

# China 'flirting with danger'

### Says Biden, vows to defend Taiwan if Beijing invades

AFP, Tokyo

President Joe Biden vowed vesterday that US forces would defend Taiwan militarily if China attempted to take control of the self-ruled island by force, warning Beijing was already "flirting with danger".

The remarks, made in Tokyo where he is meeting with Japan's prime minister ahead of a regional summit today, were Biden's strongest to date on the issue and come amid rising tensions over China's

growing economic and military

Washington and allies like Japan have framed their tough response to Russia's invasion of Ukraine as a warning to others, especially China, against unilateral military action.

Biden hammered that message home after talks with Japanese Prime Minister Fumio Kishida in which the pair agreed to monitor Chinese naval activity and joint Chinese-Russia exercises.

Biden then went further.

Asked if Washington was willing to get involved militarily to defend Taiwan, he replied: "Yes."

In Beijing, foreign ministry spokesman Wang Wenbin swiftly responded, declaring that "no one should underestimate the firm resolve, staunch will and strong ability of the Chinese people in defending national sovereignty and territorial integrity.'

"China has no room for compromise or concession," the spokesman said.

### 14 bodies found washed up on Myanmar beach

The bodies of 14 people have been found washed up on a beach in Myanmar, police said yesterday, with a local rescue group saying some were Rohingya attempting to reach Malaysia. The migrants had been travelling by boat from western Myanmar, according to a local Rohingya activist. "Fourteen bodies were found, 35 people including the boat owners were rescued alive," said Lt Col Tun Shwe, a police spokesperson in Pathein district.

### Long fuel queues persist in Lanka

Long queues snaked around gas stations in Sri Lanka's commercial capital and its outskirts yesterday even though the island nation's government was scrambling to deliver fuel supplies and douse any unrest as it battles a

devastating economic crisis. Kanchana Wijesekera, Sri Lanka's minister for power and energy, said supplies of 95-octane gasoline, mostly used in cars, had been received and were being distributed across the country of 22 million people that has been struggling with fuel shortages for

months. "With the 2 cargo vessels unloaded, petrol stocks will be available for the next 6 weeks comfortably," Wijesekera said in a tweet. Another 40,000 metric tonnes of petrol supplied by India had also reached Sri Lanka yesterday, the Indian High Commission (Embassy) said, two days after New Delhi delivered 40,000 tonnes of diesel to its southern neighbour.

### Overuse of antigastric medicine must be curbed

# Awareness and proper policy are vital

NE of the banes of poor regulatory controls and easy availability of certain medicines in Bangladesh is the long and random use of those drugs, which can result in self-medication—and overuse—and lead to the users suffering from harmful effects. It is our experience that people are generally predisposed to administering medicines on themselves without seeking doctors' advice. While till recently antibiotics topped the list of such drugs, a recent study shows that PPIs, or proton pump inhibitors, which work by reducing the amount of stomach acid made by glands in the lining of the stomach, have now topped the list.

It is little wonder that given the quality of cooking ingredients, the poorer sections of society get afflicted by gastric and stomach problems. The anti gastric medicines are available over the counters, as most medicines are, and the need for quick relief encourages prolonged use, without the user knowing the irreparable harm that it can do to their bodies. And anti-gastric medicines are taken for all kinds of stomach ailments-from constipation to diarrhoea. The negative effects of taking such medicines were revealed at a recent seminar on the overuse of PPIs at the Bangabandhu Sheikh Mujib Medical University (BSMMU). It is astounding that around 45 percent of cases of gastric or stomach cancer is caused by the overuse of PPIs. Earlier this month, one of the five types of PPI medicines available, Rabeprazole, was banned by the health authorities for its adverse effects.

We believe that time has come to exercise stricter control on the sale of over-the-counter medicines. As it is, the national drug policy prohibits the sale of antibiotics without prescription. But the policy is observed more in its violation. Certainly, sale of those drugs that are commonly used for common ailments must also be brought under regulatory purview. One must also not lose sight of the reality that not all have the means to seek a qualified doctor's advice, and they consequently seek recourse to alternative means. So their predicament must be addressed, too. Besides, public awareness campaigns should be initiated to sensitise people to the danger of drugs whose longterm use is harmful. It is important to drive home the point that in curing gastrointestinal conditions without expert advice, one runs the risk of inviting more serious diseases on oneself.

## Is the world about to face another pandemic?

### Take early measures to prevent monkeypox outbreak from happening

T is deeply concerning that right as the world looks set to recover from the Covid-19 pandemic, another deadly disease is making the rounds in countries where it is rarely found. As of May 21, 92 confirmed cases and 28 suspected cases of monkeypox have been reported from 12 UN member-states where this disease is not endemic, according to the World Health Organization (WHO). Monkeypox is endemic in parts of West and Central Africa, where it can be caught from infected wild animals such as rats, mice, and squirrels. Recently, however, cases have been detected in the UK, Spain, Portugal, France, Germany, Italy, Belgium, Sweden, the US and even Australia.

The WHO recently convened a videoconference of international experts on monkeypox because of the reported cases. And even though experts present at the meeting stressed that the monkeypox outbreak did not resemble the same scenario that we witnessed during the early days of Covid—as monkeypox is not as easily spread—they also recommended countries and individuals to remain cautious and learn about the disease, and how to stay protected from it.

Monkeypox is similar to human smallpox. Its initial symptoms include fever, headache, muscle ache, backache, swollen lymph nodes, chills, and exhaustion. Though human-to-human transmission typically occurs through respiratory droplets or contact with an infected patient's skin lesions, many of the current cases have been identified at sexual health clinics—leading experts to suspect that it is being spread as a sexually transmitted infection. Similar to Covid, those infected with the disease should isolate themselves. Maintaining good hygiene is a great way to combat it as well.

Scientists have already discovered that the smallpox vaccine is around 85 percent effective against monkeypox. Therefore, governments around the world as well as the private sector and WHO should set up the capacity to mass-produce the smallpox vaccine, should that become required. However, given that the world is still reeling from the tremendous harm done by Covid, it would be more beneficial for all concerned if countries took early precautionary measures to prevent any such outbreak from happening altogether. Thus, we urge countries that have already seen cases to remain cautious and carefully observe those who have been infected, and make sure the disease does not get transmitted any further.

The Bangladesh government should also keep a close eye on how the situation develops, and consider setting up mechanisms to prevent the disease from entering the country, including through stricter monitoring of incoming passengers at airports and other ports of entry. Moreover, building expertise among healthcare providers early is essential.

# GDP: A misleading measure of development



In fact, the per capita income of 80 percent of Bangladesh's population is less than 30 percent of the official figure. The top five percent of the population have one-third of the GDP. Black money or the thousands of crores of taka that is laundered abroad is not taken into account in this estimate. Since a large

Doubts are now rising in mainstream economies about measuring development on the basis of GDP and per capita income. That is why many ways and methods, such as Human Development Index, Genuine Progress Indicator, Gross National Happiness, etc are



while there can be many questions about how much has been achieved and how, there is no doubt that our national income has increased. When it comes to measuring a country's economy with GDP, we follow the guidelines of the World Bank and IMF. The World Bank divides the world's countries into four main categories on the basis of per capita income: 1) Low-income countries (per capita income up to USD 1,025); 2) Lower-middle-income countries (USD 1,026-4,035); 3) Upper-middle-income countries (USD 4,036-12,475); and 4) High-income countries (more than USD 12,476).

Bangladesh became a lower-middle-income country in 2015. According to the rules of international organisations, Bangladesh is no longer eligible for certain facilities, such as special benefits of the World Trade Organization (WTO) meant for low-income countries, and loans at low interest rates.

Reviewing the experiences of different countries, Nobel laureate Amartya Sen has shown that even if a country's GDP is very high, its performance when it comes to sustainable development can be weak. Even if a country's per capita income is high, the standard of living of the majority of its people can be low. In many Áfrican countries, the per capita income is higher than that of Bangladesh. Although they graduated to the middleincome status way before Bangladesh, the living standards of their populations are still poor. Nigeria's per capita income is more than double of ours, but it cannot be said that their standard of living is twice as good as that in Bangladesh. Sri Lanka's per capita income was higher than Bangladesh's, but that could not prevent their economic crisis.

Therefore, we can only get an idea about a country's financial transactions, commercial production, distribution, and the availability of services from per capita income, but it cannot perfectly depict the socioeconomic situation of the country. Rather, in a society where inequality is high, the average income estimate gives some misleading information. If one family earns Tk 10 lakh and another family earns Tk 10,000 per year, then the annual average income of both the families stands at Tk 5.05 lakh. Does their average income explain the financial

amount of wealth is concentrated in the hands of a small group, even though the GDP swells, the condition of ordinary people remains unchanged, if not worsened.

In fact, remittance and RMG are the major contributors to the steady growth of GDP and per capita income in Bangladesh. There is also the agriculture sector, as well as non-institutional sectors. But both income and safety of life of those working in these sectors are uncertain. While the GDP increases due to the corrupt activities of people involved in money laundering, the livelihood of a large section of society remains precarious. GDP can also increase through the grabbing and destruction of rivers, canals and forests, but that does not ensure sustainable development rather, it puts the economy and the livelihood of a large number of people at risk. When the project costs increase due to corruption and wastage, the annual development programmes also look big, and the GDP figure also increases. In addition, people's access to education and healthcare has decreased due to increased cost and commercialisation of these basic services. But this increased cost also increases the GDP.

The Sundarbans saves the lives and properties of millions of people during natural disasters, but that does not counted in the measurement of GDP. On the other hand, if a coal-fuelled power plant is constructed there by destroying the Sundarbans, there will be irreparable damage to the country and its

used to measure development in many countries. Despite being a so-called underdeveloped country, Bhutan is far ahead of Bangladesh with regard to per capita income. When the per capita income in Bangladesh crossed USD 1,200, Bhutan's per capita income was more than double that figure—USD 2,500. Instead of obsessing over the per capita GDP, Bhutan rejected the method of GDP calculation and invented their own method to measure development, focusing on nine areas: psychological well-being, use of time, community vitality, cultural diversity and resilience, ecological resilience, standard of living, health, education, and good governance.

It is possible to hide many qualitative aspects of GDP by only highlighting the quantitative aspects. This is convenient for the government, the corporate groups and their economics. Due to the nature of various development projects, loans and taxes are also increasing in the country. Along with the increased cost of living, destruction of our rivers and forests are also continuing. If our GDP increases in this way, the country will be in danger in the long run.

Therefore, in order to measure

real development, we need to take into account the qualitative aspects, rather than focusing on quantity only. Socio-environmental damages and opportunity costs must be included in the measurement as well.

# How to prevent future cholera outbreaks

HOLERA outbreaks in Bangladesh are quite common, particularly during pre- and post-monsoon times. There are over 20 cholera hotspots in the country, and Dhaka also remains at high risk, according to the International Centre for Diarrhoeal Disease Research, Bangladesh (icddr,b).

One of the worst cholera outbreaks of the last 60 years took place two months ago in Dhaka. During the first week of March this year, icddr,b received around 500 patients a day, which more than doubled by the last week of the month. The highest daily average number of people who needed hospitalisation at the icddr,b was around 1,000 during the diarrhoea outbreaks in 2007 and 2018. This year, the number of patients exceeded 1,200.

The icddr,b noted that they were getting relatively higher numbers of patients from five areas in Dhaka:
Jatrabari, Dakkhinkhan, Mohammadpur, Sabujbagh and Gandaria. The media revealed that the flow of patients was greater from areas that were suffering from water crisis. A group of researchers detected the cholera germ in water bodies within both the Dhaka city corporations and their peripheries. The chlorine level in the water at the consumer end was also found to be lower in some places.

Having tested the water samples from

different zones of the capital, Dhaka Water Supply and Sewerage Authority (Wasa) claimed to have found no contamination. Recently, Dhaka Wasa has been trying to replace the old pipelines with new and better ones. However, there have been instances of leakage in the existing pipelines, which could have led to infections.

Diarrhoea is mainly a water-borne disease. The number of patients rise during summer when people consume street food and drinks. And outbreaks in Dhaka are often most severe in slums and low-income communities. Many slums where NGOs do not operate lack access to safe water. Solid waste is also not collected in a systematic way from urban slums, which leads to poor sanitation.

Malnourished children face higher risks of suffering from diarrhoea and cholera. Due to having lower immunity and because of living in poor conditions, their conditions often become critical, requiring hospitalisation.

During summer, the quality of water generally deteriorates. Therefore, extra attention by Dhaka Wasa is required to ensure the quality of the water supplied, especially when they are collected from surface water sources. People from low-income communities, floating population and street food vendors are more vulnerable, as they neither have legal and safe water supplies, nor sanitation facilities. They should get more attention both from Wasa and the city corporations, so that they can have access to safe water easily,

affordably and, at the same time, can use public sanitation facilities available within their proximity. To bring this segment of the population under the required services, installation, proper operation, maintenance and management of water ATMs, mobile toilets and public toilets are required. Additionally, solid waste management system to the slum areas should be ensured.

Bangladesh is one of 20 countries in the world that are trying to eradicate cholera. It approved the National Cholera Control Plan in 2019, which clearly emphasised the role of safe water, sanitation and hygiene to eradicate the disease. The government is also thinking of preventive approaches like providing oral cholera vaccine to people. This initiative could be very useful during emergencies.

At the same time, however, it could be a quite costly venture and difficult to manage. Therefore, a combined multisectoral preventive approach might be useful by merging oral cholera vaccines with ensuring safe water supply, safely managed sanitation and adequate hand-washing practice with soap by Wasas and city corporations, with support from relevant government authorities and development agencies. To obtain a sustainable solution, the health ministry, together with city authorities and utility service agencies, should take preventive measures at the beginning of every summer to educate the people about the risks of cholera and diarrhoea.

# Bangladesh and the US need each other

Understanding the importance of Bangladesh in the Bay of Bengal and the Indo-Pacific

UR Planet Earth was so named by human beings who are essentially terrestrial creatures. But how would a visitor from outer space, from another planet or galaxy, react on discovering our planet for the first time? In sharp contrast to other planets he has seen so far, he would see a planet that is 71 percent covered with oceanic waters, with continental land masses as floating islands on these oceanic expanses. He would perceive all the oceans as being interconnected. Such an interplanetary visitor would probably name this planet of ours as "Oceana."

Zooming in on from outer space on our oceanic planet, our intergalactic visitor would see the vast Pacific Ocean on the east, the Atlantic Ocean on the west, the Antarctic Ocean on the south, and the Indian Ocean in the centre of this oceanic geosphere (geographers on Earth refer to the Indian Ocean as the great "Great Middle Bay"). Zooming in more, our intergalactic visitor would see the Bay of Bengal, the largest bay in the world as the "lesser middle bay" in this Great Middle Bay. Now, tempted to zoom in further on this triangular Bay of Bengal, our visitor from outer space would view Bangladesh, at the apex of this bay, as being at the epicentre of this oceanic planet.

### Historical development and legacy of Bangladesh

Bangladesh derives its historical legacy, and its current importance, from its geographical location at the epicentre of this vast oceanic planet of ours. Let us not forget that precolonial Bengal was famed since time immemorial, as a land of vast riches. During British colonial rule over India, Bengal was the largest of its three administrative presidencies, with highest GDP and its summer capital, Shillong, boasting the highest per capita GDP.

What enabled Bengal to achieve such remarkable attention? Historically, it was primarily through the web of riverine and maritime lanes extending through the Bay of Bengal via the coastal ports of Myanmar, Malaysia, Sumatra via Malacca to points further east. Colonial Britain added to this pre-existing riverine circulatory system the railway network from 1844 onwards. With the railways vastly augmenting the riverine routes, historical Bengal became a vital bridging country, oceanically connecting the western and eastern hemispheres. Historical Bengal flourished because of this bridging role.

Modern Bangladesh, today, is already discovering the benefits of acting as a connectivity facilitator between the West and the East. Its surge in growth and ability to attract attention and investment flows over the last decade is derived from this perceived newly established stature. To give credit where it is due, this would not have happened without the bold and visionary leadership of Sheikh Hasina, who well understood the importance of ensuring better bilateral relations with all immediate neighbours and embarked determinedly on the revival of all connectivity that had existed prior to 1947, but had been systematically uprooted after 1965.

### Re-evaluating Bangladesh's position and role within the Global Commons

Today, Bangladesh is not an inconsequential country. It is certainly not the "bottomless basket case" it was contemptuously dismissed as being on its wresting independence from neocolonialism in 1971. It has not only survived as a state, but today is globally looked upon with respect and admiration as one of the fastest growing economies not just in the region, but in the world, thanks largely to the foundational policies adopted by its Father of the

Nation ("Bangabandhu: The architect of Bangladesh's foreign policy," *The Daily Star*, May 7, 2020). Bangladeshis today can proudly claim that they have better human development indices than most of their neighbours. Two-and-a-half generations on from its gory liberation as a nation, Bangladesh today has a vibrant youthful population



that is eagerly forward-looking, replete with high aspirations, supremely self-confident and exuding pride in their nation and their achievements to date, and that does not take kindly to being patronised or dictated to by anyone. Its business community has demonstrated its entrepreneurial talents and zest by unleashing its animal spirit and driving the engine of national growth.

The bold and visionary leadership of Sheikh Hasina has stabilised the country economically and led it on the path to prosperity. This same leadership has reemphasised to the world Bangladesh's identity as a moderate, secular, inclusive Muslim majority state, with deeply embedded democratic aspirations that has zero tolerance towards forces of radicalism, terrorism, and destabilisation of any kind. By contributing the largest numbers of military, police and civilian personnel to the UN Peacekeeping Force and its global peace-building efforts, Bangladesh has palpably demonstrated its core commitment to peace and justice for all.

Ensuring economic prosperity and stability, deepening, widening, and broadening its educational base, ensuring equal participation by women, gender equality and social stability are the prerequisites for the first stage of development of any state, for progressing, consolidating, and stabilising its foundational pillars. This enables it to advance to organically ensuring social equity, inclusivity, good governance, and respect for human rights with justice for all. Most advanced industrialised nations have organically traversed this same path centuries ago. Bangladeshis are only now embarking on this second stage of development.

### Potential for growth: The next 50 years of Bangladesh-US ties

Today, the focus of attention by almost all major, middle or minor powers has pivoted to Asia. Contextually, the Indo-Pacific region is strategically at the heart of Asia. The increasing attention upon Bangladesh emanates from it being perceived as a bridging nation located at Asia's very epicentre. Bangladesh's prosperity is and will continue to be derived from this role and will also depend on its ability to maintain the best of relations with all countries, whether near or far from it. Indeed, its survival and continuing prosperity as a state depends on judicious management of its geostrategic location.

At the same time, this locational advantage and importance also devolves on Bangladesh an onerous responsibility. For Bangladesh to continue serving as a facilitator of free maritime passage in the

advocated cooperation among neighbours. It has consistently punched well above its weight in promoting regional cooperation, as clearly evinced from its active roles in the formation of Saarc, Bimstec and IORA, as well as its proactive role in fostering subregional cooperation within the BBIN. Bangladesh can, and should, now look to working in concert with other Bay of Bengal littoral and adjacent countries (who together comprise a quarter of the world's population) to engage together in economic cooperation. Such cooperation could organically progress towards the emergence of a Bay of Bengal Economic Community, whose aggregate GDP would

only be surpassed at current rates by the US, China, and the European Union. The US can help Bangladesh's leading role as the facilitator of this process.

Given Bangladesh's centrality, the US needs a stable and prosperous Bangladesh, just as Bangladesh needs the US as a continuing interdependent development partner. Of course, Bangladesh also needs to demonstrate its role as exemplar by ensuring better governance of itself that is based on the exemplary standards of social justice and egalitarian rights for all its own citizens as well. However, in this endeavour, the US, with its head start of over 250 years in nation-building and state consolidation, would surely recall its own many challenges that it has had to overcome. Today, the US can draw upon its own often difficult experience and assist Bangladesh, which embarked on its journey as an independent state a mere 50 years ago. It can help Bangladesh in capacity-building and institutional development towards an inclusive rules-based society, avoiding the pitfalls that it itself faced and is still facing to some extent.

Bangladesh has historically been part of ancient Indo-Pacific connectivity, and it has declared that it shall continue to be a part of ensuring future connectivity in the region. It is indeed in Bangladesh's interest to advocate and work for an open, resilient, and interconnected Indo-Pacific, because its own continuing sustainability as an independent, sovereign prosperous nation-state depends on this.

As an increasingly self-confident and prosperous Bangladesh moves away from a sense of obligatory dependency that defined its relationship with the US in the last 50 years, it is in the US' interest to promote a sense of growing interdependence with the relatively new nation-state that is Bangladesh, looking ahead at the next 50 years.

"I met Emil through PAW when I was volunteering to nurse sick animals back to

"Proper measurements and laws for animal rights and care have yet to be legally determined in Bangladesh," adds Emil. "Many young people provide foster care to cats and dogs at their own homes. We plan to bring animal services to the mainstream."

One of the biggest challenges in operating Furryghor for the founders is the lack of properly trained animal caregivers. "People don't usually set out to become animal caregivers. We had to train our staff from scratch. As an organisation, we are still in our initial stage. We hope to become self-sustaining as we grow," shares

Moving forward, the founders plan to turn Furryghor into a resort where pets and their parents will be able to stay together and enjoy vacations.

# Swayong's 'Jonglaphool' focuses on the strength of women

Swayong's documentary film "Jonglaphool", produced in collaboration with Manusher Jonno Foundation and UKaid, showcases diverse women of society, who, like wildflowers, know how to survive amid adversities. The storytelling platform has so far shared 121 stories and conducted 18 campaigns since its inception in 2020.

"We believe that women are like wildflowers growing in the forest. They do not need protectors; they are independent and beautiful," asserted Swatil Mahmud, the

"Jonglaphool" recognises women's unaccounted and unpaid care work, creating awareness about intersectional feminist activities and promoting women leaders and women-led initiatives that combat gender bias. The film encourages the audience to reflect on the unfairness women encounter and their roles in dismantling the patriarchy.

The segments in the documentary film are "Sarbajaya: Women Empowerment", "Bon Jui: Unpaid and Unaccounted Care Work" and "Mahabhringraj: Women Leading Movements". By covering themes that reflect on several aspects of a woman's life, Swayong wishes to present a relatable story about ordinary women who need more

representation in media.

"Growing up, I did not see women like myself on television. When I got the chance to produce visual content, the first thing that came to my mind was the fact that we need to bring better role models and share everyday stories," Swatil explained.

The first segment talks about the lives of two women, who are similar, yet different in many ways. It focuses



on the specific struggles of being an independent woman in society and the multiple nuances associated with women's empowerment. It begins and ends with a poem recitation and extends more power for people to become whatever they wish to.

The second segment revolves around the theme of care work and how it often goes unappreciated in households. It also features insights from experts who explain the nature of this problem. The women in this segment are ordinary working people, with the added burden of family responsibilities. It instantly connects with the viewers as they can associate these role models with people they know and thereby form a new idea about their lives.

The last segment showcases the feminist movements conducted by women across different generations. For this one, women from different backgrounds shared their take on conducting movements and how experience coupled with power helps them roar and rise.

Swatil, along with Nujhat Jabin Sumaiya, brainstormed the idea behind this film. She took help from her sister and Swayong's co-founder, Mitul Mahmud to design the story. "Jonglaphool is an ode to all the strong women out there, including the ones who made this documentary possible," she added. Apart from this, the videos were shot and edited by Mir Rabby and Emon Kalyan.

Swatil hopes to conduct private screenings of "Jhonglaphool" in the future, to connect with more people.

# AMAZING EFFORT' salvages the day

Bangladesh were 24 for five as the early morning conditions confounded the hosts after opting to bat in the seriesdeciding second Test at Mirpur yesterday. Openers Tamim Iqbal and Mahmudul Hasan Joy went back to the hut for naught and captain Mominul Haque, Najmul Hossain Shanto and Shakib Al Hasan failed to put up much of a resistance. But if morning shows the day, the Tigers must count themselves lucky to have turned the innings around after such a disastrous start.

Kasun Rajitha and Asitha Fernando had run rampant in that first session as Bangladesh lost five wickets inside seven overs. The last time a team had lost five in seven overs was Australia during a 2015 Test against England. The Aussies were bowled out for just 60 in that Nottingham Test and the premonitions were there that Bangladesh might slump to similar lows that they produced in South Africa only recently, bundled out for 80 and 53.

The fact that it ultimately did not happen was only made possible by the quite surreal sixth-wicket stand between the experienced Mushfigur Rahim and ever-improving Liton Das. The duo saw to it that Bangladesh scraped through to lunch and set the tone with their solidity.

Bangladesh's approach in Tests is often questionable and the first five wickets had been suggestive of that lack of application or patience. While Mahmudul Hasan Joy and Mominul were late to their shots, Tamim Iqbal and Shakib were guilty of playing across the line. The Mirpur surface had enough in there for the pacers to extract that little bit of movement and Bangladesh toporder collapsed.

Grit, determination, patience and, above all, application was shown by both Mushfigur and Liton in getting behind the deliveries, not trying to prod at anything too far away from them.

A straight bat was shown to most deliveries and they allowed the deliveries to come into their zone and then backed themselves up with good shot-selection.

### **Swiatek** extends unbeaten streak to 29

World number one Iga Swiatek put on a commanding display against Ukrainian qualifier Lesia Tsurenko with a 6-2, 6-0 opening victory on Monday to kickstart her bid for a second French Open title and extend her winning run to 29 matches.

Swiatek, who won the 2020 Roland Garros title without dropping a set, arrived in Paris having won her last five tournaments. including four WTA 1000 events, and is the overwhelming favourite to lift the Suzanne Lenglen Cup again. "I just want to keep going. I am aware that someday my streak may stop," Swiatek said on court. "Basically I am just working every day to be 100% focused on my tennis, not on stats or not on some numbers." "Just playing tennis and focusing on my game and being kind of in a bubble. That's going to help me be consistent."

# Man City crave Champions League legacy

Manchester City's latest Premier League title triumph established the champions as a burgeoning dynasty, but Pep Guardiola won't be satisfied until their domestic bliss becomes the catalyst to conquer Europe.

City's fourth title in five seasons is arguably the greatest achievement of Guardiola's glittering career as he found a way to hold off Liverpool's relentless challenge by one point.

# Washington wants Dhaka in

The US wants Bangladesh to join the Indo-Pacific Economic Framework for Prosperity (IPEF), a new regional trade initiative launched by Joe Biden in Japan yesterday.

Apart from the US, the initial partners of the IPEF are Australia, Brunei, India, Indonesia, Japan, Republic of Korea, Malaysia, New Zealand, the Philippines, Singapore, Thailand, and Vietnam, according to a White House Statement.

US Embassy Spokesperson in Dhaka, Bryan Schiller, in a message to the media said Bangladesh is an important regional partner of the US, which has been in contact with the government here about the IPEF since the partnership dialogue in March and at regular intervals in Dhaka and Washington.

"We look forward to continuing to exchange views on IPEF and the 21st century economic challenges it seeks to address, including the digital economy, clean energy transition, and supply chain resiliency," he said.

"I believe we'll win the competition of the 21st century together," said Joe Biden at the launch of the framework on his second day in Japan, where he also held talks with Prime Minister Fumio Kishida before joining a regional Quad summit.

Foreign Minister AK Abdul Momen has not made any immediate comment on whether Bangladesh would participate in the IPEF.

On various occasions he has said Bangladesh is not interested in any security alliance in the Indo-Pacific but is keen on socio-economic cooperation.

The statement said the IPEF will create a stronger, fairer, more resilient economy for families, workers, and businesses in the United States and in the Indo-Pacific

### **HAJJ FLIGHTS** PMO warns Biman, others against any mess-up

The Prime Minister's Office has sternly warned Biman and others concerned about disruptions to hajj flights and asked them to remain extremely vigilant so that there is no fiasco.

During a hajj management review meeting, chaired by Ahmad Kaikaus, principal secretary to the prime minister, on Tuesday, the PMO issued nine directives to ministries and departments concerned.

The matter, however, came to light yesterday. According to the instructions, hajj flights will only carry pilgrims and no other passengers, and carriers have to ensure that all pilgrims get their immigration procedures done at Hazrat Shahjalal International

Airport. For this purpose, the required number of booths should be set up in the hajj camp," a top official of the religious affairs ministry told The Daily Star quoting the

Two additional booths will be set up at the airport for special cases.

The Ministry of Religious Affairs has to provide necessary information of pilgrims to the immigration authorities in advance.

The health department will take necessary steps in coordination with the religious affairs ministry, for designating a hospital for smooth RT-PCR tests of pilgrims, the instructions read.

All services at the hajj camp will be 24/7.

# Diseases lurk as floodwater recedes

DWOHA CHOWDHURY, Sylhet

As the Surma has been flowing below the danger level at some points in Sylhet city and Sunamganj town for two consecutive days yesterday, floodwaters are receding fast in many areas.

Against this backdrop, doctors warn of the risk of locals contracting waterborne diseases considering that all sources of drinking water will remai contaminated for at least a few weeks.

Visiting some areas in Sylhet city, this correspondent saw that water has been stagnant in the drains, canals and low-lying spaces, and is beginning to emit bad odour.

Santu Das, a resident of the city's Jamtola area, said, "While the water is receding, all the garbage carried by the flood still remains and has been stinking up all the areas. Every previously flooded area is in need of quick cleaning and bleaching."

Meanwhile, Md Zahidul Islam, chief health officer of Sylhet City

Corporation, said, "By drinking contaminated water from tube wells or even the regular water supply, many people might contract waterborne diseases and this is a high-priority issue

"We will be running awareness campaigns in this regard twice a week in all wards,

while water purification tablet distribution continues. We are also planning to clean the city."

In Sylhet district, 140 medical teams are working in 103 flooded unions of all 13 upazilas and the city, according to Sylhet civil surgeon office.

It said 43 people in the district have had diarrhoea till

yesterday, while two people have been suffering from respiratory issues, three from skin diseases, and five others from other waterborne diseases.

Meanwhile, six people have so far died either by drowning or falling under landslides during the floods.

SM Shahreer, the civil surgeon in Sylhet, said, "All medical teams have been distributing water purifying awareness information to the people. But local representatives need to play a more vital role in ensuring that the services reach the remote parts of the affected

The situation in Sunamgani is better as not many cases of waterborne diseases have been recorded yet, said Ahmmad Hossain, civil surgeon of Sunamganj.

"As water purification tablets are being distributed among all flood-affected people, we are hoping not to see an outbreak of disease.'

### **FLOODS IN NORTH** 1.5m children are at risk **Says Unicef**

Over 1.5 million children are at increased risk of waterborne diseases, drowning and malnutrition due to extensive flooding in north-eastern Bangladesh, said Unicef Bangladesh in a statement yesterday.

Over four million people in five districts of north-eastern Bangladesh -- Sylhet, Sunamganj, Habiganj, Netrokona and Moulvibazar -- have been affected by extensive flooding.

Sylhet and Sunamganj are the worst hit, with water flowing above dangerous levels. Agricultural land and critical infrastructure, including power stations and schools, have been submerged.

Cases of diarrhoea, respiratory infection, and skin diseases have already been reported. At least three children have died after being struck by lightning, the statement said.

Hundreds of schools have been closed, further jeopardising children's education after 18 months of school closures in the last two years due to the Covid-19 pandemic.

"The damage to lives, homes and schools is heartbreaking. In this disaster, as in most others, children are the most vulnerable," said Sheldon

Yett, Unicef representative to Bangladesh. "Unicef is on the ground to protect children and to meet their urgent needs, supporting the

### You can't extract sand from Meghna **HC tells AL leader**

The High Court yesterday refused to allow Awami League leader Md Salim Khan to extract sand from the Meghna in Chandpur and sell it.

The court summarily rejected a writ petition filed by Salim seeking its permission for extraction and sale of 28.4 lakh cubic feet of sand or earth from the river bed in Chandpur Sadar upazila's Shakhua, Ichuli and Mirzapur mouzas and Haimchar upazila's Monipur and Charkrishnapur mouzas.

The HC bench of Justice Md Mozibur Rahman Miah and Justice Khizir Hayat passed the order after hearing arguments on the petition.

Lawyer Jafar Alam Khan appeared for the petitioner while Deputy Attorney General Kazi Mynul Hassan represented the state.

Jafar said his client would move an appeal before the Appellate Division of the Supreme Court challenging the HC order.

The HC rejected the petition as the Appellate Division had earlier stayed two HC orders that had allowed Salim to extract sand from other areas of the Meghna in Chandpur, he told The
