#### **NEW APBN UNITS** Commission for CHT slam govt move

Chattogram Hill Tracts Commission yesterday expressed deep concern over a government move to introduce a new unit of Armed Police Battalion in the region.

In a statement, the commission said it believes the move was a direct violation of the Chattogram Hill Tracts Accord.

Citing media reports, the commission said Home Minister Asaduzzaman Khan Kamal laid the foundation stone for four units of APBn in three hill districts on Thursday.

The event was preceded by a government decision, it said.

"The commission is surprised by this decision of the government," read the statement.

Instead of implementing the basic provisions of the accord, it looks like the government is moving away from the implementation process, said the commission.

It said the government needs to deal with the issue of CHT politically by fully implementing the accord.

To improve the lawand-order situation in the CHT, it urged the government to transfer the "Police (Local)" subject to the Hill District Councils and facilitate the formation of the "Hill District Police Force" as per the CHT Accord and the Hill District Councils Acts of 1989.

It also urged the government to discuss with relevant groups, including the CHT Regional Council, before making any important decision related to the

It further called upon the government to declare a roadmap and timeframe to implement the accord in full and without any further delays.

# Russia gains more ground in east Ukraine

Forces blast Sievierodonetsk after claiming capture of key railway junction town

Russian forces were assaulting the Ukrainian city of Severodonetsk yesterday after saying they had captured the nearby rail hub of Lyman as Moscow pressed its offensive in the eastern Donbas.

Russian gains in recent days indicate a shift in momentum in the war, now in its fourth month. The invading forces appear close to seizing all of the Luhansk region of Donbas, a main Kremlin war goal, despite Ukrainian resistance.

Russia's defence ministry yesterday said its troops and allied separatist forces were now in full control of Lyman, site of a railway junction and lying west of the Siversky Donets River in the Donetsk region that neighbours Luhansk.

However Hanna Malyar, Ukraine's deputy defence minister, said the battle for Lyman continued, the ZN.ua website

The Russian forces were likely to try to cross the river in coming days in the next phase of the Kremlin's Donbas offensive, the British defence ministry said in its daily intelligence report yesterday.

Severodonetsk, some 60 km (40 miles) rom Lyman on the eastern side of the river and the largest Donbas city still held by

Ukraine, is now under heavy assault from the Russians.

"Severodonetsk is under constant enemy fire," Ukraine's police force said in a social media post yesterday.

Russian artillery was also shelling the Lysychansk-Bakhmut road, which Russia needs to take to close a pincer movement and encircle Ukrainian forces.

"There was significant destruction in Lysychansk," the police said.

The governor of Luhansk, which along with Donetsk makes up the Donbas, said on Friday Russian troops had already entered Severodonetsk. Ukrainian troops may have to retreat from the city to avoid capture, governor Serhiy Gaidai said.

The Russian forces have been making slow but steady advances in the Donbas - large parts of which were already controlled by Moscow-backed separatists before the war - after failing to capture the capital Kyiv soon after their Feb 24 invasion of Ukraine.

Their tactics involve mass artillery bombardments and air strikes that have laid waste to towns and cities.

The General Staff of Ukraine's armed forces yesterday said Ukrainian forces had enelled eight assaults in Donetsk and

attacks included artillery assaults in the Severodonetsk area, it said.

"If Russia did succeed in taking over these areas, it would highly likely be seen by the Kremlin as a substantive political achievement and be portrayed to the Russian people as justifying the invasion," the British intelligence report said.

Some 90 percent of buildings in Severodonetsk were damaged, Gaidai said, with 14 high-rise buildings destroyed in the latest shelling. Several dozen medical staff were staying on in Severodonetsk but they faced difficulty just getting to hospitals because of the shelling, the Luhansk governor said.

Reuters could not independently verify the information.

President Volodymyr Zelenskiy remained defiant in his nightly address to

"If the occupiers think that Lyman and Severodonetsk will be theirs, they are wrong. Donbas will be Ukrainian, Zelenskiy said.

Analysts at the Washington-based Institute for the Study of War said that while Russian forces had begun direct assaults on built-up areas of Severodonetsk, tney were likely to struggle Luhansk in the previous 24 hours. Russia's to take ground in the city itself.

#### JP undecided over polls if EVM is used

#### Bangladeshi shot dead at Sylhet border

Indian Border Security Force returned the body of a Bangladeshi to the Border Guard Bangladesh yesterday, five days after he was shot dead allegedly by India's Khasi people near the Jaflong border area in Sylhet's Gowainghat upazila.

The deceased, Kabir Hossain, 32, was a resident of Champaknagar village in the same upazila. Locals and police said Kabir along with his two

friends entered India on May 23. Khasi people opened fire on them that day, leaving Kabir hit by bullets. However, his friends managed to return to Bangladesh.

Kabir's body was found at the border's Mayabi Jharna area on Thursday. The body was recovered

#### 17yr-old pregnant housewife 'sets herself on fire'

A 17-year-old pregnant homemaker set herself on fire after pouring kerosene on herself over a dispute with her husband in the capital's Shahjahanpur yesterday.

The victim, Papia Sarwar Mim, is undergoing treatment at Sheikh Hasina National Institute of Burn and Plastic Surgery with 95 percent burns, said Inspector Bachchu Miah, in-charge of the Dhaka Medical College Hospital police camp.

Victim's husband Md Ramim brought her to the hospital in the afternoon. He was later handed over to Shahjahanpur Police Station, said the inspector.

Mim's mother Parvin Akhter said her daughter married Ramim three years back. She had long been arguing with her husband over his extramarital affair, she alleged.

"My daughter set herself on fire as she couldn't bear the mental torture by her husband," Parvin

According to the law of the land, marriage of a girl aged below 18 is considered a child marriage.
