

HAJJ PILGRIMS

BB asks banks to transfer funds

Bangladesh Bank yesterday asked banks to take measures to transfer funds related to the expenditures of aspirant hajj pilgrims.

This is for the people who are set to travel to Saudi Arabia to perform hajj under private management.

Banks have to send Tk 3,04,302, or 12,522 riyals, as expenses for each aspirant pilgrim via the international bank account number of hajj agencies, said the central bank in a notice yesterday.

Those who are set to perform hajj under private agencies will have to pay a minimum of Tk 5,22,744. It is Tk 5,21,150 for those set to perform Hajj

Bus driver sued over Barishal accident

Hours after a road accident killed 10 people in Barishal, a case was filed with Ujirpur Police Station on Sunday night.

Gournadi Highway Police Sub-inspector Mahbubur Rahman filed the case with the station, accusing bus driver Anich Khan from Bakerganj, said law enforcers. Anich is on the run. Ten people died and 25 were injured as a bus of Jamuna Line Transport crashed into a tree in Sanuhar area in Ujirpur, Barishal on early Sunday.

HARASSING 2 STUDENTS
RU halts teacher's promotion

The Rajshahi University authorities have suspended the four-year increment of a teacher, and also his promotion, for harassing – sexually and mentally – two students of the university.

The decision was taken against Assistant Professor Bishnu Kumar Adhikari at the university's 514th Syndicate meeting chaired by Vice-Chancellor Prof Golam Sabbir Sattar on Sunday, said syndicate member Assistant Professor Sadiqul Islam Sagar.

Besides, the authorities will also send him a written warning, reports our RU correspondent.
