Dengue spike rings caution

At least 17 dengue patients were hospitalised in different hospitals across the country yesterday, indicating a rising trend.

According to
Directorate General of
Health Services (DGHS),
along with the 17 new
cases, 46 dengue patients
have been hospitalised
since the beginning of
June.

The total number of dengue patients this year stands at 398.

61 dengue patients are still undergoing treatment.

Experts suggested that city corporations should take extensive measures immediately to control Aedes mosquitoes, as they are expecting a major outbreak.

A pre-monsoon survey conducted by DGHS between March 23 and April 4 found three DSCC wards to be at "high risk".

It also found 10 wards o be at a "medium risk" of an outbreak.

Nine wards in DNCC are at "medium risk".

NOT OPEN FOR ALL

Gulistan's Shaheed Matiur Park now requires Tk 10 to enter, to the dismay of residents

Hoping to spend some quality time with his family, Mohram Ali recently took his three children to Shaheed Matiur Park at the capital's Gulistan. But after reaching the entrance, the family got confused and eventually disheartened.

The four were intercepted by a security guard, who wanted Tk 40 for entry tickets, Tk 10 for each of them. For the family, buying tickets to enter a public, open park was unheard of, and in fact, this is not the common practice.

"I didn't think they would ask for money to enter the park. It's not fair. A



park should be open for all, without any

entry fee," said Mohram.

This correspondent talked to several others in the area, and they all had

similar complaints.

For the last three months, people have been buying tickets to enter the park. The question is, why? When Dhanmondi Lake, Ramna Park and Chandrima Udyan are free to enter for all, how logical is it to charge visitors of Shaheed Matiur Park?

Three months back, Dhaka South City Corporation (DSCC) leased the park out to a firm, which is now maintaining the park and taking Tk 10 as entrance fee from each visitor.

The leaseholder has set up multiple rides inside, and a few will be installed soon

Under the project "Jalsabujer Dhaka", taken in 2017 to renovate 19 parks and 12 playgrounds in DSCC areas, many parks have already been opened.

Matiur Park, spending Tk 9 crore, and opened it to the public in 2020. As part of renovation works, it removed the iron fencing and lowered boundary walls to give the place an open look and ensure easy access.

But in less than a year, the corporation fenced the park boundary again, spending around Tk 80 lakh,

He mentioned that although what the authorities are doing is technically legal, it is an unethical practice, as it will deprive people's right to access open

Contacted, DSCC Ward-13 councillor Md Enamul Haque said the decision was taken by the city corporation, and he has nothing to say.

The situation is challenging, as floating people and others dirty up the park. And so, it was leased out for

proper maintenance, he said. On the bright side, the park is actually being properly maintained, as premises are clean, and the atmosphere

is pleasant for visitors.

Contacted, leaseholder Md Oli Ullah, proprietor of Oli Enterprise, said they have taken the park on lease for a year

on November 26, 2021.

They have leased it for Tk 20 lakh and already set up some rides, he said. According to DSCC's decision, the firm is not allowed to take more than Tk 10 from a visitor.

The number of visitors is still low, as many do not enter due to the ticketing system, but around 500 visitors go to the park daily on average, he said.

Contacted, DSCC Chief Executive Officer Farid Ahmed said the corporation took the decision only for locations that have rides and playing equipment. "We have also set up rides in a few places, like Kalabagan, where we are introducing a ticketing system."

Farid said they do not have the workforce to maintain the park, and so they leased it out.

Five killed in road accident

Five people were killed and a man was injured in a head-on collision between a lorry and an auto-rickshaw on Dhaka-Mawa highway near Keraniganj, on the outskirts of the capital, in the early hours of yesterday.

The deceased were identified as auto-rickshaw driver Md Tamal (18), Jonayed Hossain Jihad (23), Nahid Hossain Fahim (21), Md Samad (21) and Jony Miah (26).

The injured person is Ahad (22).

The accident occurred around 12:30am when five friends, workers of a factory in Hasanabad area, were on their way to visit Padma Bridge in an auto-rickshaw, said Mohammad Shah, officer in-charge (OC) of Hasara police station.

The auto-rickshaw collided with a lorry in Teghoria area suddenly, leaving four inside the auto-rickshaw dead on the spot, said Hasara Highway Police in-charge Afzal Hossain.

The wounded were taken to Mitford Hospital, where the on-duty doctor declared Jony Miah dead.

Police seized the lorry, but its driver and helper managed to flee.

A case has been filed with South Keraniganj police station in this regard.

DU admission test begins with 'Ga' unit

The admission test of Dhaka University (DU) for 2021-2022 academic session began with "Ga" (C) unit, under business studies faculty, across the country yesterday.

The exam started at 11:00am and continued till 12:30pm at eight universities in divisional cities, said a press release issued by DU public relations office.

A total of 30,719 students applied for 930 seats.

The venues were Dhaka University, Rajshahi University, Chittagong University, Khulna University, Barishal University, Begum Rokeya University, Bangladesh Agricultural University, and Shahjalal University of Science and Technology in Sylhet.

DU Vice Chancellor Prof Md Akhtaruzzaman, Pro-VC (Administration) Prof Muhammad Samad and Pro-VC (Academic) Prof ASM Maksud Kamal, among others, visited the exam centre at the faculty building.

The VC expressed satisfaction, as the exam was held in a fair and peaceful atmosphere.

Rice traders fined Tk 3.23 lakh

The food ministry yesterday fined rice millers and traders Tk 3.23 lakh for doing business without licence and hoarding rice in four divisions of the country.

A case was also filed against a miller, Nargis Auto Mill,

in Bogura's Sherpur.

The price of both fine and coarse rice shot up by Tk 4 per kilo on June 1, and the food ministry launched drives

against illegal rice hoarders across the country, says Trading Corporation of Bangladesh (TCB). Several teams of the food ministry and department led the drive yesterday in seven divisions. No drive was carried out in Mymensingh, said Kamal Hossain, public

relations officer of the ministry.

Two traders of the capital's Rampura and Banasree were fined Tk 9,000 for doing business without a food grain licence, while another trader of Hazaribagh was fined Tk 5,000 for the same charge.

Mobile courts fined some unlicensed traders of Shantinagar and Fakirapool Tk 30,000.

In Savar, two traders were fined Tk 30,000 due to anomalies in selling and buying receipts.

In Brahmanbaria and Natore, three traders were fined Tk 65,000 for hoarding and using plastic bags. Another trader in Natore was fined Tk 30,000 for hoarding rice and operating without licence.

GOLD TRADER'S MURDER

Four give confessional statements

Four accused in a case lodged over the murder of gold trader Anup Baul yesterday gave confessional statements before court.

The four are Anup's business partner Nayan Mondal, his cousin Ripon Mondal, Pijush Karati and Dilip Chandra Roy.

PBI produced them before the court of Dhaka Senior Judicial Magistrate Meshkat Shukrana. The court then recorded their statements and sent them to jail.

Anup went missing from Munshiganj's Sirajdikhan area on January 4. PBI arrested the four on June 1, after recovering Anup's body.



On the 12th anniversary of the Nimtoli fire tragedy, wreaths were placed on a memorial in the area, in remembrance of the deceased. In 2010, the incident shocked the entire nation with its magnitude of losses, taking 117 lives. However, such incidents have not stopped. The Nimtoli tragedy was followed by multiple others, including the Chawkbazar fire in 2019. Although many steps and reforms were promised to put an end to such incidents, no visible change has taken place.
