Target more export, remittance

Finance minister outlines measures in next budget

The government plans to boost exports by promoting large industries and send a record number of migrant workers abroad to raise foreign currency reserves.

"There will be a surprise in the upcoming budget in terms of support for large industries," said Finance Minister AHM Mustafa Kamal.

Besides, additional funds will be set aside for the poor and low-income people reeling from the rising cost of living amid high inflation. The minister shared his thoughts with The Daily Star

on Monday as he prepares to place his fourth budget in the Jatiya Sangsad tomorrow.

'We will support large industries that are capable of making and selling products in other countries ..

"We will promote 'made in Bangladesh' products and facilitate the manufacturing of products elsewhere [by Bangladeshi large industries] to meet the global demand. We will produce cars for export," he noted.

The minister, however, did not elaborate on the support to be extended to large industries.

Seeking anonymity, a finance ministry official said the assistance might include both tax relief and

The size of the next budget could be Tk 678,064 crore. The revenue generation goal may be Tk 433,000 crore and the National Board of Revenue could be tasked with collecting Tk 370,000 crore.

The budget deficit may amount to Tk 245,064 crore or 5.5 percent of the gross domestic product, meaning it will be above the 5 percent ceiling that Bangladesh had always maintained until the Covid pandemic forced the government to increase spending despite lower-thanexpected revenue generation.

The budget comes at a time when Bangladesh, like other economies, is facing the twin challenges of higher consumer prices and strain on the foreign currency

The Russia-Ukraine war has intensified volatility and is threatening to derail the recovery trajectory.

But Kamal is hopeful of keeping the country insulated from the crisis and his confidence stems from the outward movement of migrant workers as global economies reopen.

"We will send abroad the highest number of migrant workers this fiscal year."

Nearly eight lakh migrant workers went abroad in the first 10 months of the current fiscal year, comfortably exceeding the number a year ago. And Kamal expects the figure to hit 10 lakh before this fiscal year ends on June

"Western economies will require additional workers once the war in Ukraine comes to an end. We are going to set a manpower export goal of 15 lakh in the upcoming fiscal year," he mentioned.

BPDB to pay Tk 1,219.1cr for power not used

Finds study by Bangladesh Working Group on the External Debt and Growthwatch

If it does not add value, it is a waste, said the seminal American industrialist Henry Ford. And the quote best describes the situation the Bangladesh Power Development Board finds itself in with its deal with India's Adani Power.

Engineered during Indian Prime Minister Narendra Modi's maiden visit to Bangladesh in 2015, Adani Power has set up a 1,600MW thermal power in Jharkhand's Godda to supply most of the power generated to BPDB through a dedicated transmission line.

That power plant will be going into generation from August but its transmission would not be ready until December at least, meaning the power would be going to waste.

And yet, BPDB would have to pay \$141.1 million, or Tk 1,219.1 crore, in capacity charge for the four months to December, according to the report "Adani Godda Coal Power Plant: An Achilles Heel of the Power Sector of Bangladesh".

Capacity charge is a penalty paid

to the plant owner for failure to buy a certain portion of power readily

As per the agreement signed in 2017, Adani Power would supply 1,496 MW of electricity for 25 years from December 2021.

Because of the pandemic, the Adani Group subsidiary pushed the start date by six months. The power plant is all set to start commercial operation in August.

But the Power Grid Company of Bangladesh (PGCB) said more time is needed to get the infrastructure ready to import electricity. It will take at least December this year.

As per the agreement, Adani Power would install a dedicated 106 kilometres $long\,400\,kV\,transmission\,line\,from$ Godda to the interconnection point.

To relay the power from the point, PGCB took up a Tk 225.2 crore project to construct a 28 km transmission line from the Indo-Bangla border to the Rohanpur substation in Bangladesh. The substation is vet to be

> built as the materials have not arrived, Md. Mizanur Rahman Sarkar, project director of the transmission line, told The Daily Star.

"We will be able to import power from about 800 MW in the early months of the next year," he said. BPDB has agreed to pay the Adani Godda power plant Tk 3.26 as the

capacity charge per unit. For similar plants in Bangladesh, the capacity charge is Tk 2.83.

Nasrul Hamid, the state minister for power, energy and mineral resources, is not sure yet whether BPDB would have to pay the capacity charge for the

CTG DEPOT FIRE Many victims risk losing eyesight

A majority of those injured in the Chattogram depot blasts have suffered eve injuries and many are at risk of permanent vision loss.

More than half of the 100 patients admitted at the burn and plastic surgery ward of Chattogram Medical College Hospital (CMCH) and all 19 at Sheikh Hasina National Institute of Burn and Plastic Surgery in the capital are suffering from eye injuries.

Meanwhile, firefighters have found 12 more containers laden with chemicals in the depot yesterday. The series of explosions since the fire broke out at

The fire was brought under control and almost doused as of last night.

About the 19 patients with eye injuries in the capital, Dr Samanta Lal Sen, chief coordinator of the institute, said, "They are being treated by eye specialists alongside receiving

treatment for burns.' Imrul Kaisar, a police constable, was receiving treatment in CMCH. His eyes were seriously affected in the blasts and he also suffered burn injuries on his legs, said Sadia Akter, assistant registrar of the burn and plastic surgery unit at CMCH.

An eye specialist yesterday morning visited Kaisar and suggested shifting him to Dhaka for better treatment, said Raihan, the constable's elder brother.

WB revises down growth forecast for Bangladesh

Taking into account the Ukraine war, the World Bank reduced Bangladesh's economic growth projection to 6.7 percent for the next fiscal year from its January forecast of 6.9 percent.

The economy of the country will grow at its previous projected rate at 6.4 percent at the end of the current fiscal 2021-22, according to the Global Economic Prospects report released by the WB yesterday.

However, the Bangladesh government in April projected that the country's economy will grow at 7.5 percent in the next fiscal year and at the end of the current fiscal year the economy will grow at 7.2 percent. The WB report said,

Wants implementation under G2G-PPP; local experts term the project 'highly ambitious'

Following the instruction of Prime Minister Sheikh Hasina in October 2014, Bangladesh Railway carried out a feasibility study for constructing a high-speed rail network between Dhaka and Chattogram. However, the project was apparently put on the

back burner considering the huge amount of money Tk 93,35,0.93 crore (\$1=Tk 84) -- required for its implementation. În a recent development, China has proposed

carrying out the project under the governmentto-government-Public Private Partnership (PPP) framework, bringing it back into discussion.

The country has also selected China Railway Group Ltd (CREC), a state-run company, for implementing the project, which will cost more than three times the expenditure for Padma Bridge (Tk 30,193 crore).

Li Jiming, the Chinese ambassador to Bangladesh, in April wrote to Railways Minister Nurul Islam Sujan for signing a memorandum of understanding between CREC and BR "as soon as possible".

First e-gates of S Asia open in Dhaka airport

Passengers who have e-passports can now use e-gates and complete their immigration within a short time at Hazrat Shahjalal International Airport.

After inauguration of the e-gates yesterday, passengers went through those, and one could finish the immigration process in around 18 seconds, said Group Captain Kamrul Islam, executive director of the HSIA.

Monirul Islam, additional IGP, Special Branch, and Brig Gen Sadat, project director, e-passport project, were present at the inaugural event.

With the launching of the e-gates, long wait of e-passport holders to finish their immigration formalities has come to an

Twelve e-gates have been installed in the departure area and three in the arrival

On June 6, the immigration process was successfully completed through e-gate on a pilot basis.

Apart from HSIA, six e-gates each have been set up at Shah Amanat International Airport and Osmani International Airport. But those are yet to be operational.

The government has planned to set up 50 e-gates at all the airports and land ports across the country under the "E-Passport and Automated Border Control Management Project".

Mokabbir Hossain, secretary of Security Services Division under the home ministry, recently told The Daily Star that outbound and inbound passengers could $zip\ through\ immigration\ formalities$ at the country's main gateway via the automated border control system.

"Passengers don't need to stand in queues for long, as the e-gates will open automatically for the people with e-passports."

Bangladesh is the first country in South Asia to launch e-gate for e-passports.

The camera attached to the e-gate will identify the passenger automatically after analysing information with the e-passport chip. The process ensures high security during the verification of travel documents.

The government launched the e-passport programme and automated border control management in January 2020, aiming to make the immigration process easier and enhance the acceptability of Bangladeshi passports

In June 2019, e-gates were set up at the HSIA as part of the government's move to launch e-passport. The immigration officials were imparted training on operating the e-gates.

PM calls for austerity again

Prime Minister Sheikh Hasina yesterday urged the people to take austerity measures amid high inflation and price hike of goods across the world due to the Russia-Ukraine war and the Covid-19 pandemic.

"Yes, it is true that prices of goods have shot up to some extent. But it is still uncertain how much the prices would soar further. It is not only in Bangladesh, but also throughout the world. Rather we've been able to keep these under control at least [to some extent]. We've been trying our best," she said.

The premier was addressing a discussion online from the Gono

Bangladesh Awami League arranged the discussion at its central office in the city's Bangabandhu Avenue marking the historic Six-Point Day. Hasina, also the AL president, chaired it.

She said this war doesn't seem to end soon. "We all have to be economical. We'll have to pay attention so that food does not get wasted."

The shipping cost of goods went up from US\$ 800 to US\$ 2500-US\$ 3,000, she said.

Pointing to the readymade garment workers' novement to raise salary, the premier said they r lose their jobs if any unrest is created in the sector in this sector?" she said.

tough time when the purchasing power of the people is declining in the export markets of Bangladeshi clothes. "I think the matter should be informed to the workers and their leaders," she said.

She said the government has been providing subsidies in different sectors. It has given all sorts of incentives to the garment sector. "It is not possible to provide more than that," she added.

As the government helped the factories preventing their closure for Covid-19, now they get work orders, their exports increase and they can import capital

The PM said if anyone wages movement leading to the shutdown of the factories, the job would also be lost. "If you don't understand it, we have nothing to do here. Because how much more can we give to the private

Journalist held in DSA case

Police yesterday arrested the editor of Dainik Parbatta Chattogram, a Rangamati-based daily, in a case filed under the controversial Digital Security Act.

The arrestee, Fazle Elahi, was held in the evening, said Kabir Hossen, officer-in-charge of Rangamati Police Station.

Elahi is also the district correspondent of several other media outlets.

Naznin Anwar, daughter of former lawmaker (reserved seat) Firoza Begum Chinu, lodged the case with Cybercrime Tribunal last year over a report published in Dainik Parbatta Chattogram on DC Park irregularities, he said.

The OC said they received the arrest warrant from the tribunal yesterday.

Dengue cases jump in June

At least 109 dengue patients were hospitalised in the first week of June alone, an alarming spike.

Seventeen dengue patients were admitted to hospitals across the country in 24 hours ending at 8:00am yesterday, said the Directorate General of Health Services (DGHS)

So far this year, 463 dengue patients were hospitalised.

Of them, 75 are still undergoing treatment and 388 have recovered.

Warning the city corporations of a major outbreak this year, experts suggested that the corporations take extensive measures immediately to control Aedes mosquitoes, the carrier of the virus.

Dhaka is at risk of a major dengue outbreak this year, according to a pre-monsoon survey of the DGHS conducted between March 23 and April 4.

The survey found three Dhaka South City Corporation wards to be at "high risk" and 10 at "medium risk" of an outbreak. Nine wards in Dhaka North City Corporation are at "medium risk".

Swapan's family claimed that he went to nearby Galachipa upazila town on Friday to sell lentil. He got Tk 2.5 lakh from the sale and took it with him when he left home around 4:30pm on Sunday.

He had called for a motorbike ride at 9:45pm to get home from North Charalta area. But the bike rider found his phone turned off when he reached North Charalta to pick up Swapan.

To treat burn patients, time is of the essence

In conversation with Dr Samanta Lal Sen

At least 100 people were burnt, and of them, 67 were being treated after the BM container depot fire in Chattogram. Due to the limited capacity in Chattogram, patients with serious injuries needed to be shifted to Dhaka through emergency helicopters.

But why is a divisional city still lacking proper treatment facilities, and what actual steps have been taken for improvement?

In search of the answers, The Daily Star (DS) yesterday talked to Dr Samanta Lal Sen, chief national coordinator for plastic surgery and burn projects in Bangladesh.

DS: What are the limitations in providing treatment to burn patients?

Dr Sen: We are still lagging behind due to lack of supporting infrastructures like dedicated operation theatres (OT), intensive care units (ICU), high-dependency units (HDU) and relevant equipment.

The same crisis was seen in Chattogram. Although it has a burn unit, there are no ICU or OT dedicated for burn patients. On the bright side, the Chinese

We have successfully set up a skin bank at Sheikh Hasina **National Institute** of Burn and Plastic Surgery last year. But we are yet to start the procedure, as we need proper campaigning for it. We have plans to inspire people to donate skin, which will be used for burn patients. A person's skin can be taken within six hours after death.

government is building a burn unit in Chattogram, and four places have already been selected for it primarily. DS: A dedicated institute was built for burn patients,

but many people are still dying. Why? Dr Sen: Yes, people are still dying, and the death rate, at least six percent, is high. The major reason behind this

is cross infection. Due to space shortage in burn units of divisional

cities, patients are kept in close proximity, which spreads infections. Another reason is the issue of shifting patients. The first 24 hours is the most crucial for a burn patient's treatment. But patients in Satkhira or Barguna

will not get that treatment, as these places do not have dedicated burn facilities. These patients are taken to Dhaka, which takes a lot of

time. In these cases, we often have nothing to do.

DS: What steps have been taken to improve burn treatment? What is the status of setting up burn nstitutes in divisional cities?

Dr Sen: We have successfully set up a skin bank at Sheikh Hasina National Institute of Burn and Plastic Surgery last year. But we are yet to start the procedure, as we need proper campaigning for it.

We have plans to inspire people to donate skin, which will be used for burn patients. A person's skin can be taken within six hours after death.

And to set up burn hospitals in divisions -- Sylhet, Barishal, Rangpur, Rajshahi and Faridpur -- a bill has already been passed in the Ecnec meeting around seven months ago.

DS: If an incident like the depot fire happens again, what steps should be taken?

Dr Sen: At first, the casualty hospitals need to turn into specialised burn hospitals immediately. Next, all expert doctors, including those specialising in burns and causality, should form teams to provide treatment without any delay.

Finally, ICUs and separate spaces need to be dedicated for burn patients.

But for this, we need to raise awareness among every stakeholder and keep in mind that prevention is better

Children not even safe at home: study

They're abused more at homes than schools, other places, says national survey by MJF

About 95.8 percent of children become victims of violence in their very homes, which is more in educational institutes or community level, found a national survey by Manusher Jonno Foundation (MJF).

MJF vesterday unveiled the report, prepared by INCIDIN Bangladesh between June 2020 and May 2021, at a roundtable in the capital's Cirdap auditorium.

The survey also revealed that 86.1 percent of children experienced emotional abuse at educational institutes, while 82 percent were subjected to physical violence.

At the community level, children experienced emotional abuse (84.6 percent) more than physical violence (67 percent).

The situation was similar at workplaces, where 72 percent of children were exposed to emotional abuse, while 55.3

percent were faced with physical violence.

Nearly a quarter of children (24.1 percent) have experienced sexual violence at educational institutes, 36 percent at the community level and 37.8 percent at workplaces.

Within the households, 86.9 percent of children said they have faced physical violence in the name of punitive action. Around 81 percent of guardians were found to be supportive of physical punishment when a child is disobedient.

About 55 percent of children said they faced sexual violence at

MJF surveyed 5,078 children in 11 districts, of whom 3,134 were from urban and 1,940 from rural

Teachers, physical instructors, religious instructors, security guards, shopkeepers, neighbours, and unknown individuals were among the perpetrators, according to the report.

Most of the children stated that they did not report those issues because they were afraid of being judged if they complained to their parents.

"We have to involve families. communities, schools, elite groups of the society and elected representatives to stand against the violence," said Shaheen Anam, MJF executive director.

Centre for Policy Dialogue (CPD) Distinguished Fellow Dr Debapriya Bhattacharya said, "We cannot limit violence on children in three categories [physical, emotional and sexual]. The greatest of them all is child labour. Why does a 14-year-old have to go to a welding factory instead of going to school?"

"Digital violence is another major kind of violence. Using children for political purposes is another one, which will be seen frequently in the upcoming election. All violence of such kind should be abolished," he added.

Centralised toll system in the offing

Authorities developing unified system for bridge, elevated expressway, tunnel

Bangladesh Bridge Authority (BBA) has started a process to develop a centralised electronic toll collection system for all its structures -- bridges, elevated expressways and tunnels.

The authority is going to engage a consulting firm to develop the software and provide training to BBA staffers to run the system on a pilot basis for a certain period.

"We have taken the step to improve the authority's capacity," Quazi Muhammad Ferdous, chief engineer of BBA, told The Daily Star yesterday.

Bangabandhu Bridge, Mukhtarpur Bridge in Munshigani, and Padma Bridge, which would be opened on June 25, are BBA structures.

Besides, it is building Bangabandhu tunnel under Karnaphuli river in Chattogram, and two expressways -- Dhaka Elevated Expressway and Dhaka Ashulia Expressway -- in Dhaka and adjacent areas. More such projects are in the

Currently, BBA hires companies for collecting toll from their structures for a certain period and has to spend a handsome amount of money for the task.

'Raking in money by promising govt jobs'

DB arrests syndicate leader for defrauding people

Md Selim, owner of a community centre in Rajshahi, submitted a file at the education ministry last month, requesting for a promotion for his relative, who worked at a college. While Selim was trying to get his file

approved, he received a call on May 26. The caller identified himself as a personal secretary (PS) working at the ministry.

"The caller then told me to not worry about anything, assuring that the file will be approved soon. But for the process, I needed to deposit an amount," said Selim.

"It was very hard to realise that the person was a fraud, as he was talking in an official manner. So, I sent Tk 50,000 twice to a mobile financial service [MFS] account," he said.

A couple of days later, Selim went to Dhaka and requested the caller to meet him, but he refused to do so.

Selim then called the actual number of the PS, and found a different person

receiving the phone.

Interestingly enough, Selim claimed that he did not share any information about submitting the file to any unknown person. "Maybe these frauds have a link with the ministry." This is not an isolated incident.

According to victims and detectives, a syndicate using names of ministry officials has been pocketing huge sums of money over the years. For example, Nasim Atahar, a victim

from Dinajpur, paid Tk 1.25 lakh for a job in the education ministry. He talked to three different fraudsters for this. "Around 11 of us paid around Tk 1

crore in the last one and half months for

different jobs," he said. Cyber and Special Crime Division of police's detective branch (DB) disclosed findings, after arresting a fraudster from Rangpur on Monday.

The arrestee is Rezwanul Haque (21), who studied till 10th-grade, said



communal hatred. The Gono Commission called upon the ACC to take actions against them.

Asked on what basis they worked on this issue, member secretary of the Commission, said the Nirmul Committee have so far published 12 white papers on various issues, including the country's education system and Hefajat-e-Islam.

"There are instances of publishing white papers by civil society members in different countries. Publication of such white papers has a social and political basis,' she told The Daily Star.

'A hollow victory'

UK PM defiant despite Tory rebellion

UK Prime Minister Boris Johnson vesterday lauded the loyalty of his cabinet and vowed to "get on with the job" after surviving a confidence vote of his Conservative MPs that has still left him severely weakened.

The beleaguered leader has insisted that Monday evening's dramatic ballot, which saw 211 Tory party lawmakers support him remaining prime minister but 148 vote against, was a "conclusive" result.

"Thank you... everybody for all your good work yesterday, which was a very important day because we're able now to draw a line under the issues that our opponents want to talk about," he told his team of two dozen or so top ministers and officials.

But most critics and commentators disagreed, arguing that Johnson's authority has been hugely undermined and his days in Downing Street are numbered.

The Times called him "a wounded victor" while his former employers at the Daily Telegraph branded it "a hollow victory that tears Tories apart".

The vote -- just over two years after the Brexit architect won a landslide general election victory -- was brought after a string of scandals that have left the Conservative party's standing in tatters.

Chief among them was the "Partygate"

controversy over lockdown-breaking events at Downing Street, which caused public outrage and saw him become the first serving UK PM to have broken the law. Most of Johnson's cabinet publicly

backed him in the secret ballot. But more than 40 percent of the

US, South Korea fly warplanes after North's missile tests

South Korea and the United States flew warplanes including stealth fighter jets over waters around the Korean peninsula yesterday in a fresh show of force following recent missile tests by the North, Seoul

Sixteen South Korean warplanes, including F-35 stealth fighters and four US F-16 jets, formed an attack squadron over the West Sea - also known as the Yellow Sea to "respond to the enemy threat," Seoul's Joint Chiefs of Staff said in a statement

The allies "demonstrated their strong ability and will to strike quickly and accurately against any provocation from North Korea," it added.

The air manoeuvres, which involved some 20 warplanes, come a day after the allies fired eight ballistic missiles into the Sea of Japan in the wake of Pyongyang's Sunday weapons tests.

US and South Korean officials have been warning for weeks that Kim Jong Un's regime is preparing to carry out a fresh nuclear test.

US Deputy Secretary of State Wendy Sherman, in Seoul on a three day visit, warned there would be a "swift and forceful" response were Pyongyang to go ahead with what would be its seventh such test.

The entire world will respond in a "strong and clear manner," she said, adding: "We are prepared."

Indonesia, Malaysia summon India envoys

Indonesia and Malaysia have both summoned India's envoys in their countries over "derogatory" remarks made about the Prophet Mohammad (PBUH) by two officials with the South Asian nation's ruling party, their foreign ministries said yesterday. It comes as anger spreads across the Arab and Muslim world, with various Middle Eastern nations summoning New Delhi's envoys and a Kuwaiti supermarket removing Indian products. In a statement posted on Twitter, the ministry said Indonesia "strongly condemns unacceptable derogatory remarks" made by "two Indian politicians" against the Prophet Mohammad (PBUH). Malaysia also "unreservedly condemns the derogatory remarks" by the Indian politicians, its foreign ministry said in a statement late yesterday, adding that it had conveyed its "total repudiation" to India's envoy.

27 killed in Sudan ethnic clashes

Heavy fighting in Sudan's west and south has killed at least 27 people and left dozens wounded, residents said yesterday, with the United Nations envoy saying he was "deeply concerned." In separate incidents, clashes broke out in the restive Darfur region in a bitter land dispute, leaving 16 dead, as well as in South Kordofan state, where 11 people died after an argument between two people reportedly escalated into wider gun battles.

Ghani 'unlikely' to have fled with millions

Former Afghan president Ashraf Ghani almost certainly did not flee Kabul as it fell to the Taliban with millions of dollars in stolen cash,

a US government watchdog's report said Monday. Ghani hastily fled the Presidential Palace in Kabul while the Taliban marched into the capital on August 15, 2021. In subsequent days, multiple reports suggested that Ghani and the other officials took up to \$169 million in Afghan government money with them.

Ghani has always fiercely denied these claims. The report says he might have taken \$500,000 - \$1 million.

Death of sisters spotlights crisis

Before the three sisters and their children were found dead in a well, they left a message blaming the family they had married into.

Kalu, Kamlesh and Mamta Meena were victims of a dispute over dowries, the often hefty sums Indian parents pay to marry off their daughters. The sisters had wed brothers from the same

household and lived under the same roof, but suffered constant violence from their husbands and in-laws, according to the trio's grieving relatives.

They were abused constantly, they say, including when their father failed to meet demands for more money. All three were found dead last month near their marital home, a village on the outskirts of Jaipur, along with Kalu's four-year-old son and infant child. Both Kamlesh and Mamta were pregnant.

'We don't wish to die but death is better than their abuse," read a message on WhatsApp left by one of the sisters after their disappearance, a cousin said. "Our in-laws are the reason behind our deaths. We are dying together because it's better than dying every day.'

Authorities are investigating and currently treating the deaths as suicides, a senior police officer in Jaipur told AFP.

The sisters' distraught father, Sardar Meena, a farmer, said life had been a living hell for his daughters, whose husbands banned them from pursuing their education and constantly harassed them for more payments.

Police have arrested the three husbands, their mother and a sister-in-law on charges of dowry harassment and spousal abuse.

India outlawed the practice of paying dowries more than 60 years ago, and harassment or extortion over the payments is a criminal offence.

But the custom persists. India's National Crime Records Bureau recorded nearly 7,000 dowry-related killings in 2020 - around 19 women every day. The same agency reported that more than 1,700 women killed themselves that year over "dowry-related issues".

How are banned hospitals still operating?

DGHS drive must not be yet another failure of implementation

N yet another show of how rotten the roots of our health sector is, a 13-year-old child died on Sunday after she underwent an appendix removal surgery at Al-Hera Clinic and Hospital in Khulna's Shalikha upazila. The claim from Nirjala Khatun's uncle is that, after hospitalising her the night before, the clinic informed them that the surgery had been completed, but also "forced" the deteriorating young patient to be taken to Jashore Sadar Hospital, where she was declared dead upon arrival. Apparently, the surgeon left right after the surgery, without ensuring if the patient had been brought back to consciousness by the assigned anaesthesiologist. All this aside, what is perhaps most contemptible is the fact that the Al-Hera Clinic and Hospital was sealed by district health authorities eight days prior. So, the question is: How was this clinic still operating openly?

Despite the DGHS' rocky track record regarding the regulation of healthcare facilities – fully demonstrated during the peak of the pandemic – we have been slightly hopeful about this much-needed large-scale drive against illegal establishments. But we wonder what the point is of making such a fuss about quickly shutting down 882 facilities countrywide for being unauthorised, if the authorities will not follow up to ensure that these facilities remain closed until they have obtained a proper licence. Even more concerning is the Magura civil surgeon's query to this newspaper: "If anyone runs the hospital ignoring our ban, what can we do?" If this is the response of someone who is in a position to actually prevent unauthorised facilities from operating, we cannot help feeling hopeless regarding the outcome of the DGHS drive.

In another incident on May 29, doctors and nurses reportedly abandoned a mother and her newborn on the operating table at a Narayanganj hospital upon hearing that DGHS officials were raiding unauthorised hospitals in the area. Paperwork and licences aside, how is it that those in charge of looking after the citizens' health do not possess the least amount of humanity?

While we believe that some good will certainly come out of the DGHS' drive to only allow licensed healthcare facilities to operate, we urge the health directorate to also ensure that this does not turn into just another government step failing at the implementation stage. If successful, this could also lead to less exploitation of patients by private hospitals, and also allow only authorised medical professionals to practise. A country which had to deal with the overwhelming effects of the Covid pandemic just last year must realise the value of a properly-regulated health sector.

2.1m new poor in five months!

Is the government taking note of inflation inequality?

new study has confirmed what we have been fearing all along – that the number of "new poor" has increased between January and May of this year. After two years of Covid-induced hardships, all had hoped for a speedy recovery of the economy as well as of people's lives and livelihoods. Such hopes soon turned to despair, with unbridled inflation wreaking havoc on people's lives and eating away at their ever-shrivelling

According to a multisectoral research report titled "Inflation, Coping and Recovery Challenges," jointly prepared by the Power and Participation Research Centre (PPRC) and the Brac Institute of Governance and Development (BIGD), the number of new poor in the country stands at 30.9 million, which is 18.54 percent of the population. A year ago, the same researchers found that the pandemic had pushed 24.5 million people – 14.75 percent of the country's population – into poverty

The findings, based on a survey of 3,910 households, show that most of the surveyed households have drastically reduced their consumption of major food items; in fact, as many as one in five urban households said they had to skip at least one meal in the last month, while two-thirds of the respondents had to cut back expenditures on healthcare and children's education. Thirty-eight percent need to borrow money but cannot do so because they are already struggling to repay their existing debts.

We seem to have ushered in a new era of inflation inequality, in which poor households are having to bear the brunt of rising costs, and more and more new poor are being created. But the question is: Is the government taking note of people's lived realities, or is it content simply touting inflated figures of GDP growth and per capita income? Unfortunately, we are yet to see any active effort from the government to even count these people in official statistics, much less make targeted interventions to bring them out of poverty by providing stimulus packages or including them in various social protection programmes.

The respondents noted that they were in need of TCB food supply, but 50 percent of them said they could not buy what they needed from the TCB trucks because of a lack of opportunity, lack of TCB family cards, and long waiting time in the queues. A whopping 57 percent respondents believed that the government should take stern action against market manipulators to stabilise prices. We agree wholeheartedly with the proposals put forth by the households most affected by the inflation. In addition to addressing the governance oversights, the government must prioritise the realities and needs of these vulnerable groups as it finalises the national budget, scaling up targeted social protection programmes, creating new jobs, and providing policy support to revitalise local economies and SMEs.

The story is emerging to be one we are all too familiar with: a deadly combination of corporate negligence and noncompliance, which is allowed to thrive and send off workers to preventable deaths, because workers lives are disposable, but

business must always go on.

So, what is the price of 32 dead workers to a company that seemingly puts profit over people?

Well, according to Chapter XII of the Bangladesh Labour Act, 2006 (read with the Fifth Schedule to the Act), the owners of BM Container Depot Ltd are only required to pay Tk 2 lakh for every worker killed in the explosion. However, the depot authorities have published a press statement declaring that they would pay Tk 10 lakh of "cash/financial assistance" ("nogod shohayota") to the families of those killed in the "accident" ("durghotona"). Therefore, the total amount of "financial assistance" they are planning to pay to the families of 32 deceased workers is Tk 3.2 crore. Whether any "assistance" would also be paid to the families of the 12 dead Fire Service personnel was not clearly mentioned.

The press statement also mentions that the company would pay an adult family member of each of the deceased workers a monthly amount that is equal to the monthly salary the worker used to earn, until the worker's children reach adulthood. However, in the absence of any legally enforceable mechanisms, such voluntary commitments have amounted to little more than empty promises in the past

The director of BM Container Depot Ltd told *Prothom Alo* that his company between charity and accountability. "Compensation" and "damages" speak the language of accountability – and corporations refuse to be held accountable.

For perspective, BM Container Depot is one of the many companies owned by the Smart Group of Industries, an industrial conglomerate that owns corporations in an array of sectors ranging from the energy sector to the RMG sector. The Tk 3.2 crore that the depot authorities are offering to pay is only 0.2 percent of Smart Group's self-declared annual revenue of USD 160 million from RMG exports alone, as mentioned on its website.

When the price of a worker's death is limited to Tk 2 lakh in the very law that was meant to "ensure labour rights," employers (who store hazardous chemicals without proper licence, putting workers lives at acute risk) can then advertise the payment of Tk 10 lakh as a grand act of magnanimity or "unprecedented instance of humanity" – instead of having to fear unlimited liability from a class action lawsuit that would sue them for all they're worth for committing gross corporate negligence that led to the preventable loss of lives.

As long as there is no real price to pay for corporate negligence, companies won't have the incentive they need to stop acting so negligently, and workers will continue dying preventable deaths.

Celebrating 50 years of global environmental movement

HE global environmental movement started in 1972, with the first global environment conference held in Stockholm, Sweden, hosted by then Swedish Prime Minister Olof Palme. Among the heads of governments who also attended was the then Indian Prime Minister Indira Gandhi, who famously declared that environment and poverty were two major global issues that needed to be tackled together.

Since that watershed event, the United Nations set up the UN Environment Programme (UNEP), and different environmental treaties such as the UN Framework Convention on Climate Change (UNFCCC), UN Convention on Biological Diversity (UNCBD), and UN Convention to Combat Desertification (UNCCD) have been enforced, which are moving forward with their respective annual conferences of parties (COPs).

To commemorate the event, the Government of Sweden, together with the Government of Kenya and UNEP, held Stockholm+50 in Stockholm last week, with participants from around the world to take stock of the environmental movement and plan the next phase.

I had the privilege of attending the event, and will share some of my reflections on both the event and what

cities.

needs to happen next.

The two-day event started with a high-level opening session, where the heads of governments of Sweden and Kenya as well as the UN secretary-general and the head of UNEP all spoke, followed by plenary sessions for ministers from many countries, including Bangladesh Foreign Minister AK Abdul Momen.

However, the most interesting sessions were the many side events where different groups such as scientists, women, youth, farmers, indigenous groups, businesses, and many others, were invited to share their work and views about the future.

The main theme of the overall conference was to reconnect the different strands of the original environmental movement, which has become divided over the last 50 years, as well as to galvanise actions at a faster pace involving all stakeholders, rather than just governments.

I had the opportunity to share my reflections at the concluding session of the conference and said the following.

While there is much to celebrate in terms of having raised global awareness of the importance of the environment over the last 50 years, as well as some progress on different aspects such as climate change, biodiversity and pollution control, the progress has been too little, too late, and hence we needed to change our approach going forward.

The first task is to stop relying on government leaders to come to global events once a year and make promises and then go home and fail to implement their own promises. This has clearly failed as a process. Hence, there is a need to have other global stakeholders involved in such meetings and in implementing the decisions once they are approved. This

includes the private sector as well as civil society networks and groups.

The second new element that needs to happen is to make the youth more prominent in the decision-making process, and even the implementation, and not just in advocacy as they are now. Young people around the world have already demonstrated their capabilities to take actions and support environmental causes locally as well as globally. I suggested that we turn the annual pre-COP of the UNFCCC into a Youth COP as well as an "Accountability COP" henceforth. This was in fact done quite successfully by Italy, who hosted the pre-COP26 in Milan last year before the main COP26 in Glasgow in November.

The upcoming pre-COP27 will be hosted by the Democratic Republic of the Congo (DRC) in Kinshasa prior to COP27 in Sharm el-Sheikh in Egypt this year. This could be an opportunity to make it into a youth COP again.

Finally, the biggest shift we need to achieve is in the consciousness of every person in the world, where they start to think of themselves as the citizens of Planet Earth first, before thinking of themselves as the citizens of their countries and cities. This means that each and every one of us need to do whatever we can as conscious citizens to preserve our environment, while also looking after our own development and well-being. This is possible to do, but will require a major paradigm shift in our thinking and commitment starting from the individual level upwards.

It is important that we solve these problems in the next 50 years, or the future will be unthinkable for our children and grandchildren in the coming

O, silly, there is no such prize for violence. That's just a conversation starter. After all, what better way to invoke the mighty Bangladesh Chhatra League (BCL) than with a nod to violence? But, believe it or not, there was a time when we came very close to having a Nobel Prize for Violence. It was in 2009 when Barack Obama got the Nobel Peace Prize for – wait for it – not being George W. Bush. He really wasn't. He dropped more bombs in one year than Bush did during his entire presidency. Or think of when the European Union got the prize despite being one of the biggest producers of weapons in the

It takes a Megamindian sense of humour to have violence double as peace. But if there is a universe in which this headline will make sense, BCL will surely love to be in it.

After all, who doesn't love awards? In a basic sense, an award is a recognition of the hard work you put into something. When Benjamin Franklin said, "Either write something worth reading or do something worth writing about," he wasn't just raising the bar for us scribes, but also for BCL activists, who as "students" can't seem to do either. So they're doing what they do best, and with all the fists and feet they can master. We have respectable-sounding prizes for crappy achievements and crappy-sounding prizes for respectable achievements. But none for violence. How is this fair?

Violence, especially organised violence, is hard work. It takes discipline, commitment and a practised apathy to pursue an unpopular course to conflict resolution. And, contrary to popular belief, it requires both brain and brawn. You need both to commit violence, to mobilise support for it, and to dodge repercussions in case things go haywire. Ask anyone who has ever been involved in a war, revolution, genocide or terrorism.

But in Bangladesh, the peril of political showmanship is that nothing you do, however egregious, for your party is worth a dime unless it reaches the intended eves and ears. With so many competitors around, it's hard for the average muscle to get the message of his "contributions" across to senior party leaders. Anonymity does not maketh political careers, nor is the satisfaction of beating the daylights out of a rival meant to last long. Violence, after all, is not its own reward.

To BCL's credit, it knows this all too well. So after the recent series of violent attacks on the rival activists of Jatiyatabadi Chhatra Dal (JCD), many hard-hitting men and women of the organisation made no secret of their complicity. Some of them were luckier than others. They managed to get their photos and strangely revealing defences published in the media. Others, not to be outdone, came stampeding out of their social media closet to announce their "contributions," subtlety be damned.

While neither group will get any award for that, they certainly hope it will get them noticed in the right quarter and a better position when the organisation's next council is held in a few months.

But then, as always, like night follows day, comes the righteous pushback: What gives BCL the right to attack JCD? Why would its leaders give excuses that no one in the four hemispheres can believe? Why would anyone openly admit complicity in violence? Or why be so unrepentant about

Violence, defence, righteous pushback - rinse and repeat. This has been a trademark BCL outrage cycle for so long. What this shows to me is that, for all its dedication and hard work in violence and its seemingly inexhaustible ability to "keep at it," BCL sucks at public relations.

Let me explain. In director Mostofa Sarwar Farooki's 2007 drama series "420" perhaps the most scathing portrayal of grassroots politics in Bangladesh - two wannabe politicians celebrate by treating

people to sweets after a photo showing the older one wielding a gun is published in a newspaper. In another scene, the younger one forces a girl into marriage and tries to settle into a comfortable life. Hardly anyone felt put off by these scenes.

But BCL doing the same is a problem. Its violence, with helmet or without, in Dhaka or Rajshahi, is always frowned upon. Its defences are always met with incredulous reactions. Even its choice of weapons - machetes, bamboos and iron rods – is mercilessly derided. It's like whenever it goes full pistols-atdawn at JCD, the enemy is somehow replaced by the public. Somehow, what is thoroughly unforgettable for BCL becomes thoroughly unforgivable for them. What is necessary to it is excessive to them. What it finds desirable, they find repulsive. The public seems to have a problem with everything that BCL does. And this, justifiably, confuses the more sober section of the organisation.

The question is, having put every other enemy in their place, can BCL change the prevailing public perception about it, or at least nudge it in a slightly different direction? At the risk of drawing both righteous and lefteous flak, let me offer a few suggestions.

I think the BCL leadership should, first and foremost, recognise the importance of public relations in today's world. If Barack Obama can beguile the Nobel committee into giving him an award, and bemused Americans into giving him a second term in office, there is no reason why BCL cannot do the same and win a few hearts in the process. Once it has realised that, there is a lot that it can do. It can hire a PR firm to rebrand its public image. It can fund news/views outlets to present its violent activities dressed in a suit of peace, or at least buff away a pesky fact or two here and there. It can subject all its members to mandatory training, not just in the art of violence, but also in the art of guile, charm, subtlety and political spin.

The goal should be to improve its image by refining its engagement with the public. The public, as it is, has a rich history of selective mutism. The BCL just has to tap into that resource and make them mute or feel unperturbed about it. Knowing how forgiving we can be or how susceptible to suggestions, I'm sure we will not mind it.



These burnt mobile phones were recovered from the site of the deadly explosion that took place in Sitakunda's BM Container Depot. According to Chattogram District Police's count, 41 people have perished in the fire and the subsequent explosion, of whom, 26 have been identified so far. struggling to accommodate and provide treatment to these many patients with critical burn injuries.

Al Razi Chemical Complex, located at South Pahartholi (Ward 1) of Chattogram City Corporation, was found to be producing Hydrogen Peroxide nine times higher than the permissible limit by the Department of Environment.

According to DoE officials, the plant's environment clearance also expired four months ago, and its effluent treatment plant (ETP) was also found to be faulty.

The complex is owned by Smart Group, which also owns BM Container Depot in Sitakunda, where a chemical explosion took at least 44 lives and injured around 400 on Saturday.

The chemical produced in this factory was behind the explosion at the Sitakunda depot, Abdul Mobin, member of the investigation committee for the BM depot incident and vice-principal of the

fire service training complex of Mirpur, revealed to this newspaper. The Al Razi plant was allowed to

The Al Razi plant was allowed to produce 1,000 tonnes of the oxidising agent in 2020 when it went into production in South Pahartholi, a densely populated area under CCC.

However, according to National Revenue Board (NBR) data, the plant exported 9,635 tonnes of chemicals in 2021.

Mia Mahmudul Haque, deputy director of the DoE (metro), told The Daily Star that the DoE declined to renew their clearance as their ETP had flaws in its designs, asking them to apply after implementing necessary corrections.

Asked whether they inspected the factory to ensure it complies with environmental guidelines and production ceiling, Mahmudul asked this newspaper to contact Hillol Biswas, director of DoE Chattogram (metro).

This newspaper could not reach the DoE Chattogram director despite repeated attempts.

These are only the tip of the iceberg when it comes to the faults of the Al Razi Chemical Complex.

"Apart from this, the company has been fined twice -- amounting to a fine of Tk 7 lakh in total -- for cutting down hills to construct the plant," said the DoE deputy director.

Pollution from the plant and the risks of another explosion have also turned into

major reasons for concern.

During a recent visit to the complex site, this newspaper saw that toxic wastes from the factory was being dumped into the adjacent canal, polluting the environment.

Khairul Alam, a local, told The Daily Star, "This canal was our go-to source of water for paddy cultivation. Now it's all polluted."

Contacted, Jahidul Islam, administrative officer of the complex, said they have applied for the environment clearance renewal and ETP approval.

However, the official admitted to cutting down the hill for the factory's construction.

Meanwhile, despite repeated attempts, this newspaper could not reach Muzibor Rahman, owner of the complex, regarding the issue.

In the wake of this situation, locals agitated in front of the chemical complex asking the authorities concerned to shut

down the facility.

"We are worried about our safety after
the Sitakunda blast. There is a market,
residential buildings, schools and madrasas
within a kilometre's radius of the plant,"
said Gazi Maeenuddin, a local of South

"The plant authority assured us of suspending their operations. We want the facility to be closed permanently," said former councillor and local Awami League leader Jafar Alam Chowdhury.

Going beyond the call of duty

Constable who first informed fire service of explosion in critical state

Imrul Kaisar, a constable of Industrial Police at Kumira, was the first to inform firefighters of the BM Depot explosion on Saturday night. Imrul is currently fighting for his life at the Burn and Plastic Surgery Unit of Chattogram Medical College Hospital (CMCH).

Imrul, along with his two colleagues rushed to BM Container Depot minutes after receiving information that the depot had caught fire. He immediately called the fire service.

But his work did not stop at that. He and his colleagues got busy on the frontline, trying to disperse outsiders from the depot who were live streaming on Facebook and taking pictures.

"In the meantime, the fire service arrived and started dousing the blaze. Moments later, another blast occurred and sub-inspector Kamrul Hasan, constable Sohag and I were within its 100-yard radius. We felt a heat wave in our bodies and then I couldn't see anything... I couldn't open my eyes," said Imrul, while describing the horrors that unfolded that night.

and Plastic Surgery unit at CMCH, said Imrul's corneas have been badly affected. He also sustained burns on both legs.

Md Raihan, Imrul's elder brother, rushed to CMCH from their village at Narsingdi after hearing about the incident. He was attending his brother in the hospital.

"My brother went there on call of duty but now his life is under threat," Raihan told The Daily Star

"Imrul is a brave heart. He could've remained aloof from the spot but his sense of duty did not let him," he added.

Raihan said an eye specialist from Dhaka visited CMCH yesterday morning and advised them to take him to Dhaka for better treatment.

'No one came to see us'

Injured staffers yet to be visited by depot authorities

Tofajjal Haque, an IT in-charge of BM Container Depot, was on duty when the depot caught fire on Saturday night. He was around 120 feet away from the explosion spot inside the container but could not save himself from the blaze.

Tofajjal is currently fighting for his life at the Burn and Plastic Surgery unit of CMCH.

"When the firefighters came, we felt a sigh of relief. None of us could imagine what awaited us a few moments later," said Tofajjal, lying in the unit's bed B-15.

"Suddenly, I felt immense heat on my

"Suddenly, I felt immense heat on my face, head, and hands. I started running and at one stage I fell."

"Next thing I know, someone was lifting me on the ambulance," added Tofajjal.

A woeful Tofajjal, attended by his family at CMCH, said the BM Depot authorities are yet to visit any of the victims

"I have heard that the depot authority issued a statement to stand by the families of the deceased and injured staffers with financial and other logistic support. However, no official has even come to see our state," he said.

Md Akter (32), a labourer of the depot, echoed the same, lying in a bed next to Tofaiial.

Akter, an employee of the Depot for four years, had no attendant by his bed.



"My family lives in Sandwip. My wife is there but she could not come and so I lie here alone," he said.

"We have been visited and cared for by many voluntary organisations but none from the company visited."

"I cannot believe that such a big company would show such irresponsible attitude. They are yet to provide any assistance for the injured who are fighting for their lives at the hospital," said 18-year-old injured worker Anwar Hossain's maternal uncle Abdul Mannan, who is attending him at CMCH.

Contacted, Major (retd) Shamsul
Haider Siddique, general manager of BM
Container Depot Limited, said their teams
were in hospitals with food, medicine
and blood from the very first day of the
accident.

When informed about the injured staffers' accounts, he said he would look into it.

Goodwill bounded by limitations

CMCH struggling to treat burn patients

Never has the burn and plastic surgery unit of Chattogram Medical College Hospital (CMCH) faced the rush of so many patients with burn injuries at the same time. Such was the scene after the deadly explosion at Sitakunda BM Depot — an incident that not only exposed the fault lines in the country's factory management procedures yet again but also the limitations of the hospitals in Chattogram.

The city has no burn ICUs to treat critically injured patients. On top of that, Chattogram's public hospitals lack adequate equipment and facilities for state-of-art treatment for patients suffering from optical issues.

As a result, 16 patients have already been shifted to Dhaka. Another was scheduled to be moved as of filing this report.

CMCH sources said 100 patients injured in the Sitakunda blast have been receiving treatment at CMCH, while 16 others were being treated at different hospitals of the part city.

Doctors in CMCH said around 50 patients have optical injuries. However, they could not be treated at CMCH due to a lack of facilities.

During his visit to the hospital on Tuesday, Prof Dwin Mohammad, former directorgeneral of National Eye Science Institute, said he attended to 63 patients and most of them had optical injuries.

"Six such patients with major optical injuries should be immediately shifted to Dhaka for proper treatment. However, many of them sustained burn injuries in

other parts of the body and could not be moved immediately," he said while talking to journalists.



While visiting CMCH on Monday, Prof Samanta Lal Sen, director of Sheikh Hasina National Burn Institute, also emphasised establishing an ICU for burn injuries in the port city.

Asked about the difference between a usual ICU and a burn ICU, he said infection control is the first goal for treating patients

with burn injuries, along with ensuring other facilities. "These can only be ensured in a burn ICU, not a usual one." Then comes the space-related crisis in the

hospitals.

"My ward can cater to 60 patients at best. Yet on Saturday night, just after the accident, we already had 59 patients. Many more were yet to come," said Dr Rafiq Uddin Ahmed, associate professor and head of the burn and plastic surgery ward of CMCH.

CMCH is also understaffed and lacks human resources to manage a crisis of this magnitude. This posed a greater problem than ever, which could only be worked around by the goodwill of the doctors and nurses on duty.

"My colleagues from other departments, director of the hospital and principal of CMC extended their help at this crucial time... CMC Principal Prof Shahena Akter, also a professor of the gynaecology department, helped us by evacuating their ward to accommodate patients from the explosion site, while CMCH director Brig Gen Shamim Ahsan authorised the operation of the central pharmacy all night long and provided all medicines that we needed for treatment," said Dr Rafiq.

"All the doctors, intern doctors and nurses gave their best effort to save as many lives as possible," he added.

Taijul's sights on THE EXTRAORDINARY

Left-arm spinner Taijul Islam has been a revelation for Bangladesh, especially in the red-ball format, but the rather humble 30-year-old prefers to shun the limelight and do his job silently. Arguably the most overshadowed cricketer in the Bangladesh team, Taijul spoke candidly about his game, life and many other topics in an interview with The Daily Star's Mazhar Uddin before travelling to the West Indies yesterday. The excerpts of the interview are below:

The Daily Star (DS): Another away tour is approaching. How's your preparation for the West Indies series?

Taijul Islam (TI): It's always difficult to move from one condition to another. Preparation means knowing what the conditions demand. When we played in West Indies before, the pitch helped both spinners and seamers. Shakib (Al Hasan) bhai picked up five wickets and (Mehedi Hasan) Miraz and I also got a few wickets. It's not easy to comment about a pitch without assessing it. It's not like we haven't seen spin-friendly tracks in the past, but seamers generally tend to get more purchase in the Caribbean. It is difficult if you have a set plan. Instead, you have to be flexible. My initial goal is to help the seamers by bowling tight. If the spinners get purchase, it's a different ball game.

DS: How do you prepare yourself before every series?

TI: Training is one part of preparation, which includes working on skills and trying to bowl in the right areas consistently. But I think it is equally

important to prepare off the field. Preparation in your room is key, whether that is mental set-up or something else and I try to work on that both on and off the field.

DS: How do you tweak your bowling on tours abroad compared to what you do at home?

TI: The most important thing you have to realise is what the conditions are and how can I get help using them. For example, wind plays a very big role. You won't get much purchase in the first few days away from home. The line and length you choose to bowl is crucial as is how much drift you can get from bowling at a particular angle. So it's important to adjust quickly, especially abroad. Initially, I found it difficult bowling abroad but I was able to cope as time went by. Another aspect is variations, which I think is very important in the longest version of the game.

DS: You were the fastest to 150 Test wickets for Bangladesh and have been a consistent performer over the years. Do you feel overshadowed at times due to the fact that there is someone like Shakib Al Hasan playing at the same time?

TI: I don't feel that. When I do well and perform for my country, it feels good. Nothing other than that.

DS: Do you feel you should have got more exposure and been highlighted more compared to other stars in the team?

TI: I think you need to follow certain things to be highlighted which I deliberately keep myself away from. I am not active on social media. I am not saying it's bad or that I don't want to be highlighted. One day, maybe I can do something extraordinary so that the people of the country will remember me. I also try to stay away from the media because I think it's better for me to stay focused.

DS: Don't you think you have already achieved something?
TI: Yes. I have. But I think I am yet i

TI: Yes, I have. But I think I am yet to do something extraordinary that helps my country win. Suppose I single-handedly destroy a top-ranked side and snatch victory for Bangladesh or win a trophy.

I haven't done that yet.

DS: Which part of your game do you think you could improve more?
TI: There is no end to improvement.
I learn every day. Despite playing for so many years, I think there is still more to learn. But I feel that if I could contribute more than I am with the bat then it would have been great. If I could score 30-40 runs consistently, then I could have helped my team immensely. I am working on my batting. Let's see.

DS: Despite picking up a hattrick on your ODI debut, you were unable to lock down a spot as a regular in limited-overs sides. Do you feel unlucky at times?

TI: I don't think that way. I feel like I need to play better to play in the shorter formats. Maybe what I have done is not enough. Picking up a wicket while giving away 30 runs is not enough. I need to do something extraordinary. Apart from Shakib Bhai, Nasum Ahmed is also doing well. I am not thinking about it and waiting for my opportunity.

Tamim distraction ahead of WI Tests

The fracas in the media over Tamim Iqbal's recent comments and those of the Bangladesh Cricket Board has exposed a pretty dismal picture of the national team environment ahead of the West Indies tour. As the team leaves for the Caribbean for the month-long tour starting with the first Test in Antigua on June 16, it is not the longest format or the players of the format that are hogging the limelight, instead it is ODI captain Tamim Iqbal's T20I future that is the talk of the town.

The issue surfaced during an event on Sunday when Tamim reacted regarding a question that was posed to Jamie Siddons the day before. The batting coach was asked whether Tamim would do well coming down the order. While Siddons replied that 'Tamim would love that but we need to find another opening batter first,' the batter felt that the question itself was 'stupid'.

Things further rolled on during that event when Tamim was asked about

his T20I future. He said he was not being able to talk about his decision as 'either you (media) say it or someone else says it.'

This newspaper had reported back in April that according to BCB sources, an announcement from Tamim on his T20I future was imminent.

That announcement did not come and BCB sources had said Tamim would state his

decision to the media himself. With one-and-a-half months left of his self-imposed hiatus from T20Is, Tamim felt the announcement should be left up to him. In a statement yesterday on Facebook, he wrote that his words had been misconstrued and he did not, in any way, mean that the board had not communicated with him regarding his T20I future.

However, apart from the media, who that 'someone else' is was not clarified. What Tamim said on Sunday, may easily be conceived as BCB higher-ups talking ahead of time.

BCB president Nazmul Hassan Papon, speaking to a national English daily on Monday, said that Tamim had already sent a letter to the board saying he was not going to play T20Is. He also said that BCB had urged Tamim to clarify his stance. Meanwhile, Tamim, in his statement yesterday, said he has been communicated by the board and the board knows his decision and he never said that the board did not ask him about his T20I future.

However, while the BCB president did not shy away from saying what he felt, the discussion ahead of a key Test series has once again turned to the T20I availability of a player who last played in the format in March of 2020. The fracas between the board and the players, which had caused an uproar during the T20 World Cup in UAE, is once again at play.

FIFA WC trophy arrives today

The original trophy of FIFA World Cup will arrive in Dhaka this morning for a 36-hour tour accompanied by a seven-member FIFA delegation including former French World Cup winner Christian Karembeu.

"Bangladesh Football Federation president Kazi Salahuddin, along with BFF and Coca Cola officials, will receive the trophy at the airport after a chartered flight is scheduled to land at 10:45am," BFF general secretary Abu Nayeem Shohag said yesterday.

Shohagh also informed that the trophy will be taken to the President's official residence, Bangabhahan, in the afternoon before being taken Prime Minister's residence, Gono Bhaban, in the evening

"The trophy will be displayed for all at the Bangladesh Army Stadium in Banani on Friday afternoon. Some invited guests and winners of Coco Cola draws will get opportunity to take pictures with the trophy," Shohag said. "We believe the trophy tour will be the talk of town and strengthen our football."

Jamal hopeful ahead of Bahrain tie

Bangladesh are set to return to the qualification round of the Asian Cup after a lengthy 16-year gap when they take on mighty Bahrain in one of the Group E openers at the Bukit Jalil National Stadium in Kuala Lumpur today.

The match will kick off at 3:15pm (Bangladesh Standard Time).

Bangladesh had a dream campaign in their first-ever Asian Cup qualifiers, in which they secured a spot in the 10-team final round after finishing as one of four group runners up in 1979. But they had a harder time in the final round despite showing potential in two of their four matches in Qatar in 1980.

Since then, Bangladesh were part of the Asian Cup qualifying round until 2006, barring 1996 when Bangladesh withdrew from the competition. Bangladesh would not make it to the final round in their next six attempts.

Instead, Bangladesh were demoted to compete in the newly-introduced AFC Challenge Cup, a tournament that rewarded the winners with tickets to the Asian Cup Qualifiers until it was suspended in 2015.

The AFC then made massive changes to the Asian Cup and World

Bahrain are Group E favourites. They are 99 places ahead of 188thranked Bangladesh, who suffered a 0-2 defeat to Bahrain in the only match between two sides, during the President's Cup in Seoul in 1979. Bahrain appear to be in peak form, registering six wins in seven matches this year against Uganda, Congo, India, Burundi, Myanmar and Thailand. Their lone defeat came against Belarus. Bangladesh have played only three matches this year, losing to Maldives before drawing

against Mongolia and

Indonesia.

89th in the FIFA Rankings,Bahrain are Group E
Qualifiers and end their 16-year exile but have been derailed by injuries.

But ahead of their tough group encounters, Bangladesh captain Jamal Bhuiyan was upbeat of springing a surprise on Bahrain, who are 99 places ahead of Bangladesh in the FIFA

"I think the other team may think Bangladesh will be an easy target but I think the players have other things on their mind and we can spring some surprises," Jamal said at the pre-match conference yesterday.

"Tomorrow is a big match. We know that we have done everything to prepare well," Jamal said. "Of course, we lack in some areas but we have discussed that with the coach. Overall, if the game plan goes well, we can get something from this match."

Bangladesh coach Javier Cabrera knows his team face an uphill task against Bahrain and is expected to adopt a counter-attacking strategy.

"It is going to be a similar approach [as it was in a recently friendly against Indonesia] tomorrow [Wednesday]," said Cabrera, who played a four-man defence and two defensive midfielders in a five-man midfield in that goalless draw.

ACC to review allegations

The Gono Commission has recently been facing a backlash from religion-based organisations over submission of a "white paper" that named 116 religious leaders and Islamic speakers for their "involvement in laundering money, funding militancy and spreading communal hatred".

The Anti-Corruption Commission has said it will review the allegations brought by the platform, People's Inquiry Commission on Fundamentalist and Communal Violence, widely known as Gono Commission.

The ACC said it will launch a probe if it finds any substance to the allegations.

Monkeypox ʻalarm false'

Says expert after passenger screened out at HSIA

The Turkish man, sent to a hospital from Dhaka airport because he has rashes on his body, has no monkeypox symptoms, said a top official of the health directorate.

"The rashes are due to a long-term skin disease," Prof Ahmedul Kabir, additional director general (administration) of the health directorate, told The Daily Star, adding that he examined the man.

However, the authorities at Infectious Diseases Hospital said they will not discharge the man until the laboratory test confirms whether he has the disease.

"We primarily concluded that the patient is not infected with monkeypox virus. But we have sent his sample to the IEDCR for an RT-PCR test," said Mizanur Rahman, superintendent of the hospital.

The 32-year-old man was sent to the Infectious Diseases Hospital in Mohakhali after doctors at Dhaka airport noticed the rashes during screening.

He arrived at Hazrat Shahjalal

Researchers break data transfer rate record

Researchers in Japan have achieved a world record for data transmission using standard hardware, achieving speeds 100,000 times faster than 5G internet speeds. The Network Research Institute at the National Institute of Information and Communications Technology (NICT) demonstrated the first ever data transmission of 1.02 petabit (PB) per second, equivalent to just over 125,000 Gigabytes (GB) per second, using

NICT constructed the transmission system using fibres with standard 0.125mm cladding diameter, which it described as "a major step towards the realisation of ultra-high-throughput optical links... compatible with existing cabling technologies for near-term adoption."
