Govt to go all out to arrest price spiral

PM asks officials to lift all taxes on import of essentials

PARTHA PRATIM BHATTACHARJEE

The government will make all-out efforts to keep prices of essential commodities stable through measures like lifting all tariffs and taxes on their imports and taking stern action against market

As part of the measures, private food importers will get all kinds of support so they can smoothly import food grains and other essential commodities

The commerce ministry will facilitate imports by the private sector and monitor supply and prices in the market to curb any artificial Importers of essential foods will have to mention their plan for

alternative import sources while opening letters of credit at the bank. At the same time, the highest priority will be given to boosting

Prime Minister Sheikh Hasina gave these directives at a meeting at the PMO yesterday, said

highly placed government sources.

Several ministers and top civil and military officials were present at the National Committee on Security Affairs (NCSA) meeting that started at 10:00am.

During the meeting, Hasina asked that tariffs and taxes on the import of essential commodities be lifted to limit price hikes.

The PM asked the ministries concerned to keep prices of essentials within the people's purchase capacity and to continue the drives against syndicates, irrespective of their political affiliation.

Political parties will be allowed to conduct rallies, processions

Drive against food grain syndication to be continued

PM asked for proper action to ease traffic jam

Law enforcers were asked to be vigilant to avert any sort of sabotage centring Padma Bridge inauguration

Foreign ministry was asked to expedite Rohingya repatriation process

She also said food inflation is the main concern across the globe following the Ukraine-Russia war and the Covid-induced global recession, and asked law enforcement agencies to remain vigilant so that no one can cash in spreading rumours against the government

and indulge in black marketing. Earlier, the government formed a high-powered taskforce to review commodity prices and the market situation. On May 23, it advised the government to withdraw VAT on the import of refined soybean, palm, rapeseed, canola and olive oil.

All eyes on Cumilla, EC

Candidates in the Cumilla city polls made their last-minute efforts to woo voters yesterday as the electioneering ended at midnight.

Many voters believe that Awami League mayoral nominee Arfanul Haque Rifat may have an advantage over his main rival Monirul Haque Sakku, who is running in the election without party backing.

Former BNP leader Sakku, also the immediate past mayor of the Cumilla City Corporation (CCC), was expelled by his party for taking part in the polls going against the party's decision.

Voters also said Sakku, an independent candidate, may capitalise on the people's anti-government sentiments to win votes. According to them, turnout will be the deciding factor in this year's election. A big turnout may favour Sakku.

People want change: Rifat

Ruling Awami League mayoral candidate Arfanul Haque Rifat said people of the Cumilla city wants

"I have been doing politics here for the last 40 years. I came up from

Rifat, also general secretary of Cumilla city unit AL, said in the last 10 years, the city corporation office became a "den of the corrupt", and sufferings of the city residents became extreme.

Projects delayed for poor preparations, coordination

Finds first-of-its-kind IMED study on ADP

About 76 percent of the government officials involved with preparing, processing and evaluating development projects think the projects get approved without an adequate feasibility study and stakeholder consultations, found recent research.

And about 26 percent of the respondents in the survey answered that they had experienced such lacking in 61 to 81 percent of the projects, according to the study by the Implementation Monitoring and Evaluation Division on the slow implementation of development

"This is a major area of concern," said the report, which is based on a survey from 100 government officials, focus group discussions, project data for the last five years and interviews with consultants, retired government officials and

project directors. It is a first-of-its-kind study by the government. It was carried out following the instruction of the IMED secretary, and MD Taibur Rahman, a director of the division, was the lead researcher. The study is now available at the IMED website.

Bangladesh lags in completing most projects on time and within budget, causing cost overruns and lowering the expected benefits

from the projects. The poor and sluggish implementation rates of the muchpublicised fast-track projects such as the Padma bridge, the Padma bridge railway link and the Dhaka metro rail are examples, said the

report, which was published in June 6.

Of the eight fast-track projects of the government, six have already been revised and a revision proposal for another -- metro rail - has been submitted. Only the Rooopur nuclear power plant project has not been revised yet. Because of the cost and time

escalations, the majority of the projects fail to attain the objectives and targets set initially including the internal rate of return, financial rate of return and the economic rate of return.

Hence, it is important to identify the major causes and take necessary actions to prevent such mis-governance of public projects.

About 85 percent of the respondents agreed that the projects that require civil works lack proper engineering drawings, which is key to the successful completion of the projects.

About 72 percent of the respondents either agreed or fully agreed that weak project documents are a major roadblock. Only 16 percent were indifferent and 12 percent did not agree.

"This indicates that the overwhelming majority has opined that project documents are weak and this is a serious problem."

About 16 percent of the respondents experience a high incidence of such a problem: 61 to 81 percent.

As many as 89 percent of the respondents agreed with the statement that there is an inadequacy of resources to prepare a decent development project proposal (DPP).

About 70 percent of the respondents think that more than 40 percent of the projects had weak DPP or technical project proposal (TPP) due to a lack of adequate resources, it said.

"A few people are involved in preparing a large number of DPP/ TPP and this compromises the quality of the project documents,

More human remains found in Ctg depot

The death toll from the Sitakunda container depot fire now stands at 48 after the police vesterday recovered human remains from the debris, 10 days after the deadly blast.

The remains were sent to the Chattogram Medical College Hospital Morgue after taking DNA samples, said Md Ashraful Karim, additional superintendent of Sitakunda Circle police.

On the evening of June 4, a huge fire broke out at the BM Inland Container Depot, a Dutch Bangladesh joint venture, in the town of Sitakunda, 20 miles north of the country's main port in Chattogram.

At the time of the fire, at least 27 jerrycans of hydrogen peroxide were stored in the container

Hydrogen peroxide is not à flammable substance but it can cause a fire to intensify. This is exactly what transpired when the fire came in contact with the plastic jerrycans.

The jerrycans -- which came from the Hathazari based Al-Razi Chemical Complex, one of the companies of Smart Group that also owns the depot were awaiting shipment.

There were multiple explosions that aggravated the blaze to such a degree that it took three days to bring it under control.

As many as 10 firefighters died, making it the deadliest for Bangladesh's inadequate fire service department.

Following the incident, police filed a case accusing eight depot officials of their alleged negligence while on duty. But the depot's owners, one of whom is a treasurer of Awami League's Chattogram south unit, were spared.

Several investigation committees are conducting their investigation to find out the truth behind the blast.

So far 29 bodies were handed over to their families after confirming their identities.

Russia seizes centre of Severodonetsk

Calls on Ukrainian troops to 'surrender'; hundreds of civilians shelter in Azot chemical plant

Ukraine said yesterday its forces have been pushed back from the centre of the eastern city of Severodonetsk, where fighting with Russia has raged for weeks.

"The enemy, with support of artillery, carried out assault operations in the city of Severodonetsk, had partial success, pushed our units away from the city centre," the Ukrainian military said on Facebook.

Moscow-backed separatist forces said the city had been "blocked" and called on Ukrainian troops to "surrender".

"Severodonetsk has de facto been blocked after they blew up the last bridge vesterday [Sunday] which connected it to Lysychansk," Eduard Basurin, a rebel representative, told "They have two options: to

surrender or die."

He also said Moscow-backed forces were carrying out an offensive on the key city of Slovyansk from "west, north

Local governor Sergiy Gaiday conceded "the Russians were partially successful at night" in the city. He said Moscow forces control "more than 70 percent" of the city.

Gaiday said the Azot chemical plant -- where 500 civilians, including 40 children are taking shelter -- is being "heavily shelled" by Russian

"We are trying to negotiate a humanitarian corridor" for the civilians, Gaiday said in a separate video on Telegram.

He added that the efforts had "for now no success". Gaiday earlier said Moscow's forces were "gathering more and Severodonetsk and nearby

Lysychansk.

He said three civilians were killed by shelling in Lysychansk, across a river from Severodonetsk, in the last 24 hours, including a six-year-old

The governor said Ukrainian security services had exposed 50 "traitors" in Lysychansk, who he said were sending information to Russian forces, reports AFP.

Presidential advisor Mikhavlo Podolyak said yesterday that Kyiv needs "heavy weapons" to end the war. He listed what he said the Ukrainian army needed: "1000 howitzers caliber 155 mm; 300 MLRS (multiple rocket launchers); 500 tanks; 2000 armoured vehicles; 1000 drones.

President Volodymyr Zelensky said late on Sunday forces were fighting for "literally killed hundreds of civilians.

Russian strikes hit a town in northern Ukraine yesterday, with several villages evacuated due to the fire risk following the attacks, local authorities said.

"The enemy hit Pryluky with rocket strikes," Vyacheslav Chaus, governor of the northern Chernigiv region, said on Telegram. The Russian army retreated from the northern Chernigiv region in April, two months into its invasion of Ukraine.

Bangladeshi shot dead in South Africa

Criminals shot dead a Bangladeshi trader in South Africa on Sunday night.

The victim, Nahidul Islam Joy, 30, was the son of Hasmot Miah of Dakkhin Pekua village in Tangail's Mirzapur upazila.

Hasmot said his son went to South Africa over a decade ago. He later started cosmetics business at New Castle City after renting a shop.

The armed criminals entered the shop around 7:30pm (local time) and shot Joy dead on the spot, he said, adding that he could not say when his son's body would reachthe country.

Shajahan Miah, a member of Bashtoil Union Parishad, said Joy left his wife, younger sister and parents in the country to mourn his death.

Joy's uncle Faruk Hossain was also shot dead in South Africa about one and a half years ago, he

Anton used to live in a building in Green City residential area, a housing project for foreigners at Natun Hat, said Arbinda Sarkar, officer-incharge of Ishwardi Police Station.

He fell unconscious while returning to his room after he bought food from a nearby restaurant Sunday night, the OC added.

Govt spending Tk 11.33cr to send 254 for hajj; AL supporters, those close to state minister given priority, sources say RASHIDUL HASAN

A total of 254 people are going to perform hajj this year at government expense.

According to sources, the government will have to spend around Tk 11.33 crore from the public exchequer to meet the expenses.

Because of religious considerations, the government gives this opportunity to people of different levels every year. But people belonging to the ruling party or those close to the state minister for religious affairs are being given the priority, sources, involved in preparing the list, told The Daily Star.

At least 33 people from Jamalpur-2, electoral constituency of the state minister, Faridul Haque Khan, are in the list.

On Sunday, the Ministry of Religious Affairs released the list of pilgrims who are performing hajj at government expense They are under the government's hajj package-2.

However, as per instruction of Prime Minister Sheikh Hasina, this year, the selected persons will have to pay Tk 1,40,000 as airfare, a ministry official told this correspondent. According to the ministry's circular, everyone performing hajj at the expense of the government will have to pay and submit a pay-order of $\overline{\text{Tk}}$ 1,40,000 for airfare.

18 hospitalised with dengue STAFF CORRESPONDENT

At least 18 people were hospitalised with dengue in 24 hours till 8:00am yesterday, according to the Directorate General of Health Services (DGHS).

Among the new cases, five are from outside Dhaka. Seventy-eight dengue patients, including 72 in the capital, are now receiving treatment at hospitals.

This year, the DGHS recorded 589 dengue cases and 511 recoveries so far. It has not yet reported any death from the mosquito borne viral disease.

Warning the city corporations of a major outbreak of dengue virus this year, experts suggested the corporations take extensive measures immediately to control the Aedes mosquitoes.

Dhaka is at risk of a major dengue outbreak this year compared to the last couple of years, as clear, stagnant water, the breeding ground for Aedes mosquitoes, at underconstruction buildings is abundant this time.

Govt working on solving Teesta issue Says state minister for water resources

Expressing concern over the delay in completing the Teesta deal, State Minister for Water Resources Zaheed Farooque yesterday said the government is working to solve it.

He made the comment at a "Meet the Press" organised by Bangladesh Secretariat Reporters' Forum (BSRF) at the secretariat.

In 2011, India agreed to share 37.5 percent of Teesta waters while retaining 42.5 percent during the lean season between December and March.

The Teesta river flows through Sikkim and West Bengal before entering Bangiadesn.

The issue has been mired in conflict since 1947, when the Teesta's catchment areas were allotted to India.

At the event, Zaheed also said illegal sand extraction should be completely stopped as many people lost their homes and land due to river erosion.

The state minister suggested that sand extraction be done from 6:00am to 6:00pm. This way everyone, including the locals, can oversee the matter, he added.

Even foreign nationals were also found involved in such criminal activities.

For instance, on April 21, Detective Branch of police arrested 11 Nigerian nationals for fraudulence and embezzlement.

Along with their Bangladeshi counterparts, these foreign nationals would target individuals on Facebook and promise them presents after befriending them.

After a few days, a local syndicate member calls the target, pretending to be a customs official, and says a certain amount of duty has to be paid to collect the package. Upon receiving the amount, they would cut off all sorts of communication with the target.

In many cases, the criminals were found pretending to be a woman working in the US military, claiming to be stationed in

'Inefficiency main weakness' Speakers on health sector

Unless the inefficiency of officials is addressed, no progress is possible in the health sector even by increasing the budget allocation, said speakers at a seminar yesterday.

Ensuring the availability of all types of medicines and diagnosis services for every patient in public hospitals can reduce their out-of-pocket expenditure immediately. This can be done by ensuring proper utilisation of the existing budgetary allocation for the health sector, they said at the seminar titled "Health Budget Evaluation 2022-23".

Health Economics Study Alliance (HESA) -- an association of the students of the Institute of Health Economics (IHE) at Dhaka University organised the seminar on the DU campus.

For long-term impact, however, they stressed increasing the managerial capacity of health officials at all levels.

"Inefficiency is the main weakness of the health sector. There should be a mechanism

Klang MP Charles Santiago said he wanted Saravanan to spell out the reasons for the specific number of agencies and how they would help solve the problem of migrant worker exploitation.

The query comes just more than a week after Saravanan's visit to Bangladesh where, after meeting Expatriates' Welfare Minister Imran Ahmad, he said it was up to Malaysia to decide on which agencies will be allowed to send workers to

(DPP) of the latest plan contains no mention of this existing building. It only talks about the older administrative building and asks Tk 152.80 crore to build a new one.

Regarding this, eminent economist Prof Anu Muhammad said, "If the Anu authorities build the new building, around Tk 100 crore would go down the drain. They can't just do this whimsically. JU can just complete construction of the existing building."

Not mentioning that construction of one part of the existing building was finished in 2016 in the DPP is tantamount to hiding information, he added.

"Obscuring facts like unacceptable. They should've disclosed everything from the beginning, but we have been kept in the dark about

all the work. Opinions of stakeholders were also not taken at that time," Anu said.

Besides, without creating definite masterplan, authorities are building and demolishing structures as per their wish. Due to this, crores are being wasted, stakeholders said.

Admitting the gravity of the situation, SM Ashraful Alam, special superintendent CPC (Investigation and Operation) of CID, said cybercrimes are increasing in recent times.

"Majority of these crimes are related to social media, e-commerce and f-commerce. We are still thankful that crimes depending on advanced technology are still not taking place in the country on a large scale," he said.

Md Tawohidul Haque, assistant professor of the Institute of Social Welfare and Research at Dhaka University, said a large number of people, who are victims of cybercrime, do not report to law enforcers due to the social stigma associated with such crimes. He blamed the lack of awareness among users for the rising trend in cybercrimes.

"The complaints are made only when there is no other option left for the victims. By analysing different media reports and data, it can be said the numbers are indeed rising," he said.

exploitation. Santiago Bangladeshi recruitment agencies are saying that the 25 agencies selected are controlled by one guy called "Datuk Seri Mohd Amin Abdul Nor". Bangladeshi-born Amin has been accused multiple times of allegedly being behind a syndicate that is said to monopolise the recruitment of Bangladeshi workers to Malaysia.

"It is up to the minister to clarify how these 25 agencies will solve the problem. This issue has been dilly-dallied long enough, and it's being done at the expense of the people and the country," he told Malay Mail on June 12.

Meanwhile, Bevond Borders Malaysia President Mahi Ramakrishnan said Saravanan owes it to the public and stakeholders to provide a clarification on how the selection of the 25 recruitment agencies was conducted.

Adrian Pereira, founder of North-South Initiative, a rights based NGO in Kuala Lumpur, said if there are companies that have better practices, in line with International Labour Organisation markers, why they would be stopped from recruiting.



Flood situation worsens in Kurigram

OUR CORRESPONDENT,

The flood situation in Kurigram's Roumari upazila has even further deteriorated as water from Assam's hill slopes are flowing into the region. New areas have been flooded and the situation is only getting worse.

According to Roumari upazila administration sources, around 35,000 people have been displaced at 49 villages in the upazila's four unions due to the flood.

The water has submerged aman paddy seedbeds, jute and various vegetables on 592 hectares of land and 55km of roads.

Thirty-five educational institutions have been shut down.

The flood-displaced people have to travel by rafts and boats made with trees as roads are submerged. Flood waters have drowned most of

The affidavit of Monirul Haque Sakku, the outgoing mayor of Cumilla, stated that he operated his business until he was elected for the first time in 2012. Despite this, his and his family's yearly income has risen by 87 percent since the 2017 polls.

"The earnings of those who hold such posts like mayor, MP or minister -- multiply by many folds. It's like magic," said Badiul Alam Majumder, secretary of Shujan. Among the five mayoral candidates, all

except Rashedul Islam of Islami Andolon Bangladesh have been accused in cases throughout their career. An attempt to murder or murder case,

under section 302 of Penal Code, was filed against Awami League candidate Arfanul Haque Rifat. He was later acquitted. All three independent candidates -- Monirul

Haque Sakku, Mohammad Nizam Uddin and Kamrul Hasan Babul -- are facing two, eight and two cases, respectively.

Arfanul has the most wealth, Shujan found from the affidavit, but the outgoing mayor is way richer than Arfanul.

"It seems that many candidates do not mention the exact figures of their wealth in their affidavit. We repeatedly demanded the Election Commission [EC] thoroughly look into the affidavits, but it did not do so," said Badiul

Dilip Kumar Sarkar, central coordinator of Shujan, presented findings about the election candidates' income, educational background, and cases filed against them. He said among the mayoral candidates, Rashed completed post-graduation from a madrasa, and Arfanul and Nizam are university graduates.

22,704 posts vacant in railway Minister tells JS

posts is 22,704 in railway, Minister Nurul Islam Sujon told parliament yesterday. The minister placed the

statistic in response to a query from Awami League MP Mamunur Rashid Kiran. The minister said out of the total vacant posts, 201 posts are for first class officials, 1,601 for second class, 8,575 for third and 12,327 for fourth class officials.

The minister said out of these vacancies, demand for 14 first class and 554 second class posts has already been sent to Public Service Commission. Besides, 7,351 posts of third and fourth classes have been given clearance.

In a scripted answer, the minister said job circular of 441 posts of third class and 2,812 posts of fourth class have already been published. The recruitment test for ALM Grade-2 and Guard Grade-2 posts will be held on June 17. In response to a query, the minister said the amount of unused land of the railway is 10,843.15 hectares.

The unused lands of the railways and vacant lands in residential areas are somewhat illegally occupied, which are being freed by turn, he added.

The minister also said eviction activities are being conducted every month.

Women still carry the load of unpaid work

Says BBS survey

Women spend eight times more than men on domestic work and care-giving, found a recent survey by Bangladesh Bureau of Statistics (BBS) published vesterday.

According to the "Time Use Survey 2021", men spend around 1.6 hours a day in domestic work and caregiving,

while women spend 11.7 hours -- nearly half of the day.

These works also do not meet the conventional criteria of productivity and thus remain unpaid and unrecognised, says the report.

Besides

conducting such unpaid work, women also pass 1.2 hours conducting the conventionally productive work, while men spend 6.1 hours on those.

In light of this, the report mentioned that gender equality cannot be attained in the absence of equal rights and women themselves have to be the active agents for this change. The exclusion of women in the labour market is unjustified and

JU on path to waste crores?

Authorities constructing new buildings 'on a whim'

Jahangirnagar University's (JU) latest development decisions have the potential to waste crores, as claims of building new establishments whimsically, and hiding information are echoing throughout the university.

JU currently has two administrative buildings, one of which has been partially built. But instead of completing its construction, JU's new plan is to erect a brand new 10-storey administrative building, at a cost of Tk 138. The reason, according to authorities, is to

house all the university's offices in one building, as the existing two structures are not fit for that.



If the authorities build the new administrative building, around Tk 100 crore would go down the drain. They can't just do this whimsically. JU can just complete construction of the existing administration building.

However, Abdus Salam Md Sharif, the university's chief engineer, said this can be accomplished by just finishing construction of the existing building, which will require around Tk 40 crore.

According to documents, construction of the existing building started in 2009, and works of a part of the structure was finished in 2016. This cost Tk 11.19 crore.

The Daily Star has obtained a copy of the building's design, which indicates that the structure can be used to conduct all administrative activities if construction is completed.

The chief engineer has confirmed this. Meanwhile, the development project proposal SEE PAGE 4 COL 4

Biden to travel to KSA, Israel next month

US President Joe Biden will travel to Saudi Arabia and Israel next month and the White House is planning to announce the trip this week, a source familiar with the planning said on Sunday.

Biden's trip, which is expected to take place around mid-July, could include a meeting with Saudi Crown Prince Mohammed bin Salman, the source said.

A spokesperson for the National Security Council confirmed a Biden trip to Israel and Saudi Arabia was being planned. "We have no further trip details to confirm, but we will announce as soon as we

do," the spokesperson said. The White House has said Biden feels that the crown prince is a "pariah" for his role in the killing of a political opponent, Washington Post journalist Jamal Khashoggi, in Turkey in 2018.

World nuke arsenal set to grow

Say researchers as global tensions flare amid Russia's war in Ukraine

The number of nuclear weapons in the world is set to rise in the coming decade after 35 years of decline as global tensions flare amid Russia's war in Ukraine, researchers said yesterday.

The nine nuclear powers -- Britain, China, France, India, Israel, North Korea, Pakistan, the United States and Russia - had 12,705 nuclear warheads in early 2022, or 375 fewer than in early 2021, according to estimates by the Stockholm International Peace Research Institute (SIPRI).

The number has come down from a high of more than 70,000 in 1986, as the US and Russia have gradually reduced their massive arsenals built up during the Cold War.

But this era of disarmament appears to be coming to an end and the risk of a nuclear escalation is now at its highest point in the post-Cold

War period, SIPRI researchers said. "Soon, we're going to get to the point where, for the first time since the end of the Cold War, the global number of nuclear weapons

Scientists map brain network linked to addiction

Researchers said yesterday they had mapped the network in the brain linked to addiction by studying long-time smokers who abruptly quit after suffering brain lesions.

They hope the research will give future treatments a target to aim for in the fight against addiction to a range of substances.

To find out where addiction resides in the brain, the researchers studied 129 patients who were daily smokers when they had a brain lesion.

While more than half kept on smoking as normal after getting

the lesion, a quarter immediately quit without any problem

-- even reporting an "absence of craving", according to a new study in the journal Nature Medicine.

While the lesions of those who stopped smoking were not located in one specific region of the brain, they mapped them to a number of areas -- what they called the

"addiction remission network". They found that a lesion that would cause someone to give up an addiction would probably affect parts of the brain like the dorsal cingulate, lateral prefrontal cortex and insula -- but not the medial prefrontal cortex.

To confirm their findings, the researchers studied 186 lesion patients who completed an alcohol risk assessment.

They found that lesions in the patients' addiction remission network also reduced the risk of alcoholism, "suggesting a shared network for addiction across these substances of abuse", the study

Shun protests

Indian Muslim groups urge followers over anti-Islam comments

Leaders of prominent Islamic groups and mosques in India yesterday appealed to fellow Muslims to suspend plans for protests against derogatory remarks about the Prophet Mohammad (PBUH) made by two members of the ruling Hindunationalist party. The message to avoid big gatherings was circulated after demonstrations took a violent turn last week. "It is the duty of every Muslim to stand together when anyone belittles Islam but at the same time it is critical to maintain peace," said Malik Aslam, a senior member of Jamaat-e-Islami Hind.

CRITICISM OVER CHINA UN rights chief declines 2nd term

The United Nations human rights chief, Michelle Bachelet, indicated yesterday that she would not seek a second term, the surprise announcement coming in a wide-ranging speech to the Genevabased Human Rights Council. Bachelet made a trip to China last month for which she was criticised by rights groups as well as some Western governments, including the United States, who said conditions Chinese authorities imposed on the visit did not enable a complete and independent assessment of the rights environment.

The EC can only go so far with the old ways

It must show courage and determination to build confidence

F morning shows the day, the Election Commission's is not exactly showing a very good day. If anything, its early days in office have been more reflective of the old, bureaucratic ways of doing things than a genuine drive to build public trust with courage, determination and foresight. This is also evident from how it is approaching problems in the run-up to the June 15 Cumilla City Cooperation (CCC) election – its first major hurdle to overcome. The fact that the CEC has refused to exert his authority after a lawmaker reportedly flouted an official directive shows that the EC has a lot to do to effect change, nowhere more so than within itself.

Such helpless surrender is a throwback to his predecessor who would notoriously refuse to take responsibility for any electoral irregularity reported. But this, we must say, is unbecoming of a commission tasked with damage control. It came with the promise of restoring confidence in the electoral system after two highly controversial general elections. No one expects it to deliver miracles. But executing the right policies and standing firm in the face of opposition, particularly from the ruling quarters, is part of the job. It means finding ways around non-compliant parties as well as legal and institutional bottlenecks to prepare the ground for fair and participatory elections.

The EC's ongoing dialogue with all stakeholders involved should give it pause for thought. There are ideas galore, but ideas alone don't work without a strong motivation. During its sixth round of talks held on Sunday, former election commissioners shared some observations that are worth consideration, such as the importance of inclusive elections and the decisive role that the ruling party can play in creating a conducive environment. They talked about the importance of a neutral election-time government. One stressed the need for completing counting of votes in daytime to avoid the influence of "jinns and ghosts" after sunset. There was even a suggestion for placing the public administration and home ministries under the authority of the EC during polls to ensure the neutrality of these vital institutions.

The CEC also weighed in by reminding everyone that the EC alone cannot hold elections – that "voters and political parties are vital stakeholders" too. True, but where is the initiative to gain the trust of voters and opposition parties? What message do they get when the CEC refuses to take action to ensure that the rules apply to everyone during election campaigns? We urge the EC to own up to its part of the responsibility to hold fair elections. We also urge the government to ensure that it has unconditional support in fulfilling that responsibility.

Who will hold the reins of brick kiln owners?

Toxic smoke from these kilns is damaging crops, health

E as a nation are proving to be consistent in damaging the environment in every possible way. We have destroyed most of our natural forests, followed by the deliberate pollution of vital resources like water and air. With the vanishing forests, many beautiful species of birds and animals have also vanished, and many surviving species of sweet-water fish may soon be gone too as water pollution continues across the country. As for air pollution, we've managed to hit all the wrong indicators to become a country with the worst air quality.

Brick kilns – there are still many of them – are a major reason why we have a huge presence of micro-pollutants in the air. This daily has been regularly publishing reports on the assault of brick kilns on nature, highlighting the fact that most of them still burn wood as fuel which contributes to the release of lethal carbonmonoxide in the air.

In this respect, another dismal story was published on Monday. It shows how toxic smoke from brick kilns is damaging Boro paddy on nearly 100 acres of land in Mirzapur upazila, Tangail. The fume is damaging vegetables and other forms of vegetation growing adjacent to the paddy fields. It is disconcerting to learn that the brick kilns start their operation before the onset of the Boro paddy cultivation season in most areas. We have often come across graphic reports in print and electronic media of half-ripe paddy turning black and lifeless on the fields, causing huge financial losses to the farmers.

Though some brick kiln owners reportedly complied with the government directive to keep the height of the chimney at 130 feet, in reality, many owners hardly follow the rules. As a result, toxic emissions continue to damage the Boro paddy before the harvest time. The local administration and political representatives seldom admit responsibility for this situation or do what's necessary to make these unruly elements conduct their business in a responsible manner.

The story from Tangail is but a reflection of what's happening all over the country with brick kilns spewing toxic smoke in the air. Besides damaging important cash crops and vegetation, it also causes health problems by entering the respiratory system of humans. If there is any record of the number of people who die each year from air pollution, it would be frightening. The government, therefore, must take urgent steps to undo this damage and save our environment by punishing non-compliant brick field owners.

New Election Commission, Same Old Course?

■ HE Election Commission of Bangladesh has been mired in controversies over the last decade. Bar a few rare instances, the elections held at the national and local levels since the 2009 general election have been questionable at best. From allegations of rigging and voter fraud to instances of violence and murder in the vicinity of polling centres – every election has been marred by one or multiple such incidents. Consequently, the people of the country have lost their trust in the electoral system, which is an ominous sign for a democratic process. And for this situation, the last two election commissions, led by Kazi Rakibuddin Ahmad and KM Nurul Huda, are largely

So when the process of appointing the new election commission started at the end of last year, many political parties did not show any interest. BNP and some other political parties did not even join the dialogues leading to the formation of the new election commission. Although the new commission was formed through a new law in February, it is yet to gain the trust and confidence of a good number of opposition parties, including the BNP.

There was a time when only the major political parties used to publicly express their distrust of the electoral system and the election commission. But at the time the present Election Commission was formed, it became clear how far the crisis of confidence had reached, because the response from the general public was lacklustre and rather unenthusiastic.

It is in this context that the new commission adopted a submissive tone since its formation. Soon after the formal announcement, I spoke to the newly appointed chief election commissioner (CEC), Kazi Habibul Awal, over the phone. He said, "If I can hold acceptable [to all] elections, maybe I will have the joy of success, or else I will have regret."

Still, we remain optimistic as the CEC has said they will try their best to hold a participatory election. He also said it was not possible for the commission alone to ensure a good election. In this case, all political parties and law enforcement agencies would also have to do their part – so would the civil society and the media.

There are several challenges before the Habibul Awal-led commission. First, the opposition parties need to be reassured enough so that they participate in the elections. Second, the commission should present a roadmap for overcoming the shortcomings of the last elections to the nation. Third, it should make it

clear to everyone that they would not be susceptible to external interference while performing their duties – and be prepared to resign en masse if they are unable to do so. Overcoming these challenges are key to making the upcoming general election beyond reproach.

Although they have not yet confirmed whether the next general election will be held with electronic voting machines (EVMs), it appears that the commission is favouring the idea, despite the fact that most political parties in the country are against using EVMs in elections. Such a stance is only contributing to further distancing the Election Commission from the political opposition.

In May, at a function in Madaripur, Election Commissioner Anisur Rahman said the political parties were welcome to use their own IT experts to examine how EVMs work. He also said the CEC would give a USD 10 million reward to anyone who could find faults with the EVMs. The CEC quickly refuted his fellow commissioner's claim, pointing out that he could not make such bizarre comments.

While the debate over using EVMs in elections continues, former CEC KM Nurul Huda, who is dubbed by detractors as the "organiser of vote by night," said recently that elections under the ruling party were sensitive and challenging. He said it was not possible for the Election Commission alone to hold a free and fair election without the cooperation of all

not be more obvious. Here was the election chief who had overseen the most questionable election in the country's recent history that left little doubt about irregularities among almost everyone who followed it. It could well be said that it was his failure to hold free and fair elections that led the BNP to become sceptical about joining the electoral process, lest they lose face again.

Nurul Huda's former colleague, former election commissioner Mahbub Talukdar, later brought some of the incidents from that time to light. But the former election chief remained undeterred.

Free and fair elections are part and parcel of a democracy. Failure of the previous two election commissions to ensure it has deeply hurt our democratic process, with the general people turning apathetic towards the electoral process and major political players losing faith in it. In order to bounce back from this situation, the Election Commission needs to build trust among both the people of the country and the political parties. And then they must work towards delivering a free, fair and participatory election that is above question and acceptable to everyone. But the new Election Commission seems to be walking the old path of its predecessors, and needs to change course if it wants to be credible.

Let the Rohingyas set their own narrative

T has been quite clear in various segments of society in Bangladesh that the solution to the Rohingya crisis is becoming a distant dream. The attitude of the West and donors is gradually gravitating towards blame instead of appreciation as Bangladesh is criticised for shifting the Rohingyas to Bhasan Char as well as for not allowing proper education, skill development, lack of human rights and employment opportunities. The donors are pressuring Bangladesh to have long-term planning and budget for the Rohingyas. There are loose comments about the option of integrating Rohingyas into Bangladeshi society. Apart from this, a recent China-mediated repatriation initiative of situating 700-800 Rohingyas (few members from a family) at different places in Myanmar is an uncomfortable proposition.

This initiative includes about 300 Hindu Rohingyas (possibly the last of the community in the camp, and as a whole family package). Meanwhile 40,000-60,000 Rohingyas who fled to India during the genocide are also slowly entering Bangladesh – perhaps they are being pushed back, meaning India, the regional heavyweight, is also getting rid of the Rohingyas. So, finally, it all boils down to Bangladesh. The other regional power that is trying to mediate the recent repatriation initiative would favour Myanmar's interest. As a

student of social studies, I understand Myanmar's interest would get preference over Bangladesh, because Myanmar is a strategic partner of China, whereas Bangladesh is a development partner. Meanwhile, due to the Covid-19 pandemic, the Russia-Ukraine war, the impending food shortage and fuel politics, the budget for Rohingyas will shrink, and there are indications of this already on the horizon. All these factors are making Bangladesh anxious from a feeling of "being left alone," despite its generous humanitarian approach towards the Rohingyas during their most difficult days.

My understanding is that Rohingyas are not returning to Myanmar anytime soon – not at least the way Bangladesh wants. Interestingly, negotiation from a position of weakness seldom brings the desired result. Both Bangladesh and the Rohingyas are bargaining from a position of disadvantage compared to Myanmar. So what are the alternatives?

Let me share a story. In 2018, at the UN General Assembly session in New York, I was nominated to attend a sideline event organised by the International Labour Organization (ILO). It was on indigenous peoples' rights. There were seven speakers, of whom six were officials of the ILO and other agencies of the United Nations. The only speaker who was not from the UN, but representing the indigenous people of the world, was a Chakma gentleman from Bangladesh. The point I am trying to make here is that the scope for education, exposure and empowerment allows vulnerable communities to have their voices heard in international forums.

The Rohingya issue is becoming a struggle for Bangladesh, and the Rohingyas' plight must not lose its sensitivity, tempo, impetus or strength. Rohingyas should be intellectually, politically and economically empowered

to speak for themselves and they should be assisted to create a position of advantage in international political, intellectual and human rights spaces. This approach is likely to create more anxiety regarding their repatriation among some strategic communities in the country. In spite of that, Bangladesh may consider the reality and allow internationallevel education, skill and leadership development for the Rohingyas to develop their own narrative and tell their own stories to the world. A developed human resource is better for everyone. On the contrary, a traumatised young population without proper education, hopes and dreams is a ticking "insecurity time

As the US has recognised the crackdown on the Rohingyas as genocide, this situation may be pursued to help marginal Rohingya families to migrate abroad, and settle there and pursue education. This diaspora, in two decades, will turn into a major advocacy tool. However, Bangladesh has to keep this issue alive and on the table, bringing the Organisation of Islamic Cooperation (OIC), regional organisations, the egalitarian world community and the UN on board.

It would be too much of an expectation on Myanmar's part that Bangladesh would let "Myanmar's battle" take place on Bangladesh's soil. They should find political solutions for the political issues they have created themselves, instead of securitising them and unnecessarily blaming its neighbours (It is on record that Bangladesh offered joint and coordinated patrolling along the border. This is a gesture that is one of a kind in this neighbourhood. Myanmar has not been very enthusiastic about this). It should, moreover, not be forgotten that even "strategic patience" has a shelf life.

To properly utilise health budget, we need a system overhaul'

Dr Syed Abdul Hamid, professor at the Institute of Health Economics in Dhaka University, speaks with Naznin Tithi of The Daily Star about the allocation for the health sector in the proposed national budget, and how to efficiently utilise this allocation.

What do you think about the allocation for the health sector in the proposed budget? Why is the allocation in this sector so low, despite it being one of the most important sectors where improvement is needed?

In the proposed budget, around Tk 36,864 crore or 5.4 percent of the total budget has been earmarked for the health sector. This is not a great amount. But compared to the rate at which we utilise the allocated funds, this is not a bad amount either. We can, of course, demand a bigger allocation for the sector, but only if the disbursed allocation is utilised in a qualitative and efficient way. Every year, a major part of the allocation remains unutilised due to the weaknesses and flaws in the system. If the health ministry and the relevant government agencies can address these flaws, they can demand increased

There is no novelty in the budget other than the expansion of maternal health voucher scheme in some upazilas. The overall budget has increased by 14.24 percent, while the health budget has increased by 12.62 percent. The incremental costs and inflation will basically eat up the growth of the allocation.

There are two sides of a budget: operational budget and development budget. If we look at the last five national budgets, we will see that about 20-30 percent of the operational budget and 30-40 percent of the development budget remained unutilised in a fiscal

What are the weaknesses in the system that you mentioned earlier? Why does the budgetary allocation remain unutilised?

There are various cost centres under the health ministry that prepare their own budgets and send them to the ministry. All the district and upazila hospitals, health complexes and offices send their yearly budgets to the ministry through the Directorate General of Health Services (DGHS). The government medical colleges and specialised institutes and hospitals - such as the cancer hospital, kidney hospital, etc also send their estimated budgets to the at least 32 operation plans (OP), whose budgets they determine themselves. In addition, the health ministry takes up some big projects, such as building new medical colleges or hospitals. So, the finance ministry decides the budgetary allocation as per all the health authorities' estimated expenditures. If they do not have new plans and projects, how will they get an increased budget?

In our upazila health complexes, there are 21 posts of doctors and junior consultants in each of them. But if you go there, you will hardly find seven or eight doctors. This is because there are 11 positions of junior consultants, which always remain vacant. Then there are also many vacant posts of cleaners, medical technologists and drivers. We need to recruit manpower in these positions to provide quality healthcare to people. But that is not done, so the budget remains unutilised.

Currently, the government allocates Tk 1-1.5 crore for buying medicines in every upazila. Although the upazila authorities buy the medicines, they

cannot provide the patients with the necessary medicines because of a basic flaw in the system: there are no modern storage facilities in the upazilas to store medicines, nor are there any storekeepers. It is often seen that the medicines in stock are unutilised and get expired because of the flawed dispensing mechanism. What is missing here is the lack of accountability in failing to provide the people with the services they need. In many cases, the responsible people in the health complexes experience difficulties in buying the medicines because, coming from the medical background, they often find the system of procurement pretty

It is the duty of the health ministry to find out these problems and resolve them. If the health ministry can find the places where development is needed, then they could ask the finance ministry for the funds. But the health ministry does not have the efficiency, capacity or willingness to do so.

What are the problems with procurement that the health authorities often face?

We cannot spend the allocation for procurement efficiently mostly because it takes a lot of time to get the files for procurement approved by the relevant ministries. Then the line directors for the OPs, the programme officers and deputy programmes officers - who are medical professionals – do not have adequate knowledge about procurement. So, despite having crores of taka as funds for procurement, they cannot use it. What they basically do is depend on their accountants or statisticians or staff who have been working there for a long time. These staff are often connected with local syndicates and involved in corruption.

How do you think the system can be fixed?

There are some institutional problems that need to be addressed urgently. The health ministry needs approval from the apex government bodies, such as the public administration ministry, planning ministry, the Planning Commission and the finance ministry, for undertaking any new project, procurement and appointing manpower. If the ministry can better negotiate with other ministries, then it can get its projects passed in a short time and apply for more funds.

Another major problem is that those who work at the secretariat come from the administration cadre, who do not have much idea about the medical profession and the health sector. And those who work at the DGHS are mostly doctors without any training for administrative work. But what we need is a combination of both. In the current system, when an important file from the DGHS goes to the ministry for approval, the ministry delays it because they hardly understand the importance of the matter. So, a lot of time is wasted to approve a new project or plan.

If we could make a new stream under the BCS medical cadre, who will be dedicated to health administration from the beginning of their careers, much of the problem could be solved. Those who will go to the administration cadre will be prepared with managerial skills, but will also have medical knowledge. If that can be done, the unnecessary waste of

time at different government offices to get the important projects approved can be stopped.

In addition, the organograms of the different institutions must be changed and modernised - particularly the upazila health complex organogram. The health ministry must do this with cooperation from the public administration ministry.

And a small development in medicine procurement can change the situation in the upazila health complexes. We need to set up a modern storage facility and a medical storekeeper to keep track of the medicines in stock, using digital technology. The expiry dates of the medicines can be tracked by using colour codes: for example, medicines that would expire in six months can be kept under the yellow section, and those that will expire in a year can be kept under the green section, and the medicines that must be used as soon as possible should be kept under the red section. That way, no medicine will go to waste. Is that too difficult to implement? If we can make this small change and invest here, then the funds can be spent in a qualitative way.

In the last two years of the pandemic, we saw how weak our healthcare system is, and where improvement is needed. Is there any reflection of that lesson in the proposed budget?

The Covid-19 pandemic has opened our eyes. It has shown us that nothing is as important as our health. The pandemic has exposed the weaknesses and pitfalls of our health sector. Although during the two years of the pandemic we took some ad hoc measures to improve the

healthcare services, we got back to our business-as-usual attitude as the pandemic waned.

What we realised during the pandemic was that the preventive care of our health service had been totally ignored - the government struggled to make people wear masks or maintain social distance. Besides establishing a good immunisation programme, we couldn't make much progress there. Preventive care means that we need to educate people about health safety, which is a continuous process: we need to educate them about the importance of safe air, safe food, safe water, and a safe environment. But we don't seem to have any plan at work to improve our preventive care. So, naturally, there is no allocation for this in the budget.

We have told this time and again during the pandemic, but nothing has changed. For example, we have an office for preventive care at the upazila level. But there is not enough manpower to run those offices. This needs to change.

How can we utilise the full budgetary allocation in the health sector and increase the budget?

Usually, the funds in the health sector are disbursed in four instalments. While the first two instalments are released very quickly, the last two instalments are disbursed very late. The last instalment is given in late May or early June, and all the procurement and purchases have to be finished by June 14. So, in most cases, the money disbursed in the last instalment cannot be properly utilised due to time constraint. If the last instalment can be disbursed in April, then the managers at upazila level have enough time to utilise the funds following proper procedures - floating tenders, selecting vendors, etc.

Then there should be provisions for emergency funds in our health budget. Say, for example, if the district hospitals are annually given Tk 10-20 lakh and the upazila hospitals are given Tk 5 lakh as emergency funds, we will need only Tk 37 crore. With this money, the hospitals can meet their emergency needs such as repairing machinery or making emergency purchases. This will not only improve the quality of the service provided, but will also ensure that the fund is utilised properly.

Then, if the vacant posts in the government hospitals can be filled by recruiting manpower, they can ask for more allocations. If we can ensure proper utilisation, we can get twothree times more benefits from the same budget. But for that, we need to completely overhaul the system.

National Action Plan on Women, Peace and Security (NAP-WPS) was launched by the Bangladesh

Government in November, 2019. The Ministry of Foreign Affairs is leading the action plan along with 11 other ministries. Bangladesh Nari Progati Sangha (BNPS) and Bangladesh Mohila Parishad are associated with this action plan as CSOs. A monitoring team will be formed involving the feminist network of women organizations in Bangladesh to monitor the implementation process

of NAP-WPS. The time frame for implementing this plan was 2019-2022. We are already into the final year, and there is very little progress in its implementation. Today we want to discuss the following issues: progress of the action plan, how it can be associated with the national budget, how natural disaster, manmade disaster, VAWG, violent extremism can be addressed, how we can move forward jointly with the law enforcement agencies and how we can extend the time frame of NAP-WPS for its effective implementation.

The UN Security Council adopted resolution 1325 on women, peace and security on October 31, 2000 following

the demand of global women's movement. The resolution reaffirms the role of women in the prevention and resolution of conflicts, peace negotiations, peace-building, peacekeeping, humanitarian response and in post-conflict reconstruction and stresses the importance of their meaningful participation and full involvement in all efforts for the maintenance and promotion of peace

In the context of Bangladesh where intolerance and violence against women are widely prevalent, a National Action Plan was formulated in 2019 under the leadership of the Ministry of Foreign Affairs, and with the support from UN Women. BNPS supported this process by collecting evidence, opinion, information from different areas of the country. The plan can be an effective tool for advancing women's cause and ensuring their participation in the socio-political and economic development process. Unfortunately, we haven't been able to make much progress in the implementation of this national action plan.

In today's roundtable, we will discuss how we can take this plan to the grassroots level and ensure proper implementation of it as well as how the existing barriers to women empowerment can be removed.

and security agenda. It played a key role in the adoption of Resolution 1325 which for the first time called for a meaningful participation of women in peacebuilding and resolution of

Bangladesh has made commitment to the global normative framework and the implementation of 1325 Resolution by adopting a National Action Plan on Women Peace and Security (NAP WPS) in 2019. This plan will be extended further to ensure its full and effective implementation.

UN Women, in partnership with BNPS, is supporting grassroots civil society organizations throughout the country to capacitate them on women, peace and security (WPS) issues and to localize the agenda so that the

implementation of the plan can take place with the government and the civil society in tandem.

We must remember that the WPS agenda is not only applicable for conflict situations. We are living in a global pandemic context where the peace and security of women have been severely compromised, as women are disproportionately impacted by the effects of the pandemic. The absence of conflict does not always mean peace. We need to make sure that we take this WPS agenda throughout the nation and enable young women, young men, civil society and all other actors to support the implementation of the WPS agenda.

Gender inequality remains the most stubborn and persistent of all inequalities. UN Secretary-General António Guterres has stated, "Today, women's leadership is a cause, tomorrow, it must be the norm." So we need strong women leaders both at national and local levels to take the WPS agenda forward.

The existing national action plan can be extended for a year since the plan couldn't

be implemented properly due to the Covid-19 pandemic.

The NAP-WPS didn't pay adequate attention to the Rohingya refugee crisis. During the formulation of the plan in 2019, it was thought that the problem will not persist for a long period. However, it has now become a protracted crisis for Bangladesh. Hence we should consider this issue while revising the NAP-WPS. Another important issue to be considered seriously is the impact of Covid-19 pandemic.

Recovery is one of the three pillars through which the national action plan will be implemented. We have to strengthen our recovery efforts by putting special emphasis on climate change, the Rohingya refugee crisis and Covid-19 pandemic.

Domestic violence is the most prevalent type of violence in Bangladesh. It has become so pervasive that a single ministry will not be able to prevent it. It requires collective action involving all the relevant stakeholders. It should be given special emphasis in the WPS agenda. We also need to take preventive measures to combat hate speech against women.

Finally, we have to develop the capacity of our institutions to fight against gender-based violence. We often talk about gender budgeting which means preparing budgets or analyzing them from a gender perspective. Unfortunately, it doesn't reflect in our budgeting process.

empowerment, but the problem lies in the implementation of these policies. As to the implementation of CEDAW, the government often says that our society is not yet ready to accept such modification. But it is the duty of the government to prepare the society for such developments.

Civil society organisations, particularly women organisations, in Bangladesh have been at the forefront of the women's rights movement. However, the space for CSOs is gradually shrinking in our country, and therefore, the women's rights movement is also losing strength.

The National Action Plan has three pillars: 1) prevention, 2) participation, and 3) protection, relief, and recovery. We should evaluate what progress has been made in these three sectors and what are the outputs.

We have to transform the women's rights movement into a social movement to prevent the wide prevalence of gender-based violence.

The galloping growth of madrassa education in Bangladesh is a matter of serious concern. Our constitution quite categorically stresses a common education system for all. The government should work to fulfil this constitutional pledge.

We should focus more on the impacts of the pandemic while revising the national action plan.

Civil society organisations should start preparing a parallel report on the progress of NAP-WPS. It will ensure better implementation of the action plan.

We should conduct a rigorous study to identify the impacts of gender-based violence on the peace situation of our country.

Journalists should be made familiar with the components of NAP-WPS to make the action plan more visible as well as engaging them in the implementation process

what role women police can play to ensure the security of every woman in Bangladesh. We follow up on the progress of the strategic plan on a regular basis. UN Women is also providing us support in this regard.

Bangladesh women police have been working with exemplary dedication in the peacekeeping missions since 2000. We sent an all-female police contingent to Haiti in 2010. Currently, another all-female police contingent is deployed in DR Congo.

One-stop service desks for women, children, persons with disabilities and elderly persons have been set up at all 659 police stations across the country, marking the birth centenary celebrations of Bangabandhu Sheikh Mujibur Rahman. This desk is led by a female police officer. Last year, we provided support to 3,44,000 persons through this help desk.

A large number of women faced cyber violence during the pandemic. We launched police cyber support for women to counter this menace. The programme is run by police women.

Female officers of the Armed Police Battalion are also working in Rohingya support shelters. An all-female contingent can be deployed to run these support shelters.

We have a gender module. We are working on upgrading this module in collaboration with UN Women. We will hold a day-long training programme on gender for the newly recruited constables this month. We will soon upload an online gender module for the male police members who didn't get gender sensitization training. They can complete the module online, and the completion certificate will be added to their service book

Police women badly need day care centres. We have the necessary infrastructure but don't have adequate human resources for running these centres. The Ministry of Women and Children Affairs can help us in this regard. There should be daycare facilities in all localities so that more women can participate in the workforce.

Finally, I want to claim that we are trying our best to implement the NAP-WPS. Other government institutions should also come forward. The Ministry of Public Administration should be included in this action plan. They can help coordinate among different ministries

We have been providing support to women, children, persons with disabilities and elderly persons through our one-stop help desks. However, we don't have adequate training to address the trauma faced by these persons. If we get training on counselling skills we will be able to provide better services. We also need to develop the capacity of our rehabilitation centres. Finally, we all need to work together and ensure coordination of our efforts to fight violence against women effectively.

Women's rights organizations get a minuscule portion of the government's development budget. We should raise our voices for increasing the allocation to the gender fund.

When a woman faces violence, not only she personally gets traumatized, it also affects all other women and their family members. A country can't make progress keeping half of its population behind trapped in the four walls of the households and in the threat of violence inside or outside of the household.

The spirit of our Liberation War is that every citizen is equal irrespective of their religion, ethnicity, gender, or class identity. Everyone has the right to live, to be free, and to feel safe. We must live up to that spirit.

Women made equal contribution to the Liberation War than men but suffered worst sexual violence. However, we only mention them as victims of rape and abuse. Many women actively participated in the war but we do not recognize their role. BNPS has prepared a list of female freedom fighters and shared it with the Liberation War Ministry. More work is needed in this regard. In this respect, BNPS took efforts to train journalists for gender sensitive reporting of rape, to build national narrative such a way where women's heroic role is reflected. Still it needs more work to do.

Bangladesh has made remarkable progress in many sectors. However, we are still lagging behind in terms of ensuring a safe environment for our women. If we fail to do that then all our achievements will be eroding, since the cost of VAWG is very high.

Finally, we all should work together to implement the NAP-WPS. If it is implemented properly it will help remove many barriers for the emancipation of women in Bangladesh.

UN Women has been providing assistance to the Foreign Ministry in this regard. The orientation process should be strengthened further to ensure proper implementation of the action plan.

A remarkable aspect of NAP-WPS is the inclusion of CSOs in the consultative platform. This platform should be activated immediately.

There are still many laws in our country that promote and perpetuate gender inequality and genderbased discrimination. We have to identify those laws and policies and reform them. We have to rethink the government's reservation to CEDAW.

We also need to change our institutional outlook. In many cases, a victim of gender-based violence has to go through further ordeal during the investigation process. As a result, many

Will Shakib's captaincy cure Bangladesh's DRS malaise?

Technological advancement has aided all forms of sports worldwide. While the introduction of the Decision Review System (DRS) has seen the rate of errors made in matches drop down significantly and also provided a clarity to players and viewers alike, its effectiveness still depends highly on the refined decision-making from the cricketers out on the field.

And in modern cricket, the three DRS calls allocated in Test cricket to each of the teams go a long way in almost determining the outcome of a game.

Apart from the usual cricketing issues, the one other thing that Bangladesh have struggled with in recent times, especially in Tests, is their inability to make proper use of the DRS.

To put things into perspective, Bangladesh have seen a total of 10 unsuccessful reviews in their recent-most two- iest series against Sri Lanka wniie getting only six reviews upheld successfully. In the series before that, away to South Africa, Bangladesh saw a total of 12 unsuccessful reviews against six successful ones in the two-match Test series.

Even in the preceding away Test series against New Zealand in January this year, Bangladesh had 11 reviews turned down while seeing only five reviews being successful. Interestingly, it was in the first Test in Mount Maunganui in which the Tigers clinched a historic eight-wicket victory that they saw a total of eight reviews turned down.

But it is true that only the numbers don't accurately reflect the review

taking precision of a side as not all the unsuccessful reviews were due to a bad call from the Tigers' camp with a number of decisions turned down on umpire's call. Then again, even considering that the numbers aren't a true reflection of Bangladesh's ability to make the right call in going upstairs at opportune moments, a total of 33 unsuccessful reviews against 17 successful ones in last six Tests certainly do not bode well for the Tigers.

In the six Tests played in their last three series. Bangladesh had seen a total of 33 unsuccessful reviews.

During the same period, the Tigers were only able to take 17 successful reviews.

However, not all the unsuccessful reviews were due to a bad call from the Tigers' camp as a number of decisions were turned down on umpire's call.

In fact, there were instances of woeful and, at times, hilarious DRS calls made by Bangladesh. The most glaring blunder made by Mominul Haque's side was probably the one made against the Kiwis during their historic Test win.

In the 37th over of New Zealand's second innings, a loud appeal from bowler Taskin

Ahmed and the fielders were made for an LBW against right-hander Ross Taylor. Even though the umpire had turned it down immediately, Mominul went on to review it with seconds left on the timer only to be embarrassed by the review shown on the big screen. Not only did the ball have any connection with the pad, it was defended with the middle of the bat by the Kiwi batter, which only brought to ears a muffled laughter from the commentary

During the first Test against Sri Lanka in Chattogram last month, Bangladesh lost two of their reviews inside the first session of the game.

Not only that Bangladesh regretted taking ill-timed reviews in recent past, there have also been handful of instances when the situation was the other way around. Such was the case in the second Test against South Africa when Mominul decided not to review after umpire had turned down a solid LBW appeal from pacer Khaled Ahmed against Sarel Erwee who was batting only on 4 at that time.

It is true that the skipper only gets a few seconds before making a DRS call and has to rely heavily on the body language of his troops, still the Tigers, as a team, ought to follow a more judicious approach in making such calls.

With the Mominul-era concluded, it will be interesting to see how Bangladesh do in regards to their DRS calls in the upcoming Test series against the West Indies under the leadership of Shakib Al Hasan, considered one of the 'best thinkers' of the

Booters hoping to end on a high

Bangladesh were looking forward to ending their Asian Cup Qualifiers campaign on a high ahead of today's third and final group-stage match against hosts Malaysia at the Bukit Jalil National Stadium in Kuala Lumpur.

The match will get underway at 7:00pm (Bangladesh Standard time) and be broadcast on

Bangladesh are bottom of the four-team table in their group, with no points to show despite impressing with their never-say-die approach.

Meanwhile second-placed Malaysia, with three points, will hope they can secure a place in the next round with a runners-up finish, although their fate also hinges on the outcome of the day's first match between group leaders Bahrain and third-placed Turkmenistan.

Bangladesh suffered narrow defeats to the group's higher-ranked sides, Bahrain and Turkmenistan, and are expected to face another stiff challenge not only from Malaysia, but also from their huge home crowd.

However, Bangladesh coach Javier Cabrera saw the crowd as motivation for his charges.

"Playing in front of 70 or 80 thousand spectators is not only extra motivation for players, it is a player's dream to play in front of such a big crowd in that kind of atmosphere. It is the perfect moment for us to show that we can compete against anyone. It is time to be consistent," the Spaniard told reporters at the pre-match press conference in Malaysia yesterday.



"It is a fantastic opportunity for the boys and will be beautiful day for us to do our best. Show consistency again like we did in the past three matches. I think we deserve more and want to give something to our supporters and go home with something. We believe in ourselves and we will do our best tomorrow."

Responding to a question about whether his side could score against Malaysia, Cabrera said: "Malaysia are going to give everything from the first second and try kill the match in the first 10 minutes. You need full concentration and attention to be able to stop them, hold them and punish them."

Captain Jamal Bhuiyan believes the pressure will be on Malaysia and his teammates are ready to deliver their best.

"Tomorrow [Tuesday] is our last game and everyone is looking forward to it. We want to end with a good result. I think all players are motivated for the match," Jamal said." It is a big match and the pressure will be on Malaysia because they have to win. Of course, we also need a result but I think we have to run more than Malaysian to get something."

Bangladesh's history against Malayisa is inauspicious, with six defeats in nine matches, although the last two meetings between the teams in 2012 and 2015 ended in draws. Bangladesh's lone win over Malaysia came courtesy of a 2-1 result in the 1982 Asian Games.

The breeding grounds for young cricketers

School cricket has played a huge role in scouting aspiring cricketers over the years and, following a halt due to the Covid-19 pandemic, the prestigious tournament once again made a positive impact as Shishu Niketon High School clinched the Prime Bank National School Cricket title by beating Meherpur Government High School by 59 runs in the final yesterday.

The Bangladesh Cricket Board's attempt to rekindle school cricket competitions, where youngsters can showcase their talents in a festive environment, was spearheaded by board director and BCB School Cricket Committee chairman Obeid Rashid Nizam. The matches being telecast on TV has only added to the excitement.

Shishu Niketon leg-spinner Shaikh Imtiaz Shihab, who was named player of the tournament, starred in the final with a five-wicket haul as Meherpur were bundled out for just 43 runs in chase of a modest of 102 at the Shamsuzzoha Sports Complex in Narayanganj.

Like Shihab, who scalped 33 wickets in 10 games in the tournament, many others have been testament to school cricket's being a source of producing cricketers at the grassroots level.

"School cricket is a regular program under game development activities. The tournament didn't hit the field due to the Covid-19, but it was a regular feature in

the past. We previously had around 550 schools participating but this time we reduced it to 348. The reason was to ensure quality," BCB age-level selector and former Bangladesh opener Hannan Sarkar told The Daily Star. "We made sure schools would meet specific criteria to be able to participate so that the standards of the

teams could be ensured."

Selectors will conduct a training camp with 120 cricketers from the school cricket tournament and form a 15-member squad. They are also planning to provide scholarships to the cricketers.

"Shihab was in our national under-15 camp and is part of the set-up. When we

make the shortlist, you will see a majority of our age-group cricketers coming through the process. However, there are some players who somehow miss out or were dropped. Those players got the opportunity to showcase their worth," he

Hannan also chimed in on why he

felt that Bangladesh were struggling to produce leg-spinners for the senior side despite many leggies coming through the system.

"We announced the under-15 squad recently and included two leg-spinners. We have three leg spinners in the under-17 squad and we will have four to five leg spinners in the team in the upcoming under-19 squad. We never had a shortage of leg-spinners at the age-level. But I don't want to comment about what happens after that. Honestly, I think maybe clubs don't show interest in playing leg-spinners at the competitive level. That is probably one aspect," Hannan said.

There have been instances of players attempting to hide their age to fit into the system, but Hannan said the board ensures proper medical tests to determine age.

"When the medical tests start before the tournament, we have one representative from the board designated to follow procedures. We also have a doctor in the team along with district and divisional coaches. Officials provide papers such as a birth certificate.

"Each individual grows differently so it's quite difficult to determine age perfectly. But we take it that sixty to seventy percent is right. If we have any doubts about a player, we go for bone tests as an authentic and final option," he added.

Follow health protocols to contain Covid

Says health minister amid steady rise in virus cases

Health Minister Zahid Maleque yesterday urged all to maintain health protocols as Covid cases in the country rose for the 12th consecutive day.

The Directorate General of Health Services (DGHS) reported 128 new cases yesterday. The number was 109 the previous day.

The test positivity rate, however, declined slightly yesterday. It stood at 1.91 percent after 6,668 samples were tested across the country. The previous day, the rate was 2.06 percent.

No death from the virus was reported yesterday. "Covid has not yet been eradicated... though the situation is normal now, it may take an alarming turn any time," said Zahid at the Secretariat, reports UNB.

"Everyone must follow the health rules and wear a mask," he said after a meeting on the automation of admission process at private medical and dental colleges. Since June 2, the country has been a seeing a steady rise in Covid cases.

Amid such a situation, Zahid urged those who are yet to be vaccinated to get jabs immediately.

The minister further said that in the proposed budget, the health sector received an allocation of around Tk 4,000

crore which is higher than that in the previous fiscal year.
About the automation of student admission at private medical and dental colleges, he said this will make the admission process transparent.

Give pointers on polls-time govt

Transparency International Bangladesh yesterday said the Election Commission can give suggestions to the government or the authorities concerned on how the polls-time government should conduct itself.

The Bangladesh chapter of the Berlin-based anticorruption watchdog, which also carries out research on various election issues, also proposed that the EC should decide to use electronic voting machine (EVM) only after ensuring that it is accepted by all stakeholders and is technically faultless.

"Election Commission said that they are still thinking about it [use of EVM] and they are yet to take any decision regarding the matter," TIB Executive Director Iftekharuzzaman told reporters after holding a meeting with Chief Election Commissioner Kazi Habibul Awal at the EC office in the capital.

"People of the country have expectations and concerns about the character, behaviour, shape and composition of the election-time government ... The EC can give its suggestions to the government or the authorities concerned on how the polls-time government should behave during elections. The Election Commission can also propose to reform laws if needed," he said.

A polls-time government usually works to perform routine functions after the election schedule is announced. In November 17, 2013, the then government formed a polls-time cabinet ahead of January 5, 2014 elections.

No such government was formed ahead of the last national election held on December 30, 2018.

OTT draft rules prohibit news, talk-show broadcast

Info ministry submits outline to HC

The information ministry yesterday submitted to the High Court a draft of the OTT (Over-The-Top) regulations prohibiting broadcast of news or talkshows, except for the contents defined in the draft, on the OTT

and asked the ministry and
Bangladesh Telecommunication
Regulatory Commission (BTRC)
to keep it updated about future
developments.

According to the draft, OTT is a type of media service that broadcasts entertainment programmes, drama, movie, documentary, sports, infotainment, advertisement and video on demand or telecast permitted contents of television channels live through internet or equivalent technology in

Bangladesh.
It further said no news and talk-shows, except for the

contents defined in the draft, can be run on the OTT platforms in any manner.

It has also banned all contents that go against the spirit of the Liberation War, the country's culture and social values; damage communal harmony; create threats to state discipline and its unitary form; and contradict the existinglaws.

Complying with an earlier HC directive, Deputy Attorney General Tushar Kanti Roy placed the draft, "Over-The-Top (OTT) Content Based Service Providing and Conduct Regulation-2021", before the HC.

The BTRC also submitted a draft on "the Regulation for Digital and Social Media Platforms, 2021" through its lawyer Khandaker Reza-E-Raquib to the HC during the hearing on a writ petition filed over the issue.

Talking to The Daily Star, writ petitioner and Supreme Court lawyer Md Tanvir Ahmed said the information ministry drafted the OTT regulations prohibiting the publication and broadcast of news or talk-shows, except for the contents defined in the draft, on digital platforms, which may be passed as a law by parliament.

In July 2020, Tanvir

Opposition MPs blast law enforcers

Stars experience 'quakes' like on Earth

Stars experience quakes like we have on Earth, scientists have discovered, after data revealed new information on nearly two billion stars in the Milky Way. These "starquakes" –

known as non-radial oscillations – are tsunami-like movements on stars' crusts which cause

the shape of the star to change with their force.
This was an unexpected discovery from
the latest data release from the Gaia space
observatory, which is located about 1.5 million
kilometres from Earth and carries two telescopes
to document the galaxy, as it was only designed

Illegal migrant crossings to EU up 82pc Says Frontex

Illegal migrant crossings into the European Union rose by 82 percent between January and May compared to the same period in 2021, the European border agency said yesterday.

Frontex said there were 86,420 irregular crossings into the 27-nation bloc in the first five months of the year, according to its initial calculations.

In May alone, 23,500

irregular migrants made the journey, a rise of 75 percent on the previous May, it said. Ukrainians entering the

EU via recognised border crossing points were not included in the data.
