2 killed, 1 hurt in road accidents

Two people were killed and another was injured in road accidents in two districts yesterday, report our local correspondents.

In Gopalganj, a truck driver was killed in a bustruck collision in Sadar upazila of Gopalganj.

The accident happened on Dhaka-Khunla highway in Haridaspur bridge area, said police.

Sohag Mollah (35), son of Sohidul Mollah from Chandradigholia village in the upazila, was declared dead at Gopalganj General Hospital. In Dinajpur, a motorcyclist Moinul Islam (45) was killed and his pillion passenger Mina Khan hurt after a sandladen tractor hit their motorcycle in Ghoraghat upazila.

Moinul was initially taken to Ghoraghat Upazila Health Complex. Later, he succumbed to his injuries on the way to M Abdur Rahim Medical College Hosptial in Dinajpur, said police.

Man sent to jail over acid attack


A Barguna court yesterday sent a man to jail for allegedly throwing acid on a woman's face in Sadar upazila the day before.

Following the attack in Ayla Patakata area, locals caught the accused Kamal and handed him over to police. The victim -- Parveen Begum (30), a resident of the area -- is a tea seller.

Parveen's relatives said she went to her shop on Monday night. At that time, four to five people passed by on two motorcycles and threw acid on her. Victim's father Shahjahan Mia said, "We had a land dispute with several people including Kamal, which led to the attack."

UP member Shahjahan Mia said locals caught Kamal after the family sought justice. Barguna Police Station OC Ali Ahmed said further legal actions will be taken later.

Parveen was initially taken to Barguna General Hospital. Samsuddoha Shams, an assistant surgeon at the hospital, said her face, eyes and throat were burnt. The doctors sent her to Dhaka for better treatment.

A series of DELAYED JUSTICE

Razia Rahman had to wait for six years to get a trial court's verdict in her husband Faisal Arefin Dipan's murder case.

One and a half years have gone by since the judgment, but she still does not know when the legal process of the case would be completed and she would get final justice.

The case currently lies pending with the High Court.

"Common people like us have nothing to do to expedite the legal process. All we can do is to place our demands for justice," said Razia, with a tinge of sadness in her voice.

Dipan (43), owner and publisher of Dhaka-based publishing house Jagriti Prokashoni, was hacked to death by members of banned militant outfits at his office inside Aziz Super Market in the capital's Shahbagh on October 31, 2015.

He was murdered for publishing books written by American-Bangladeshi writer Avijit Roy, who was killed on Dhaka University campus eight months earlier. The attacks were part of a wave of violence targeting freethinkers, bloggers and agnostic writers, which started in 2013.

On February 10 last year, an Antiterrorism Special Tribunal in Dhaka delivered the verdict in Dipan's case, sentencing all eight accused in the case filed by Razia to death.

Appeals filed by the convicts and death references in the case are now pending with the High Court.

"After the lower court verdict, the case has now been stuck in the upper court.

The sooner verdicts are delivered in all such cases from the court, the better it would be for everyone. Otherwise, the cases will get buried," said Razia.

Although attacks on freethinkers and bloggers, and their murders by suspected Islamic militants have decreased significantly due to multiple anti-militant crackdowns, none of the families of those killed have got complete justice yet. Most and LGBT activists were killed across the country in 2015. Four of them were killed within the span of seven months. Al-Qaeda-influenced Ansarullah Bangla Team, also known as Ansar Al Islam, was responsible for the killings, according to law enforcement agencies. STATUS OF THE CASES

Of the cases, the trial courts concerned have so far delivered judgements in the

of the victims' family members, like Razia, blamed slow legal progress for the delayed justice.

In 2013, Bangladesh started witnessing a string of violence targetting bloggers and freethinkers by suspected Islamic militants, after a small group of secular bloggers and online activists launched a massive protest movement, demanding death penalty for war criminals of the Liberation War and an outright ban on religious politics.

The motive of the attacks, as police investigation revealed, was to muzzle their secular voice, views and freethinking.

At least 10 freethinkers, bloggers

cases filed for killing six bloggers, while the High Court gave verdict in one case, filed for killing blogger Ahmed Rajib Haider, who was the first secular blogger to have

been killed by militants.

The Appellate Division of the Supreme Court is yet to start hearing the appeals filed by the convicts, challenging the HC verdict in Rajib murder case.

Trial proceedings of three murder cases are currently pending with the lower courts. The cases were filed for killing bloggers Niladri Chattopadhyay Niloy, Nazim Uddin Samad, and Oyashiqur Rahman Babu.

'I don't know where I'll go'

Dhaleshwari river erosion takes a serious turn in Manikganj

Hundreds of families in Patilapara area in Manikganj's Saturia upazila have been affected by river erosion. Vast crop lands and houses have been washed away by the Dhaleshwari river

in the last few days. Hundreds of houses and crop lands, including, Abdur Rahman Khan High School are now at risk of erosion.

Water Development
Board (WDB) office sources
said 11 rivers -- including
Padma, Jamuna, Kaliganga,
Dhaleshari, Ichhamati,
Kantabati -- flow through
Manikganj district, making
it prone to erosion during the
rise and fall of water level.
On a visit to the Patilapara
area, this correspondent saw that

more than 100 bighas of crop land and six houses have been washed away by the Dhaleshwari. Jabeda Khatun was seen cooking in a river e kitchen. Most of her house has been washed

side kitchen. Most of her house has been washed away by the river. The kitchen is almost on its way to be drowned. She said, "We took shelter on a neighbouring

She said, "We took shelter on a neighbouring land near Abdur Rahman High School as a major portion of our home was washed away in the river a few days ago. Now it seems that the school will be engulfed by the Dhaleshwari as well. I don't know where I will go. No one is coming to our aid."

Sameul Hague, another resident said. "I

Samsul Haque, another resident, said, "I planted fruit trees, but they were uprooted due to river erosion. Each five trees go for Tk 3,000. Now I'm cutting down the trees to use as firewood since I'll be moving. What am I supposed to do?"

Mofigul Islam Khan Kamal, former Manikga

Mofizul Islam Khan Kamal, former Manikganj-Saturia constituency AL lawmaker and president of Abdur Rahman Khan High School's managing committee, said, "Every year, the river erosion situation gets worse. This time, people of the surrounding areas, including Patilapara, became homeless due to river erosion. We need to build a permanent dam."

Manikganj WDB Executive Engineer Md Main Uddin said, "We've used 7,500 geo-bags in the area to prevent erosion. When the water recedes, the rest will be placed there so that there is no further erosion."

"WDB has approved and allocated funds for constructing permanent dams in 10.5 km area at 12 points of Kaliganga river. Permanent dams will also be constructed in phases in risky areas surrounding the Dhaleshwari."

Broadband for 1 lakh schools by 2025

The government is planning on providing broadband internet connections to one lakh educational institutions by 2025, as part of its efforts to spread online education across the country.

The information was revealed at a workshop on connectivity for educational Institutions, "Bangladesh Broadband Policy 2022", organised by Bangladesh Telecommunication Regulatory Commission, Aspire to Innovate and Alliance for Affordable Internet at a Dhaka hotel yesterday.

Post and Telecommunications Division and Education ministry have already identified 98,349 schools, colleges, madrasas, universities and other institutes eligible for the connections.

A total of 13.89 lakh internet connections have to be established, as there will be several connections for each of the institutions.


