

Abu Abdullah Jahangir passes away

Freedom Fighter and renowned engineer A b u Abdullah Jahangir passed away on Wednesday night at a London hospital.



He was 65. Abdullah had been undergoing cancer treatment in London.

After the Liberation War, he travelled to the UK in 1974, where he completed his BSc in civil engineering and his MSc and MBA as well.

He went on to work for Camden, Wandsworth, and Redbridge Council and was the chief Engineer of Haringey Council.

He designed many iconic landmarks in London, such as the Euston underpass and flyovers over the North Circular Road etc. Abdullah will be buried in Devon, where he had been living with his wife and three children, today after Juma prayers.

The art expert joined Dhaka Museum (later Bangladesh National

Museum) in 1962. He became the principal of the institution in 1965, director in 1969 and served as its director general from 1983 to 1991.

In recognition of his contributions, he was awarded Ekushey Padak in 2014, Swadhinata Padak in 2017 and Padma Shri award of India in 2020.

are still living in shelters," Lewis said.

"The flood waters are receding very slowly and their homes are completely destroyed. There is an urgent need to scale up our support to the government's emergency

response," she added.

This brings the current funding of the Humanitarian Response Plan to \$12 million (Tk 112 crore), which is approximately 20 percent of the necessary \$58.4 million that was identified.

BNP that go to the people instead, who will elect their next leaders. It's the people who have real power, not foreigners," added Razzaque.

Meanwhile, Local Government and Rural Development Minister Md Tazul Islam yesterday said calling on foreigners to interfere in internal affairs of the country, including the national elections, will bring misfortune to the country.

Tazul made the comment after a meeting with newly-appointed EU ambassador Charles Whatley at his office.

The minister said Bangladesh is an independent-sovereign country. If there is any internal problem, people can discuss it among themselves.

"If you discuss [internal matters] with a representative of a foreign country, it belittles your own country."

Bangladesh wants all eligible agencies to be allowed to recruit workers to Malaysia. The Malaysian government, however, sent Bangladesh a list of 25 recruiting agents. There are allegations that one Dato Amin, a Bangladeshi-born Malaysian citizen, is behind the syndication. He is also reported to be behind the syndicate of 10 agents during the 2016-18 period.

Over a week ago, Malaysian Anti-corruption Commission raided the office of Bestinet, an IT firm owned by Amin, in Malaysia. The firm provides IT support for the recruitment of migrants from Bangladesh.

Asked about the TIP report, the US official said she was not going to say what tier Bangladesh falls in the report this year. But, the country was in Tier-2 for the last two years. Before that, the country fell under Tier-2 Watch List for three consecutive years.

1, Tier-2, Tier-2 Watch List and Tier-3, with Tier 1 being the best category in terms of taking actions against human trafficking and Tier-3 being the worst.

Any country falling in Tier-3 faces sanctions on development assistance.

Asked how the US government assesses the situation in Bangladesh, the official said generally the US and Bangladesh have good partnership in anti-trafficking cooperation. The measures include creating awareness, investigation and prosecution, and victim support.

TIP Report 2022 will be its 22nd instalment and will cover 188 countries, including the US. Trafficking means falsifying to, coercing and defrauding people for employing or transferring them from one place to another for labour or commercial sex. This can happen within a country or from one country to another.

we cannot move forward. This only makes the process more time-consuming," he said.

Olive Limited is a private company that manages and provides technical support to the web portal.

"Due to the hassle in online payment, service seekers often ask for manual support for certification," added Tofail.

Saifuddin Ahmed, secretary of ward-23 of Narayanganj City Corporation, echoed the same.

Mohammad Samawat Ullah, managing director of Olive, said they received only a handful of complaints on "unpaid"

issues.

"It happens in only five to seven percent of cases due to the glitch by wallet service providers. We're not responsible for it," he said.

"Many officials still prefer a manual system due to a lack of technological knowledge. That's why they keep complaining," said Samawat.

He said that they could not expand the service to wider areas primarily due to the pandemic.

Besides, initial non-cooperation from the local representatives also slowed the expansion, he said.

The Cabinet Division in a letter on February 3 directed LGD to introduce Protoyoyon in all city corporations,

municipalities and union parishads.

In an order passed on February 27, LGD asked the deputy commissioners to introduce Protoyoyon in the union parishads under their jurisdiction.

LGD is also working on upgrading its manual services online through different vendors.

The ministry provides 128 services through its different local government organisations, Shafiqul Islam, a programmer at LGD, told this correspondent.

repatriation is concerned," said a foreign ministry official.

On the other hand, Asean has been in trouble due to Myanmar's double crisis - one being the Rohingya influx following a military crackdown, which the US determined as genocide, and the other is the military coup.

In April last year, Asean adopted a five-point consensus on Myanmar. Those include an immediate end to violence in Myanmar; dialogue among all parties concerned; the appointment of a special envoy; provision of humanitarian assistance by Asean; and a visit by

vicinity, a significant amount of wildlife is under threat," he added.

Muntasir Akash, lecturer of zoology at Dhaka University, said the most flood-affected animals are fishing cats, snakes, civet species, wild cats, foxes, and monkeys. Their habitat has been completely destroyed.

"It's also worrisome that there's hardly any data on how many animals have been endangered or how many of them have died," he added.

On June 17, the forest department recovered bird-hunting devices and several cages from Kakkia Bazar in Sreemangal. The following day, it rescued a snake from a fruit shop at Bhanugachha Bazar in Kamalganj.

A fishing cat took refuge in Lal Mia's house in Ganpur village of Habiganj's Baniachang upazila. Upon receiving

the news, the forest department also rescued it.

Hunting traps for capturing wild animals were seized from a forest in Lawachhara National Park.

Prof Md Enamul Haque, chairman of the department of animal nutrition at Sylhet Agricultural University, said food crisis and habitat has become the biggest problem for wildlife like birds and insects in the floods. Various animals, including monkeys, often come to the locality for food. The crisis has become more acute due to the floods.

Rezaul Karim Chowdhury, divisional forest officer of Sylhet's Wildlife Management and Nature Conservation Department, said, "Many wild animals have been trapped due to the floods. Many of them are at risk, and only some of these animals have been rescued."

union, said he was also against the construction and was unaware of the project being implemented there. This correspondent tried to contact the union parishad chair Jiaul Alam Jhunu but found his cell phone switched off.

"The land is recorded as an abandoned Khas land. Hence we decided to implement the project there," said Shahzadpur UNO Md Tarikul Islam.

"There is no official

document proving it as a playground. We have already submitted the proposal and are currently waiting for funds to be allocated," he added.


About the protest, Tarikul said they discussed it with the local MP and UP chair before taking up the project.

"As the locals are protesting the project, the decision will have to come from the higher authority. We will inform them of the issue," the UNO added.
