## Portraying rural beauty of Bangladesh Samar Majumder's solo exhibition concludes today

Renowned artist Samar Majumder's third solo exhibition, titled "Soul Searching: A Personal Journey" took place at the Shilpangan, Lalmaia. The month-long exhibition concludes today.

female migrant workers went abroad between January 1991 to June 2022.

"While the instances of harassment got more coverage, information related to the migration process and availability of services was given very little focus," she said.

Mohuya Leya Falia, MJF programme coordinator, said, "[The media] should be careful about their wordings while reporting on the issues of female migrant workers to not

disrespect them in any way."

However, Rashad Ahmad, staff correspondent of The New Age, said, "It is the responsibility of the media to report on migrant workers' troubles. The focus should be on improving the migration process for female workers."

Chaired by Nusrat Sultana, treasurer of CWCS, representatives from different bodies working on migrant workers' welfare spoke at the event.

department Prof Dr Md Tofazzol Hossain, for the treatment of the newborn.

She is now being treated at Neonatal Intensive Care Unit (NICU), said Dr Wayez Uddin Farazi, deputy director of the hospital.

The girl has been suffering from jaundice and anaemia along with fractures in her right hand, the doctor said.

In another development, the High Court yesterday

directed the social welfare secretary to immediately form a committee to take care of the child and asked to submit a report before the court in three months.

In response to a writ petition, the HC also ordered the trustee board – which was formed under the Road Transport Act – to give Tk 5 lakh as the initial cost for the newborn's treatment, wellbeing and other necessities in 15 days.

## Killing a canal

"Filling up any canal is a punishable offence under the existing law, and action will be taken against those who filled the canal without permission," Mufidul Alam, director of Department of Environment's Chattogram region, told The Daily Star recently.

Rafiqul Islam, chief engineer of CCC, said in a meeting that the tunnel authorities have illegally filled a part of the canal and turned it into a drain. Despite objections, they did not stop filling the canal.

Due to this, new areas are being flooded in Patenga. If the canal is not restored, waterlogging cannot be solved, he added. "We have written to the tunnel authorities to restore the canal to its original form. But they did not respond to our letter."

Despite the original dimensions of the canal being in Karnaphuli Tunnel's (also known as Bangabandhu tunnel) master-plan, the tunnel authorities filled a part of it to widen the nearby road.

Abul Kalam Azad, deputy project director of Karnaphuli tunnel, told this newspaper, "We have made drains for the movement of water to avoid waterlogging during monsoon."

He said, "We have signed an agreement with Chattogram Development Authority [CDA] to re-dig the canal. CDA will re-excavate it after completion of road work."
