Three killed in road accidents

Three people were killed in road accidents in three districts yesterday, according to reports from our correspondents.

In Chattogram, a college student was killed after a covered-van ran her over on Bayezid Link road in Sitakunda upazila.

Fateha Jahan Zeba (18), a student of the port city's Enayet Bazar Mahila College, died instantly, said police.

Zeba -- who was from Sitakunda's Kalu Shah area along with her father Md faruk was going to her college on a motorcycle.

The accident happened when the bike skidded off the slippery road and she fell from it, said Md Towhid, in-charge of Fouzderhat Police Outpost.

Police sent the body to Chattogram Medical College morgue autopsy, he said.

The covered-van driver managed to flee with the van, he added.

Meanwhile Patuakhali, Rana helper of a bus driver, died as the vehicle ran him over at Nachnapara intersection in Kalapara.

According eyewitnesses and police, the bus of Molla Enterprise had left Kuakata in the morning for Patuakhali and was waiting at Kalapara bus stoppage to pick up passengers.

Rana got down from the bus and was going to the ticket counter. Meantime, he was hit by the bus as the driver was trying to park it at a suitable place.

He was declared dead at Kalapara Hospital.

Kalapara Police Station OC Jasim Uddin said they seized the bus but its driver fled the scene.

In Barguna, a bank officer named Sahidul Islam (35) was killed as a microbus hit his motorcycle from the opposite direction on Amtali-Kalapara road at Manikjuri, said police.

Hill cutting on, defying ban

Disregarding a High Court directive and environmental laws, illegal hill cutting continues unabated in Dinarpur of Habiganj due to lax monitoring of the authorities concerned.

Responding to a petition, the HC in 2015 directed the government to stop hill cutting in the area and take appropriate legal steps against offenders.

According to Bangladesh Environment Preservation Act 1995, amended in 2000, cutting of hills without approval of the authorities concerned is prohibited.

Punishment of such an offence for the first time is up to two years' imprisonment or Tk 2 lakh fine or both.

For subsequent offences, the punishment is up to 10 years' imprisonment or Tk 10 lakh fine

This gross disregard to the HC directive first came to the fore in 2016, when two workers were killed in a landslide while cutting hills in Dinarpur -- just a year after the ban.

Still those involved with illegal hill cutting and sand extraction did not face any consequences, much to the astonishment of environmental activists in the district.

Several groups, under the leadership of brothers Sirul Mia and Salim Mia, are currently active in cutting hills in the region, locals said, seeking anonymity.

In May, they extracted sand from a canal next to Nalsuja football field in Nabiganj upazila of Sadarghat New Market in exchange for Tk 20 lakh. Initially,

A high-rise building was built in Debpara Konapara area after cutting huge hills in the months of June-July. This was also reportedly led by Sirul and Salim.

On July 9, they started cutting a hill at Shankarsena village of Ghaznaipur union.

Nabiganj Upazila Assistant Commissioner (Land) Uttam Kumar Das conducted a raid and detained a soil-laden tractor and

However, the two brothers used their influence to get the tractor and driver released later, locals alleged.

Contacted, Salim Mia denied the allegations, saying, "We have no affiliation with hill cutting. Some people are trying to spoil our reputation."

His brother Sirul Mia could not be contacted for comments.

Tofazzal Sohel, general secretary of Bangladesh Poribesh Andolon in Habiganj, said, "Hills are being cut despite the High Court directives. Strict measures have to be taken against the perpetrators."

Uttam Kumar Das said they will write a letter to the DoE to take necessary measures on the

Mohammad Emran Hossain, director of DoE Sylhet, said a team will visit Dinarpur to investigate the matter.

DNCC demolishes two police boxes

Bringing a wind of change

Kurigram youth spends his days spreading education, stopping child marriage

Six years ago, Shyamoli Akhter used to be a playful seventh-grader - who loved studying, playing, and roaming around the village with her head held high.

But her parents didn't approve. They started taking up frantic efforts to marry her off, jeopardising her childhood.

Shyamoli hails from the remote Dharmapur village in Kashipur union of Kurigram's Phulbari upazila, near the Indian border.

"It was a bleak winter morning of 2016 when I found out that my parents finalised my marriage without my consent. There was no way out," she said.

"Just a day before the marriage, a man came to my house as a blessing. He convinced my parents to dismiss the marriage after discussing child marriage's adverse impacts with them for hours," she added.

Shyamoli was eventually able to continue her education. At present, she studies at Kashipur Degree

The man behind saving Shyamoli

is Habibur Rahman, a 25-year-old from Kashipur union, studying law at a university in Rangpur. Habibur has single-handedly

stopped around 300 child marriages in the last nine years, said locals. Apart from this, his activism

also includes counteracting school dropouts and awareness about smuggling.

He is now popularly known as a "Border Volunteer" in the locality. Most residents of Dharmapur

are poor. Because of that, most still don't give much importance to their children's education. distributes also Habibur

notebooks and pens among poor children, free of cost, to encourage them to continue their education. "I was able to send over 700

dropout children back to school," he said. Abdul Jabbar (55), a village resident, said, "Habibur often

homeschools children free of cost." "Student attendance was very low even five years ago but it's gradually increasing, thanks to Habibur's

from the grasp of child marriage role," said Paresh Chandra Sarkar, headteacher of Kashiabari Govt Primary School.

As the village is along the border, there have been many incidents of smuggling in Dharmapur.

"Even children are being used in smuggling. Habibur has been working against smuggling for the last couple of years," added Abdul

Habibur devoted himself to such social and philanthropic activities in 2013, after passing his HSC examination.

"I noticed that people in my area are lagging due to a lack of education. I emphasised teaching children and then gradually shifted my focus to ending child marriage and smuggling," Habibur said.

Habibur also provides tutoring and spends his earnings mostly on conducting social activities.

At present, he has formed a "Youth Forum" at each of the union's nine wards to speed up social activities. Each committee comprises nine youths.

He sought the cooperation of administrations in this regard.
