## **'Vaccines** protect to a great extent'

#### Says DGHS chief, four more deaths recorded

Though vaccines cannot provide complete protection against the coronavirus, they do protect people to a great extent, Prof Abul Bashar Mohammad Khurshid director general of DGHS, said yesterday.

"As many as 70 percent of those who died during the fourth wave of the pandemic had not been vaccinated," he said at an event in the capital.

He added that majority of those who have been recently infected do not require hospitalisation.

Meanwhile, the Directorate General of Health Services reported four Covid-19 deaths and 430 new cases in the 24 hours till 8:00am vesterday. Of the four dead, three were men.

With the latest count, the total number of deaths in the country rose to 29,266 and the total confirmed

So far, around 97 percent of all Covid-19 patients have recovered.

## Pakistan High Commission removes 'objectionable' photo from FB

The removal came a day after the foreign ministry objected the way Pakistan High Commission used the national flags.

"I believe that there is no bad motive behind it... We hope Pakistan High Commission will withdraw it." Foreign Minister AK Abdul Momen said at a press briefing in the ministry vesterday morning.

The Pakistan High Commission removed the photo of the flags from its Facebook after the media published the news of the minister's statement.

On Friday, Bangladesh Freedom Fighters Platform protested the image in which the flags of the two countries were merged.

# Over 1,000 migrants reach Italy in hours

Say NGOs, authorities; five bodies recovered

More than a thousand migrants arrived in Italy within a few hours while hundreds of others, rescued by humanitarian vessels, were waiting for a port to receive them, NGOs and authorities said yesterday.

The influx this year comes as Italy gears up for early elections which could bring the hard right to power.

Between January 1 and July 22, 34,000 people arrived in Italy by sea compared with 25,500 during the same period in 2021 and 10,900 in 2020, Italy's interior

More than 600 people attempting to cross the Mediterranean on board a drifting fishing vessel were rescued on Saturday by a merchant vessel and coastguards off Calabria, at the southern

They were landed in several ports in

The authorities also recovered five bodies of migrants who had died in so far undetermined circumstances.

Somalia, among others, arrived from the late hours of Italian island, the daily said.

After hitting Barek, the biker fled the scene, leaving the bike that he borrowed from another teenager. The Daily Star is withholding the biker's name for legal reasons.

Subsequently, he told the bike owner, Nahidul Islam Nirob, 19, and some other friends about the accident. In the hope of getting back the bike, they contacted the victim's family immediately, offering compensation. They also supported Barek with his treatment at two hospitals.

Nirob and four of his friends made an agreement with Bappi that they would come the following day (March 8) for final settlement regarding compensation for Barek and the return of the bike.

In the meantime, a man known as a Rab informant in the neighbourhood who happens to be an acquaintance of Bappi, told Bappi that he could use his influence to secure the compensation.

#### Macron says Iran nuclear deal 'still possible'

President Emmanuel Macron on Saturday told his Iranian counterpart Ebrahim Raisi that reviving the landmark 2015 deal on Tehran's nuclear capabilities was "still possible" but must happen "as soon as possible".

"expressed his Macron also disappointment" at the absence of progress after the suspension of talks in Vienna and underlined the need for Iran to return to the accord and implement its nuclear commitments, according to a French presidency statement.

The French leader's telephone call with Raisi comes as negotiations in Vienna between Iran and world powers including the United States have stalled since March.

The 2015 deal aimed to prevent

Iran from developing the capability to acquire an atomic bomb in exchange for lifting sanctions that have hobbled its economy. But former president Donald Trump unilaterally withdrew the United States

from the accord in 2018 and reimposed sanctions, leading Tehran to begin rolling back on its commitments. In June, Qatar hosted indirect talks between the United States and Iran in a bid to restart the diplomatic efforts in Vienna, but discussions were

interrupted after two days without a breakthrough. The Iranian presidency said Raisi "condemned the unconstructive positions and actions of the United States and European countries" during his two-hour conversation with

Macron on Saturday

Last week, an Iranian official said Tehran had the technical capacity to make a nuclear bomb but clarified that it had not decided to make any.

The Iranian foreign ministry said there was "no change" in its nuclear policy, referring to an Islamic ruling that forbids "arms of mass destruction".

The man had attended a stag party recently in Manali in Himachal Pradesh, official sources said yesterday, adding that he was admitted to the Maulana Azad Medical College Hospital in New Delhi around three days ago after he showed symptoms of monkeypox.
