# **Govt formally** seeks \$4.5b from IMF

Finance Minister AHM Mustafa Kamal has sent in a formal request to the IMF for a \$4.5 billion loan, putting to bed the speculations on whether the country would be seeking the support from the Washington-based multilateral lender at all.

According to documents seen by The Daily Star, Kamal sought the amount as balance of payment and budget support as well as to mitigate the effects of climate change on Bangladesh.

The loan request was made in a letter to IMF Managing Director Kristalina Georgieva on Sunday.

The development means Bangladesh joins a growing list of countries seeking support packages from the lender to help their recovering economies navigate the fallout of the Ukraine war that has sparked rampant inflation at home.

Earlier this month, the International Monetary Fund agreed to provide Pakistan \$4 billion over the next year and Tanzania \$1.05 billion, while Ghana, one of West Africa's largest economies, has sought \$1.5 billion.

Bangladesh's need for a balance of payment support comes as the spiralling global inflation has left the country with a bloated import bill for more or less the same volume of goods.

Between July last year and May this year, imports stood at \$81.5 billion, up 39 percent from a year earlier, according to data from Bangladesh Bank.

As a result, the current account deficit -- which is the shortfall between the money received by selling products to other countries and the money spent to buy goods and services from other nations -- widened more than six times to \$17.2 billion in the first 11 months of fiscal 2021-22.

This is entirely cost-push, Kamal said in the letter to Georgieva.

At the same time, the inflated import bill means the additional costs were passed on to consumers at home, which caused the inflation to race

In June, inflation hit a nine-month high of 7.56 percent, which took the average inflation for fiscal 2021-22 to 6.15 percent, overshooting the revised annual target of 5.9 percent.

The rampant inflation means a cost of living crunch for the poor and hence the need for budget support from the IMF to maintain economic stability and protect the vulnerable.

Of the \$4.5 billion sought, \$1.5 billion would most likely be interestfree and the remaining amount would come at an interest less than 2 SEE PAGE 2 COL 1

# Think twice before taking up projects

PM issues directives to shore up forex reserves

Prime Minister Sheikh Hasina yesterday issued a host of directives that include stopping nonessential procurement and exercising caution in taking up new development projects.

She also discouraged imports of items and minimising costs in every sector in efforts to keep foreign exchange reserves stable.

Sources in the cabinet said the premier told her cabinet colleagues to stop unnecessary vehicular movement to save fuel consumption.

Chairing the cabinet meeting virtually from the Gono Bhaban, she reiterated the need to ensure proper use of both public and private cars and to take all-out measures to tackle the

ongoing energy and economic crises. Other cabinet members and officials concerned participated from the Cabinet Division at the Secretariat.

Hasina's directives came at a time when the country's foreign currency reserves dropped below \$40 billion, and Bangladesh Petroleum Corporation is finding it difficult to import fuel amid a dollar shortage at local banks.

A cabinet member who was present at the

meeting quoted the PM as saying, "Financially, we are now in a good condition, but we don't know what awaits us. Bad days may come in future. We will all have to be prepared to face

Wishing anonymity, the cabinet member added, "The prime minister also asked us to stop procurement of items that are not required immediately."

She also asked all concerned to exercise caution when taking new development projects, said sources present at the meeting.

The premier also restricted all governmentfunded overseas visits by government officials

#### EVIDENCE ACT AMENDMENT

## Cabinet gives the final nod

The Cabinet Division yesterday gave the final approval to the draft of Evidence (Amendment) Act, 2022, which will allow electronic records and digital data to be admissible

The proposed amendment will now be placed in parliament and once passed, it will give both the prosecution and defence the opportunity to produce digital evidence before the court. Such evidence is not taken into cognisance at present.

Welcoming the move, legal experts, however, warned of its abuse.

"Digital evidence cannot be used to prove an accused innocent or guilty as the existing act does not permit it. So this is a positive move. But there needs to be a transparent method in procuring evidence. Otherwise, there remains a chance of its abuse," said Barrister Jyotirmoy Barua, a human rights lawyer.

As per the amendment, digital record or electronic record means any record or information generated, prepared, sent, received or stored in magnetic, electromagnetic, optical or micro films, computer memory, computer-generated microfiche including audio, video, DVD, CCTV footage, drone data and records from cell phone, hardware, software or any other digital device as defined in Digital Security Act, 2018.

### **FALSE CASE** Natore court asks 3 cops to explain

Allegations have been raised against three police officers of filing a narcotics case against two persons who admitted robbing a rickshaw-van puller.

A local court has asked the police officers to appear before it on Thursday and submit explanations about their conducts. Senior Judicial Magistrate Abu Sayeed came up with the order on Saturday.

The police in question -- Mahabur Rahman, Md Zahid Hossain and Md Akhtaruzzaman are sub-inspectors of Gurdaspur Police Station.

According to the accused robbers' court depositions, the two intercepted the rickshaw-van puller, beat him up and took away the van at Gurdaspur upazila's Moddhompara area on
