Prime Minister Sheikh Hasina is likely to visit Japan this year as the two countries want to further strengthen relations

"Our prime minister has been invited. It will be a priority visit," State

Minister for Foreign Affairs Md Shahriar Alam told reporters on Sunday after his meeting with Honda Taro, parliamentary vice-minister for foreign affairs of Japan.

The state minister said the visit would take place at a time convenient to the both sides. He termed the Bangladesh-Japan relations "very deep and comprehensive".

The two sides discussed ways to strengthen political and economic relations, with continued support from Japan to Bangladesh in the post-LDC era.

They also discussed ways to expedite Rohingya repatriation efforts and cooperation on mega projects.

The Japanese parliamentary vice-minister termed his meetings with Prime Minister Sheikh Hasina and Foreign Minister AK Abdul Momen fruitful and meaningful.

Over Tk 86,811cr lost to floods

More than 28 lakh people in 18 districts affected

The recent devastating floods in 18 north and northeastern districts caused damages worth over Tk 86,811 crore, State Minister for Disaster Management and Relief Enamur Rahman said yesterday.

The deluge claimed 12 lives and injured 2,880 people. Over 28 lakh people were affected by the floods, he added.

The state minister was speaking at a press conference at the secretariat after an inter-ministerial meeting, organised to discuss flood damages and what to do in this regard.

The floods were triggered by torrential rains beginning in the second week of May.

Enamur said the deluge completely about Tk 4,442 crore. damaged crops worth Tk 1258.53 crore and partially damaged crops worth Tk 55957.21 crore.

Besides, damages caused to fully destroyed houses was worth Tk 368.84 crore, while the figure for partially damaged houses was over Tk 1,355.03 crore, he added.

He said the flood completely destroyed 229 bridges, 664km concrete roads, 315km brick roads, 721km dirt roads and 169km stretches of embankments, which financial damages of which amounted to around Tk 240.65 crore.

A total of 1,496 bridges, 1,886 km concrete roads, 676 km brick roads, 6,085 km dirt roads, and 2,882 km stretches of embankments were party and 8,000 bundles of corrugated iron damage, causing financial losses of sheets for the flood victims.

The damages to schools, colleges, madrasas, mosques, and temples were estimated at Tk 68.83 crore.

Heavy rains in the bordering Indian states of Meghalaya and Assam and onrush of water from the upstream aggravated the flood situation, the state minister said.

"The Surma was flowing above the danger mark from May 13 due to torrential rains and onrush of water from upstream, causing floods in Sylhet, Sunamganj and their adjacent areas."

Poor in India can dream Droupadi Murmu says

after taking oath as 15th president of the country

India's first president from marginalised Santal community, Droupadi Murmu, said yesterday after

being sworn in that her election was an "achievement of every poor person in the country".

Murmu's elevation to India's highest constitutional post has been seen as an important gesture of goodwill by Prime Minister Narendra Modi to the communities that make up more than 8% of its 1.4 billion people ahead of a general election due by 2024.

Murmu, a former teacher and state minister from Modi's Bharatiya Janata Party (BJP), was born into a poor family of the Santal community from the eastern state of Odisha.

She is the 15th president of India and the second woman head of state after Pratibha Patil. Murmu succeeds Ram Nath Kovind whose five-yearterm ended on July 24.

Members of parliament and of state legislatures elected Murmu last week for a five-year term after she was

5 Covid patients die, positivity rate 7.84%

Five Covid-19 patients died in the 24 hours till 8:00am yesterday, up from four fatalities the previous day.

The number of new cases during that period also increased to 548 from 430 the previous day, according to the Directorate General of Health Services (DGHS)

Against a total of 6,987 samples tested countrywide, the positivity rate was 7.84 percent, whereas it was 7.04 percent the previous day.

With the latest counts, 29,271 Covid patients have died in the country since the first death was reported on March 18, 2020, and a total of 20,02,323 people have tested positive.

At least 1,277 patients have recovered from Covid during the 24-hour period. The total number of recoveries now stands at 19,37,240 and the recovery rate at 96.75 percent, said DGHS.

Private producer to set up 3MW hybrid power plant

The government has signed a contract with a private company to set up a 3 MW hybrid power plant -- a combination of solar, battery and dieselrun generator -- at southern Monpura Island in the Bay of Bengal.

As per the contract signed on Monday, Western Monpura Solar Power Limited (WMSPL) will set up the power plant from which the state-owned West Zone Power Distribution Company Limited (WZPDC) will purchase electricity over the period of 20 years.

The power will be supplied to consumers in Monpura, an island of about 77,000 inhabitants living in an area of 373 square km in Bhola.

Nirodh Chandra Mondal, joint secretary of the Power Division, Md Alamgir Kabir, secretary of the WZPDC, and Bashir Ahmed, managing director of the WMSPL, signed the implementation agreement and power purchase agreement on behalf of the res ective si capital's Biduyt Bhaban.

footprints, signatures and certificates will also be admissible as evidence before a court.

After yesterday's cabinet meeting, held virtually and chaired by Prime Minister Sheikh Hasina, who joined it from the Gono Bhaban, Cabinet Secretary Khandker Anwarul Islam said, "Since the digital [virtual] court has been given recognition, it was felt that there should be some amendments to the [evidence] act.

"Data along with information can be used as evidence [under the amended law].'

The instruction has been issued to incorporate both "information" and "data" in the Evidence Act. he told journalists in his briefing.

Another amendment is brought to section 146 (3) of Evidence Act, 1872 that deals with raising questions over the character of a witness or victim.

"There is a tendency of raising

questions about a victim's character through obnoxious questions. Restriction has been imposed on it. No such question can be asked straightway without the permission of a court," said Anwarul Islam.

If it is completely repealed, bad people will take advantage, he added. On March 14, the Cabinet approved the draft in principle. At that time, the cabinet secretary said the amendment had been brought to eliminate future legal complications over the trials held virtually during the Covid pandemic.

Barrister Jyotirmoy said they had long been demanding inclusion of digital evidence in the act.

Citing the example Bangabandhu murder case, he said there was video evidence of murderers but it could not be used against them. The amendment will benefit both

the prosecution and defence but there remains concern over the handling of

digital evidence.

Recently, he said, there has been a trend that a Facebook account of a person is hacked or a fake account is created to write status demeaning religion, leading to communal violence. Afterwards, an innocent gets framed for inciting the violence but those who are behind it remain scot free.

This can be an example of how digital evidence can be abused, explained the lawyer.

The Cabinet vesterday adopted a condolence motion on the demise of slain former Japanese prime minister Shinzo Abe.

Sheikh Hasina recalled Abe's role in several mega projects of Bangladesh.
