Forex reserves enough for 6-9 months' food import: PM

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said Bangladesh would be able to meet six to nine months' food import expenditures with its current forex reserves.

"We have money in our hands to import food grains and other [essentials] items for at least three months during any crisis. With our current reserve, we'll be able to import food not for only three months, but for six to nine months," she said.

The premier was addressing the 28th founding anniversary programme of Bangladesh Awami Swechchhasebak League at the capital's Krishibid Institution Bangladesh auditorium. She joined the event virtually from the Gono Bhaban.

Swechchhasebak League, an associate body and the volunteer wing of the ruling Awami League, was founded on July 27,

Bangladesh's population growth rate has slowed over the past four decades, a decline that experts attribute to massive family planning campaigns and the country's socio-economic advancement.

The growth rate came down to 1.22 percent from 1.46 percent in 2011, according to the preliminary report of the Population and Housing Census chairman 2022. The rate was 2.84 percent when of the second census was conducted in Department

About the decline, officials and experts say Bangladesh is getting the dividends of efforts from the government and non-government organisations to control population boom.

Besides, women empowerment, rational decision-making, rising education levels, especially among women, are the reasons for which the country's population dynamism is in the right direction as revealed in the preliminary report.

to chalk out an appropriate policy. Echoing Islam's views, Dr Ubaidur Rob, country director of Population Council, said the use of contraceptive was crucial in reducing the growth rate, and the country is gradually heading towards population stabilisation when the growth rate will be zero.

"Population growth rate is and death rate will increase and at one point the growth rate will be zero. It is expected that the population will stabilise by 2050," he said.

The population growth rate means annual average percentage change of population size, for a given country, territory, or geographic area. It is the highest in Dhaka among all

the divisions with 1.74 percent while the lowest in Barishal division with 0.79 percent. In the last 11 years, the country's

population has grown by 2.1 crore and the population rose to 16.51 crore, excluding the expatriates.

Bangladesh Bureau of Statistics (BBS) released the primary report of its first digital census at the Bangabandhu International Conference Centre in the capital. Dildar Hossain, project director of the BBS, highlighted various aspects of the report.

Apart from this, the country witnessed another major demographic shift with females outnumbering males for the first time.

Of the population of around 16.5 crore recorded in the latest census, 81,712,824 are males and 83,347,206 females -- which means for every 100

THAKURGAON POLLS VIOLENCE

Infant 'hit by bullet', dies in mother's lap

A one-year-old-girl died after being hit by what locals said was a stray bullet fired by police amid post-polls violence in Ranisankail upazila of Thakurgaon last evening.

Several hundred villagers demonstrated in front of Ranisankail Police Station until late last night demanding

But Additional DIG Walid Hossain of Rangpur range police said the cause of death would be investigated because she might also have been hit by a brick chip thrown by the villagers.

Upazila Vice-Chairman Sohel Rana said he heard that a woman holding her baby was standing near the polling centre at Bhangbari VF Junior High School when the supporters of a defeated union parishad chairman attacked election officials and police around 6:00pm.

As police used firearms to disperse the locals, the baby got hit by a bullet in the head and died at the scene, he added.

Several other villagers told The Daily Star that a stray bullet fired by police had hit the infant.

The girl, Asha, was the daughter of farm worker Mohammad Badsha who is a resident of Mirdangi village, said Upazila Nirbahi Officer (UNO) Sohel Sultan Zulkar Nain Kabir.

The UNO said the supporters of a defeated candidate in the election to Bachor Union Parishad started demonstrating as soon as the result was announced in the afternoon, claiming that the election was rigged.

After the election officers managed to leave the polling station with the electoral materials, the locals attacked police deployed in the area, he added. Police then used two tear gas shells and fired four blank

No worries over fuel stock

Says BPC chairman

Bangladesh Petroleum Corporation yesterday said the government has a fuel import plan for the next six months and that there is no problem with the import, storage and BPC Chairman ABM Azad said the country has 4.31

lakh tonnes of diesel, which is enough to meet 32 days' worth of demand, and the current stock of petrol (21,883 tonnes) is enough for 15 days. Even if the government stops importing fuel, the

current stock of octane (12,238 tonnes) is enough for nine days, furnace oil (85,041 tonnes) for 32 days, and jet fuel (62,891 tonnes) for 44 days, he told a press conference at BPC's Dhaka Liaison Office. "This does not mean that the BPC will stop importing

from tomorrow. Import, storage and supply is a cyclical process. At present, the stock of octane is for nine days. Within a couple of days, a ship carrying 30,000 tonnes of octane will reach Bangladesh. Then, the stock of octane will rise to 28 days. It's an ongoing process," he said.

According to the energy and mineral resources division, the daily demand is 13,607 tonnes for diesel, 1,300 tonnes SEE PAGE 2 COL 1

Kyiv moves closer to grain exports

Coordination centre to oversee UN-backed deal opens in Istanbul

Ukraine said yesterday it had restarted operations at its blockaded Black Sea ports as it moved closer to resuming grain exports with the opening of a coordination centre to oversee a UNbacked deal.

Progress towards fulfilling the landmark agreement came as Kyiv's artillery struck a key bridge in Moscow-controlled territory in south Ukraine, damaging an important supply route as Ukrainian forces look to wrest back the Kherson region.

German authorities said Russia's state giant Gazprom drastically cut gas deliveries to Europe via the Nord Stream pipeline to about 20 percent of capacity in a move decried in the EU as revenge for Western sanctions over the invasion.

Ukraine and Russia last week agreed a plan with the help of Turkey and the United Nations to allow grain stranded by Moscow's naval blockade to be exported from three ports.

BARAPUKURIA MINE Coal production resumes after three months

Production at Barapukuria Coal Mining Company Limited (BCMCL) resumed yesterday after three months. The authorities suspended coal production on April 30 for

development work. Officials hope that coal produced at the mine will be a relief for the 525MW Barapukuria Coal-Fired Power Plant, which has been facing a

shortage of coal. Saiful Islam Sarkar, the new managing director of Barapukuria Coal Mining Company Limited, said production would continue for the

next seven days on a trial basis. Production would bump up after a week, he said, adding that all of the coal would be supplied to the power plant.

Around 2.5 lakh tonnes of coal were at the stockvard when production was suspended. The stock came down to just 60,000 tonnes at the beginning of this month as the power plant has been regularly

taking coal from the stockyard. As coal production was supposed to resume at the end of August, the power every day, would have run out of coal.

ROAD CRASH ON HIGHWAYS

Transport leaders for curbs on bikes

Transport leaders yesterday called for restrictions on motorbike operations on highways in a bid to reduce the number of road crashes - a major concern over the past years.

Shajahan Khan and Mashiur Rahman Ranga, two top transport leaders, briefed reporters after a meeting at the Secretariat

However, the taskforce, led by Home Minister Asaduzzaman Khan Kamal, did not take a final decision in this regard, meeting sources said.

The taskforce was formed in October 2019 to implement 111 recommendations, given by a committee led by Shajahan Khan, to curb road crashes and bring discipline in the road transport sector.

Yesterday's was the taskforce's fifth meeting. The proposal came at a time when

authorities, citing safety concerns, are taking stricter steps against bike operations.

The Bangladesh Bridge Authority earlier banned bikes on Padma Bridge.

Moreover, bike movement on highways were restricted for a week (from July 7 to July 13), aiming to ensure road safety during the Eid rush.

Besides, a government probe committee has recently recommended banning bikes sharp rise in accidents involving bikes them.

ahead of this year's Eid-ul-Fitr.

For the lack of public services and rise in bus fares, many people resorted to using two-wheelers to go home ahead of Eid. But the huge number of bikes caused more accidents, different road safety organisations said.

More than 35 lakh bikes have been registered with Bangladesh Road Transport Authority so far. But many unregistered bikes still operate unchecked across the country.

Many bike riders and users alleged that the decision was taken due to pressure from the bus owners.

After yesterday's meeting, Shajahan Khan, president of Bangladesh Road Transport Workers' Federation, said motorcycles account for around 40 percent of road accidents in the country.

Shajahan, also a lawmaker of ruling Awami League, said ride-sharing services by bikes are also dangerous.

The number of fatal road accidents will come down if we control motorcycle [movement].'

Contacted, Ranga, president of Bangladesh Road Transport Owners' Association and also a Jatiya party lawmaker, said he has pressed for the nonoperation of ride-sharing bikes on inter-

About how ride-sharing service bikes would be recognised, he suggested having separate number plates and licences for

However, at least three participants of the meeting said although they have talked about ride-sharing services by bikes and recent accidents, no concrete decision against bike movement was taken.

Meanwhile, ABM Amin Ullah Nuri, secretary of the Road Transport and Highway Division, said the meeting decided to fix an economic lifeline of commercial vehicles to ensure safety and scrap those after expiry.

Another participant said the meeting mulled over fixing a 20-year lifeline for buses and 25 years for trucks.

"However the decision would become a government order after Buet experts give their opinions regarding it and a guideline is finalised in this regard."

Meanwhile, prominent road safety campaigner Ilias Kanchan, also a member of the taskforce, said the transport leaders often dominate the meeting and talk about their own issues, which are discussed all the time.

He said he and two other Buet experts were asked to join the meeting virtually, while transport leaders were allowed to join in person.

The meeting discussed several decisions taken previously, including taking action against illegal driving schools, giving appointment letters to transport workers, and increasing the number of centres for conducting done tests before professional driving licences.

Pair of new studies point to natural Covid origin

An animal market in China's Wuhan really was the epicenter of the Covid pandemic, according to a pair of new studies in the journal Science published Tuesday that claimed to have tipped the balance in the debate about the virus' origins.

Answering the question of whether the disease spilled over naturally from animals to humans, or was the result of a lab accident, is viewed as vital to averting the next pandemic and saving millions

The first paper analyzed the geographic pattern of Covid cases in the outbreak's first month, December 2019, showing the first cases were tightly clustered around Wuhan's Huanar Seafood Wholesale Market.

Mahr or denmohor is important in a scenario where women still do not get paternal property,

"We need a uniform family law for all religions and women, which governs marital and inheritance rights as well as rights that ensure self-guardianship, regardless of religion," said Dr Debapriya Bhattacharya, eminent economist at Centre for Policy Dialogue.

"If a woman does not have other rights, she will never be able to realise the right to mahr," said Dr Bhattacharya.

The women do not have any control over this dowry," said Dr Huda.

Women have to wait for years on end for courts to settle mahr related cases before they can get the amount they are entitled to, said Dr Abdullah Al Faruque, law professor at Dhaka Universitty.

"The arbitration council should be empowered to deal with mahr related cases," Dr Abdullah said, adding that village arbitrations usually award women less money than formal

Speakers also said that the time limit for filing dowry related cases should be withdrawn as soon as possible.

"While I recognise that many women need mahr to restart their lives after divorce, I dream of a day when equality exists and women do not need mahr," said Shaheen Anam, executive director of Manusher Jonno Foundation, at the discussion.

Fazlul Haque, who heads Madaripur Legal Aid Association, also spoke at the event as a special guest, among others.

HC dismisses petition seeking Odhikar's registration

STAFF CORRESPONDENT

The High Court yesterday dismissed a petition filed by non-governmental organisation "Odhikar" challenging the legality of the government's decision of not renewing its registration.

The NGO Affairs Bureau on June 5 cancelled Odhikar's registration, which expired in March 2015, saying that the organisation published misleading information about various extrajudicial killings, alleged disappearances and murders, which have severely tarnished Bangladesh's global image.

Odhikar is reportedly one of the few organisations that have routinely logged cases of enforced disappearances and published quarterly and annual reports detailing the incidents. They also support and mobilise the families of enforced disappearance victims.

Yesterday, the HC bench of Justice Md Khairuzzaman and Justice Md Iqbal Kabir Lytton delivered the verdict after Odhikar's lawyer Ruhul Amin Bhuiyan said his client will not proceed with the petition as it has submitted an appeal to the office of the secretary concerned of the PMO.

Replying to a query, the lawyer said there is no legal bar for Odhikar to run its functions as a volunteer

Contacted, Deputy Attorney General Kazi Mynul Hassan said Odhikar has no registration, and so it cannot run functions from now on.

However, Odhikar's lawyer Ruhul Amin Bhuiyan said the DAG's comment is not right as Odhikar needs registration only for foreign donation.

Odhikar, established in October, 1994, applied to the DG of the NGO Affairs Bureau on September 25, 2014 for the renewal of its registration.

As the Bureau kept the application pending, the organisation filed the petition with the HC in 2019.

The HC on May 13 of that year, issued a rule questioning the inaction of the NGO Affairs Bureau.

Increase capacity of labour wings at foreign missions Speakers urge govt

Labour welfare wings at different foreign missions need to be more friendly and sensitive towards migrant workers while providing services to them, speakers said at a workshop yesterday.

They said besides strengthening the capacity of the existing 29 labour attaches, more such wings have to be established. The experts also called for digitising the services of the labour attaches to reach out to a greater number of migrant workers.

The workshop titled "Migrants Friendly Consular Services" was organised by Warbe Development Foundation in collaboration with International Labour Organisation (ILO) at Probashi Kalyan Bhaban.

"There have been allegations that migrant workers do not get adequate service at the labour welfare wings," said Warbe Chairman Syed Saiful

"Considering such issues, a set of tools has been incorporated in the manual aiming to ensure

better services to migrant workers, " he added. Riaz Uddin Khan, an independent consultant on migration, said while migrant workers' contribution is immense in the country's economic progress, it is often heard that they do not get required services





Right policies to tackle crisis vital

Speakers tell webinar on poverty induced by Russia-Ukraine war

STAFF CORRESPONDENT

With global food and fertiliser prices alarmingly high already, the government must come up with policy responses to offset the increase in poverty stemming from the Russia-Ukraine war, said policy researchers in a webinar organised by Bangladesh Institute of Development Studies (BIDS) yesterday.

Speakers said global food, fuel, and fertiliser prices have risen rapidly in recent months, largely driven by the fallout from the ongoing war in Ukraine and the sanctions imposed on Russia.

Other factors, such as export bans, have also contributed to rising prices. Palm oil and wheat prices increased, respectively, by 56 and 100 percent in real terms between June 2021 and April 2022.

Pakistan in new crisis after top court's ruling

SC invalidates PM son's victory in Punjab, hands power to Khan's ally **AGENCIES**

Pakistan's top court has ruled to hand control of the country's most populous province, Punjab, to a candidate backed by ousted Prime Minister Imran Khan, triggering fresh political uncertainty in the South Asian nation amidst a crippling economic crisis.

The move ramps up pressure on the federal government, made up of a coalition of parties that ousted Khan from premiership in April, as it attempts to implement tough, and unpopular, economic reforms to stave off a financial

In a short order, Pakistan's Supreme Court ruled that a Khan-backed candidate for Punjab's chief minister, Chaudhry Parvez Elahi, had been wrongfully denied victory in a vote last week, and ordered he be installed as the province's premier before midnight on Tuesday. He replaces Hamza

Shahbaz of PML-N. Pakistan's President Dr Arif

administered the oath to Elahi in Islamabad. Elahi had to rush from Lahore to the federal capital after Punjab Governor Balighur Rehman refused to carry out the job.



Elahi had been denied victory by the speaker of the Punjab assembly, who disregarded votes cast in his favour on the basis of them being against party line and handed victory to the candidate of the ruling coalition.

The court overturned the speaker's decision.

Meanwhile, Pakistan's Interior Minister Rana Sanaullah yesterday warned of imposing governor's rule in Punjab if he was restricted from entering the province, reported Dawn.

The development gives Khan's campaign for fresh elections a shot in the arm. The ousted premier has been holding protests across the country for snap general elections, which are not due until late next year.

The tug of war between Khan and his opponents has already weighed heavily on the economy of the nuclear powered nation of 220 million, which is in the middle of a tough IMF programme.

Pakistan is struggling with falling foreign exchange reserves, a widening current account deficit and a sharply depreciating currency.

Adding to the uncertainty, the decision may lead to a standoff between the government and judiciary.

Strong quake hits Philippines

Four killed, dozens injured; nearly 300 aftershocks recorded

A 7.0-magnitude earthquake killed at least four people in the northern Philippines yesterday, toppling buildings, and shaking high-rise towers more than 300 kilometres away in the capital Manila.

The shallow but powerful quake struck the mountainous and lightly populated province of Abra on the main island of Luzon at 8:43 am, the US Geological Survey said.

Shallow earthquakes tend to

ones. This one left more than a hundred people injured across the hilly region, triggered dozens of landslides, damaged buildings, and knocked out power.

In Vigan City, a UNESCO World Heritage site in the province of Ilocos Sur, centuries-old structures built during the Spanish colonial period were damaged, police said.

Yesterday's quake was one of the strongest recorded in the Philippines in years and was felt across swathes

Fear of autocracy as Tunisia votes 'yes'

A new Tunisian constitution giving far more power to President Kais Saied passed in a referendum with a 30.5 percent turnout, the electoral commission said, tightening his grip in what critics fear is a march to a new era of autocracy.

The commission said 95 percent of voters approved the constitution in Monday's referendum boycotted by opposition groups, which accuse Saied of staging a coup against the young democracy that emerged from Tunisia's Arab Spring uprising of 2011.

Opposition groups, which have struggled to counter Saied since he began amassing power a year ago, accused the authorities of inflating the numbers and said they still recognised the 2014 constitution as the legitimate one.

The new constitution includes changes that shift power back to the presidency and away from

parliament which - to Saied's supporters had become synonymous with political

bickering and government paralysis. Saied has denied accusations that he is a new dictator, and says freedoms won in 2011 are protected.

Even though the vote was for a permanent change to the constitution, the rules set by Saied did not require a minimum turnout for it to be approved.

The main opposition alliance said the official results were "false and not credible".

US State Department spokesperson Ned Price said Washington noted widespread concerns that the constitution was not written in an inclusive way and that it weakened checks and balances and could compromise human rights.

His initial moves against the parliament a year ago appeared hugely popular with Tunisians, as thousands flooded the streets to support him, but with little progress in addressing dire economic problems, that support may have waned.

"We are firmly opposed to (US House) Speaker Pelosi's visit to Taiwan. If the US pushes ahead and challenges China's bottom line... the US side

will bear all the consequences."

Don't allow criminals to milk the banking sector

Authorities must take stern action to stop scams and frauds

T'S unfortunate that at a time when we should err on the side of caution and restraint – rather than of excess – in ▲ financial matters given the country's economic crisis, the opposite is happening. A combination of factors including bad decisions, poor regulation and absent accountability for the wrong-doers continue to plague us. The High Court on Tuesday made a succinct observation that should be taken seriously: that the "most serious crimes" are being committed in the banking sector. How can our economy get out of the current mess if we don't stop this procession of scams and

The court's observation comes on the heels of the exposure of another scam in which a firm named SB Exim, using forged documents in the name of exporting terracotta tiles, allegedly swindled Tk 200 crore from Bangladesh Commerce Bank Ltd (BCBL) in 2018. That wasn't the end of it, however. BCBL, in response, created a loan against the payments made to the borrower as it hadn't received the money from foreign banks. Subsequently, the loan defaulted, leading to BCBL rescheduling it without informing Bangladesh Bank. Then, in a shocking move, the central bank permitted rescheduling the defaulted loan in violation of its own rules. It's like a crime cycle that begins and ends with bad decisions, with the public the main sources of funds for lenders – caught in the middle.

Such scams are taking place quite regularly, thanks to lack of good governance and legal action for the criminals and their enablers. Our memories of scams involving BASIC Bank, Hallmark Group, Farmers Bank, Reliance Finance Ltd, International Leasing and Financial Services, People's Leasing and Financial Services and other institutions are still fresh. Many billions of taka were thus looted. But hardly anything happened to the nexus of politicians, bankers and business magnets that took advantage of our fragile regulatory

The government's role in all this is quite disquieting: Not only has it not taken exemplary action against these "financial thugs", to quote an earlier HC observation, the central bank has even appeared to harbour defaulted borrowers, relaxing rules on loan classifications and rescheduling and thereby helping the industry camouflage scams. Reportedly, bad loans totalled Tk 113,441 crore in March this year, just shy of the record high of Tk 116,288 crore totalled in September 2019.

A vested quarter is clearly at work trying to cripple our economy, laundering money through under-invoicing and over-invoicing in the name of exports/imports. Had the laundering been tackled, our foreign exchange reserves would have been in a better shape today. Besides the financial regulators, the Anti-Corruption Commission and the cumbersome judicial process are also responsible for the continuation of this situation and the culture of impunity enjoyed by criminals. We urge the government and the judiciary to take strong measures to stop financial irregularities.

T is inconceivable that despite calls by the prime minister for government employees to observe austerity Linvolving foreign exchange such as public projects and foreign trips, some are ignoring the directive. According to a report by The Daily Star, as many as 39 officials of the civil aviation ministry and the Civil Aviation Authority of Bangladesh (CAAB) made over 50 foreign trips during the 2021-22 fiscal year, which cost around Tk 1.5 crore. Earlier, in mid-July, we were surprised to learn of foreign trips made by officials of the Chattogram Water Supply and Sewerage Authority (CWASA), including its managing director, as part of a project that had over 80 percent of its physical work already completed.

It should be mentioned that the government banned nonmandatory official tours to ensure the best use of scarce resources amid the ongoing economic crisis. According to our report on aviation employees, the list of officials who went on trips included the civil aviation secretary and CAAB chairman. Reportedly, these officials went abroad despite there being no urgency, but merely to attend seminars, conferences, and workshops, and even to enjoy air-shows or product demonstrations. In case of CWASA, the purpose apparently was to train and inspect some factories. In other words, those were simply pleasure trips, undertaken at a time of national crisis, using public money that should have been saved for

The question is: How will the "experience" thus gained help the work or sectors of relevant public officials? In the wake of the financial crisis stemming from the pandemic, the government had ordered all routine foreign tours to be abandoned, except for those involving emergencies. On July 1 last year, the finance ministry issued a circular on this, suspending 50 percent allocation for tours, saying the money can only be spent for unavoidable purposes. We see neither "emergency" nor "unavoidable purposes" in these recent tours. The CAAB chairman remains ahead of all other aviation officials when it comes to foreign trips. After him comes the secretary of civil aviation. And lo and behold, even the personal secretary of the state minister for civil aviation visited a country to attend a

This is totally unacceptable. We urge the higher authorities to strictly monitor the activities of all government agencies to ensure compliance with the travel restrictions. Public officials also should use better judgment before making such decisions or using hard-earned taxpayers' money to ensure it only serves public interests, and not anyone else's.

'We can't afford any further depletion of our reserves'

Ahsan H Mansur, executive director of the Policy Research Institute, talks about Bangladesh's current economic crisis and related solutions in an interview with Eresh Omar Jamal of The Daily Star.

There has been a sudden increase from different development partners in the price of the dollar recently. In reaction to that, some experts have criticised the central bank's policy of trying to artificially keep the taka's price high against the dollar. Do you think that criticism is justified?

The central bank did two things. It intervened significantly in the exchange rate market by selling USD 8 billion in the last one year. This intervention didn't work and resulted in a significant reserve loss. What the global experience tells us is that market intervention works to smoothen things out, but it cannot stop

fundamentally driven market trends. The market trend in weeks recent that showed the taka would depreciate against the US dollar that cannot be stopped. But if on a particular day there is a shortage dollars and price is rising, an intervention be used to smoothen things out.

But what we've had continued largeinterventions,

which have led to a reserve loss of USD 8 billion. In the face of strong and unending market pressure, the Bangladesh Bank (BB) has now let the exchange rate float, as it could not afford any further reserve loss.

Aside from that, the BB staff are calling the banks and verbally asking them to fix their dollar rate at around Tk 94. But no private transactions are happening at this rate in the interbank market – the only transactions in the interbank market that are happening are when the BB gives dollars for public sector imports - for example, to import oil or gas. I learned that we are importing oil at the rates of Tk 97, Tk 98 or Tk 100 – because the interbank exchange rate set by BB is completely ineffective. Since the BB authorities no longer want to spend more dollars, which is the right policy stance, they can no longer intervene in the market directly, but they are intervening verbally. Because of that, the interbank market has become completely dysfunctional.

What is happening as a result is that, if someone sends remittance through the official channel, they will get around Tk 93 for USD 1. But if they send it through hundi, they will get around Tk 110. So, remittance through the official channel has decreased. Obviously, this policy is not working and needs to change. The interbank rate should be brought closer to the market rate, so that the difference is not more than Tk 2.

USD 40 billion. But, in reality, according to the IMF's definition of reserves, Bangladesh has USD 8 billion less than the official number. The reason behind that is that USD 7 billion has been allocated to the Export Development Fund (EDF) and is being used by Bangladeshi exporters. Another USD 450-500 million is locked up in the Green Transformation Fund, and around USD 250 million has been given to Sri Lanka, which is unavailable for now.

What we have right now will allow us to import merchandise and services for about four months. Since having reserves that can pay for imports for three months or less is considered to be critical, what we have right now is above the bare minimum. It is below a comfortable level, but it's okav. However, because the direction is also negative, it's concerning.

Even the new BB governor, on his first day at the job, said we need to think about how to increase our forex reserves. We cannot afford any further depletion of our reserves, because

we will need to keep importing and imports will be naturally increasing growing economy.

Another issue is the high trade imbalance we had in the last fiscal amounting around USD 33 billion, while the current deficit account amounted to almost USD 17-18 billion, which we borrowed to cover the financing gap. If we cannot address such a high current account

deficit and trade imbalance, then our reserves will continue to deplete. So, we have to work urgently on correcting the imbalance in our balance of

The government's debt service is still at an acceptable level this year. The debt obligation for many of the big projects – Roopur Nuclear Power Plant, Karnaphuli Tunnel, the Padma Railway Bridge - will come due around 2024. In the future, that will exert some

pressures to absorb some of the additional debt service pressure.

There will, however, be problems on the budget management side. The sudden depreciation of the taka against the dollar will increase our public sector debt by Tk 1.8 lakh crore, to Tk 7.7 lakh crore, and there will be corresponding increase in the total debt servicing cost in taka terms. Managing the taka amount will be a major challenge given the very low revenue-to-GDP ratio of only 9.5 percent. Private sector debt will also increase by Tk 65,000 crore to Tk 2.75 lakh crore, which will be a major problem for our corporate sector, since this debt would need to be repaid within a few years or would need to be rolled over in the next one to three years. The rollover risk may emerge as a major challenge for private debts if foreign creditors become risk-averse and recall their money upon maturity.

How can the government contain imports?

There are three policies the government can use. One is by adjusting the exchange rate, so that imports become expensive. The second is to use monetary policy - by increasing the interest rate - to bring down our overall credit demand. This would again bring down aggregate demand. Almost every central bank in the world is increasing its interest rates to tighten credit, bring down demand, reduce imports, and lower prices. But Bangladesh cannot do the same if our interest rates are stuck at nine percent and six percent. During the pandemic, it was fixed at nine percent, keeping in line with the market fundamentals at that time. Though the situation is different now, the government has not changed its policy accordingly.

Thirdly, the government can use fiscal policy. Here it has taken some good decisions, like cancelling foreign trips of its officials, etc. But it still has to pay vast amounts of subsidies for

want long-term growth. For that, we need to create a stable environment. That's why we need to focus on restoring macro-economic stability.

Since the next parliamentary election is due next year, could the government be politically motivated not to sacrifice shortterm growth?

I would say that political motivation should encourage the government to make the necessary changes right now. Because if it delays, things could blow up right before the election.

Some have suggested that our banking sector, which has been hit by one scam after another, and has been plagued by corruption and regulatory failures, is now a house of cards. What are your thoughts

Our financial sector is very weak and underdeveloped. Its size, in comparison to India, China and even other East Asian countries, is very small. It has many problems as well. And it's because of these problems that it is not growing.

When we evaluate the sustainability of a country's forex reserves, we look at two things: a) The adequacy of the reserve level; and b) its direction. In Bangladesh's case, the direction is obviously a big concern. We have already sustained a reserve loss of USD 8 billion. So there is a significant declining trend, despite the

loans till December last year amounted to USD 92 billion: public and publicly guaranteed loans were nearly USD 70 billion, and non-government loans around USD 22 billion. The latter already increased to more than USD 25 billion by this June, and USD 15 billion of that is short-term, which needs to be repaid in one year. That can also create some pressure on the reserves if the private sector cannot roll over USD 15 billion of loans. Even if they are non-government loans, they are ultimately to be paid out of our total forex availability, and ultimately, it's

pressure, but will still be manageable.

Government and non-government

Eminent economist Debapriya Bhattacharya recently said that Banaladesh's debt situation may become tricky from 2024-25. How well-positioned are we to repay our loans that are soon to come due?

currency for this repayment.

He was referring to the government debt, and the debt servicing required for the megaprojects. I think we should be able to handle such payments, if we don't have any problem with rolling over the private sector debt, and our exports and remittances perform relatively well. The issue is that we need to contain our import growth at healthy rates. We need to bring down import growth to 15-20 percent over the medium term. If we can do that, we shouldn't have much problem, as we will be able to use higher foreign exchange inflows and contain import fuel, gas, fertilisers, etc. Since most of these price-controlled products are imported and paid for in US dollars, the cost of these products will significantly increase in taka terms. The government has allocated Tk 82,000 crore as subsidies in FY2022-23 budget, but the amount can easily rise beyond Tk 1 lakh crore, only because of the recent exchange rate depreciation.

The government may be hoping that since Western countries are increasing their interest rates and are likely to continue increasing their policy rates further, that may lead to a global recession, which would slow down the economies, leading to falling commodity prices. As a result, we may not have to make any adjustments. Whether that presumption works out or not, I don't know.

But wouldn't our GDP growth be affected if the government adjusts the interest rate to slow down inflation?

Of course, it would. The purpose of adjusting the inflation rate would be to slow down growth. But this year is not the year for economic growth; but for macro-economic consolidation restoring balance to our balance of payments, stabilising the exchange rate, bringing down inflation, and addressing other macro-imbalances.

So, would it be correct to say that we are at a point of trade-off, where we need to sacrifice some short-term

growth for long-term stability? Yes; instead of short-term growth, we

their return on equity in 2010 was 24 25 percent. That has now come down to around 4.5 percent. As a result, stock prices of banks have collapsed. No one wants to buy and hold them, since there is no return. But it is still highly taxed and abused at the same time. These matters are of great concern.

The non-stop loan rescheduling that we are doing will stop working at some point – when deposit growth stops or slows down. When that happens, it will lead to a major economic and political downfall. Since we have not reached that point yet, it looks alright. But it's a Ponzi scheme.

Economists worldwide have always said that you cannot taper a Ponzi scheme forever. If what we have in the banking sector is a Ponzi scheme, isn't there a point where it becomes impossible to hide?

In the case of many banks, it is a Ponzi scheme. They believe that deposits will keep growing to keep them afloat. There is also the expectation that BB would bail them out. And so far, their expectation has been correct as the government has always bailed out the failed banks.

But that's basically socialising banks' losses onto the public.

Yes. And when it happens on a massive scale, they would have to give these bailouts by printing more money. That would create huge inflation and destabilise the whole economy.

The origin of the om: Ahmed Sofa's aura

TTH the death of Ahmed Sofa on July 28, 2001, Bangladesh (or modern Bengal in historical perspective) lost not simply one of its most original thinkers; it also marked the passing of an age. In death, as in life, Sofa found himself on the wrong side of power, which explains why his passing was shunned by the powers that were and mourned only by a handful of friends and fellow workers. I, for one, have never been ashamed of expressing my admiration for

Ahmed Sofa was engaged with the large questions of the day in Pakistan and Bangladesh for at least four decades and provided a unique intellectual terrain of resistance to tyranny, injustice, and inhumanity in his homeland and beyond. Today, some 20 years later, his work, distinguished for both its depth and clarity of thinking, continues to speak to thousands, if not to millions. In this tribute, I will not call on his sundry interventions but will invoke one of his enduring contributions. As a storyteller, Sofa became, in Walter Benjamin's formulation, "the figure in which the righteous man encounters himself."

But what is a storyteller? For Benjamin, he is an artisan, a worker of sorts: "The storytelling that thrives for a long time in the milieu of work – rural, maritime, and then urban – is itself an artisanal form of communication, as it were. It does not aim to convey the pure 'in itself' or gist of a thing, like information or a report. It submerges the thing into the life of the storyteller, in order to bring it out of him

In 1976, the year I made Sofa's acquaintance in Dhaka University, it was already two years since he discovered his calling as a thinker with an incomparable aura surrounding him. He had already joined "the ranks of the teachers and sages," as Benjamin would say. What may be the basis of this aura? It lies in "the ability to reach back through a whole lifetime," a life which includes not simply his own experience, but the experiences of others as well, what he knows by himself as well as what he knows by hearsay. "His gift," Benjamin says, "is the ability to relate his life; his distinction, to be able to relate his entire life." The storyteller is a

kinsman of Plato's Socrates: "I want to tell you a story. You may think it is a mere story, but for me it is the logic.'

Ahmed Sofa was able to produce two slender poetic collections, "Time the Hangman^{*} and "Songs of Sufferance" in 1975. Earlier, in 1974, he put out the novella, *Omkar*.

With a traditional realistic novel, a short story collection, and a bouquet of tales for children before, Omkar is the first work with which Sofa discovered what is most his own storytelling, the allegory. It made all the difference between him and the rest in Bengali literature of the late twentieth century. The signifier "om", kit and caboodle would henceforth follow his path until his last tales were crafted. Its denouement would be evident in Alatchakra, Circle of Desire, realised a decade later.

Thanks to Holiday, Omkar came out in an English rendition in 1975. Introducing her translation much later, Roushan Jahan put *Omkar's* storyline in a capsule: "the story of a young dumb [sic] girl, who refuses to accept the physical limitation and after persistent and desperate efforts, finally succeeds in mastering the handicap." The story, however, goes a little beyond this challenge.

Set in historical time, a time out of joints in East Pakistan, the story draws on a formative voice has delivered an intelligible word. She fell

Salimullah Khan an urban milieu, becomes desperate in her attempts to speak. In passionately forcing open her glottis, at the end of the day she succeeds in uttering "Bangla", but loses consciousness and starts to bleed from the mouth. It is significant to recognise that a signifier represents a subject for another signifier, and not for another subject. What is also significant is that Sofa does not let out either the girl's or her husband's name. Her attempt at uttering a signifier is provoked by roaring sounds out there, the fury of marchers on the streets of Dhaka, signifying something; thus linking up *Erlebnis* (or everyday experience) with Erfahrung (or longtime historical events). This is a tale told by no idiot. It tells the story of a transformation, churning logos out of mythos. Omkar, in other words, raises itself to the status of an allegory.

As the first-person narrator speaks: "For all these years, she has expressed all the feelings of joy and pain, wonder and frustration by grumbling like a dynamo. What pains of expression she must have suffered. By now, the procession was passing our house. It was like the crater of a volcano. The whole country seemed to be in long labour. The shouts of these people were those of a mother in labour. I was trembling. It seemed Bangladesh, her sky, her air, everything was trembling. Suddenly my wife jumped clear off the ground and said 'Bangladesh'. At last her dumb [sic]

phase of the new Bengali Muslim middle class. The story is told as the fable of the country lawyer Abu Nasr, also the father of the girl, who made a paltry fortune as collaborator of the Pakistani military regime. The simple fable, in Jahan's take, "has a surprising depth, breadth and resonance". Abu Nasr in a typical single shot kills two birds, marrying his physically challenged daughter off to a parvenu and neutralising a rival clan all the same. Narrated by the girl's husband, "a timid, passive young man from a downward mobile family," as Jahan comments, "the two main strains of the story – the public and the private mesh beautifully."

The climactic moment of the story coincides with the beginning of the end of old Pakistan when Pakistan's myriad peoples united against Ayub Khan's military regime and East Pakistan rose up, unwilling to put up with the loss of self under neocolonialism, in the face of waning national identity and dignity. Ahmed Sofa opens up the myth of the origin to an allegorical gaze.

An everyday story reaches its climax when the speech-impaired girl, a housewife in prestige, in 1947 and in 1971.

unconscious and lay bleeding. I looked at the blood-splattered floor, then at my wife."

Ahmed Sofa could well have left the myth there. Dissuaded by a thesis that claims that "style is not the man himself but one the man addresses," the narrator adds: "A question rose in my mind, 'whose blood is redder? That of Asad, the martyr, or that of my dumb wife?" This veil of choice serves a subtle propaedeutic to the inaugural signifier om. As there is no meta-language, it all depends on the unfolding of history. It is history that shapes both the signifier or existence and the signified or its meaning.

The heights Sofa reached, enormous wings he carried, tempests he haunted and archers he ridiculed, of course, came not without a price. He had been indicted as a German agent or even "Ghaddafi's man." These attacks were not merely defamatory on Ahmed Sofa's identity as a Bengali Muslim and dignity as a thinker, but part of a much larger project to undermine the cause he resolutely stood for, the cause of workers and peasants in a nation that shed buckets of blood in struggles for

Why is Dhaka city so dirty?

THE Dhaka metropolitan area is teeming with a population of 22.5 million, according to UN estimates in 2021. In 1971, this population was 1.5 million. With a centralised administration and the best infrastructure in the country

including education, healthcare, and communication - Dhaka has been the focus of rapid urbanisation. This gives rise to numerous challenges – from unruly traffic, health and hygiene issues, social problems, and economic disparities, to their effects on the environment. With more people in a relatively small urban space, their consumption needs are bigger, which then translates into waste disposal problems.

This problem has become massive because of the indiscriminate manner of waste disposal by Dhaka residents, along with the insufficient and inefficient waste management practices. This is reflected in the accumulation of garbage in the streets, the playgrounds, open spaces, the landfills, etc. Why is this happening? What is the psychology of littering or improper waste management?

The root of the problem lies in human behaviour, especially people's apathy towards dealing with waste. For them, it is someone else's problem. The individual is the beginning of the vicious circle; therefore, things must change with them

There's a term called "habit loop," which describes the essential features of habits: The trigger (waste accumulation at home), the behaviour (disposal of waste as conveniently as possible) and the reward (saving time by not experiencing the "hassle" of searching for a garbage bin or thinking of separating waste by categories, such as organic waste, liquid, recyclable or non-recyclable, and hazardous). Most people usually work in an "autopilot mode." As a result, bad habits become ingrained. This habit loop needs to be reframed.

The idea of rewards would seem to offer some possibilities. We believe that creating the right incentives could play a significant role to break into and change the passive "autopilot" habits and turn them into active and more "thoughtful" ones, which would result in developing positive routines and impulses. A simple behavioural change, such as separating waste at the household level, would thus reflect a change of bad habits, which is then rewarded through a system of points.

Behavioural change is also facilitated by raising awareness about the significance and importance of dealing with household and other types of waste (cognitive learning theory) through - both formal and informal education - to help the city residents think more about their recycling behaviours and their far-reaching consequences. Raising awareness requires persistent efforts to make people put more thought into changing their waste disposal behaviour.

So how do we get a cleaner city? How do we become better and more responsible residents of Dhaka?

As a city producing thousands of tonnes of solid waste a day, the problem could be broken down into four phases:

Phase 1 - The Pre-Waste Phase: This is where people are informed of how much they waste and of their own carbon footprint to help them make responsible decisions when purchasing consumables, choosing packaging, daily usage of water, burning rubbish, using air conditioners year-round, printing pages unnecessarily, etc.

Phase 2 - The Act of Disposing: When eople are made more conscious, they will begin to "segregate" waste properly. They may even begin to reuse some of it, expand the lifespan of an item, or repurpose it before dispensing with it.

Phase 3 - The Collection System: Behavioural change must be accompanied by an efficient waste collection system that is in sync with the households.

This requires a proper, organised, and coordinated system of waste collection with timing/locations/logistics all worked

Phase 4 - The Post-Waste Phase is essentially about how the waste is treated. Is everything ending up in the same landfill or is there a recognition of value

In some regions of the world, organic waste is composted and sold; in other areas, portions of the landfills are seeded with larvae to be fattened on organic waste and used later for fish or poultry feed. How are metals recovered? How is non-biodegradable waste treated? Do the current methods of recycling or composting have adverse effects on the environment? These questions must be given serious consideration.

Behaviours such as senseless littering, garbage not being collected, or primary and secondary waste segregation not coordinated with transportation can amplify the problem. But the root of this massive problem is about targeting and changing mindsets. And mindsets are embedded in culture and some inherent traits such as habits. As culture influences the way we are brought up and what we value, it affects our way of thinking, behaviour, and actions. Over time, some elements of culture will thus have to

Importantly, change will begin levels, conscious reflection, and ethical behaviour. In addition, collaboration is critical at all levels: Individual level, community level, and public service provider level, who must operate jointly within a set of regulations.

To benefit the household, the environment and the economy, the greening and cleaning of Dhaka (and other cities) is imperative and will only come with people acting consciously, incorporating innovative features of recycling, and developing teamwork between formal and informal bodies that make up the city. This process must begin





Like the unforeseen rip and the "phot" with which Abdul Mojid's footwear breaks away in the beginning of Shahidul Zahir's Life and Political Reality (Samhati Prokashan, 2022), translated from Bangla by V Ramaswamy and Shahroza Nahrin, the readers too are dropped like egg-yolks within the sprawling, caustic narrative of Zahir's story. A split in time occurs as our protagonist scuffles through his dismal memories of 1971. Tortuous branches of prose flow through the fabric of history, intertwined with the debris of appalling cruelty, navigating eddies of crises, and setting off flash floods of collective remembrance. This novella examines the war, keeping the focus narrow, on a particular mohalla but exploring the destruction of idealism and the spirit of frustration encompassing Bangladesh in her post-war years. Thus the personal space is the same as the political sphere, the individual on the same strand as the collective.

Through the use of anaphoric instances, Zahir stamps certain images in the reader's mind. Mojid's sandal straps, the inauspicious dispersion of cut flesh to the ravens by Moulana Bodu, the murder of Momena, and Mayaraani's Satanic chants are some of the snapshots among many others which reemerge through the span of the novel. These images in turn work as a kind of hook for the readers to rely on and to get hold of where the story is headed. Hence the narrative is not necessarily an open-ended stream of consciousness, one that moves from point A to B, from B to C and so on-but one which circumnavigates, touching all the points and creating many intersections. It might sound chaotic, yet it is anything but, as nothing becomes repetitive or cacophonous, let alone monotonous.

The themes and the distinctions of the plot-the substance, so to speak-tend to fall flat to Zahir's grasp over style. Instead of aligning itself with a steadfast arc or a steady plotline, the story moves restlessly through



the treacherous terrains of time and space. Without a single break in the paragraph, *Life* and Political Reality hovers over readers like a massive cloud of text formed with a deft pen.

Abu Ibrahim's Death, the second novella in the collection, may seem like an odd choice for Life and Political Reality's accomplice, in so far that it is a text that is riffed with the occurrences of everyday life. The story opens with the death of Abu Ibrahim and then reverts into the life he lived. We see him in different roles, an absent spouse, a loving father, a righteous government worker.

The protagonist is someone who acts as a shadow of Maoist, Marxist morality. However, when offered a bribe by a businessman, a Shylockian figure who is cartoonish and sinister with his talks of whiskey and moneymaking, Ibrahim's conscience gets a hold of him. He stands against the culture of taking backhanders but simultaneously is afflicted with a burden to buy land for his own family. He does not resist the man, however, with a bellowing horn of an idealist hero like the a steely, quiet rumination which infuriates the

shady merchant. First published in 1991, the political context of then-Bangladesh and the zeitgeist of uncertainty and disillusionment are captured through Ibrahim's struggle of navigating his principles in a fractured world.

While reading Abu Ibrahim's Death, I was surprisingly reminded of Wong Kar Wai's meditations on Hong Kong's urban spacesthe pages saturated with aching glances, quiet longings which become deafening in unsaid words. Zahir draws up a shade of Dhaka abloom with flame flowers and a kind of tranquillity that appears to be a myth in this present day.

However, despite the dreariness of the themes, there are instances in both novellas which act as a celebration of unobtrusive, everyday beauty. From Ibrahim's act of savouring an ice-cream with his daughter, to Abdul Mojid choosing not to become a gunda when he finds access to the doors of the

neighbourhood library-it all adds an emotional, wistful tuning to the callous realism and the indisposition of cut flesh and horror.

Shahidul Zahir's expertise lay not only in the depiction of social reality or the nuances of local culture, but in the experimental language he opted for, in his play of dialogues and dialects. In case of the translation of Abu Ibrahim's Death, the dialects were not translated like in Life and Political Reality. The inclusion of that would have perhaps helped to draw a better picture of the characters, given an indication of their social class too.

While the Bangla, original renditions of the two pieces evoke a certain sense of maya, the English versions do not fall short. Ramaswamy and Nahrin provide worthy translations of these masterpieces, concurrently holding the audience haunted and mesmerised.

What's missing from quirky period dramas?

The '90s offered something of a renaissance of period dramas, particularly with meticulous screen adaptations of Jane Austen's beloved novels. While filming 1995's Sense and Sensibility, Emma Thompson, who wrote the screenplay and starred as Elinor Dashwood, agonised over line changes and refused producers' pleas to "novelise" her script and sell it as an "update".

Fast forward two decades and a new type of period drama is taking over today. Filmmakers are ditching accuracy and precision in a move to cater to Millennials and Gen Z audiences. Young and "good-looking" actors are cast, contemporary music is played in ballroom scenes, and the flirting and sex are ramped up. From the language to the set design to the score, forays into period drama are increasingly spiced up with modernity to both delightful and disappointing effects.

The Austen-inspired Bridgerton (2020)-Netflix's Regency-set romance based on Julia novels published from 2000 to

2006-uses candycoloured costumes and an idealised depiction of race in society, featuring prominent Black and South Asian characters and motifs like string quartets playing Ariana Grande covers instead of period waltzes. Lady Whistledown, scandal

Gossip Girl-esque narrator, dominates the plot. Since its release,

Bridgerton proven to be as controversial as it is popular. It explores race and representation in the early 19th century through the Duke of Hastings, Black man named Simon Basset (Regé-Jean Page) in

Season 1, and

Kate Sharma (Simone Ashley) in Season 2, an Indian. But in a rush to be inclusive, it glaringly overlooks nuances. A controversial scene in Season 1 depicts the sexual assault of a Black man by a white woman in a context where the inverse was

a narrative that used to kill Black men. This is appalling, to say the least.

'Sharma", Kate's surname on the show, is a common name among upper-caste Indiansand herein lies the problem. In celebrations of representation, the notion of being an "Indian" continues to be cemented in the upper-caste Hindu mould in popular culture and media. And even though it is appreciable that Hollywood is showcasing diversity in a genre that has long been greatly fronted by white characters, in its bid to be a light, frothy, and visually pleasant show, Bridgerton does not meaningfully address these complex issues.

Emma. (2020), starring Anya Taylor-Joy as the titular smart, wealthy, and meddlesome matchmaker, is a great example of a period film that incorporates subtle contemporary influences into the personality and costume design of characters. This adaptation is distinguished by its commitment to snarky retorts and a bright aesthetic, as seen in Emma's flashy mustard yellow gown and extravagant black hat with yellow feathers.

Emma and Mr Knightley's relationship is also edgier in the film, more socially acceptable. There are dance scenes without gloves, fleeting male nudity, and kisses when the girl's father is present in the room. She has her widowed, neurotic father to care for—or is that just her excuse to live as free of constraints as any man? It's a radical notion for the Regency era, and Taylor-Joy relishes in Emma's snobbery and callousness, confounding expectations of how a young lady of fortune should behave. Such playfulness is in keeping with the spirit of the book and with Austen's humour. Nevertheless, Emma. falls at a risk of being so highly stylised and goofy that it loses many of the deeper layers of the novel.

The recent Netflix adaptation of Austen's Persuasion (2022) plays like a romantic comedy rather than a complex, sombre story about second chances at love. In the film, protagonist Anne Elliot (Dakota Johnson) ends up in several contrived circumstances on her quest to win back her "ex". Breaking the fourth wall, she cheekily addresses the audience after comments from her family members, which seems nonsensical for the introverted and dejected Anne we know from the novel. She has been turned into the awkward yet sassy and vivacious heroine that has been popping up in recent, contemporary period dramas. Trying too hard to be quirky, the film widely fails to capture the tone of the book. This points to a prevailing issue in adaptations of classic novels today where studios seem to think female characters need to be glossed with a "zany" and "feisty" persona in order to be relevant.

It appears that in warping period pieces on screen into colourful, digestible, and clickable content for Millennial and Gen Z viewers, filmmakers are doing a disservice not only to historical and literary texts, but also to the audience that they are, apparently, so desperate

Ali Riaz's 'More than Meets the Eye' and a writer's responsibility

I stand amazed by the prolificity and eclectic scope of his work. On July 23, 2022. Dhaka's University Press Limited (UPL) organised at its head office in Farmgate a publication ceremony of his book More than Meets the Eye: Essays on Bangladeshi Politics (2022). The event was broadcast live on UPL's Facebook page, which enabled me to attend it remotely from Kuala Lumpur.

Truly more than meets the eye, the book discusses contemporary politics and the erosion of social and political institutions in Bangladesh. Ali Riaz examines the profound social divisions cohesion in the country. Discussants congratulate the author of More about sociopolitical problems that have of the publication ceremony deplored the policies of what they called an 'authoritarian' government that has been ruling Bangladesh for over a decade.

As Bangladeshis, whether inside the country or abroad, we keenly follow its political and other developments. We are alive to most of what is happening in the country and reported in the media. Hence, it is almost impossible for the writer of such a book to say something new or completely unheard of.

During the publication ceremony, some suggested (though not cynically) that much of what the book discusses is what we, as Bangladeshis, already know. What is more, some sought from the author solutions to the political ills that he has diagnosed in the book.

Since I attended the event virtually, my opportunity to engage in the discussion in a personal way was limited. I wanted to say that some members of the audience seemed to have missed the point that a writer's job is not always to say something new or original, especially when they act as a social or political commentator. Nor is it necessarily their duty to carve out solutions that will transform a country into a land of freedom and opportunity.

In her powerful essay "The Small Personal Voice" (1957), the British-African writer Doris Lessing maintains that a writer writes out of "a feeling of responsibility, as a human being, for the other human beings". She regards completely given up to the policy goals the writer as "an architect of the soul" who must know the nature of the soul the temptations to turn off one's they wish to persuade. In that sense, Ali Riaz does not belong to those writers who, in Doris Lessing's words, "can be bludgeoned into silence by fear or economic pressure".

In his book Representations of the Intellectual (1994), the Palestinian-American public intellectual Edward Said argues that a true intellectual who seeks to represent his people cannot be "a functionary nor an employee of a government.... In such situations, writes what they and we see, though at trusted". Here Said emphasises two on high.

beset Bangladesh.

In this respect, Ali Riaz seems to think along the same line with the famed Nigerian writer, Chinua Achebe. In an essay titled "The Black Writer's Burden" (1966), Achebe states: "One of the writer's main functions has always been to expose and attack injustice". That is to say, when a writer avoids this responsibility of exposing the truth about a government, they actually take off the badge of a writer from their

The South African writer Nadine Gordimer suggests that a writer should not hesitate to tell the truth to power even if such telling renders them political. She says: "If you're writing honestly about your society and that society is in turmoil, you become a political writer". Morally, one cannot remain a detached scholar and observe

Establishing the untenability for an society built on a structure of inequality, where do we stand? Can we remain neutral, cocooned in our libraries and scholarly disciplines, muttering to ourselves: I am only a surgeon; I am a scientist; I am an economist; or I am simply a critic, a teacher, a lecturer?"

Writers and intellectuals are obligated to discuss the conditions of their fellow human beings. They embody the sensitive, artistic conscience of their people. It is their responsibility to stir moral indignation at gross injustices and the plight of the masses. Readers in return receive a cathartic pleasure after reading what the writer has said about them. In "African Literature and Social Problems" (1975), Romanus Egudu states that through depicting people's difficulties, writers provide readers with "intellectual pleasure in the midst of tears". W H Auden says it more beautifully in his "In Memory of W. B. Yeats":

Follow, poet, follow right To the bottom of the night, With your unconstraining voice Still persuade us to rejoice; With the farming of a verse Make a vineyard of the curse, Sing of human unsuccess In a rapture of distress.

Lastly, the British writer John Osborne came to my mind when someone from the audience at the UPL event urged Ali Riaz to provide solutions to the problems he describes in More than Meets the Eye. Reflecting on his role as a writer in 1950s Britain, Osborne says in his essay, "They Call It Cricket" (1957): "I am a writer and my own contribution to a socialist society is to demonstrate those values in my own medium, not to discover the best ways to implement them".

Accordingly, Ali Riaz employed his training in political science to comment on the new "political settlement" that has developed in Bangladesh and to articulate the threats it poses to the country. However, providing solutions is not the task of the writer alone. That will need to involve many stakeholders at various levels.

Nova's 'dream came true'

Piash Ahmed Nova's dream to strike against India in SAFF U-20 Championship came true when the BKSP student struck a brace to power Bangladesh to a 2-1 win over the neighbouring nation in their second match at the Kalinga Stadium in Bhubaneswar, India yesterday.

Fresh from a single-goal win over Sri Lanka in their tournament opener, the boys in red and green came strongly against the hosts to notch up consecutive victories in the inaugural U-20 Championship, which previously was a U-18 tournament where India beat Bangladesh 2-1 in the final to win the title in 2019.

Nova, also a player of Bashundhara Kings, gave Bangladesh the lead in the 29th minute with a brilliant left-footed strike inside the box after Indian defenders fumbled to clear a long ball from Bangladesh, who rattled the woodwork twice prior.

Six minutes later, Gurkirat Singh levelled the margin with an eye-catching header inside the box but Bangladesh restored the lead with the 10-grade student Nova – converting from the spot one minute into the stoppage time of the first half.

"I had a wish to score against India and I thought of it almost the whole night. Even I thought of how I would celebrate after scoring goals against India. I'm really happy that I have struck against India and my dream came true," Nova told The Daily Star from Odisha over the phone after

Nova also informed his elder brother Pial Ahmed phoned him from Bangladesh to inspire him to score against India before the match day.

'My elder brother named Pial Ahmed called yesterday [Tuesday] to inform me that India is a large country which has big provinces like Bangladesh and they have a lot of footballers across the country.

"He asked me to show India that Bangladesh also possess talented footballers by scoring goals. I am also happy to keep the words of my brother," said the 6-feetheight forward from Amla of Kushtia.

Nova also knows the tale of Bangladesh U-18 team's defeat to the Indian counterparts in the SAFF U-18 Championship but he believes the current group of the players are better than the previous squad.

"I have learnt from seniors that Bangladesh created more chances than India in that final but the players tried individually instead of playing as a team, thus squandering the chances to miss the title," Nova added.

"However, we are a team who are determined to play the final of the ongoing tournament. Each of the players are also trying to give their level best from their respective positions. All three departments are also functioning as a unit because we first want to ensure the final berth."

Coach Paul Smalley said: "We've got young elements in the squad. It's a mixture of our Elite Academy players and Under-20 players. Home conditions at **2024 T20 World Cup** embolden Salma

Bangladesh will host the 2024 ICC Women's T20 World Cup, the first time the country will host a major women's event, and it is expected to be a great opportunity for the Tigresses, who are looking to take the next step in world cricket.

Despite Bangladesh's disappointing performance in previous T20 World Cups, T20 skipper Salma Khatun said that the Tigresses were looking forward to the challenge and preparing accordingly.

"Playing host always gives you an added advantage and motivates the team to give their best. Since we will host the T20 World Cup in 2024, I think it is important for us to prepare from now. It might seem like we still have a lot of time, but the fact is that we need a longterm vision for the mega event," Salma told The Daily Star vesterday.

The tournament will be held between September and October in 2024. It will be the second time Bangladesh will be host a T20 World Cup, previously staging the men's 2014 edition.

Bangladesh can also take positives from the fact

that the Tigresses are defending Asia Cup champions. Coupled with home conditions and support from a local crowd, those factors could play big roles as the

Tigresses attempt something extraordinary. "It is too early to comment on whether we can win the title or not. The thing that we need to do is give our best on the field. Another thing to remember is that we are the defending Asia Cup champions, so we do have the ability to do something special. But at the moment it is important to stick to our process and not look too far beyond," Salma said.

According to Bangladesh Cricket Board (BCB) women's wing manager Tawhid Mahmud, Bangladesh will have a busy schedule leading up to the 2024 World Cup. He hoped that would prepare the hosts well enough before the mega event.

"Although it is the ICC who announce all future schedules officially, at the moment I am not able to comment on the number of matches and series we are going to play. But I can say that the Bangladesh national women's team has a very busy schedule till January 2025. We will be playing a lot of matches before the 2024 World Cup," Tawhid said.

Commonwealth Games get undeway today

The 22nd edition of the Commonwealth Games opens in Birmingham on Thursday, bringing together around 5,000 athletes from 72 nations and territories - mostly former British colonies -- to compete in 19 sports over 11 days.

Some track and field stars will be absent when the competition gets under way -- just days after the end of the world championships in Eugene,

But there will still be plenty of big names on show at the event, which features sports as diverse as lawn bowls and marathon running.

The Commonwealth Games are not on the scale of the Olympics that Birmingham once aspired to host the city was beaten by Barcelona for the right to put on the 1992 Games but officials hope they can provide a big economic boost for the area.

According to the Financial Times, the West Midlands Combined Authority estimates the event will be worth £1 billion (\$1.2 billion) to the regional economy.
