Three people were killed and another was injured in road accidents in two districts during the last two days, said reports from our correspondents.

In Gopalganj, motorcyclists were killed and their co-rider was injured when a truck, microbus and their collided in motorbike Gopalpur Bazar area under Kashiani upazila on Wednesday night.

The deceased identified as Maruf Mollah (18), son of Raidul Mollah; and Mafij Mollah (17), son of Rowshan Mollah from Khagail village in Sadar upazila of the district, said police. Md Sirajul Islam, sub-

'Please don't write about us, we still have to live here'

Victims of Narail mayhem tell civil society members

"It was a whimsical attack. The situation is normal now. Everyone lives here in a friendly atmosphere and harmony," said seniors of the Hindu community at Sahapara village of Narail district.

They talked to correspondent before members of the civil society visited the village after the communal attack carried out on July 15.

When the conversation civil between society representatives and leaders of the Hindu community turned to the identities and motives of the attackers, the latter seemed hesitant. "Please don't write anything that raises enmity. You will go back to Dhaka but we have to live here. And we want to live in peace," they said.

During his visit to the village on Tuesday, this correspondent saw the hint of fear and anxiety still looming over the faces of Sahapara residents.

Though several police officers were guarding them round the clock in different points of the village, the sense of security seemed completely shattered. The trauma was more evident than ever.

A 50-year-old Hindu woman living near Sahapara's Gobinda Temple claimed that life in their village was turning towards

whereabouts of her daughters, she replied that her daughters, along with a son-in-law, have not yet returned from their relative's house in another village since the night of the attack.

Residents of the locality said elders of the attacked families returned to the village one or two days after the incident.

His father, mother and younger brother did not return home after the attack, said a relative from the house next door.

An official of Chattogram Custom House has reportedly received a death threat from abroad, after he disclosed information about seized liquor consignments, which were illegally imported using false declaration.

The consignments were seized by customs officials and Rapid Action Battalion (Rab) on July 22 in Narayanganj.

Assistant Revenue Officer (ARO) Rashedur Rahman lodged a general diary (GD), seeking security, with the port city's EPZ police station on July 24, after informing the matter to his higher authority. He is attached to Chattogram Export Processing Zone customs station.

Shahed gets permanent bail in graft case

The High Court yesterday granted permanent bail to Regent Hospital Chairman Mohammad Shahed in a corruption case filed on charge of embezzling Tk 2 crore from Padma Bank (formerly Farmers Bank) in the name of purchasing an MRI machine.

The ACC filed the case with its Dhaka office on July 27, 2020 against Shahed, Mahbubul Haque Chisty, former chairman of the bank's audit committee, managing director of Regent Hospital Ibrahim Khalil; and Mahbubul Haque Chisty's son Rashedul Haque Chisty.

Yesterday, the HC bench of Justice SM Kuddus Zaman and Justice KM Zahid Sarwar Kazal delivered the verdict after holding hearing on a petition filed by Shahed. He cannot get released from jail as he is arrested in other criminal cases.
