Today is the 34th death anniversary of Justice Abu Sayeed Chowdhury, former president of Bangladesh. On the occasion, a qurankhwani and milad mahfil will be held at Nagbari Jame Mosque in Tangail, says a press release. Justice Chowdhury resigned as vice chancellor of DU on March 15, 1971 protesting killings of two students by Pakistan army. He later played a significant role in mobilising world opinion for the cause of Bangladesh as special envoy of the provisional government. In 1985, he was elected chairman of the UN Human Rights Commission. He authored five books, on the Liberation War, law and human rights.

"Successful person with autism" from Prime Minister Sheikh Hasina. Her paintings were also selected for the prime minister's Eid greeting cards.

Ishaba and a group of children with ASD participated in the Autistic Talent Gala, Hong Kong in 2019, and the team won awards in three categories.

According to Md Amir Hossain, senior programme specialist of PFDA-VTC, more than 100 PFDA graduates who have neurodevelopmental disabilities are now working in different organisations. Around 30 graduates are running their own businesses, or working from home due to lack of a proper atmosphere.

For admission at PFDA, the admission team interviews the child and family members to collect relevant data on the candidate.

Then the pre-admission team observes the potential student to develop a personalised training plan. The data is handled through a customised

software called "CUMO". The team also suggests necessary therapy, vocational trades, and co-curricular activities for each student's development. Finally, the candidate is admitted to either PFDA's pre-vocation or vocation section.

Danny said most of these children remain confined to their home after being rejected from schools or after completing primary education.

"I've seen that all these children have tremendous potential and a drive to learn. We strive to recognise their talents and design teaching-learning methods according to their strengths and needs."

"When we introduced this method in Bangladesh, most people told me that this wouldn't work. However, I didn't give up, and I believe that the decision I took in 2014 was right," she added.

Since the establishment of PFDA-VTC, Danny, however, has been fighting countless obstacles centring around stigma and lack of financial support.

Lots of discriminatory and negative attitudes exist in our society against persons with disabilities. "Such a negative mindset creates insurmountable obstacles for us when we want to collect funds, resources, and support for this institution. We have to procure different types of expensive teaching-learning equipment for our students. Funding crisis remains a constant challenge," she said.

A determined Danny now dreams of extending PFDA's services to all over the country, accessible for people from all socioeconomic backgrounds.

While some villagers claimed that Lazmikanta's supporters launched the attack, other victims said they could not identify the attackers.

"The attackers hit on my head with a stick from behind. I could not see them as they ran away quickly," said Sunil Mandal, a resident of the attacked neighbourhood.

However, another victim Bharat Mandal claimed, "We could identify the attackers from our neighbouring village. They were hired by Laxmikanta."

Contacted, Ratan Kundu made the same allegations.

This correspondent could not reach Laxmikanta over the phone despite repeated attempts.

However, Sreekatna Mandal, Laxmikanta's supporter, denied the allegations.

Shaillkupa Police Station's Officer-in-Charge Aminul Islam said no one filed any case in connection with the violence till yesterday evening.

Police have been deployed in the area to avert further violence, he added.

to the previous Tk 4,500 to Tk 5,000 airfares. US-Bangla Airlines General Manager (Public Relations) Kamrul Islam said the number of passengers on Barishal and Jashore routes have decreased following the inauguration of Padma Bridge. He, however, said the months of June-July are considered an off-season for air travel and travellers are enjoying using the recently opened Padma Bridge, as it save

them both time and money. Meanwhile, sources in the US-Bangla said one-third of their flights remain empty after the inauguration of the Padma bridge.

Kamrul said they are still operating six daily flights to Jashore and two daily flights to Barishal.

Rezaul Islam, an employee of a private company, told this newspaper that before the opening of Padma Bridge, he used to travel to

Barishal by air to save time as it took more than nine to ten hours by road to reach there. "But now I can travel to Barishal by road within three hours from Dhaka," he added.

Monirul Islam, another private service holder who also used to fly to Barishal regularly, said, "It takes three or four hours to travel by bus, but we can start the journey immediately after work instead of waiting for a flight. This saves both time and money."
