Dengue claims two more lives 65 hospitalised in 24 hours

Two patients died of dengue while 65 patients were admitted to hospitals across the country in 24 hours till 8:00am yesterday, according to the Directorate General of Health Services (DGHS).

With the deaths in Cox's Bazar, the death toll from dengue this year rose to 12. With the new cases, 14 from outside Dhaka, the total number of dengue patients rose to 2,812.

Among the patients, 322 are still undergoing treatment, of whom 76 are from outside Dhaka.

A total of 2,478 patients have been released from hospitals, 367 from outside Dhaka.Warning the city corporations of a major outbreak of dengue virus this year compared to the last couple of years, experts suggested the corporations to take extensive measures immediately to control the Aedes mosquitoes.

living in the facility which can accommodate up to 100 children. All the kids -- aged between one month up to seven years -- have been either lost or abandoned.

Established in 1962, Chotomoni Nibash has so far provided shelter to more than 2,000 children, where all of them have been given new names.

The facility has three rooms -- one for the children, one for storing food and one for office work. Inside the large room allocated "Khadiza has been battling eye cancer for the children, there are facilities like slides and swings for them to play. There are also

There are five branches of Chotomoni Nibash in five divisions -- Chattogram, Rajshahi, Sylhet, Khulna and Barishal.

The shelter takes in children between the age of zero and seven. Many are adopted before turning seven. The ones who remain are shifted to other government facilities like Shishu Paribar upon turning seven.

To adopt a child from the home, adoption seekers are required to apply to the family court that has jurisdiction over the child's place of residence for legal guardianship of





Today is the date for her chemotherapy," Lovely told this correspondent on Saturday before leaving for the hospital with Khadiza.

Chotomoni Nibash, the home for lost and abandoned children, has been Khadiza's home since she was six months old. Her mother has been going through mental health issues for a long time and is currently staying in a shelter home in Gazipur's Kashimpur.

The nannies in the home have been taking care of Khadiza's needs ever since she was brought here.

"We are putting all our efforts and spending as much as we can to get Khadiza fully cured. We are using the funds allocated for her treatment apart from the donations given by people," said Lovely.

Khadiza is among 28 children currently

arrangements for outdoor games like football and cricket on the building's rooftop.

The children are provided with meals five times a day with proper nutritional foods. Feasts are also arranged at different festivals or occasions.

The shelter currently has 26 staffers, including one matron/nurse, three teachers, three nannies and eight "Khalas" as they are called by the children, two cleaners and one chef. Besides, eight nannies work here on a freelance basis.

The staffers have made the facility their second home and spend a major time of the day raising the children. They work in four shifts. The nurse or nannies are actual families to the children, who call them either "ammu" (mother) or "apu" (sister).

The court then summons Chotomoni Nibash. The home reviews the adoption application and replies to the court, which in turn takes the final decision.

During the visit to the Azimpur facility, this correspondent saw how the nannies spent time with the children. Some were seen feeding infants, some playing with the children while others were busy keeping an eye on the children playing.

But they all had one thing in common. The look of profound care and love they carried for all the children.

Zublee Begum Ranu, deputy superintendent of Chotomoni Nibash, said, "All of us working here love the kids as much as they love us. They are also very sincere as you can see."

India to move oil thru Bangladesh

Indian Oil Corporation to sign MoU with RHD today

Indian Oil Corporation (IOC) is going to sign a memorandum of understanding with Roads and Highways Department (RHD) today for transporting fuel from Meghalaya to Tripura through Bangladesh.

Bangladesh agreed following the request of its neighbouring country, as the local rail network has been snapped due to massive landslides in Assam, officials said. The MoU will be signed at the Road Transport and

Highways Division in the afternoon, ABM Amin Ullah Nuri, secretary of the division, told The Daily Star yesterday. "We will give them the facility for a temporary period." They [IOC] have to pay a certain charge for using our road

network," he said. As per the plan, IOC, an Indian government-owned oil and gas exploration company, will send its convoys of fuel to Bangladesh via Dawki (in Meghalaya)-Tamabil (in

Sylhet) border, said an RHD official. Then the vehicles will enter Kailashahar in Tripura via Chatlapur check-post in Moulvibazar, the official said, wishing anonymity.

In 2016, IndianOil-AOD, the company's northeastern division, sent a few consignments to Tripura via Bangladesh, when the supply was badly affected due to run down road conditions in Assam's Barak Valley, reported PTI on May 29.

The Indian news agency said after the only rail link connecting Assam's Dima Hasao and Barak Valley, Mizoram, Manipur and Tripura to the rest of the country SEE PAGE 4 COL 4

MONEY LAUNDERING HC denies bail to 2 NSU trustees

The High Court yesterday refused to grant bail to two members of North South University's (NSU) trustee board -- MA Kashem and Rehana Rahman in a Tk 304 crore money laundering case.

The court, however, issued two rules asking the state and the Anti-Corruption Commission (ACC) to explain in two weeks why Kashem and Rehana should not be granted bail in the case.

The bench of Justice Md Nazrul Islam Talukder and Justice Khizir Hayat came up with the rules after hearing two petitions. The bench also fixed August 16 for hearing on the rules.

On May 22, the HC bench led by Justice Md Nazrul Islam Talukder rejected anticipatory bail petitions filed by four members of NSU trustee board in the same case and also ordered Shahbagh police to arrest them immediately and to produce them before the trial court in 24 hours
