condition, who have to wait in ambulances for a long time before entering MMCH.

Anwar Hossain, attendant of a patient, said, “It’s a double trouble for us as a major portion of the road has been occupied by the stand, while the footpaths have been occupied by hawkers.”

“This makes it difficult for us to even walk to the hospital,” he added.

“Despite a widespread public outcry against illegal parking and footpath occupation, no one took any step to mitigate the sufferings,” said Arabinda Patranabish, a patient of the hospital.

The demand to remove the stand has repeatedly been ignored by city authorities, said MMCH sources.

Wishing anonymity, a Mymensingh City Corporation official said a lack of manpower is the reason behind addressing this situation.

Asked, MD Aminul Islam, assistant secretary of MCC, said they have already talked with the owners of auto-rickshaws to shift the stand from this busy area to an appropriate location.

“They have also assured us to act on it as early as possible,” he told The Daily Star last night.

50 pills of ecstasy – a synthetic, psychoactive drug – every month due to its high demand in the country. He brought the rest of the seized drugs, including synthetic opioid drug fentanyl to assess its demand in local market.

Son of a textile businessman, Onaisi went to the US for higher education in 2001 after completing his O levels.

He returned home in 2007 after completing his BBA. In 2012, he went to

Malaysia to get an MBA, where he stayed till 2014, said Moin.

“From what we know so far, he used to study different types of drugs during his stay abroad and started his business in 2019. He does not consume the drugs himself,” he said.

Onaisi would often make foreign trips to collect his consignments.

Apart from that, he also has a Bangladeshi aide in Canada who sends him the drugs through online courier services, he added.

India to move

was washed away in May, the company started moving all its supplies by road via Meghalaya, bearing more than double the cost.

“After the Dima Hasao landslides, the only way to reach Manipur, Mizoram, Tripura and southern Assam was the road connectivity via Meghalaya. This route is also landslide prone,” IOC Executive Director (IndianOil-AOD) G Ramesh told PTI at that time.

The situation forced IOC, state governments and central government to scout for alternative ways to supply fuel to the southern region of the north-east, he added.

According to the PTI report, IOC was initially planning to move 1,400

kilolitres of fuel via Bangladesh at a total transportation cost of Rs 57.78 lakh, as opposed to Rs 34.22 lakh for their rail route.

The distance for transporting different types of fuel from IOC’s Betkuchi depot to Dharmanagar depot via Bangladesh will be 376 km, including 137 km inside Bangladesh, as opposed to 579 km for the normal route through Meghalaya-Barak Valley.

On September 9, 2016, IOC flagged off seven tankers carrying 84,000 litres of kerosene and diesel from its Guwahati depot to Tripura through Bangladesh for the first time, to avoid the dilapidated national highway in Assam, it reported.

She said staffers who have young children of their own are not appointed at night shifts so that they can take care of their children as well.

Fatima has cerebral palsy and was abandoned right after her birth. She cannot talk but can hear partially.

She was seen playing with a nanny in the home. At that moment, she looked truly happy and no barrier could stop her.

“I joined the home after just four months of my son’s birth. Initially, it was difficult for me to leave my child at home and come here. But these children made me forget the pain of leaving my own at home,” said Reshma Begum, a nanny who has been working in the home for eight years.

“We all love them like our own children. That’s what they need the most now,” she said.
