CHT Commission condemns govt directive of prohibiting use of the word 'indigenous'

The International Chittagong Hill Tracts (CHT) Commission was shocked to learn about the government's prohibition on using the term "indigenous", said a press release published yesterday.

The Commission finds this position by the ministry very undemocratic, derogatory to the indigenous peoples, and a serious threat to the freedom of speech, said the press release signed by the commission's co-chairs Sultana Kamal, Elsa Stamatopoulou, and Myrna Cunningham

The information ministry has recently issued a circular directing all the electronic media not to use the term "indigenous".

Patients suffer as intern doctors continue strike

The strike that started on Monday to protest the attack on students of Sylhet MAG Osmani Medical College Hospital and harassment of a trainee doctor continued yesterday as well. As the intern doctors enforced

an indefinite strike, hundreds of patients are suffering at the division's largest public healthcare Hospital Director Brig Gen Mahbubur

Rahman Bhuiyan said healthcare fell into a crisis due to the strike. "All the pressure is now on the mid-level doctors."

Many patients were seen returning to their homes being unable to see a doctor. Those who came from far had to suffer the most.

"The students and intern doctors have remained

agitated, as police could not arrest some prime accused yet. The matter has been communicated to the health and foreign ministers, and we hope it will be resolved soon," he said.

Students also boycotted all classes and examinations for an indefinite period and locked the administrative building's gate in the morning. College Principal Prof Moynul Haque could not be contacted.

Police are yet to arrest all the accused in two separate cases filed on Tuesday. Earlier, two people were detained and later shown arrested in those cases.

Ctg Wasa to hike water tariff yet again

 $Just six\,months\,after\,its\,last\,tariff\,hike, Chattogram$ Water Supply and Sewerage Authority is set to impose another hike -- of more than 38 percent in an apparent bid to bridge the gap between production cost and existing water price.

CWasa wants to raise the tariff for residential connections from Tk 13 to 18, while the nonresidential tariff would increase to Tk 37 from 31.82 per unit of 1,000 litres.

Water tariff was last raised in January, before which the tariff for residential connections was Tk 12.40 and for non-residential connections Tk 30.30 per unit.

Prime Minister's Office approved the request for the hike. Water bills following the new tariff will be collected from September, Nazim Uddin, chief revenue officer of

Asked about the reason behind the hike, he told The Daily Star, "The production cost of

water is now very high, so the price of water has to be increased."

However, they will try to reduce the cost of various sectors. Apart from this, human and system losses will also be reduced, he added.

"The government does not give us any subsidy and has asked us to be self-dependent. We have a huge amount of unpaid loans from various international lenders. Considering the situation, we have no option but to increase the tariff," he

"The money we are spending must be recouped by raising the water tariff. CWasa will not survive unless we do it," he claimed.

Meanwhile, Consumers' Association of Bangladesh (CAB) has rejected the proposal.

The rights body also demanded ensuring uninterrupted water supply and holding public hearings before increasing the tariff.

SM Nazer Hossain, vice president of CAB Central Committee, said, "It is customary to hold a public hearing for increasing tariff for any utility service. However, CWasa has arbitrarily taken the decision to hike the tariff, without holding any such hearing, which is unacceptable and against

'ABDUCTION OF STUDENT' Two madrasa teachers arrested

Police have arrested two madrasa teachers over abduction and disappearance of a student in Hatibandha upazila of Lalmonirhat.

They were arrested from a house in Tangail on Tuesday night, said Hatibandha Police Station Officer-in-Charge Shaha Alam.

The arrestees -- Riazul Islam and Rabiul Islam are teachers of Alimer Danga Hafizia Madrasa in Singimari village.

The missing boy, Rabbitul Islam Rabbi (14), is a student of the madrasa. Rabbi's father Rashidul filed a case against the two with a local court on July 17. Later, the case was registered with the police station on July 21. The two teachers went into hiding.

According to the case statement, at least 14 to 15 students -- including Rabbi -- went to tabligh for three days at a mosque in Sohagh Bazar on July 6. Rabbi disappeared from there.

Rabbi's father also claimed that the teachers kidnapped his son and hid him. Earlier, the two offered to teach Rabbi in Dhaka, he alleged, but he

However, the arrestees and other students who went for tabligh claimed that Rabbi drowned while bathing in Teesta river on July 7. The OC said they are investigating the incident.
