Dhaka South City Corporation (DSCC) mayor Sheikh Fazle Noor Taposh yesterday said they want to build Dhaka city as a pedestrian-friendly city.

“Forty percent of commuters in the city move on foot and we are working to ensure smooth pedestrian movement. Unplanned urbanisation and encroachment are the main obstacles to making the city pedestrian friendly,” he said.

The mayor was addressing a press conference on budget announcement at Nagar Bhaban.

“We will hold discussion with all

stakeholders to come up with a better solution for hawker management. We will also continue our efforts to remove them from footpaths,” Taposh said.

He said they have a plan to mark some areas or roads as “red” where hawkers will not be allowed, some roads will be marked as “yellow” where hawkers will run their business for a certain time.

The mayor said they understand that hawkers need rehabilitation and they will take initiative in this regard.


He also mentioned that they have taken initiative to recover the old Buriganga channel.

Today is the 73rd birth anniversary of Sheikh Kamal, the eldest son of Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

Born on August 5, 1949 at Tungipara in Gopalganj, Sheikh Kamal was an executive member of the central committee of BCL.

Awami League, its associate bodies and different political, socio-cultural and sports organisations have taken elaborate programmes to observe the day.

AL and its associate bodies will pay homage to Kamal by placing wreaths at his portrait on the premises of Abahani Club at Dhanmondi at 8:00am.

Wreaths will also be laid at his grave at Banani Graveyard at 9:15am. Later, Quran Khwani, milad and doa mahfil will be held.

Abahani Limited has also chalked out day-long programmes to observe the day. Kamal was one of the pioneers of modern football in Bangladesh and also founder-president of Abahani Krira Chakra.

He was martyred on August 15, 1975 at the age of 26.

‘Think twice before signing’

Say experts on Energy Charter Treaty

Energy experts of the country yesterday urged the government to be cautious in its bid to sign Energy Charter Treaty, warning that it might jeopardise the already volatile energy sector due to its design to safeguard the interest of the energy giants.

They came up with the warning in a dialogue titled “Bangladesh Energy Transition Policy-2022 and Energy Charter Treaty”, organised by Consumers Association of Bangladesh (CAB) along with NGO representatives on raising social awareness about energy sector.

Prof Shamsul Alam, eminent energy expert and vice-president of CAB, said the treaty was designed in a way that ensures profits interests of energy giants would never be affected no matter what the situation is in the country.

Such a beneficiary (like the giants) has already grown in our country, like the 22 families of erstwhile Pakistan who used state machineries for such undue benefit, he said.

Coming up with the example of KAPCO, he said the government is still supplying gas to KAPCO with the price fixed around 30 years ago under a contract. In this way, the country's national capacity was threatened, which is alarming for an independent nation.

He said taking the advantage of lax regulation, Oxidental and NIKO -- two energy companies -- endangered our national energy security.

action. We have been losing the capacity gradually in the energy sector. We can't design a power plant, can't construct a powerplant, and thus, we became paralysed in this sector”, he lamented. Indicating policymakers, he said, “They were not making mistakes. They are doing this because they are benefitting from this in many ways, which led to the rise of Begum Para in various developed countries. We have to stop this.”

“We won't let them commercialise the energy sector as we did not let the government proceed with gas export once,” he added.

He urged all to stand united to put an end to such activities.

Prof Tanzimuddin Khan of international relations at Dhaka University explained how the Energy Charter Treaty is risky for the country's energy sovereignty.

He said section-18 of the treaty and its declaration contradicts each other. Though section-18 ensured the right and sovereignty on energy of the signatory countries, the declaration states that it has to be ensured that sovereign policy won't hamper the other sections of energy treaty.

“The signatory country won't have the right to compel the companies to use its products and

Will take steps to start migration to Malaysia

Says expatriates' welfare minister

Expatriates' Welfare Minister Imran Ahmad yesterday said the ministry will take steps to ensure that the flow of migrant workers to Malaysia starts soon.

“We did whatever we could, but people's flow has not started yet... We will look into whether there is any problem [in the process] so that people can go,” he said.

He was addressing an event to award children of expatriate Bangladeshis with education scholarships, organised by Wage Earners' Welfare Board (WEWB), at the capital's Probashi Kallyan Bhaban.

The minister's remarks came amid a delay in sending workers to Malaysia after a memorandum of understanding in this regard was signed between the two countries in December last year.

Recently, the expatriates' welfare ministry started issuing employment approvals to local recruiting agencies for sending workers to the Southeast Asian country.

Attending the event as chief guest, Imran said besides blue-collar work, there is also high demand for skilled workers for white-collar jobs, such as nursing, in some migrant-receiving countries

Make names of conspirators public

Fakhrul tells PM

Stating that an anti-government movement cannot be a plot, BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday urged Prime Minister Sheikh Hasina to make public the names of those conspiring against her.

Speaking at a discussion programme, he categorically said any movement for toppling a government is not a conspiracy, reports UNB.

“We would like to clearly and openly declare that we want to establish a pro-people government by removing this authoritarian regime through a mass movement. There's no question of any plot here,” the BNP leader said.

He said it is Awami League that came to power by resorting to conspiracy in 2008.

The pro-BNP faction of the Dhaka Union of Journalists arranged the programme at Jatiya Press Club, marking its founding anniversary.

On Thursday, the PM said a fresh plot has

‘Better service, better returns’

Biman MD seeks to expand airline to increase yearly turnover

Biman Bangladesh Airlines has planned to expand its business in a bid to make a yearly turnover of Tk 9,500 crore, from the current Tk 6,650 crore, said Biman Managing Director and CEO Zahid Hossain yesterday.

“We want to establish and run Biman as a commercial entity like any other commercial airline – which is the biggest challenge in itself,” he said while speaking at a press meet at Biman's headquarters in the capital's Kurmitola.

He said customer service and luggage handling services of the national flag carrier aren't at the expected level. “There are opportunities to improve Biman's customer service.”

“Why will people buy our tickets if we can't provide services as per their expectations?” he also said.

“Passengers will increase and the business will grow if services are improved,” he added. “We've asked our cockpit and cabin crew to be more cordial with passengers on board, treating them with respect and humanity.”

He said at present, the national airliner makes a yearly turnover of USD 700 million. “But we want to increase it to
