He was also jailed several times throughout 12 years for his political connection. He joined journalism in 1957 with the Daily Azad and later switched over to Daily Sangbad.

His post editorial under the pen name "Aniruddha" made him one of the most popular journalists at home and abroad in his time. The ideology behind his writings on politics, economics and the country circulated around objectivity, independence and honesty. His article, analysis, critique on politics and economics added a different trend in journalism.

Gupta was awarded Ekushey Padak, Sher-e-Bangla Padak, Maulana Tarkabagish Padak Jahur Hossain Memorial Padak, Kazi Mahbubullah-Zebunnisa Welfare Trust Award and many more.

To mark his death anniversary, Santosh Gupta Smriti Parishad will place wreaths at his memorial at Postagola crematorium.

Earlier, UNO Abu Hasnat Mohammad Shahidul Haque confirmed that accused Humayun was temporarily dismissed from his job. The case statement

mentioned that the UNO's office sent three separate letters to the registry office, dated on March 28, April 24 and May 19 this year. In those letters,

Humayun was given the responsibility to register the acceptance of 195 applications for semi-paved houses on government khas lands for homeless and landless individuals.

Humayun However, concealed the original letters from the UNO's office and forged his signature to include 42 ineligible and well-off individual's names in the original list.

containers, was filled by C&F agents instead of the owners, violating a rule of IMDG Code.

Apart from that, there is no obligation for field visits by the office's scientific officer before issuing NOC.

The probe report also said The Dangerous Cargoes Act and "Standing Order for The Working Vessels Carrying Dangerous Cargo in the Chittagong Port", which issues the NOC, were formed during the Pakistan period. Besides, Bangladesh is a member of the International Maritime Organization (IMO), so it has to properly follow the IMDG Code, which is frequently updated.

#### SAFETY-SECURITY **QUESTIONS REMAIN**

During the investigation, the committee found that NOCs for the BM depot have been issued by the fire service, the Department of Environment and the DG shipping office, but the presence of chemical containers was mentioned.

According to the report, the DG Shipping office said the office issues International

and Port-facility Security certificates considering only security (like proper surveillance) and not safety issues. But security and safety issues are related to

each other. The committee said the DG Shipping office should consider both security and

safety issues together. Meanwhile, the report said firefighters do not know storage and handling as well as the IMDG Code. It mentioned that the BM depot had scored only 11 out of 54 points in the fire safety evaluation, conducted by Bangladesh Investment and Development Authority (BIDA).

#### RECOMMENDATIONS

The committee proposed equipping the DGIO (DG Cargo Inspection Office) with a trained workforce and asked for field inspection of cargo before issuing NOCs.

Apart from that. exporters should appoint trained workforce for packaging and transporting goods, include off-docks Chittagong Port in regular meetings of the monitoring committee, and provide Shipping following the IMDG Code.
