Rab yesterday arrested a man for his alleged involvement in the murder of a doctor inside a hotel room in the capital's Panthapath.

Police recovered the body of doctor Jannatul Nayeem Siddique, 27, from a room of Family Serviced Apartments on Wednesday night, said Saiful Islam, officer-in-charge of Kalabagan Police

Her father Shafiqul Alam, a retired physician, filed a murder case against Rezaul Karim, 32, a former banker, with the police station the same day, he

Rezaul, hailing from Cox's Bazar, was arrested in Chattogram city, said ANM Imran Khan, assistant director (legal and media wing) of Rab.

Rezaul and Jannatul took the hotel room identifying themselves as husband and wife on Wednesday morning, the OC said, quoting hotel

By the afternoon, Rezaul locked the room from the outside and left.

Contacted over the phone by the hotel staffers, he said his wife was asleep and he would return soon. In the evening, Rezaul

unreachable. At one point, the hotel staffers

informed police about the incident. On information, police went to the spot and recovered the body, said the OC.

"Her throat was slit and the body had stab marks," he added.

According to the victim's father, Jannatul completed MBBS from Dhaka Community Medical College and was studying a gynaecology course

at Dhaka Medical College Hospital. She left home saying she was going to attend classes, he added.

Police took the hotel manager in custody for interrogation, the OC said.

Militants attack Indian army post in Kashmir

Militants attacked an Indian army post in the disputed Kashmir region yesterday, killing three soldiers, while two attackers died in the shootout that came amid heightened security ahead of India's independence day celebrations.

The attack in the Rajouri area of India's only Muslim majority region took place in the early hours, and the area around the post was cordoned off afterwards as security forces conducted searches, an army official told Reuters.



Russian shelling hits military, civilian targets

Says Ukraine; satellite images show Russian warplanes destroyed in Crimea airbase attack

Russia is attacking scores of civilian and military targets in its bid to establish full control over the east Ukraine regions of Luhansk and Donetsk, with 120 rockets hitting the area around the town of Nikopol overnight, Ukrainian officials said

Dnipropetrovsk governor Valentyn Reznychenko said three people were killed and seven wounded by shelling in Nikopol.

"The enemy is concentrating its efforts on establishing full control over the territories of the Luhansk and Donetsk regions," Ukraine's General Staff said in a report, citing more than 60 settlements and military targets.

Heavy fighting raged around the eastern Ukrainian town of Pisky yesterday, while to the west, Ukraine accused Russian forces of using Zaporizhzhia nuclear

power complex to shield artillery. An official with the Russia-backed Donetsk People's Republic said Pisky, on the front line 10 km (6 miles) northwest of the provincial capital Donetsk, was under the control of Russian and separatist

"It's hot in Pisky. The town is ours but there remain scattered pockets of resistance in its north and west," the official, Danil Bezsonov, said on Telegram.

Ukrainian officials denied that the heavily fortified town, a key to the defence of Donetsk, had fallen, reports Reuters.

The Donbas region, comprised of uhansk and Donetsk provinces, became Russia's main objective after it failed to seize the capital Kyiv at the beginning of the war in February. Luhansk is now almost completely under Russian control but Donetsk is holding out.

Ukraine state energy company Energoatom yesterday said the Zaporizhzhia nuclear power complex was shelled again yesterday, putting the blame on Russian forces that seized the area in March.

The plant's area was struck five times, including near the site where radioactive materials are stored, but that nobody was injured and the situation at the plant remained under control, Energoatom said in a statement.

Meanwhile, satellite pictures released yesterday showed devastation at a Russian air base in Crimea, hit days earlier in an attack that suggested Kyiv may have obtained new long-range strike capability with potential to change the course of the war.

Pictures released by independent satellite firm Planet Labs showed three near-identical craters that had precisely struck buildings at Russia's Saki air base. The base, on the southwest coast of Crimea had suffered extensive fire damage a Ukrainian with the burnt-out husks of at least eight presidential adviser, said in an interview destroyed warplanes clearly visible.

46 cops sued over killing of JCD leader in Bhola

Forty-sixpolice personnel were made accused in a murder case filed yesterday by the wife of Bhola Jatiyatabadi Chhatra Dal president Noor-e-Alam, who was injured during a clash between police and BNP activists in the district town on July 31.

Noor-e-Alam died in a hospital in the capital three days later.

Iffat Jahan filed the case with the Senior Judicial Magistrate's Court of Bhola and not a police station as the case accused cops, plaintiff's lawyer Amirul Islam Bachet told The Daily Star.

Judge Ali Haider Kamal accepted the statement and directed the Bhola Sadar Police Station OC to submit evidence by September 8.

Arman Hossain, inspector (investigation) the police station, was among 46 policemen accused and 25-30 unnamed accused.

Amirul said Noor-e-Alam was shot during the clash with police, adding that Sub-Inspector Md Anisuddin shot him in the face and head.

Man sent to jail for verbally abusing PM on FB

A court in Meherpur yesterday sent a man to jail in a Digital Security Act case filed over the man's verbal abuse of Prime Minister Sheikh Hasina in a Facebook Live video.

Detective Branch of police in Meherpurarrested Abu Taleb on Wednesday night, said Abdur Razzak, officer-in-charge of Gangni Police Station. Anisuzzaman, a Chhatra League leader, filed

the case with the police station. The OC added that Abu Taleb, son of Harun Rashid of Garabaria village in Meherpur Sadar upazila, was produced before the court in the afternoon and was sent to jail.

Saiful Alam, an inspector of DB, said Taleb went live on Facebook on Saturday night and abused the PM over the hike in fuel prices.

He said on the order of senior officials, raids were conducted in Jashore, Chuadanga and Meherpur districts for two days to arrest Abu Taleb.

Three Rohingyas arrested for killings in refugee camp

Three Rohingya refugees were arrested yesterday in a case filed over killing two Rohingya leaders at a refugee camp in Ukhia of Cox's Bazar.

The arrestees - Zafar Alam, 42, Mohammad Soyeb, 23, and Sha Miah, 37 - are residents of Rohingya camp-15. They were arrested from the camp, said Md Kamran Hossain, additional superintendent of Armed Police Battalion

Rohingya leaders Abu Taleb, 40, and Syed Hossain, 35 were shot dead on Tuesday night in the same camp.

Abu Taleb's wife Toyaba Begum filed a case with Ukhia Police Station yesterday morning, accusing five named -- including the arrested trio -- and eight unnamed persons.

The two other named accused are: Mahamudul Sheikh Mohammad Ali.

Shakib to terminate External debt situation more comfortable now Rough time

partnership with Betwinner News on August 3 through a social media post. According to the BCB by-laws, cricketers and staff associated with the board cannot be in association with companies related to betting, alcohol, tobacco etc.

Cricketers are also supposed to inform the board officially before signing any sort of sponsorship

With Shakib not conforming to any of the aforementioned rules, the BCB president informed the board is yet to get a clarification from Shakib as to why he agreed to such a deal without informing BCB about it in the first place.

"It's okay that he now agreed to terminate his contract with Betwinner News. But what he is yet to clarify is why he agreed to get involved in such a deal without informing us [BCB]. We will need to meet him and be clear on the matter.

"If it is about money, it is alarming for us as to what he will do if he gets a much bigger offer in the future. We need to straighten this out. I can assure you that if anything similar happens in the future, we will not wait for his clarification before taking a hard decision," warned Hassan.

The Shakib issue had also put BCB's plans on hold for the upcoming Asia Cup, slated to begin from August 27 in the UAE. With Shakib being considered as the potential candidate for taking over the T20I side's captaincy, BCB delayed announcing the squad for the tournament.
