NOAA STUDY Landfills a key source of methane

Decomposing food waste is releasing thousands of tonnes of planet-warming methane gas at landfills in Buenos Aires, Delhi, Mumbai, and Lahore, new research finds.

With about 570 million tonnes of the greenhouse gas emitted every year from both industrial and natural processes, the concentration of methane in the atmosphere has been increasing at a record pace, according to the US National Oceanic and Atmospheric Administration.

In some countries, the biggestsourceisagricultural fields and farm animals particularly cows but also livestock and chickens. In the United States, the oil and gas industry is largely responsible.

Yet there is another major global source garbage.

With data from a satellite-mounted detector showing high methane levels over cities in India, Pakistan and Argentina, a team of scientists looked more closely to pin down the emissions sources.

A landfill in Mumbai, for example, was putting out about 9.8 tonnes of methane per hour, or 85,000 tonnes per year, according to the study's findings

Landfill waste responsible for about 11% of global methane emissions is expected to increase about 70% by according to the World

Methane is 80 times more powerful than CO2 over a 20-year period.

Satellite technologies are a boost to scientists, said Jean Bogner, a University of Illinois environmental scientist not involved in the research. This new approach helps to "adequately capture sitespecific emissions, which for landfills can vary by orders of magnitude" depending on everything from soil conditions to whether mitigation measures are in

China threat remains

Says Taiwan president

China's threat of force is undiminished, Taiwan President Tsai Ing-wen said yesterday, even though Beijing's largest ever military drills around the island seemed to be scaling down. Furious about a visit to Taiwan last week by

US House of Representatives Speaker Nancy Pelosi, China launched ballistic missiles and deployed multiple aircraft and warships in recent days to simulate sea and air attacks.

China said on Wednesday it would keep up patrols but had "completed various tasks" around Taiwan, signalling a possible end to the war games even while keeping up pressure.

In a white paper published the same day, China's Taiwan Affairs Office said Beijing would

"not renounce the use of force" against its neighbour and reserved "the option of taking all necessary measures". "We are ready to create vast space for peaceful reunification, but we will leave no room for separatist activities in any form," it said in the paper.

Several dozen prominent US and international economists urged the United States Wednesday to hand over to Afghanistan \$7 billion in central bank reserves frozen when the Taliban seized control of the country nearly one year ago.

"We are deeply concerned by the compounding economic and humanitarian catastrophes unfolding in Afghanistan, and, in particular, by the role of US policy in driving them," 71 economists and development experts said in a letter to US President Joe Biden and US Treasury Secretary Janet Yellen.

"Seventy percent of Afghan households are unable to meet their basic needs," they wrote. "Some 22.8 million people face acute food insecurity, and three million children are at risk of malnutrition."

This is worsened by the refusal of the United States to return to the Afghan central bank the \$7 billion in foreign exchange reserves, as well as \$2 billion blocked by Britain, Germany, and the UAE, they said.

Under the BB's moratorium in 2020, borrowers were not considered defaulters even when they missed instalments for an entire year.

The moratorium has been withdrawn, but the borrower-friendly repayment rules remain.

Ahsan reckons that borrowers are under a lot of pressure as they now have to pay their pending and current instalments, which is why many of them have been defaulting on their instalments. The BB has recently relaxed the loan

rescheduling policy to regularise default loans, allowing the wilful defaulters to give a lower amount in down payment, a portion of outstanding loans, he said. In such a situation, bad loans will decrease to

some extent in the coming days, but it will not bring any good news for banks as they will not recover their money, Ahsan said. Fahmida Khatun, executive director of the

Swiss envoy's claim

The amount of money that individuals from around the world stashed in Swiss banks has decreased recently, she said.

However, according to the annual report published in June this year by Switzerland's central bank, the funds deposited by Bangladeshis in Swiss banks have increased by nearly 55 percent to 871.11 million Swiss francs vear-on-year in 2021.

There are allegations that most of this money was earned illegally.

Chuard had further said Switzerland is committed to maintaining international standards, and it is possible to exchange information with the consent of the

punishable offences," he said. Barua said when an order with regard to raising the prices of petroleum was issued in November last year, CAB filed a writ petition saying that the ministry does not have the authority to increase the prices arbitrarily.

The BERC never wrote to the ministry asking for the rationale behind hiking the price, he said.

"Now, you can ask what difference does it make whether the BERC or the ministry sets the price since both are state organisations. The difference s fundamental. Since there is a law in effect, the government must comply with it. But the government apparently does not obey the law. This is the reality and is a crime as well," Barua said.

He said when the ministry sets the

Regulator's mandate price, it leaves no scope for the public killed in Kabul to give their input. When the hike is done through the BERC, however, the commission has to listen to stakeholders and arrange a public hearing before setting the prices -- a practice that was followed recently for adjusting gas prices.

"But when it comes from the ministry, they [the ministry] can increase the price however they see fit, and they don't need to explain it," he added.

On August 6, the day the hiked prices came into effect, when asked whether it was a violation, State Minister for Power, Energy and Mineral Resources Nasrul Hamid told this newspaper, "It's a violation of law if we consider it in one way. But another logic says it isn't.

"Since the market is now volatile, the prices needed to be increased several times. Now if we arrange a hearing every time before raising prices, it would create problems. There would be difficulties if we were to give a 90-day time before increasing the prices."

Top Taliban cleric suicide blast

A senior Taliban cleric known for his fiery speeches against the jihadist Islamic State (IS) group was killed yesterday by a suicide bomber at his madrasa in the Afghan capital, police

Rahimullah Haqqani, who had recently spoken publicly in favour of girls being allowed to attend school, had survived at least two previous assassination attempts -- including one in Pakistan in October 2020.

"He is the only one martyred, Kabul police spokesman Khalid Zadran told AFP, adding that at least four others were wounded in the

Government spokesman Bilal Karimi confirmed his death "in an attack carried out by a cowardly enemy", but did not offer further details.
