He was 71 years old. He left behind his wife and daughter.

He was buried at Mirpur Martyred Intellectuals' Graveyard after a namaz-e-janaza at Gulshan Azad Mosque, said a press release.

GRAFT CASE HC denies bail to UP chairman Selim Khan

The High Court on Sunday refused to grant bail to Chandpur's much-talked about union parishad chairman and expelled Awami League leader Md Selim Khan in a corruption case filed on charge of amassing illegal wealth worth Tk 34.53 crore.

The HC also ordered Selim Khan, chairman of Laxmipur Model Union Parishad in Chandpur, to surrender to the lower court in three weeks.

The bench of Justice Mustafa Zaman Islam and Justice Md Salim passed the order after hearing a petition filed by Selim seeking anticipatory bail in the case. Earlier, Selim appeared before the HC for bail.

Lawyers Md Tamiz Uddin and Khorshed Alam appeared for Selim while lawyer Fowjia Akhter Popy argued for the ACC during hearing. The ACC filed the case against Selim over his alleged involvement in amassing illegal wealth and concealing information.

“There are two alternative roads to reach the highway, but you have to spend over 15 to 20 minutes,” said Soheli.

The railways should appoint a gateman there to avoid accidents, he added. Shopkeeper Salim Mia, close to Noyabati unregistered gate said at least one accident happens there every month.

There is another illegal rail gate just in front of BL College, which is used by over 30,000 students and teachers every day.

Tanushri Bagchi, a student of the college, said, “Authorities can build an overpass or appoint a gateman here.”

Visiting the registered rail gate in Muigunni

Dighirpur area at 5:00pm on Saturday, the gateman's room was found locked.

After some time, the gateman arrived and told this correspondent that he is only on duty when someone calls. “Generally every gateman does this,” he said seeking anonymity.

The same picture can be seen at Daulatpur Bazar rail gate. “There's a gateman there but he's not always at the spot,” said Palash Das, a resident of Boyra area.

Advocate Kudrat E-Khuda, general secretary of Sujan in Khulna, said the railway sector is the country's most corrupt sector. The authorities do not monitor risky rail gates regularly.

“Gatemen of Khulna and Jashore are not performing their duties properly. Railway authorities cannot avoid the liability for accidents,” he added.

Kazi Waliul Haque, assistant executive engineer of Khulna-Jashore region, said, “We alert gatemen from the station at the time of departure and entry of a train. We have already informed the high-ups for appointing more gatemen and ensuring proper monitoring.”
