DEPOSITS WITH SWISS BANKS

Dhaka in talks with Bern to find ways to exchange info

DIPLOMATIC CORRESPONDENT

Bangladesh has started a discussion with Switzerland to develop a mechanism for exchanging information on funds deposited by Bangladeshi citizens in Swiss banks, to ensure that there is no confusion over the matter.

The mechanism will also help bring back money if it was laundered from Bangladesh, said Foreign Secretary Masud Bin Momen.

"We will try to ensure that no one from Bangladesh illicitly transfers money. This does not only concern Switzerland but other countries as well. For example, we know about tax havens like Panama and the Caribbean islands," he told reporters at the foreign ministry yesterday.

At an event at Jatiya Press Club on August 10, Swiss Ambassador Nathalie Chuard said Bangladeshi authorities did not seek information about any particular fund from Swiss authorities.

'Our movement will go on'

Tea workers' strike for pay hike to continue as meeting with govt officials yields no results

A government-convened meeting to discuss revising wages of tea garden workers ended without any decision

The Department of Labour yesterday held a day-long meeting with workers at its Sreemangal's office in Moulvibazar.

As the officials and workers could not reach a consensus over the wage hike, the department will hold another meeting with both workers and tea garden owners today at the department's head office in Dhaka.

"In today's (yesterday) meeting, I heard problems and demand of workers. Then I requested the workers to resume

work. At the same time, we assured them that we will continue discussions with owners about the wage hike. But the workers did not agree," said Khaled Mamun Chowdhury, director general of the Department of Labour.

"We will hold another tripartite meeting tomorrow (Wednesday) at 4:00pm in Dhaka," he told this (Wednesday) correspondent last evening.

However, the workers remain rigid to continue their work abstention until their demand is met.

"We will resume work only after our demands are fulfilled," said Nipen Paul, acting general secretary of Bangladesh Tea Workers Union.

Workers of 166 tea estates across the

country, including those in Chattogram and Sylhet, have refrained from working since August 13 demanding a hike in daily wage from existing Tk 120 to 300.

Meanwhile, tea workers held daylong demonstrations and rallies in different gardens to press home their demands yesterday.

Around 11:00am, workers blocked roads in Gazipur area of Moulvibazar's Kulaura upazila and observed a oneand-a-half hour hunger strike.

Addressing the programme, a female worker Gouri Almik said, "We don't want to conduct any movement. But we have no alternative. It is impossible to survive with a daily wage of Tk 120. We demand

4 killed, 21 hurt in road accidents

Four people were killed and 21 injured in road accidents in three districts during the last two days, according to reports from our correspondents.

In Thakurgaon, helper of a truck driver was killed as another truck hit their parked vehicle in front of Thakurgaon bus terminal early yesterday.

The deceased is Rabiul Islam (20) of Gopalganj. In Tangail, two persons were killed and three injured as a CNG-run three-wheeler hit a paddy laden parked truck from behind on Tangail Mymensingh highway in Nazunbagh area of Ghatail around 5:00am yesterday.

Mohammad Shahjahan (65) and Nepal Chandra Saha (62) were returning home on the threewheeler after attending a wedding party.

Meanwhile, at least 17 people were injured when a Dhaka-bound bus of Jannat Paribahan lost control and fell into a ditch beside the Tangail-Mymensingh highway at Bangra in Kalihati upazila around 6:00am yesterday. Being informed, highway police and fire service personnel took the injured to Tangail General Hospital.

In Panchagarh, a chili trader was killed and another injured as a timber-laden pickup hit their motorbike from behind on Panchagarh-Atwary road in Atwary upazila on Monday night.

Sarwar Kamal (60) from Chattogram's Satkania upazila died on the spot, said police.
