Probe body finds gateman, driver responsible

Both the rail crossing gateman and the microbus driver are responsible for the train-microbus collision at the Mirsarai Borotakia rail crossing that killed 13 people, a probe committee has found.

The committee, led by Railway divisional traffic officer of Chattogram Ansar Ali, submitted its report on Monday with eight recommendations.

The report accused gateman Saddam Hossain -- who is currently in prison -- and deceased microbus driver Golam Mostafa of the collision and subsequent deaths.

The incident occurred on July 29, killing 11 people on the spot and injuring seven others. Of the seven injured, two died while undergoing treatment.

Railway formed two committees to investigate the accident.



The probe committee report found that the gateman of the rail crossing was not present at the time of the accident and the driver of the microbus was negligent.

The committee recommended that the gateman be punished for his negligence in duty.

The report mentioned that the gateman put up barriers on both sides of the crossing before the train's arrival and went to say his prayers.

Someone removed the barrier on one side during his absence. The microbus driver took this chance to cross through.

The committee also mentioned that according to the Railway Act, the microbus violated the rules. It was also

2 rights bodies object to the comments by HC bench

It said such comments brought into question whether Bangladesh has made progress in establishing women's rights.

"Freedom of women, their right to choose or take decisions, right of movement are all constitutional rights. These are also recognised by various international instruments. At the same time, in a place where a woman's dignity, rights and safety should be ensured in the best possible way without giving importance

to clothes, the woman is being harassed again through such a statement."

Naripokkho said such comments by the HC will further encourage harassers.

"The court is the last refuge of the people seeking justice. In that case, such comments of the High Court are highly insulting and totally unacceptable and in conflict with Article 32 [right to life and liberty], Article 36 [right to movement] of the constitution of Bangladesh," said the Naripokkho statement.

Bachelet said, "We have submitted our recommendations for the repeal and revision of certain provisions of the act, with a view to ensuring their compliance with international human rights laws and standards, and preventing arbitrary application or misuse."

The law allows the government to make rules for carrying out the

purposes of this act. It states, "If any difficulty arises in implementation of the provisions of this act, the government may, by notification in the official gazette, take any necessary action in this regard to remove such difficulty."

If the law ministry approves the proposal, it will be published as an official gazette under the orders of the president.

Besides institutional or professional obligations, what a person wears and where the person goes in that attire is entirely a matter of personal taste and preference. So, far from attacking the person, even making indecent comments or raising objections is against civil dignity.

"The girl was in an objectionable state in the platform, which is seen in the CD [containing footage of the incident]. Is it your rights? Is it your rights to dress?" the HC bench asked on Tuesday.

Challenging the bail order, the prosecutor, Assistant Attorney General Syeda Zahida Sultana, argued that Shila started the incident. Shila had asked the student why she had worn the dress and then called other people to the scene, hurled derogatory remarks and pulled the student and her friends by their clothes.

Syeda said a person is entitled to wear any dress they wish and nobody can harass them for that.

Then the court asked the prosecutor, "Are there rights

for preserving culture and tradition? Isn't the dress a part of culture? The socio-economic condition of a society where you visit is also an important issue. There are differences between Dhaka and the rural areas in terms of socio-economic conditions."

The assistant attorney general said culture was changeable.

The HC bench's remarks also touched off outrage in social media.

Yesterday, lawyer Kamal Hossain, who stood for Shila in the hearing, asked

the HC bench to take action against Facebook users who are criticising the judges.

But the bench didn't deliver any order and asked him to submit a written application before the court with relevant documents and screenshots.

Two days after the incident at the railway station, Imaidul Jahedi, in-charge of Narsingdi Railway Police Outpost, filed the case with Bhairab Railway Police Station under Women and Children Repression Prevention Act.

in this regard, this will be the first instance of a rule being passed to aid the implementation of the DSA.

The act has been consistently criticised for being unfairly used to silence journalists and proponents of freedom of expression, to target political opponents and to victimise minority communities.

Data from the Centre for Governance Studies and independent sources show

that between 2019 and February 2022, at least 224 journalists were prosecuted and at least 70 arrested.

At the moment, 14 of the law's 20 offence-related sections are non-bailable, while it allows for arrest without warrant. A warrant is not needed even in instances where an offence is yet to be committed but officers "suspect it will be so".

Since the beginning

of this year, Law Minister Anisul Huq had been making comments about taking steps to address the problematic implementation of the law. In January, he said the law can be amended if necessary.

In May, he said this law has been misused and abused "to some extent" and he had instructed the home ministry to ensure that cases lodged under the act go to special cells, established in

2006 under the Information Communication and Technology Act, for examination.

These cells -- separate entities from the ones proposed the by the ICT Division yesterday -- would assess the cases for primary evidence and accordingly transfer them to the court. Arrests can only be made after the cell's recommendation, Anisul had said.

Sources said another loan for the project has been in discussion for some time between the government and ADB. The lender wants to ensure full safety compliance so that no such incident happens again.

The contractor was asked to resume work after ensuring full safety compliance, he added.

On Tuesday, a government probe

committee in its preliminary report blamed the contractor, China Gezhouba Group Co Ltd, its safety management team, and the crane operator, for negligence.

Although the probe committee led by additional secretary Neelima Akhter has so far not named any individual responsible for the tragedy, experts and road safety campaigners

said the project officials should be held responsible for their negligence.

MEETING WITH MAYOR

Dhaka North City Corporation will today meet the representatives from the agencies implementing development projects in its areas.

The issues of safety at project sites will be discussed at the meeting, expected to be chaired by

Mayor Atiqul Islam.

In another development, the High Court yesterday issued a rule asking the authorities concerned why a directive should not be issued to pay Tk 5 crore in compensation to the victims' families, reports UNB.

The HC bench of Justice Farah Mahbub and Justice Ahmed Sohail passed the order after hearing a writ

petition filed by Supreme Court lawyer Zakaria Khan.

Home secretary, roads and highways secretary, inspector general of police, Bangladesh Bridge Authority, Roads and Highways Department and Dhaka Bus Rapid Transit (BRT) Company are respondents to the rule.

The HC also wanted to know what steps the BRT authorities took in the

last five years for people's safety while carrying out development work. The court asked them to submit a report in 60 days.

Contacted last night, RHD Chief Engineer AKM Manir Hossain Pathan said he was yet to receive any directive.

Shafiqul Islam, managing director of BRT company, could not be reached for comments.
