Earlier at a Janmashtami programme in Chattogram on Thursday, Foreign Minister AK Abdul Momen reportedly said that he urged the Indian government to back Prime Minister Sheikh Hasina so that she can stay in power.

GM Quader, also the deputy opposition leader in parliament, said many people are leaving the country and going to other countries in order to survive. "A reign of corruption has been established in the country. Ideals and justice are being washed away by the tsunami of corruption."

He said the government

can take initiatives to formulate the Minority Protection Act and form the Minority Commission.

GM Quader said their party founder HM Ershad ensured equal rights for all religions alongside making Islam the state religion.

He said huge money is being siphoned off abroad from Bangladesh every year through corruption. "Corruption is rampant in every sector due to lack of accountability. If anyone

criticises corruption, the government considers him/her as conspiratorial and anti-state element." The Jatiya Party chief said criticism must be tolerated and accountability must be ensured to govern the country properly.

Stating that the electoral system of the country has collapsed, he said people need to have the scope to elect their representatives by exercising voting rights in elections.

chance of a permanent job in the tea garden later on," Rajat said. "It's a generational struggle that the government needs to pay attention to."

According to the Statistical Handbook on Bangladesh Tea Industry 2019, there are 166 gardens in the country with a total of 1,40,164 tea workers. In three Sylhet districts, there are 135 tea gardens, where 46,450 registered female workers and 15,153 casual female workers work.

About 74 percent of tea workers live in poverty, according to a 2018 study by Bangladesh Bureau of Statistics (BBS).

Prof Chitta Ranjan Rajbongshi, a tea worker analyst, said, "Keeping aside the government's dependence on tea workers, the one thing that I cannot ignore is that they're the protectors of the 25

percent of the country's forest area. That's why the government high officials should consider improving their living conditions as tea gardens are assets to the government."

"Ninety-nine percent of the tea population voted for the current government. They should keep that in mind as well," he added.

Philip Gain, director of Society for Environment and Human Development, said tea workers are still living like slaves and their wages are never proportionate with present expenses.

"Tea workers are among the most marginalised, excluded and poverty-afflicted population of Bangladesh. They have seen how the garden owners have hijacked the Minimum Wage Board and kept their future hanging in the balance," said Philip.

"It's the government's

responsibility to establish rules of fair trade in the tea sector, and ensure justice and protection for tea workers, who are the most important asset for the country's tea industry," he added.

Nipen Paul, acting general secretary of the Bangladesh Tea Labour Union, said, "These long discussions usually just yield insignificant decisions."

"We're continuing discussions with the worker leaders... But the strike isn't a solution. The tea industry was facing huge losses because of the strikes," said Golam Mohammad Shibli, chairperson of Bangladesh Tea Sangsad (Sylhet).

"This is the season for tea leaves. If raw leaves are wasted, I think the workers will lose the most," said Nahidul Islam, deputy director of labour in Sreemangal.

maintaining the serials, those will not be settled within the tenure of the current government as a long period of time will be needed for this. However, if the chief justice assigns special benches of the HC and Appellate Divisions for hearing and disposing of the matters within few months, long period of time will not be needed to this effect," he added.

Senior lawyer Khurshid Alam Khan, another criminal law expert, said at least five years' time will be needed for final disposal of the cases if the HC starts hearing death references and appeals within a week.

"From little experience, I can say that the High Court may need at least 60 working days for hearing and disposing of the matters. After announcement of the High Court verdict, its judges will write down and release the full text of judgement."

"Then appeals will be moved before the Appellate Division against

the High Court verdict and subsequently review petitions will be moved before the apex court. Therefore, not less than five years' time will be needed for the final disposal of the cases," he added.

On August 13, Law Minister Anisul Huq told The Daily Star that the government has taken all necessary steps to prepare the paper books, which contain all the details of a trial, expeditiously for quick disposal of the cases.

"The paper books are ready now. I have already talked to the attorney general to take necessary initiative so that the High Court starts hearing of the death references and appeals in the cases," he said.

Contacted on August 15, Attorney General AM Amin Uddin refused to make any comment on this issue.

A Dhaka court on October 10, 2018 sentenced 19 people, including former state minister for home

Lutfuzzaman Babar to death in the two cases

for the murders, and for explosives which were used in the grenade attacks.

Nineteen others including BNP acting chairman Tarique Rahman were given life imprisonment and 11 people were handed different prison terms.

Eighteen of the convicted accused, including Tarique Rahman, who is in London, are absconding and 31 are in jail. The SC sources said 63 appeals have been filed by the convicts in connection with the cases and all of them are pending before the HC.

The death references reached the HC on November 27, 2018, for examination of the trial court's verdict.

On January 13, 2019, the HC accepted the appeals filed by the convicts. The same day, the HC bench of Justice M Enayetur Rahim (now a judge of the Appellate Division) and Justice Md Mostafizur Rahman also stayed parts of the trial court verdict that fined the convicts.

have no other option than resigning," he added.

Contacted, Amir Hossain Chowdhury, chief conservator of forests, told this correspondent that he does not know why pervious officials did not regularise the forest guards in due time.

"Our hands are tied as per the Regularisation and Seniority Deciding Regulation 2005. There is no scope for us to go beyond the regulation," he added.

When informed about the High Court ruling that declared the regulation of 2005 to be unlawful, the top boss of the department said he was not aware of the ruling.

When asked why the letter asking the divisional heads to send the updated service book and other necessary information for the regularisation of forest guards was not followed, he said there are issues which may arise while updating the service books.

"If anyone can show me that there was a deviation in following the procedure during regularisation, there are scopes to rectify it," he added.

As per Forest Guard Welfare Association, 2,000 forest guards were recruited from 1982 to 1990. Only 500 out of them received promotions. The fate of the rest has been uncertain since then.
