GIRDER TRAGEDY Four accused granted bail

3 others confess to negligence

Four days after their arrest, four accused yesterday got bail in a case filed over the deaths of five people from the fall of a BRT project's girder segment in the capital's Uttara on August 15.

The four are Iftekhar Hossain, managing director of IFS CON Bangladesh Limited, and its Head of Operations Ajharul Islam Mithu; Build Trade Engineering Company's Administrative Officer Ruhul Amin Mridha and its Marketing Manager Tofazzal Hossain Tushar.

Dhaka Metropolitan Magistrate Shuvra Chakraborty granted their bail after their lawyers moved separate bail petitions, said court

In the order, the magistrate said the four were not named in the first information report (FIR) and all sections under which the case was filed are bailable.

According to the case documents, the two officials of IFS CON Bangladesh outsourced a crane operator and helper through the Build Trade officials for the project.

Three other accused -- IFS CON engineer Zulfikar Ali Shah, crane operator Al Amin Hossain Hridov, and his helper Rakib Hossain yesterday confessed to their gross negligence in maintaining safety and operating the crane that was moving the girder segment.

They were produced before the court on completion of their two-day

Another accused, Manjurul Islam, procurement officer of Gezhouba Group Company, the Chinese contractor of the Bus Rapid Transit (BRT) project, was sent to jail as no lawyer appeared on his behalf.

On Sunday, two other accused Four Brothers Securities employees Md Rubel and Afroj Mia confessional statements admitting negligence. According to case documents, China Gezhouba Group Company appointed the two for traffic management.

A day after the girder tragedy, Afran Mondal Babu, brother of two victims -- Fahima Begum and Jharna Begum -- filed the case with Uttara Paschim Police Station.

A preliminary report of the government probe committee exposed negligence on the part of the Chinese contractor, its safety team and the crane operator.

Nearly 9,000 Ukrainian troops killed so far

Says Kyiv, bans Independence Day rallies for fear of Russian rocket strikes

Nearly 9,000 Ukrainian soldiers have been killed since Russia invaded, the country's top military officer said yesterday, as Moscow accused Kyiv over the assassination of the daughter of a leading hardliner.

The European Union foreign policy chief Josep Borrell meanwhile told reporters in Spain that the bloc was considering military training for Ukraine's

General Valeriy Zaluzhny, Ukraine's commander-in-chief, said Ukraine's children needed particular attention "because their fathers have gone to the front and are maybe among the nearly 9,000 heroes who have been killed".

Zaluzhny's comments on the Ukrainian death toll, reported by Interfax-Ukraine news agency, was the first indication of Kyiv's military losses since April.

On Wednesday, Ukraine will mark its Independence Day -- and six months since Russian troops invaded.

The capital Kyiv has announced a ban on public gatherings around Wednesday's public holiday, and the city of Kharkiv, in

the east, has declared a curfew amid fears of Russian rocket strikes.

an early Russian push on the capital Kyiv, Moscow's forces have focussed on gaining ground in the east of the country.

Covid claims 1 more life; 178 get infected

One more person died from Covid-19 in 24 hours till 8:00am vesterday.

The total number of coronavirus-related deaths is now 29,316, and the death rate stands at 1.46 percent, said a press release of the Directorate General of Health Services (DGHS).

At least 178 new Covid cases were recorded during this period. With the new infections, the number of cases rose to 20,10,148, the release added.

The daily positivity rate is 3.15 percent, while the total positivity rate stands at 13.66 percent.

A total of 5,656 samples were tested across the country during the 24-hour period.

At least 281 Covid patients recovered within this time. The number of recoveries now stands at 19,52,838, and the recovery rate at 97.21 percent, said the DGHS.

Mosharraf Saiful, Sumon's brother-in-law, asked, "How could police hand over the body without informing my sister? We didn't see the father of my brother-in-law in the last two days. He is not mentally stable.

"While waiting outside a Dhaka court to file a case, we received a call from the Hatirjheel Police Station OC. He told us that we should settle the issue keeping in mind the future of Sumon's six-year-old son. He asked us to wait at the court for them, but the police handed over the body to his father and arranged the burial,"

he told this correspondent.

Sumon, a 25-year-old delivery man at a private company, died inside the lockup of Hatirjheel Police Station early Saturday, hours after he was detained. Police later that day filed an unnatural death case.

Law enforcers showed CCTV footage to journalists, which showed that Sumon died by suicide inside the lockup. His family members alleged that police demanded bribes, and tortured and framed him.

Faruque Hossain, deputy commissioner (media) of Dhaka Metropolitan Police, said police didn't force anyone to receive the body.

He alleged that Jannat was "doing politics" over the body. Earlier yesterday, police officials and Sumon's father and brother held a meeting at Hatirjheel Police

Station, said family sources. The namaz-e-janaza of the deceased was held at a mosque in West Rampura before the
