While people might not be aware of it, the trailers and teasers for some of the most successful film franchises—such as Marvel Studios' "Doctor Strange" and DC Extended Universe's "The Batman"—were touched by the hands of a young Bangladeshi motion



graphics designer.

Kamrul Hasan Jisan, born and brought up in Bangladesh, has made great strides towards achieving his dream of becoming a motion graphics designer in the US. The senior motion graphics designer for Wild Card Creative group opened up to The Daily Star for a heartfelt chat about his journey, from Laksham to Los Angeles.

What led to you wanting to become a motion graphics designer? I was brought up in Laksham, Cumilla, in a

very cultural family who were involved in theatre. While their love for the arts had a great influence on me, my dream of working in this line began in 2002, when I first came across "Lord of the Rings".

I was amazed by the type of graphics in Hollywood movies at that time, and so I began pursuing a course in graphics design under a local institution in Laksham.

How did your journey as a motion graphics designer begin?

I first moved to Dhaka in 2008, and began practicing Photoshop with the help of YouTube. With time, I became acquainted with 3D animation and motion graphics, but was limited by the lack of a computer on which I could practice.

In 2010, I began my bachelors in CSE from Ahsanullah University of Science and Technology. By then, I was already earning money through photography and graphic designing.

Around 2012, a senior from my university asked if I would be interested to join his company as a graphic designer, particularly for motion graphics. Even though I did not know anything about motion graphics at that time, I decided to say yes. I learned the basics of motion graphics design overnight from YouTube and joined my first job the next day.

Tell us about your journey to Hollywood. Me and my family came to the US in win a Golden Globe Award.

However, I always knew that I wanted to work in cinema. The thirst to work in cinema brought me to Los Angeles in 2017. It was when COVID began that I left my current job to find luck in Hollywood.

What your first was Hollywood gig?

My first gig was making a trailer for the film "Last Night in Soho". However, personally I feel that my first proper gig was the trailer for "House of Gucci".

Then I worked on making the trailers for Steven Spielberg's film "West Side Story". Coming from the suburbs of Bangladesh, it was a big deal for me to work on a Spielberg film, and to watch my work on television.

Eventually, I worked in big projects like 'Doctor Strange and the Multiverse of Madness", "The Batman", "Bosch: Legacy", "Morbius", and "Tehran".

Where do you see your career headed in the near future?

Right now, I'm very satisfied. There was a time when my friends and family discouraged me, and mocked me for my dreams. But 15 years of struggle have finally paid-off.

Ten years down the line, I want to see myself as an art director. My dream is to become a world-renowned art director and

RIVER BANK EROSION

Jamuna devours over hundred houses in a week

The Jamuna river took a serious turn and devoured over a hundred dwelling houses in Bhuanpur upazila in the last couple of days.

Tangail Water Development Board (WDB) sources said the mighty river turns furious since the very beginning of the monsoon this

Among many other affected villagers, dwelling house of Khalek Miah of Chituliapara village also collapsed in the river a few days ago.

"I can't see well due to my poor eye sight. Now I have no ability to shift somewhere else at this age," said the 80-year-old.

Elderly Razzak Miah of the village said "I came here about a decade ago after my previous dwelling house at Konabari Char was devoured by the

"I've been passing sleepless nights

for the last few days, fearing there will be nothing left if the river devours my house once again," he said. Another villager Amin Chakdar

said four structures of his house have already been devoured by the river while the rest may go to the river anytime.

More than 100 dwelling houses of the village have gone into the river in the last couple of days as the water level in the Jamuna river keeps receding, Noor Hossain of the village

Locals said erosion hit the village during the flood couple of months ago, but villagers checked the erosion then by dumping sand bags.

They also urged the WDB authorities to dump GEO bags to prevent the erosion, but WDB did not take any measures in this regard.

were devoured by the river last year, they added.

Moreover, nearly 200 houses

During a recent visit to the village this correspondent saw riverside villagers were shifting their structures after erosion hit about 500-metre area of the village.

Erosion occurred at Kostapara, Khanurbari and Bhalkutia villages that left several hundred families homeless last year, said Ovijit Ghosh, a rights activist in Bhuanpur.

Local peoples' demand for a permanent embankment still remains a far cry, he added.

Nirbahi Bhuanpur Upazila Officer (UNO) Ishrat Jahan said she informed the WDB officials about the erosion and they already started dumping GEO bags to check it.

Construction of a permanent embankment is also under process, she added. Tangail WDB Executive Engineer Sazzad Hossain said emergency measures have been taken to protect the erosion-hit

But the leaders want to stop us using the name of the prime minister.

Ojit Kairi, another worker, said, "If we agree with the wage increment to Tk 145, then our movement will end with no achievement."

On Saturday, the wing of the government concerned announced the wage hike to Tk145 per day, but the workers rejected it and continued their movement.

Against this backdrop, the Moulvibazar Deputy Commissioner Mir Nahid Ahsan, along with government officials concerned, sat with the representatives of Bangladesh Tea Workers' Union at his office on Sunday night.

In a joint statement, the both parties said that the tea workers will return to work at their current wage of Tk120 and the garden owners will pay the arrears to the workers for the strike period as per tradition.

The wage will be fixed upon the consent of the prime minister following a video conference with her before the upcoming Durga Puja, as per the demand of the union leader, according to the joint statement.

Other demands of the tea workers will be submitted to the deputy commissioner in writing, and the DC will forward them to the Prime Minister's Office. Nipen Paul, General Secretary

of the union, said, "We want direct intervention from the prime minister.' Meanwhile, a tripartite meeting

has been scheduled today in Dhaka with the labour and employment minister in the chair.

During yesterday's protest, Pankaj Kando, vice president of Bangladesh Tea Workers Union, was assaulted allegedly by workers of Kalighat Tea Estate in Sreemangal as he tried to convince them to withdraw the strike.

HC blasts Kushtia DC

so that all ordinary people, including those wearing lungi, can see you working and approach you to get their problems solved.

"We know from our experience how habituated you have become to leading a luxurious life and how you exercise your powers. We are sorry to say that ordinary people cannot enter your offices and bring their problems to you. Your offices are covered by curtains and therefore, people even cannot see your faces,' the HC bench of Justice Abu Taher Md Saifur Rahman and Justice AKM Rabiul Hassan said during hearing of a contempt of court petition.

Justice Abu Taher Md Saifur Rahman told DC Saidul, "Do good work. Take prompt actions against robberies, thefts, muggings and grabbing [of properties]. As a deputy commissioner, you are the heart of the government like the people have hearts. You have many responsibilities. The image of

the government depends on your Always keep your office rooms open activities. The government's policies are implemented through your performance.

"The petitioner of this case went to our office with a complaint. But the staffers of your office did not accept his compliant. If you could hear the complaint, you wouldn't have needed to come here. We know that you [DCs] do many good work. Nevertheless, keep your doors open to the people. If you collapse, the government's image will be damaged," the justice said.

The HC bench, however, thanked DC Saidul for appearing before it and exonerated him from appearing in person before it in connection with the rule. It also fixed October 24 for further hearing on the rule.

Contacted, Waseqa Ayesha Khan, the chairman of the parliamentary standing committee, said, "I didn't get any such proposal.'

When she was informed that it was in the working paper of yesterday's meeting, she said, "So many things were included in the working paper but those are not decisions. We didn't take any decision in this regard."

The committee's recommendations

will be placed soon, she added. On June 5, State Minister for Power, Energy and Mineral Resources Nasrul Hamid placed the bill in parliament and it was then sent to the

House committee. According to the bill, it was prepared as the 15th amendment of the Constitution repealed all the
