### Don't dump sand on farmland

Speakers urge **Mongla Port** authorities

Mongla authorities must withdrew its decision to dump sand on 300 acres of farmlands in Khulna's Banishanta union, said speakers at an event yesterday.

Bangladesh Environmental Lawvers Association, Bangladesh Poribesh Andolon and seven more environmental and rights organisations organised the event at Jatiya Press Club.

In the pretext of increasing navigability and capacity, the Mongla Port authorities are dredging the Pashur river.

The speakers said the recent plan of the port authorities to dump sands on over 300 acres of cropland in Banishanta union of Dacope upazila will have a disastrous impact on the environment and displace at least 5,000 farmers of 1,500 families.

Despite having space to dump the sand in the port area, they are planning to waste agricultural land to cut costs, alleged Md Nur Alam Sheikh, convener of Bapa Mongla unit.

While talking at the programme, farmers of Banishanta union claimed that croplands where sands are dumped can't be harvested for 8-10 years. They demanded that the authorities find alternative ways to dump sand.

Syeza Rizwana Hasan, chief executive of Bela, authorities should consider the locals' demand and find an alternative place to dump SEE PAGE 4 COL 4

# High taxes hindering tourism

Says parliamentary body

The current rates of VAT and other taxes are a major obstacle to developing the country's tourism industry, a parliamentary body said yesterday.

VAT and other taxes on hotels, motels, and goods associated with the tourism industry are much higher than those of other countries. This is a major obstacle to attracting foreign tourists, said the parliamentary standing committee on civil aviation and tourism ministry.

In a meeting at Jatiya Sangsad, with Awami League lawmaker RAM Obaidul Muktadir Chowdhury in the chair, it was said the municipality and city corporation have started the process of collecting holding tax at a new rate and 5 percent tax from those staying in hotels or motels, which will directly hinder the industry's development.

### **COMMISSION HIKE** Petrol pump owners call token strike on Aug 31

Petrol pump owners vesterday called a token strike across the country on August 31 from dawn to 11:00am in demand of increased commission for selling fuel.

The owners also threatened stricter measures if their demands are not met.

Md Nazmul Huq, president of Bangladesh Petroleum Dealers. Distributors, Agents and Owners' Association made the announcement during a press briefing at Dhaka Reporters' Unity.

In 2013, commissions for selling octane and patrol was 4.75 percent, and for diesel it was 3.22 percent, he said.

However, following the fuel price hike on August 5, the commissions have decreased to 3.78 and 2.56 percent respectively. He demanded seven

percent commission for

selling fuel. "If we want, we can create a deadlock across the country but we kept patience. But now our

backs are against the wall," he added. The organisation's other demand was to

ensure the presence of Bangladesh Petroleum Corporation (BPC) or the distributor companies while conducting drives in the pump stations, determining lease fee at a reasonable rate by the Roads and Highways Department. stopping harassment in name of checking documents of tank-lorries while transporting fuel by road.
