# End culture of impunity

14 foreign missions in Dhaka ask Myanmar over Rohingyas

Fourteen foreign missions in Bangladesh, including that of the US and the UK, yesterday called for an end to the "culture" of impunity" in Myanmar and reiterated their commitment to international accountability initiatives for the genocide committed against the Rohingya people.

In a joint statement vesterday, they also said they continue to raise the plight of the Rohingyas on the international stage and seek solutions that would allow for the Rohingyas' voluntary, safe and dignified return to Myanmar as soon as conditions allow.

In a separate statement, US Secretary of State Antony Blinken said the US would support a UN Security Council referral of

the Myanmar situation to the International Criminal Court, apart from supporting the Gambia's case at the International Court of Justice (ICJ).

He also reiterated its commitment to advancing justice and accountability for Rohingyas and the people of Myanmar in all credible courts around the world that have jurisdiction in cases involving Myanmar military's atrocities.

"The US is working to significantly increase resettlement of Rohingya refugees from the region, including from Bangladesh, so that they can rebuild their lives in the US," said Blinken.

Meanwhile, at a seminar on the Rohingya crisis in Dhaka yesterday, Japanese Ambassador to Bangladesh Ito Naoki said his country is considering further possibilities of Rohingya resettlement in Japan with the guidance of UNHCR. The UK's Foreign, Commonwealth and Development Office in another statement said it imposed new sanctions against Myanmar's military-linked companies to target the military's access to arms and revenue. "Our decision to intervene in The Gambia v Myanmar case and a further round of sanctions sends a strong signal of our continued support to seek accountability for the atrocities in 2017 and also restrict the military junta's access to finance and the supply of arms," UK RELATED STORY ON PAGE 3 SEE PAGE 2 COL 1

# **ARREST OF PUBLIC SERVANTS** No prior nod needed: HC

Law enforcers can now arrest government employees in criminal cases without needing to get permission from the authorities concerned.

In a watershed verdict, the High Court yesterday cleared the way for the law enforcers. It declared that section 41 (1) of the Government Service Act 2018 went against fundamental rights and the constitution.

The section made it mandatory for the law enforcers to get prior approval if they wanted to detain public servants in criminal cases before a charge sheet was filed.

"Everyone is equal before the law. From now on, government officials will not get the protection," Anti-Corruption Commission Commissioner Jahurul Haque told The Daily Star.

The HC observed that the section had given protection to a particular segment of the populace and it is contradictory to articles 26, 27 and 31 of the constitution.

Article 26 says that laws inconsistent with the fundamental rights are to be void, and articles 27 and 31 guarantee equality before

the law and the right to protection of the law.

The High Court had earlier scrapped section 32 (Ka) of the Anti-Corruption Commission Act, 2004, for giving similar protection to public servants. The government did not appeal and therefore, there is no scope for the formulation of such a law, the HC observed. The HC bench of Justice

Md Mozibur Rahman Miah and Justice Kazi Md Ejarul Haque Akondo delivered the verdict following a writ petition filed by Human Rights and Peace for Bangladesh, a right organisation, challenging the legality of the Government Service Act 2018 section.

The HC is vet to release the full text of the verdict, which is expected to have details and observations.

Writ petitioner's lawyer Manzill Murshid told The Daily Star that arrest warrants issued by judges for government employees could not be executed because of the section and it hindered judicial independence.

Replying to a question, the lawyer said the section was not exercised in any case, as the writ petition was filed and a rule was issued immediately after the law was formulated.

Meanwhile, Attorney General AM Amin Uddin told reporters at his office that the government would appeal before the Appellate Division challenging the HC verdict.



During the hearing on the rule on Wednesday, Manzill told the HC that the section was discriminatory and contradictory to the constitution, as all citizens are equal in the eye of the law.

Deputy Attorney General Arobinda Kumar Roy told the court that the parliament passed the act to protect public servants considering them a separate class of people.

He said the section applies only when an employee is on duty.

Transparency International Bangladesh (TIB) Executive Director Iftekharuzzaman hopes the Appellate Division would uphold the HC verdict.

"If the public servant is given the protection for being a separate class of people, other sections of the society -- doctors and businessmen -- may also seek the same type of protection," he said, terming the provision discriminatory.

# **JRC MINISTER-LEVEL MEET** Draft finalised on Kushiyara water sharing

The text of the MoU for interim water sharing of the Kushiyara river was finalised at the 38th minister-level meeting of Bangladesh-India Joint Rivers Commission vesterday

The Kushiyara water-sharing agreement is likely to be signed during Prime Minister Sheikh Hasina's visit to New Delhi on September 6-7, a member of the Bangladesh side, who was present at the meeting in New Delhi yesterday, told The Daily Star last night.

Bangladesh brought up the issue of using water from the Kushiyara to irrigate 5,000 hectares of farmland.

At the meeting, held after 12 long years, the Bangladesh delegation also expressed its concern over the delay in signing the Teesta water-sharing treaty.

Shri Gajendra Singh Shekhawat, India's water resources minister, assured that the issue is under their active consideration, said a press release issued by Bangladesh foreign ministry.

Zaheed Farooque, state minister for water resources, led the 17-member Bangladesh delegation, which included AKM Enamul Hoque Shameem, a lawmaker, and Kabir Bin Anwar, senior secretary of the ministry, among others.

The Indian delegation was led by Shri Gajendra, and Shri Pankaj Kumar, secretary of the water resources ministry, attended the meeting among others.
