THEIR FIVE-POINT DEMAND

1. The case against "Hawa" under the wildlife conservation laws should be withdrawn immediately, without further allegations.

2. The censor board should give a clear explanation as to why "Saturday Afternoon" is stuck at the censor board, and has been denied from getting a clearance certificate.

3. The censor board should be abolished and an updated and inclusive film certification law should be formulated, subject to consultation with all stakeholders regarding the proposed film certification

4. An updated and inclusive OTT policy needs to be formulated in consultation

with all stakeholders, regarding the proposed OTT policy.

5. Before filing any case related to film or content, it must be discussed with the relevant authority (For example, the draft OTT policy proposes to create a separate commission board for the platforms).

We will not be able to survive without our wages hiked," said Mohan Urang, a tea worker in Moulvibazar Sadar upazila. "We are victims of discrimination.

We are not paid just wages. We will not resume work until our demand is fulfilled," said Bishwajit Robidas, a worker in Moulvibazar's Kulaura upazila.

Hundreds of workers held a meeting at Sreemangal's Kalighat Garden around yesterday noon and vowed to continue their demonstration until their demand for Tk 300 daily wage is met.

"We, all the workers, have no alternative to continuing the movement as the tea garden owners are not increasing our wage as per our demand," said Pankaj Kondo, vice president of the Bangladesh Tea Labour Union.

Around 125,000 workers in the country's 241 tea estates have been holding protests demanding their daily wages be raised to Tk 300 from Tk 120.

The price of sugar is stable in the international market and the import cost has also remained normal, said Biswajit Saha, director for corporate and regulatory affairs of City Group, one of the leading commodities players.

"But we are buving dollars by paying 20 to 22 percent more." The amount paid to the export

merchant is at the current dollar rate and not the rate when the letter of credit for the import was opened. "Due to this reason, the prices of all

kinds of imported products including sugar are increasing. The price of the product has

increased in the last month although the supply of the product is normal, said Mamunul Hague, a wholesale trader at the port city's Khatunganj market.

Data from the National Board of Revenue Board does support Saha and Haque.

In June, 1.46 lakh tonnes of sugar were imported for Tk 584 crore, meaning each tonne cost Tk 40,000.

The following month, 1.81 lakh tonnes were brought in for Tk 672 crore, with each tonne coming in at

about Tk 37,127. In the first 24 days of August, about 2.37 lakh tonnes of sugar worth Tk 1,039 crore were imported. This means each tonne cost about Tk 43,840.

Rab probing 'false' case

Bappy's father Abdul Barek to its office and recorded his statement to "their liking" after The Daily Star on July 25 ran a report headlined "Bike accident turned into extortion case".

On that very day, Rab-4 received the case documents from Pallabi Police Station.

On March 7 evening, Barek, 60, was injured after being hit by a teenager's motorcycle in the capital's Mirpur-12. However, the statement of a case, drafted by Rab-4 three days later, tells a very different story. There is no mention of the accident or the biker. The Rab accused five college

students and three more teenagers, including two schoolchildren, from the same neighbourhood of beating and injuring Barek, a tea vendor, and extorting Tk 40,500 from him.

Barek, his family members and witnesses told The Daily Star that they had no idea about the alleged assault and extortion.

Rab-4 in June applied to the home ministry's Public Security Division, seeking to take the responsibility of the case investigation.

On July 3, the Crime Division of Dhaka Metropolitan Police wrote to the deputy commissioner (Mirpur division) to transfer the investigation from Pallabi Police Station to Rab-, according to case documents submitted to the court.

about this, Commanding Officer Mozammel Haque said they received the case documents.

"We will now investigate this case. We have talked to the plaintiff," he told The Daily Star earlier this month.

On July 31, Rab-4 Sub-Inspector Monirul Islam, investigation officer of the case, applied to a Dhaka court for permission to record Barek's statement under section 164 of the Code of Criminal Procedure as a "neutral witness".

The IO in his prayer said, "Barek was run over by a recklessly driven motorbike of five college students and the five then hit him with locally made weapons, breaking his arm."

However, Barek earlier told this newspaper that he fainted after the motorbike hit him that day and locals took him to a nearby hospital. Several witnesses also gave the same description of the incident.

Bappi, the plaintiff of the case. said he wanted to file a case over

statement drawn up by Rab. He alleged that the elite force kept him and five of the accused in the Rab-4 office in Mirpur's Paikpara for about 24 hours before they were all taken to Pallabi Police Station for filing the already drafted case and handover of the five accused to police.

The police station recorded the ase on March 10.

Hours after filing of the case, Bappi filed an affidavit with a Dhaka court, saying, "The case was filed following a misunderstanding with the five college students. Later, the plaintiffs and the accused reached a settlement, mediated by some locally respectable persons. The plaintiff will have no objection if the accused are freed on bail and subsequently acquitted of the charges."

Speaking to this correspondent recently, Bappi said Rab-4 had been putting pressure on him ever since he Daily Star published the report.

They have already recorded a statement of my father to their liking. Officials of Rab-4 came to our house looking for me in plainclothes," he alleged. Monirul Islam, who is now

investigating the case, told The Daily Star yesterday that there is no such pressure on the plaintiff or his family. The allegation is baseless."

He added, "We are investigating the case. Recently, we took a statement from the plaintiff's father under section 161 of CrPC.

Meanwhile, sources said the Rab Headquarters has launched an "internal enquiry" into the allegations. Investigators from the intelligence unit have talked to the plaintiff, his father, witnesses, accused and their family members recently.

A family forced into never-ending distress

Describing the April 10 arrest incident, Raju said the Rab members went to their house around 11:30pm in a microbus, a car and two motorbikes. Seven to eight men in plainclothes first entered the house with several others waiting outside.

They introduced themselves as Rab men and asked him to go with them in connection with a narcotics case filed eight years back.

The family, still in shock over the disappearance of Mohon four years ago, thought the men, who were in plainclothes, were bluffing. Jamsher even told them that some Rab members picked up his elder son in a similar fashion.

About half an hour later, some Rab members in uniform went there and insisted that Raju go with them.

The family members wanted to see the warrant, but the officers did not show it. At one point, they "grabbed Raju by his collar" and forced him onto a vehicle.

"Inside the vehicle, they slapped me thrice," Raju said, adding that his mother and wife followed the vehicles and saw them enter the Rab-4 office. In the courtroom, court officials

said the case was summarily dismissed in January 2019 as there was no witness, he said. "My brother went missing three

months after I flew to Malaysia. Then I myself was about to become a victim of enforced disappearance," Raju told this newspaper.

Mohon was picked up in front of a crowd on the night of June 10, 2018, and three CCTV cameras captured parts of the incident.

One clip seen by The Daily Star shows five to six men in civilian clothes near the house in Mirpur 2. Two others came on a motorcycle, forced Mohon to sit between them and sped away.

About 10 days later, a man named Hafizur Rahman, claiming to be a Rab-4 member, went to Jamsher's house and told him that Mohon was in the Rab custody. The desperate father gave Hafizur some money and

medicines for his son.

The next day, Hafizur returned, this time with a letter apparently written by Mohon to his wife. It read Mohon was in confinement and was being tortured in custody, Jamsher

Jamsher held a press conference about the incident on August 28, 2018, where he provided journalists with what he said was the call history showing about a hundred calls were made from Hafizur's number to his phone between June 13 and 24.

Ninety-four of the calls were made from Mirpur-Paikpara area where the Rab-4 office is located. Of the remaining six calls, one was from Rajarbagh Police Lines. Several calls were made to three official numbers of Rab-4, according to the Call Detail Record that Jamsher obtained from a law enforcer.

Jamsher also showed journalists what he said was the registration this. form of Hafizur's SIM card, which had a photo of the man in police uniform.

While investigating Mohon's disappearance, The Daily Star in May 2019 talked to Hafizur. He said he had served in Rab-4 earlier but was now posted in Meherpur police.

The same month, the then Rab-Commanding Officer Chowdhury Manjurul Kabir denied that his unit abducted Mohon.

The current commanding officer, Mozammel Haque, talking to The Daily Star on August 1 declined to comment on this, saying he was not posted in the unit at the time.

About picking up Raju, he said Rab often acts upon arrest warrants issued by the court. He has to look into whether the warrant was recalled in this case.

LAND DISPUTE LINKED?

Jamsher links all his "troubles" to a dispute over a piece of land with a local named Azizul Hossain Khan, and said some Rab members may have turned against him having been influenced by that man, a claim this newspaper could not independently

Azizul obtained the power of attorney over the disputed 0.75 katha plot in Mirpur in 2007 after signing a deed with one Faruk, according to

But Jamsher claims the plot is within their ancestral land where they had built their house and the matter is pending with the court.

"He [Azizul] has long been trying to evict us. I filed two general diaries after he had threatened me. Then several cases were filed against my family members one after another. We have been cleared from all charges. Now they have filed a fresh case against my grandson and nephew," he added.

Azizul refuted all the allegations and said, "There was a dispute over the land in the past. That does not mean I have influenced [Rab] to do all these.' Locals, including a councillor in Mirpur, wishing anonymity said

Azizul is linked to the ruling Awami League and has a number of close relatives in the police. Azizul declined to comment on

Jamsher also points to a man

named Joy Ahmed, an "informant for Rab" who spent time in prison in a case he filed for allegedly taking Tk 2 lakh from him, promising to have Mohon Mia released from Rab custody.

Joy, however, denied his involvement in all this.

Meanwhile, the extortion case has been handed over to the Rab upon its application to the home ministry, documents show, though Mirpur police had been investigating it.

Anwar Hossain, sub-inspector of Pallabi Police Station, who investigated the case earlier, said Rab received the case documents on July 25, the day The Daily Star published a

The plaintiff, Nazmul Hossain Bappi, told The Daily Star that it was in fact an incident of a motorbike accident in Mirpur on March 7, when his father was injured as a teenaged boy hit him with a speedy motorbike.

The next day, when five college

students known to the biker went to their house to settle the matter, some Rab-4 members picked them up.

Jamsher's grandson and nephew were later named in the case without the knowledge of the plaintiff.
