

BRIDGE ON SUBORNAKHALI RIVER

# Villagers' wait gets longer

Despite assurances by public representatives for the last 50 years a permanent bridge over Subornakhali river in Jamalpur's Sarishabari upazila has not been

As a result, thousands of residents of at least 25 villages of the upazila and Sirajganj's Kazipur upazila have been suffering immensely.

In absence of a permanent bridge over the river people of several villages have to cross the river by boats, risking their lives, locals said, adding that despite repeated pleas, the authorities concerned are yet to take any initiative in this regard.

Abu Bakar Siddique of Char Pogoldigha village said they have been getting promises about building a concrete bridge over the river during every local and national elections, but nothing has been done so far.

The river flows through

Jamalpur's Sarishabari upazila and Sirajganj's Kazipur upazila, villagers said, adding that thousands of people of different use Gamartola Ferry Ghat to cross the river on small boats

Nagar area said nearly 50,000 people of some 25 villages on for their agricultural products. either side cross the river daily as Kazipur upazila headquarter is about 100 kilometres by road via Tangail and Sirajganj, while it is only 25 kilometres on waterways.

Due to lack of a concrete bridge over the river for decades, people's sufferings get worsened during the monsoon, Abul Kalam Azad of Pogoldigha village said.

A permanent bridge can connect two snapped unions of Kazipur with Jamalpur and other districts including the capital, he added.

It is very difficult for many families, living at different proper education to their kids

due to the poor communication system, Mamunur Rashid of the area said.

Farmer Suruzzaman of villages under the two upazilas Monsur Nagar in Kazipur said due to lack of a permanent bridge over the river, local farmers are compelled to sell their produce Ashraful Alam of Monsur at a cheaper price, while in many cases they have to count losses

> If a bridge connects the two unions of Kazipur with Sarishabari, it will bring more developments, said Shams Uddin, former chairman of Pogoldigha Union Parishad (UP).

Students are the worst suffers as they have to attend their classes by crossing the river on boats during the rainy season or walk-through sandy lands in the dry season, said Shipon Miah of Guiyakhara village in Kazipur. Sarishabari Upazila Engineer of Local Government Engineering Department (LGED) Jahidur Rahman said he will visit the area villages along the river, to provide and submit a report for necessary

He said the Bangladesh Border Guard forces are, however, on high alert as precaution.

Jahangir Aziz, chairman of Ghumdhum union, said heavy gunfire was being heard from the other side of the Bangladesh-Myanmar border for the past two weeks, adding that the landing of the mortar shells made everyone in the area panic.

BGB officials in Cox's Bazar could not be reached for comments on the matter. Asked, Foreign Minister AK Abdul Momen told reporters at the foreign ministry that the government would inquire into the matter if the mortar shells landed there accidentally or on

### Tea workers return to work

By yesterday morning, workers started collecting tea leaves in Khaichhara, Bhurbhuria, and Zerin tea gardens in Moulvibazar's Sreemangal.

"Most of the tea estates remain closed on Sunday. So, all the held workers are expected to join work by tomorrow [today]," said Nipen and rail tracks to press home their Paul, acting general secretary of the Bangladesh Tea Workers Union.

the country's 241 tea estates have meeting with a delegation of tea been protesting since August 9 demanding their daily wage be raised to Tk 300 from Tk 120.

They abstained from work from August 9-12 for two hours a day before going on a full-scale strike from August 13.

On August 21, some workers' leaders agreed to end the strike, accepting an offer to raise the pay to Tk 145. But most of the workers refused and continued abstaining from work.

In the last two weeks, workers demonstrations, formed human chains, blocked roads, demands.
