### **ENFORCED DISAPPEARANCE** Gross violation of rights: ASK

The government must set up a cell where the victims of enforced disappearance can lodge complaints, demanded Ain o Salish Kendra (ASK).

independent Furthermore, an commission must be set up to investigate each case, and prevent further incidents from happening, the organisation said in a statement.

"Enforced disappearance is a gross violation of human rights, and a state based on human rights must ensure accountability for this crime," the statement read.

They demanded trial and punishment of those involved in forcefully disappearing people. They also demanded justice and victim protection for the disappeared and their families.

ASK demanded that Bangladesh sign the International Convention for the Protection of All Persons from Enforced Disappearance, an international treaty meant to prevent this crime.

They asked that the government admit that enforced disappearance happens, and SEE PAGE 5 COL 5

### Give Tk 5 lakh to Jaha Alam SC orders Brac Bank STAFF CORRESPONDENT



Bank Ltd to give Tk 5 lakh to jute mill worker Jaha Alam in seven

days Alam had been wrongly imprisoned for three years in place of the real accused in several corruption cases.

Chamber judge of the Appellate Division Justice M Enayetur Rahim passed the order while hearing petition filed by Brac Bank challenging the HC verdict that directed the bank authorities to pay Tk 15 lakh in compensation to Jaha Alam.

The judge also stayed the verdict and sent the petition to its full bench for hearing the matter on October 31.

If the Brac Bank authorities fail to give Tk 5 akh to Jaha Alam in seven days, the stay order on the HC verdict will be stand vacated. On September 30, 2020, the HC directed Brac Bank Ltd to pay Tk 15 lakh in compensation to Jaha Alam as two of its officials Faisal Kayes and Sabina Sharmin -- supplied the photo and information of Jaha Alam, instead of the real accused Abu Salek, to the IO of the ACC. The ACC investigation officers then identified Jaha Alam and implicated him in the corruption cases, the HC observed.

KAU has already formed a committee to formulate a policy akin to that of appointing teachers Bangladesh Agricultural for University to address anomalies in recruitment, said a university official.

University Grants Commission (UGC) has found several anomalies in the recruitment of teachers and staff for KAU. As per the findings, on August 3, the ministry gave several directives centring the anomalies. The Daily Star obtained copies of the findings Department of Computer Science and recommendations of UGC's probe committee.

transport Improving trade and connectivity, alongside regulations and logistics, between India and Bangladesh, as well as other neighbouring countries can be a game-changer not only for the two countries but also for the entire region, said Indian High Commissioner Vikram Kumar Doraiswami yesterday.

He said currently, the big challenge of trade between the two countries is high cost, as most of the trade happens through land route, which is inefficient and not environmentally friendly. A truck cannot carry more than 15 tonnes of goods, and mostly has to use one land route.

"If you think about that, this is a recipe for creating monopoly. This is one of the reasons why our trade is so expensive and so difficult," Doraiswami said at a SEE PAGE 5 COL 1

Even after 51 years of independence, the noncommunal country that Bangabandhu dreamed of has not been built yet, said Liberation War Museum Trustee Dr Sarwar Ali at a discussion marking National Mourning Day.

"Bangabandhu Sheikh Mujibur Rahman sacrificed a lot to build a non-communal Bangladesh," he said while addressing the programme, organised by Moni Singh-Farhad Memorial Trust on Sunday.

Ramendu Majumdar, renowned thespian who has received Ekushey Padak, said, "A proliberation party is running the government, but the fundamentalists are running the society."

## **Of empty wallets** and cracked eggs

A mother of three, Nasima Begum (30) is a regular customer of "Fakinni Bazar", under Bijoy Sarani-Tejgaon Flyover, along the rail tracks.

This market is a go-to place for lower-income people.

"My husband is a rickshaw puller. Fish and meat were always beyond our purchasing capability, so eggs were our last resort to get nutritious food. But after the price hike of eggs, we were unable to purchase it," she told this correspondent.

Left with no other choice, she has resorted to eating cracked eggs.

"I often feel eggshells in my mouth while eating. But we are not in a position to buy an egg for over

Tk 10," said Nasima.

The bazaar is set up on both sides of the rail tracks, where people living in shanties nearby sell daily goods. The sold product is not particularly in good condition, as most are on the verge of rotting. But for people like Nasima, this market is the only option they have.



Rozina Begum (34) echoed the same. She said despite the recent decrease in the price of eggs, they have to buy cracked eggs as the costs of other daily commodities are still off the roof. "I have four children. Earlier my husband used to earn Tk 800-900 per day through his tailoring job. Now his income has dropped to Tk 200-300 a day.'

"I am not in a position to spend more than Tk 100 for food. So we have to settle with cracked eggs," said Rozina. The rising prices of eggs last month threatened lower-income people's protein intake.

Despite a recent drop in egg prices, these families are still depending SEE PAGE 5 COL 5
