Large firms fleeced consumers: probe

Large producers in Bangladesh colluded with each other to send the price of eggs to an unprecedented level in the middle of August, hurting the pockets of consumers struggling to make ends meet, according to a probe report. In normal times, wholesalers sell eggs at a profit of 15-20 paisa per piece, but between August 9 and August 13, they made a profit of Tk 2.70 per egg, it said.

EMPLOYEES' ARREST SC chamber judge hears govt petition Refuses to stay HC verdict

The Supreme Court chamber judge yesterday refused to stay a High Court verdict that cleared the way for law enforcers to arrest government employees in criminal cases without permission from their authorities concerned.

Justice M Enayetur Rahim, the chamber judge of the SC's Appellate Division, heard a petition filed by the state seeking a stay on the HC judgement.

The apex court judge, however, sent the petition to its full bench for further hearing on the matter today

Evidence (Amendment) Bill placed in JS

"Evidence (Amendment) Bill, 2022' incorporating the admissibility of digital evidence in the court was placed in parliament

At present, digital evidence is not accepted in

According to the proposed law, digital record or electronic record means any record or information generated, prepared, sent, received or stored in magnetic, electro-magnetic, optical or microfilms, computer memory, computergenerated microfiche including audio, video, DVD, CCTV footage, drone data and records from mobile phone, hardware, software or any other digital device as defined in Digital Security Act,

Besides, finger, palm and iris impressions and digital footprints, signatures and certificates will also be admissible as evidence before a court.

Law Minister Anisul Huq placed the bill, which was sent to the parliamentary standing committee on the law ministry for further examination. The parliamentary watchdog was asked to submit its report within 30 working days.

Another salient feature of the proposed law is that it bars any questions on the character or previous sexual behaviour of the victim during cross-examination in rape cases.
