

## MUNIA'S DEATH PBI given time again to finish probe

A Dhaka court yesterday again asked Police Bureau of Investigation (PBI) to submit – by September 28 – the probe report in a case filed against Bashundhara Group Managing Director Sayem Sobhan Anvir and seven others over the rape and murder of a college student in Dhaka's Gulshan.

Dhaka Metropolitan Magistrate Begum Yasmin Ara passed the order after IO Md Alauddin, an inspector of PBI, failed to submit the report.

With this, PBI took 18 dates to submit it.

Police recovered the body of the 21-year-old in a Gulshan flat on April 26 last year.

Her elder sister on September 6 filed the case bringing allegations of rape and murder.

## Man fined Tk 1 lakh for cutting hills

A mobile court fined a man Tk 1 lakh on the charge of cutting hills in Barlekha upazila of Moulvibazar yesterday.

The court led by Jahangir Hosain, executive magistrate and Barlekha assistant commissioner (land), took the action against Md Dinar Hosain, a tractor driver at Banikuna.

He said the fine was imposed in accordance with section 15 (I) of the Sand and Soil Management Act 2010.

## Petition challenges legality of DAP

A Supreme Court lawyer yesterday filed a petition with the High Court challenging the legality of the gazette notification of the Detailed Area Plan (DAP) for the capital.

Advocate Md Eunus Ali Akond submitted the petition to the HC, saying that the government has approved the DAP and issued a gazette notification to this effect on August 22 in violation of the Town Improvement Act, 1973, Water Bodies Protection Act, 2000 and Acquisition and Requisition Act, 2017.

According to the laws, the government cannot cancel the previous DAPs and change its water bodies, but the government approved the DAP defying the provisions, he said.

Eunus said his 5 katha plot in Bashundhara area has been included in the recent DAP though it was out of the DAP of 2010. Therefore, Rajuk is not giving him no objection certificate for building a house in his plot, saying that a 200-foot road will be constructed through it.

He prayed to the HC to stay the effectiveness of new DAP.

On August 22, the ministry of housing and public works issued a gazette notification for the DAP of 1,528 square kilometres under Rajuk.

With the new gazette, the effectiveness of the old DAP was reportedly abolished on that day, so the new DAP, effective from 2016 to 2035, will be valid from now.

## BCL leader assaults RU teacher

A leader of Bangladesh Chhatra League allegedly assaulted a teacher of Rajshahi University on the campus yesterday.

Prof Moizur Rahman of veterinary and animal science department revealed the information after submitting a written complaint with the university's vice chancellor.

In his complaint, Prof Moizur claimed that the incident occurred while students of Institute of Business Studies (IBA) and his department clashed over an inter-department football match on Habibur Rahman Hall playground at 11:00am.

When the professor went to resolve it, the IBA students assaulted him.

A video footage given with his complaint shows the RU IBA unit of BCL president Abu Sinha was pulling his t-shirt's collar while joint secretary Saikat Raihan was seen running towards the teacher with a stick in his hand.

Students of veterinary and animal sciences department protested the teacher's assault and formed a human chain demanding punishment for IBA students including the BCL leaders.

Denying the allegations, Abu Sinha said, "I didn't know whether a teacher was there during the incident, I did not hurt anyone."

RU Proctor Ashabul Hoque said they formed a three-member committee to investigate the incident.

## JS body finds proof of ex-MD's

The sub-committee submitted its report before the parliamentary body in March.

Later in July, Sirajul Islam submitted a letter before the body, requesting to relieve him from the allegation.

In the letter, Sirajul claimed that he had done everything on the instruction of Iftekharul.

The parliamentary body yesterday recommended to suspend pension and other financial benefits of Sirajul Islam till the investigation against him is disposed of.

According to the investigation report, Iftekharul acted as per his whims without considering government regulations. He did not follow any rules in leasing out trust property.

During investigation, the sub-committee asked Iftekharul to appear before it and explain. But he did not do so, nor did he send any statement before the sub-committee.

The report highlighted several specific allegations against Iftekharul and said that Southeast Metal

Industries was the highest bidder for taking lease of two acres of land of Metal Packaging Ltd, owned by Muktiyoddha Kalyan Trust, in Chattogram's Nasirabad.

But he leased the land to one of his loyalists by showing the lowest bidder as the highest. The former MD did it for personal gains.

According to the report, financial transactions, abuse of power and violation of rules have been clearly proven in the process of leasing out Purnima Filling Station in Dhaka, without the approval of the trust's executive committee and trustee board.

The report said there is nothing like "gate tender" in the government procurement policy. But Iftekharul leased out seven pieces of the trust's land and 7.25 acres of Tabani Beverage under gate tender.

The sub-committee also revealed that Iftekharul had appointed employees of the trust to serve his son. Iftekharul's son used to work in a private company in Mymensingh. Three employees of Muktiyoddha

Kalyan Trust were appointed there to work full-time. Tk 16.48 lakh was spent from the trust's funds to pay their salaries and allowances.

Besides, a driver of the trust was employed full-time at Iftekharul's residence and was paid salary from the trust's funds as well.

During the former MD's tenure, his mobile phone bill incurred additional expenses of Tk 11,300. And Tk 83,085 has been spent on additional fuel beyond the allotted amount for his car.

Talking to The Daily Star, Iftekharul yesterday said that findings of the sub-committee are completely false.

Asked why he didn't appear before the sub-committee, he said the sub-committee was not formed maintaining due legal procedures.

Meanwhile, the parliamentary body yesterday in its meeting recommended taking legal actions against private television channel Nagorik TV for publishing news related to the trust.

Some of them were arrested earlier, but they returned to their fraudulent ways after securing bail, said detectives. Investigators said the gang used to deceive people using their professional identity.

For instance, Enayet is a contractor and has some connection in this sector. While meeting people for work, he used to deceive newcomers by saying that getting a new work- or

tender-order is easy for him, said detectives.

Foyez is a computer operator by profession and was responsible for printing all fake appointment letters.

The Daily Star has also managed to collect some copies of Foyez's fake letters, which have original letterhead pads of different banks and offices, and seals of top officials.

Jalal is a private-job employee, and Kawsar

is an NGO staffer. Their major role was to collect new candidates in the name of offering jobs, said detectives.

ADC Junaed said, "We have received a huge number of appointment letters from the arrestees' phones."

"We are now trying to know how many more people were involved with the gang, and how much they have collected by deceiving people," he said.

Abdul Qayyum, officer-in-charge of Chawkbazar police station, said Department of Archaeology inspected the site recently and stopped construction work.

Rakhi Roy, regional director of Department of Archaeology, said they heard about the issue a while ago and immediately visited the site. The owner of Holding-15 has pledged to not demolish the structure further.

The department officials will inspect the relevant papers, Rakhi said.

Earlier, owner Ali Hossain said they were demolishing the structure as the city corporation identified it as a risky, and they obtained permission to construct a multi-storey building on the site

from Rajuk. He had also claimed that this was not part of Boro Katra and they purchased it in 1978.

Contacted, Shah Alam Chowdhury, director of Rajuk's zone-5, denied giving such a permission.

### ABOUT BORO KATRA

"Katra" is a Persian word that means caravanseraai or roadside inn. Multiple katra were constructed during Mughal and Nawabi era in Dhaka. Of them, Boro Katra and Chhoto Katra are mentionable, according to historians.

Boro Katra is located at a point in between Buriganga river and Chawkbazar. Mughal prince Shah Shuja constructed it for his official residence. After construction, the prince did not want to use it as a residence, which is why the palace had turned into an

inn. The Department of Archaeology on December 21, 1989, announced the structures as "Protected Archaeological Site".


In 2020, Rajuk declared the two structures as "Traditional Special Establishments".

The existing rules prohibit any kind of expansion, exclusion and change of such archaeological sites. Even, no permanent establishment can be constructed on their premises or adjacent areas.

However, defying the rules, occupiers have constructed many structures inside the premises of the two establishments and its adjacent lands.

And now, a section of it became the recent victim of so-called development.
