"Narco-Saints", which was released this month with the title "Suriname" in South Korea, tells the story of a man who risks his life to join a secret mission to capture a Korean drug lord operating in Suriname. The show is based around real-life events from almost two decades back.

In a statement on the government's website, Foreign Minister Albert Ramdin said, "Suriname no longer has the image that emerges in the series or no longer participates in these kinds of practices.'

Rangpur JP rife with tension

The sudden decision to relieve Ranga came through a JP press release on Wednesday afternoon. It said Quader relieved Ranga of all party posts, exercising his power conferred under the party's charter.

In an immediate reaction, Ranga on Wednesday evening said Quader did not have the powers to expel him.

"Either he or I will do politics. I accept this as a challenge. I helped him become the party chairman at a time when everyone was against him. He won't be able to go to Rangpur.... Earlier, he ignored the party charter and removed me from the post of secretary general without holding any council."

The lawmaker, however, made a U-turn yesterday saying he would not create any trouble in Rangpur centring the issue.

"I was a bit angry when I received the party's order. That's why I issued the challenge to the chairman [GM Quader]. But I have withdrawn it. I am announcing that there will be no trouble in Rangpur over this issue.

"I want withdrawal of the party's decision on my removal. But I will not be unhappy even if it is not withdrawn," the JP MP said at a press conference at the Dhaka Reporters

quit the party if it was not run in a democratic manner.

"I will not be in the party even as a member if it is not run democratically. However, I won't join any other party.

Speaking at another press conference yesterday, JP Secretary General Mujibul Haque Chunnu said Ranga was relieved of all party posts as he was involved in activities that violated the party's discipline.

"He [Ranga] had been involved in such activities for about a year. His activities went against the party's policy and discipline. He was relived of all party posts in line with the party's constitution."

Chunnu said Ranga would be able to return to JP only if the party chairman wanted him to.
