# State coffers robbed of Tk 4,697cr by Petrobangla, BPC

Finds CAG compliance report

The government has been deprived of about Tk 4,697 crore for 19 counts of irregularities by Petrobangla and Bangladesh Petroleum Corporation, found an audit.

disclosure comes after the Comptroller and Auditor General (CAG) pored over the books of 11 companies under Petrobangla from fiscal 2014-15 to 2016-17 and two companies of BPC for fiscal 2013-14. The findings were presented in parliament in June.

The irregularities include spending beyond the rules to buy goods and services at high prices; flouting the instructions of the finance ministry and the National Board of Revenue; and disregarding the Gas Sales Rules 2004 and 2014, the Bangladesh Gas Act 2010, Bangladesh Energy Regulatory Commission, the Public Procurement Act 2006 and the

Public Procurement Rules 2008.

Of the Tk 4,697 crore that was lost, Petrobangla's failure to deposit in full the value-added tax and supplementary duties, collected from the gas distribution companies, to the exchequer alone accounts for Tk 4,597.3 crore, the CAG

In fiscal 2016-17, Petrobangla collected VAT and SD of Tk 6,015.5 crore, which it was supposed to deposit to the exchequer. But it deposited Tk 2,080.3 crore, keeping the rest in its accounts. There has been a 2 percent interest on the outstanding sum, which comes to Tk

So the state coffer has Tk 4,270 crore outstanding from Petrobangla, the report

# Panicked, locals scramble to safety

Thirty-year-old Noor Hasina lives in a house in Konarpara along the Tambru border in Bandarban's Naikhongchhari

Around 8:30pm on Friday, a mortar shell suddenly hit the fence around her house. Her husband, Badiul Alam, was

She left the house immediately with her four children, the youngest only four months old.

"I took shelter in a relative's home in Ghumdhum, about half a kilometre off the border," she said.

The Daily Star met her in the border area around 9:00am yesterday when she returned home to see its condition.

Like Hasina, some other families left their homes on Friday night in fear of life after a mortar shell fired from Myanmar exploded at a Rohingya camp on no-man's land near Tambru Bazar. The explosion killed a Rohingya youth and injured five other people, including two children.

"At least 35 families of Baisfari,

Paharpara, Konarpara and Majherpapra areas have left their homes and taken shelter at their relatives' in different areas of Cox's Bazar," AKM Jahangir Aziz, chairman of Ghumdhum Union Parishad, told The Daily Star.

Monowara Begum, 32, a resident of Paharpara, said they could not sleep Friday night because of the sound of continuous gunshots coming from across the border.

"The sound was so loud that it felt like our home would collapse," she told this newspaper near Tambru Bazar.

Visiting the border area yesterday, these correspondents found that the situation was tense. Some local traders did not even open their shops

Abdul Karim, a grocer at Ghumdhum Bazar, said he didn't open his shutters over worries that anything bad could happen anytime.

Meanwhile, a special one-hour closed-door security meeting was held at the Bandarban deputy commissioner's office from 3:30pm vesterday.

DC Yasmin Parvin Tibriji, however, didn't disclose anything about the meeting.

## UN group records five more cases

Five new incidents of enforced disappearance in Bangladesh were reported to the UN Working Group on Enforced Disappearances in the last one year.

communicating with. According to the Hong Kong-based Asian Human Rights Commission (AHRC), there were 19 new reported cases of enforced disappearance within this reporting

period, and four of the victims still remain missing. AHRC keeps an account of enforced disappearances

reported by the media in Bangladesh. Of the five new cases taken up by the UN Working Group, two are considered "time-sensitive" or "urgent procedure" cases, where a person is being detained arbitrarily, and the situation warrants urgent action by the government.

This means the UN had proof that two people were being

#### Hospital had no clue man died falling down lift shaft

A 60-year-old patient was killed after falling down a lift shaft from the ninth floor of National Institute of Cancer Research and Hospital in Mohakhali.

Even though Kalam Bepari tumbled down the shaft on Thursday morning, the hospital authorities did not notice what happened until yesterday evening, when they looked at the security camera footage at his son's request.

Kalam, a rickshaw puller from Barishal, was admitted to the hospital with stomach cancer and he was supposed to go through a surgery today.

The incident happened around 7:32am as the lift got stuck between the ninth and 10th floors while the door remained
