

### ATTACK ON JOURNOS 2 BMDA staffers sent to jail

A metropolitan magistrate court in Rajshahi yesterday sent two employees of Barind Multipurpose Development Authority to jail for assaulting two journalists while they were on duty on September 5. The convicted are Jiban Ahmed, a storekeeper and general secretary of BMDA Employees Union, and Abdus Sabur, a driver of BMDA executive director Abdur Rashid. Earlier in the day, police arrested them from a BMDA rest-house in Dhaka. They were among the seven named accused in the case for assaulting two journalists - Bulbul Habib and Md Rubel Islam. Islam, cameraperson of ATN News, and Habib, a reporter for ATN News and The Business Standard, came under attack when they went to the BMDA premises and started broadcasting live around 8:30am. It all began when Rashid entered the office half an hour late. As the journalists went to talk to him, an infuriated Rashid began rebuking them. At one point, Rashid hit Bulbul and asked him to leave. Minutes after Rashid went inside his office, at least 20 staffers, led by Jiban swooped on the reporters.

On June 16 of 2016, ACC Deputy Director Jahangir Alam and also the investigation officer of the case, submitted a charge sheet against Jalal and Shamsur, showing 43 people as prosecution witnesses. Shamsur's name was not included in the first information report but his involvement with the incident was found in the investigation. On December 31, 2014, ACC filed the case against Jalal and three others with Banani Police Station. The others accused are Jalal's wife Aleya Fatema, the vice-president of the cooperative; his son Talha Ahmed, its general secretary, and his daughter Radia Ahmed, its joint secretary. According to the case statement, Dhara Multi-purpose Cooperative Society Limited - founded

by Jalal and his wife - collected about Tk 59 crore from 1,451 investors alluring them with high interest rates. But Jalal allegedly siphoned off the money to his son and daughter living in the US. In April 2013, Jalal provided a bond in the presence of army and intelligence officials, promising that he would return all the money deposited by the cooperative members by 13 July, 2013. But he failed to do so. Jalal went into hiding in September 2013. Dhaka Cantonment Board had taken several measures to pay back the investors' money but failed, said the case statement. Names of Jalal's wife, son and daughter were dropped from the charges of the case as their involvement with the graft was not found.

Contacted, Shamsul Alam Talukder, general secretary of Rangunia upazila Awami League, said a part of Samshuddoha's speech has been made viral for negative publicity. "He is a candidate for the leadership of Jubo League's central committee. I think the video has been made viral by his rival to tarnish his image," said Shamsul Alam. "Many things can be said during speeches out of emotion. Even BNP leaders threaten us and make derogatory comments about us during their speeches."

"I spoke to Shamsuddoha about the speech. He said it to energise our activists. However, we have asked our leaders and activists to be more responsible in such cases," added Shamsul Alam. Contacted, Mahbub Milki, officer-in-charge of Rangunia Police Station, said "I just want to say that he [Samshuddoha] did not do the right thing." He declined to make any further comments. This correspondent failed to contact Samshuddoha despite repeated attempts.

complete primary school. In addition, nearly half of the children remain unregistered at birth. One in every two girls falls victim to child marriage. Meanwhile, untold millions of children live on the street. Prime Minister Sheikh Hasina, in a video message, made the ground-breaking commitment of increasing the number of social workers by 200 percent, by recruiting 6,000 new social workers, bringing the workforce from 3,000 to 9,000 yesterday at the

Police Benazir Ahmed said threat of militancy has not been removed completely and will remain until the problem persists globally. Dhaka Metropolitan Police Commissioner Shafiqul Islam, who was the first chief of ATU, said militancy may see a rise ahead of the national election when police will remain busy for election purpose and advised all to keep an eye on that. Chief of ATU, Additional IG SM Ruhul Amin, said

the unit was formed on September 19, 2017 in the backdrop of militant attacks in 2016 and 2017. It started its operations following the enactment of rules in 2019. He said ATU, along with other units, have brought militancy under control. "No third party was involved in the negotiation, pricing and policymaking process," claimed the statement. It also wrote that in the government-to-government process, the government committee, which includes the officials of several ministries and divisions attended the negotiation process, held a four-hour long meeting and took the decision unanimously.

As the neighbouring countries did not export wheat, the country tried to collect wheat from Australia, Canada, Brazil and Argentina on a G2G basis and found the price over 500 dollars per tonne. That is why the government did not express its interest in that.

issuing a work order to company Prodintorg, a company considered to be controversial, the ministry press release said it was also nominated by the Russian government, which has been supplying wheat to Bangladesh since 2016-17. The TIB statement wrote that a South Asian country cancelled the agreement with Prodintorg recently due to the inflated rate. This information is not available to the ministry, it said in the statement. The food ministry thinks that by hiding the right information, TIB intentionally issued the statement to mislead people and conspire against the government.

rampant cases and arrests under this law. As an example, he mentioned the recent shocking incident of a female student of Jagannath University being arrested under DSA for conducting a webinar two years back, when she was only 17 years of age. "She has been in jail for almost a month and rejected bail prayers three times so far." "As with most DSA lawsuits, the very ground

of the cases filed against the student in question is also shaky. She has been charged with 'provoking' incitement to overthrow the government through a single webinar that she was only moderating. This is very unfortunate," added Faisal. Article 19 also called for the immediate release of the Jagannath University student and the withdrawal of the case filed against her in the statement. They also pointed out

that with DSA, it is very common to see students at the school and college level being sued, including a 14-year-old ninth grader who was arrested for allegedly defaming the Prime Minister. "For the sake of democracy, Article 19 demands immediate implementation of the promise made by the government to amend the controversial sections of DSA," read the statement.

Acting Foreign Secretary Admiral (Retd) Khurshed Alam and the foreign ministry's Southeast Asia wing director general Najmul Huda briefed the envoys of ASEAN on the escalation of violence on the Bangladesh-Myanmar border between the Myanmar military and insurgent group Arakan Army. Except for Myanmar, diplomats of all the ASEAN countries - Brunei, Cambodia, Indonesia, Laos, Malaysia, the Philippines, Singapore, Thailand and Vietnam - were present at the briefing yesterday. The foreign ministry will today brief the rest of the foreign diplomats posted in Dhaka about Myanmar's repeated space and land violations.

assets of Bangladesh are under threat," he added. Since the middle of August, the foreign ministry summoned Myanmar Ambassador to Bangladesh, Aung Kyaw Moe, four times. However, the situation has not changed. The government has ordered the Border Guard of Bangladesh and Coastguard to remain on high alert but asked them not to mobilise their troops yet. "We also said both Bangladesh and Myanmar agreed on Rohingya repatriation. This decision might also be affected by ongoing conflicts. This also jeopardises the safety and security of the Rohingya community," said Najmul Huda. He also mentioned that the Myanmar ambassador, while summoned by the foreign ministry, tried to blame the Arakan Army for the firing of mortar shells on the Bangladesh side of the border. However, Dhaka said Myanmar has to take responsibility for air or land space violations regardless of the reasons for such violations, he added. Asked what was the response of the ASEAN diplomats in this regard, another official present

at the meeting said the ASEAN diplomats would convey the issue to their headquarters and make sure that Myanmar's overall situation is strongly raised in the ongoing UN General Assembly. They said they were also unhappy about Myanmar's conflicting situation where the Myanmar junta and pro-democracy civilian forces are fighting. Members of the Rohingya community, who took shelter in Bangladesh in 2017, could not return to Myanmar due to the lack of safety and guarantee of citizenship. ASEAN diplomats said they were frustrated that there was no progress on the five-point consensus reached at an ASEAN meeting early last year. The consensus includes an immediate end to violence in the country; dialogue among all parties; the appointment of a special envoy; humanitarian assistance by ASEAN; and the special envoy's visit to Myanmar to meet with all parties. "We hope our ASEAN friends will use their influence on their member state Myanmar to stop the escalation of violence and violation of international rules," said Najmul Huda.

### Mixed tidings for idol artisans

The 60-year-old has been making idols for about five decades. Although he grew up in Savar, he moved to Shakhari Bazar before the Liberation War. Since his childhood, he saw his father and grandfather making idols and learnt the craft from them. "Our business picks up during puja season. We start working after having breakfast and it goes on throughout the night," he said. Orders are taken two to three months in advance to make each idol. Depending on the size, design and quality, prices range from Tk 10,000 to Tk 2 lakh. "However, we struggle during off-seasons when the celebrations are over," he said, on a rather depressing note. Old Dhaka's Shakhari Bazar is famous for idol-making. Currently, four to five shops make such idols for puja. This correspondent stopped in one such outlet to talk with artisan Paltan Pal. He said the number of people making idols has decreased, mainly because of the lack of workers, as the new generation is reluctant

to enter this profession. Sitting next to Paltan, another veteran artisan Haripada Pal, said, "I am old and can no longer work like I used to. Due to the lack of workers, I could not make any idols." According to the Mahanagar Sarbojanin Puja Committee, this year's Durga Puja will begin with Shashthi Puja on October 1 and end with Bijaya Dashami on October 5. Mahindra Nath, president of the organisation, said, "There will be 241 puja mandaps in Dhaka, six more than last year."
