ATTACK ON JOURNOS 2 BMDA staffers sent to jail

A metropolitan magistrate court in Rajshahi yesterday sent two employees of Barind Multipurpose Development Authority to jail for assaulting two journalists while they were on duty on September 5.

The convicted are Jiban Ahmed, a storekeeper and general secretary of BMDA Employees Union, and Abdus Sabur, a driver of BMDA executive director Abdur Rashid. Earlier in the day, police arrested them from a BMDA rest-house in Dhaka.

They were among the seven named accused in the case for assaulting two journalists -- Bulbul Habib and Md Rubel Islam. Islam, cameraperson of ATN News, and Habib, a reporter for ATN News and The Business Standard, came under attack when they went to the BMDA premises and started broadcasting live around 8:30am. It all began when Rashid entered the office half an hour late. As the journalists went to talk to him, an infuriated Rashid began rebuking them. At one point, Rashid hit Bulbul and asked him to leave.

Minutes after Rashid went inside his office, at least 20 staffers, led by Jiban swooped on the reporters.

"We have told the ASEAN diplomats that mortar shells and firing of bullets from Myanmar to the Bangladesh side are a serious concern for us. On Friday night, a Rohingya youth was killed and several others were injured," Najmul Huda told this correspondent. "People living along
