

Tension over holding tax heats up in Ctg

Kordata Surakhkha Parishad, mayor's supporters face off

The tension between the Kordata Surakhkha Parishad Chattogram and the followers of city Mayor Rezaul Karim Chowdhury over holding tax is heating up.

Several hundred leaders and activists of Chhatra League formed a human chain and rallied in front of Chattogram Press Club yesterday, demanding the arrest of the Parishad president Nurul Absar over his recent remarks about the mayor.

Habibur Rahman Tarek, president of Omar Gani MES College unit of BCL, presided over the programme.

BCL activists from Government City College, Omar Gani MES College and Hazi Muhammad Mohsin College mostly took part in the rally, said sources.

The speakers warned the Parishad leaders of resisting them on the streets if they make any "derogatory" comments about the mayor in future.

Meanwhile, the Parishad brought out a procession from the city's Kadamtoli intersection that paraded some thoroughfares.

Contacted, Amir Uddin, its general secretary, said their procession was heading towards Chattogram Press Club. On the way, police requested them not to go there to avert an untoward situation. "As a result, we concluded the procession at Kodomtoli," he said.

Kordata Surakhkha Parishad Chattogram, a citizens' platform to protect taxpayers' rights, has been demonstrating for over a month against increased holding tax under the new assessment system.

SAFF winner Akhi's family in legal trouble over land gifted by PM

When the entire nation has been celebrating the victory of female football players for winning SAFF Women's Championship, footballer Akhi Khatun's family from Sirajganj's Shahjadpur upazila is facing legal trouble for a land gifted to her by the prime minister.

Prime Minister Sheikh Hasina on June 4 gifted the piece of khas land to Akhi, who won the golden boot in SAFFU-18 Women's Championship, for building a house.

A local court on September 19 imposed section 144 on the eight-decimal land and ordered local administration to submit a report.

Since then, her family has been facing legal troubles regarding the ownership of this land. A local man filed a case with the court claiming the land originally belongs to a mosque.

Akhi's father Md Akter Hossain said, "I am a labourer. I am lucky that my daughter has been performing well for the nation. When we got the prime minister's gift, we were elated. Now I am worried if we will ever get possession of the government-donated land."

Akter also blamed the local administration for giving him the

"disputed land".

"When the land was selected by the local administration, they might not have checked the land's present situation. When I visited the spot, I came to know that this is a wet land, occupied by others in the name of building a mosque," he said.

Shahzadpur UNO, however, said the khas land is under Khotian No-1, so this is originally government land. "Nobody has the right to occupy the land. If the right papers are submitted at the court as per its order, the complexity will be

resolved," he said.

Meanwhile, two policemen of Shahzadpur Police Station have been closed and attached to the district police lines on charges of misbehaving with the family members over the land issue. Akhi's father said the two policemen visited his family to deliver the court order on September 21 and misbehaved with them. A committee was formed to investigate the matter, said Additional Superintendent of Police (Shahzadpur circle) Md Hasibul Islam.

2 govt hospitals limping along

Understaffing, equipment shortage hamper services in Narsingdi

The two government hospitals in Narsingdi are struggling to provide healthcare services to patients due to a shortage of doctors and basic equipment.

Around 800-1,000 service-seekers come to Narsingdi Sadar Hospital and Narsingdi District 100-bed Hospital every day, from Narsingdi, Kishoreganj and Brahmanbaria.

Patients alleged that doctors mostly remain absent as they remain engaged at some 40-45 private hospitals around these two government facilities.

The doctors also refer patients to private hospitals for "proper treatment", stating limitations at the government facilities.

Besides, most doctors are reluctant to get into such government facilities in the first place, meaning most of the openings remain vacant.

Sources at Narsingdi District 100-bed Hospital said out of 33 doctor's posts, only 13 are currently filled. There is only one pharmacist against six,

One killed, ten hurt in Rangpur road accidents

A man was killed and 10 were injured in three separate road accidents in Rangpur yesterday, said police.

At the city's Hasna Mor, the helper of a trucker was killed and the driver was injured as it hit another truck from behind.

The deceased was identified as Alamgir Hossain (34) of Modern Mor area in Rangpur.

Quoting locals, police said the Modern Mor bound truck hit another at Hasna Mor after one of its front tyres burst.

Fire service personnel rescued injured Jalal Mia, and sent him to Rangpur Medical College Hospital.

In another accident, seven bus passengers were injured as it fell into a ditch beside Dinajpur-Rangpur highway at Hajirmor.

The injured were taken to RMCH, confirmed Badsha Masum Alam, station officer of Rangpur Fire Service and Civil Defence.

Meanwhile, a driver and his helper were injured after a sand-laden truck plunged into a ditch after the driver lost his control over the vehicle in Keranihat area.



GONE TOO SOON

The last of Lawachhara's African Teak Oak

Among the 167 species of plants in Moulvibazar's Lawachhara forest, two rare species of trees, known as the "African Teak Oak", were the elements that attraction for hundreds of tourists to the forest.

Typically, this species of trees live upto 500 years.

The larger one between the two was uprooted during a storm around 15 years ago. Since then, the one remaining became the only trace of the species in Bangladesh.

But now, even that lone tree is slowly dying.

The researchers of Bangladesh Forest Research Institute have announced that the tree is dying, after collecting some samples of its roots, which have been rotting for quite a few days now.

Adding that not much can be done to revive the tree, scientists said whether the death is coming at its natural course or influenced

by any external factors, can only be determined after thorough research on the collected samples.

Sylhet Divisional Forest Officer Rezaul Karim Chowdhury said, "We think the around 100 feet tree was planted here in the 1930s. Probably the British brought the tree and planted it. It hasn't been found anywhere else in Bangladesh."

A British official planted several saplings of the African tree in Lawachhara, only two of which survived, said Saju Marchiang, a Lawachhara resident.

Lawachhara National Park's Bit Officer Md Anisuzzaman said, "With the demise of the country's only surviving teak tree, a century-old legacy in this region will also end."

Director of Forest Research Institute Rafiqul Haider said the soil under the base of this tree was changed a year ago. They initially thought the tree died due to some bacteria that came with the fresh

soil.

Md Zillur Rahman, research officer of Forest Conservation Department of Bangladesh Forest Research Institute, and Abdul Rashed Molla, research officer of its Soil Science Department, were in the team that collected they dying tree's root samples recently.

"A plant may die due to a disease, insects, microorganisms or soil problems. It can also happen because of multiple other factors. We cannot immediately tell what happened," he said.

"The sample roots and the soil around the tree will be researched and analysed in the laboratory of our institute, after which we can submit a report on the matter to the relevant authorities," he added.

Rashed Mollah said, "The tree is still partially alive. But the chance of survival is very low because its roots have rotted. Since it can't produce food, it's dying."
