Jhumon denied bail again

A Sunamganj court yesterday denied bail to Jhumon Das, who was arrested in a case filed under the Digital Security Act.

Judge Zakia Parvin of Sunamganj District and Sessions Judge's Court passed the order, said Pankaj Kumar, Jhumon's lawyer.

We will be filing a bail plea with the High Court," the lawyer said.

Around 11:30am on August 30, police picked up Jhumon from his home in Noagaon village of the district's Shalla upazila over an allegation of "hurting religious sentiments" through a Facebook post.

Next day, Sub-inspector Sumnur Rahman of Shalla Police Station lodged a DSA case against Jhumon. A court then sent him to jail.

On September 4, his first bail appeal was rejected by another local court.

Police arrested Jhumon on March 16 last year for a Facebook post criticising Hefazat-e-Islam leader Mamunul Haque. The following day, people attacked Noagaon village, vandalised and looted at least 90 Hindu houses and four temples.

After serving almost six months in jail in a DSA case, he was released on bail on September 28 last year.

Young couple found dead in city flat

Police suspect murder-suicide

The bodies of a young married couple were recovered at their newly-rented flat in Dhaka's Mohammadpur in what police suspect was a murdersuicide incident on Sunday.

The dead were identified as Md Noman, 27, an expatriate returnee from Saudi Arabia, and his wife, Shamima Akhter, 20. They got married about a year ago.

"Noman's body was found hanging from the ceiling while Shamima's was on the floor," said Pantosh Banik, sub-inspector (SI) of Mohammadpur Police Station.

Post-mortem reports indicated that the woman might have been strangled to death while the man might have committed suicide, morgue sources said.

According to police, the couple rented the flat on the second floor of a five-storey building on Babar Road on September 12, four days after Noman returned from Saudi Árabia.

On Sunday, they were supposed to submit copies of their NID cards to the landlord, but they were not

'No decisions' on closing borders

Says Moscow amid exodus of military-age men; US warns Russia against using nuke weapons in Ukraine

The Kremlin yesterday refused to deny that Russia might close its borders to prevent an exodus of military-age men after President Vladimir Putin declared a partial mobilisation in an effort to regain the upper hand in the war in Ukraine.

Kremlin spokesman Dmitry Peskov also confirmed that Russia was in "sporadic" contact with the United States on nuclear issues, after Washington warned of "catastrophic consequences" if Moscow used nuclear weapons to protect Ukrainian regions it looks set to annex.

Citizens in four regions of Ukraine were voting for a fourth day yesterday in Moscow-organised referendums on joining Russia, a plan Kyiv and the West have branded a sham. They say the votes are rigged and they will not recognise the

Asked about the possibility of border closures, Peskov told reporters: "I don't know anything about this. At the moment, no decisions have been taken on this."

Multiple reports have documented how people with no military service have Finnish authorities said, while Russian received draft papers - contrary to Defence state media said the estimated wait to Minister Sergei Shoigu's pledge that only enter Georgia hit 48 hours at one point those with special military skills or combat experience would do so - prompting even queuing.

"Today the situation is critical: our residents are scared, our residents are panicking, they don't know what will happen tomorrow and when they will actually take our people away for enlisting," Mayor Ivan Fedorov said.

The governor of Luhansk, another region Moscow aims to annex, said Russian-backed officials were carrying ballot boxes from door to door accompanied by security officials.

Six die from Covid, highest in 2 months

At least six Covid-19 patients died while 718 people tested positive for the infection in the past 24 hours till 8:00am yesterday.

This is the highest number of Covid deaths and

highest number of cases reported in a day since the beginning of August.

The new cases were lodged after 5,288 samples were tested across the country.

The daily positivity rate rose to 13.58 percent from the previous day's 12.96 percent, says a press release published by the Directorate General of Health Services.

With the new numbers, the total number of deaths have reached 29,259, with the death rate at 1.45 percent.

Three of the deceased were male, while the other three were female. Two were aged between 31 and 60, and the rest were above 60.

13-yr-old tortured to death
