Around 44 percent of processed food was found to contain a higher amount of salt than mentioned in the packet. According to the study, around 97 percent of people consume packaged food twice a day.

brands who provide false information on labels.

Recently, the clinic authorities have managed a free X-ray test facility at a Brac centre in the city's Mashkanda area.

But it is not a good deal for many poor patients coming from faraway places as it would be better if the tests are available at the clinic, said Razib Mia, a patient from Mymensingh's Trishal upazila.

Only cough examination can be conducted at the clinic. For all the related examinations, if needed, like blood, CT Scan and FNAC (Fine Needle Aspiration Cytology), patients are referred to Mymensingh Medical

College Hospital, said Tajul Islam, who came to the clinic with his ailing mother.

Dr Anupam Dutta Roy, consultant of the clinic, said the engineers of Department of Public Health visited the clinic in May to install an X-ray machine in the facility, and it will be done soon after ensuring necessary budget.

Dr Md Nazrul Islam, Mymensingh civil surgeon said, the X-ray machine that went out of order more than 20 years ago could not be replaced due to space constraint.

The civil surgeon said they are taking steps to ensure proper facilities.

Sayed Hajj Tours and Travels, Subway Travels and Holiday, Sunflower Air Linkers, and Arab Travels and Tours. Common allegations are that the agencies misbehaved with pilgrims and sent them to Saudi Arabia late, according to the Bangladesh ministry.

Despite repeated attempts, The Daily Star could not contact the agencies for comments. **ANSWERS SOUGHT**

On Monday and Tuesday, the religious affairs ministry sent show-cause notices to three hajj agencies – Al Aksa Travels, Super Khidma Travels and Khaja Air Wesis – for not providing proper service and cheating pilgrims.

Earlier, the ministry also

sent notices to six agencies for their involvement in various irregularities.

The ministry on Tuesday asked Khaja Air Wesis to send its reply within seven days, as it did not provide services to one pilgrim as per the agreement.

In a notice served on Monday, the ministry said Super Khidma Travels took Tk 2.30 lakh from a person, but the agency did not send him to Saudi Arabia for hajj. The ministry asked the agency to send its reply within seven days, asking why actions will not be taken against it.

In another notice served on Monday, the ministry asked Al Aksa to send its reply within three days, as it cheated and misbehaved with seven pilgrims.

more likely to avail of C-section deliveries, than mothers who had none.

In addition, mothers with stronger educational backgrounds were 2.87 times more likely to have C-section deliveries, compared to mothers with no formal education.

Mothers from a higher-income background were also found to be more likely to avail of C-section services compared to those belonging to lower-income groups.

According to Dr Razzaque, the authorities should implement effective

national monitoring measures to put restrictions on the rising number of caesarean deliveries.

Naripokkho founding member Shireen Huq also joined the seminar virtually and suggested that the training for the traditional birth attendants or midwives should be resumed and they must be included in the referral chain.

According to Shireen, the idea of 100 percent institutional delivery is a wrong move from the government, which was influenced by international organisations.

"It resulted in the exclusion of trained midwives from the referral chain," she added.

BIDS Director General Dr Binayak Sen moderated the seminar and highlighted the importance to find out if the increase in C-section deliveries in private facilities is a result of malpractice or not, through the study.

"The media can also play an important role in creating awareness among women so that before the delivery, they can decide whether they actually require the caesarean section or not," he added.
